## Eliminating Public Notices in Newspapers is a Bad Idea

**H**ere we go again! Arizona Senator John Kavanagh (R) Fountain Hills wants to eliminate Public Notices

from Newspapers through SB1006. I do not want to go down the rabbit hole of lousy ideas Senator Kavanagh has had

over the years, but this recurring debate over public notices in newspapers is insidious. We have issues to resolve in this state, and on the list of importance, this one does make the cut of 'important.' Hating the press is not a good enough reason for us engaged citizens.

Whenever the government takes over a task that is being done efficiently by the private sector, several things always happen. It becomes more expensive than originally planned, it takes more manpower than originally planned, and the result is less than desirable than planned. The current method of delivering important information to the taxpayers through the local newspapers' print and online platforms is not broken, and it serves the best interests of the citizens.

Public Notices published in local

newspapers is THE definition of transparency.

Newspapers are the last bastion of locally written, trusted, credible, verifiable information dissemination with a keen knowledge of the community. Senator Kavanagh, I'm sure you cannot say the same about government-controlled information sites. Let's all make sure that Public Notices remain in the local newspapers across this great state. Send a message to Senator Kavanagh at [jkavanagh@azleg.gov](mailto:jkavanagh@azleg.gov), and your local State Legislator to tell them to fix things that are broken, not create remedies for issues that do not exist.

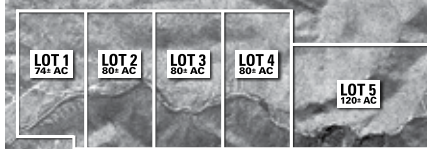

**Summary**

On November 15, 2022, Arizona Water Company ("AWC" or "Company") filed a Notice of Intent to file a Rate Application with the Arizona Corporation Commission ("Commission").

On December 15, 2022, AWC filed a Rate Application for its Eastern Group which consists of the Southeastern Region (Apache Junction, Superior, Miami, Bisbee, Sierra Vista, and Winkelman water systems) and Falcon Valley (Falcon Valley, Oracle, Saddlebrooke Ranch, and San Manuel water systems).

The Company asserts that for the test year ending June 30, 2022 ("TY"), AWC had adjusted operating income of approximately \$3 million and an original cost rate base ("OCRB") of \$117.9 million and fair value rate base ("FVRB") of \$171.2 million resulting in a rate of return of 2.55 percent on OCRB. AWC's proposed rates and charges that would produce an overall revenue increase of \$9.7 million or approximately 32 percent, to produce an 8.21 percent rate of return on the Company's OCRB or a 5.97 percent rate of return on its FVRB. The Company requests that its new rates take effect no later than January 15, 2024.

In addition, AWC proposes further consolidation of rates within its Southeastern Region and Falcon Valley service areas. The Company also requests to continue its approved Central Arizona Project surcharge as well as its Purchased Power Adjustor Mechanism.

The Company requests to expand the applicability of its Arsenic Cost Recovery Mechanism ("ACRM") to address compliance with federal regulation of "forever chemicals" and to then rename the ACRM the Federal Compliance Cost Recovery Mechanism ("FCCRM"). AWC estimates that FCCRM investments will total approximately \$43 million. AWC also proposes to continue its System Improvement Benefits ("SIB") surcharge mechanism to recover a return on and of net investments made between rate cases for water main and water service connection replacements, and to be administered consistent with the currently approved SIB mechanism for the Eastern Group.

AWC requests the implementation of a new Tax Expense Adjustment Mechanism to allow it to adjust for changes to federal and state income taxes. The Company also proposes to increase the Water Availability Fee charged to developers in Apache Junction, and to implement a new Sustainable Water Acquisition Mechanism to acquire and maintain a sustainable water supply for the Eastern Group water systems. The Company's proposed rates and charges are intended to produce the following revenue increases within each service area:

Your request **must be filed or eFiled no later than June 12, 2023**. Your request to intervene **must** contain the information below:

1. Your name, address, and telephone number;

3. A short statement explaining:
  - a. Your interest in the proceeding (e.g., a customer of the regulated company involved, etc.),
  - b. How you will be directly and substantially affected by the outcome of the case, and
  - c. Why your intervention will not unduly broaden the issues in the case;
4. A statement certifying that you have sent a copy of your request to intervene to the regulated company or its attorney and to all other parties of record in the case; and
5.
