



Angela Hillan-Ramirez, the chamber director, has been doing double duty. Gerry Kaufhold, the new chairman of the parade this Saturday, has undertaken his job with enthusiasm. Chamber members and friends are all volunteering their time. And Rosalind Padilla's quiet and effective presence will be felt everywhere.

The Kearny Police Department is deeply involved too. Chief Richard Corso has set up extra patrols, and deputies from Pinal County will be assisting. Moreover, several Arizona Rangers are coming to help out, providing historical color as well

They meet monthly for training and organizational purposes, and stand ready to assist the

officers at any time.

The VIPS are an integral part of our community. They are volunteers pure and simple. Their only pay is the shirt they wear! Well, they are also paid with the satisfaction of doing a good job in helping to keep our community safe.

The VIPS are eager to expand their presence with new members. Residents who would like to serve are encouraged to let Chief Corso or any current member of VIPS know of their interest. Training is required, and all VIPS are finger printed and given a background check before beginning. The VIPS schedule is very flexible, allowing volunteers to give as much of their time as they desire.


## Take marijuana cultivation question to Pinal County voters

On Feb. 27, 2015, the group Citizens Against Open Cultivation filed a referendum petition application (REF20150227) against Ordinance No. PZ-C-001-14, which is a text amendment to the current medical marijuana ordinance. The Pinal County Board of Supervisors approved the text amendment to the current ordinance on Feb. 18, 2015. The Planning and Zoning Commission voted 9-1 and recommend the Board of Supervisors deny the proposed changes. The Pinal County Attorney's office and the county staff members assigned to the case also recommended the board deny the changes to the current ordinance.

The new ordinance dramatically alters

the manner and location of which medical marijuana can be cultivated in Pinal County. Under the prior county ordinance, medical marijuana could be cultivated in an enclosed building


Please check in to the office upon arrival, there will be a sign-in sheet specifically for the rocket launch.

## Pinal County resident shares memories of Selma

There are times in our lives that define who we are. There are the small things, personal tragedies and triumphs. Then there are the big things. The things that make us ask, "Where were you when?"

We are just now as a country experiencing the anniversaries of those defining moments.

We mourned again in 2011 the 10th anniversary of the terrorist attacks in New York and at the Pentagon. The nation remembered the 50th anniversary of the assassination of President John F. Kennedy in 2013. Last year marked the 70th anniversary of the end of World War II.

Saturday, though, was the anniversary of one of the most powerful times in American history.

On March 6, 1965, Civil Rights Activists began their historic march from Selma, Alabama to the state capitol in Montgomery in protest of practices that the local government were using to obstruct voter registration of African Americans. That day became known as Bloody Sunday after 600 peaceful unarmed marchers were attacked by Alabama State Troopers as they attempted to cross the Edmund Pettus Bridge.


A second march began March 9, 1965. Protesters again headed to the Bridge, but when Troopers stepped aside to allow them to pass, they instead returned to the church in Selma.

It wouldn't be until March 21, 1965 when the march would finally get underway.

Alabama Governor George Wallace refused to help the marchers in any way and so it fell to President Lyndon B. Johnson to intervene. The marchers, under the protection of the United States Army, National Guard, Federal Bureau of Investigation and U.S. Marshals, crossed the bridge and began the 50-mile, four-day trek to the Alabama State Capitol in Montgomery. Just outside of Montgomery, the protesters were joined by more than 25,000 students and church members from across the United States, who walked the remaining two to three miles to the square in Montgomery where Dr. Martin Luther King Jr. delivered a speech.

For those born after 1965, the march from Selma to Montgomery is just a chapter in a history book. It's real, but not really tangible. It's studied in school, dissected in college courses, but hard to really understand. Hollywood has brought this time back to life with it's dramatization of those events in the movie Selma. This makes the history a little more real.

semi-finals of the 2014 state playoffs.



no more than 2,000 square feet and located in a commercial zoning district. The new ordinance allows medical marijuana to be cultivated in an open field, on no more than five acres of land, in general rural zoning districts. General rural districts include residence uses.

The Rose Law Group, on behalf of Sidewinder Dairy, proposed the new law. The Rose Law Group argued, to the Board of Supervisors, the open cultivation of medical marijuana would allow local farmers another farming option. This information is misleading because according to Arizona law, medical marijuana is not an accepted agricultural product and it does not receive an agricultural farming exemption. The ordinance change will result in an overabundance of medical marijuana in Pinal County. It is important to note, there is just over 2,500 qualified medical marijuana patients in Pinal County. The overabundance of medical marijuana in Pinal County will greatly increase the access of marijuana to the county's youth and likely increase the potential for criminal activity throughout the county.

It is the intent of Citizens Against Open Cultivation to send the newly adopted county ordinance to the voters of Pinal County to decide if outdoor cultivation of medical marijuana should be permitted in the county. The group must obtain approximately 8,000 signatures, from registered voters in Pinal County, on the referendum petition by March 20, 2015 for the issue to be presented to the voters. The vote would be held at the next general election in November 2016. But for one Pinal County man, this is more than a story. It was very real.

James Walsh, the former Pinal County Attorney, grew up in Chicago, Illinois, "in the real city," he said, and not a suburb. It was a segregated city with real divisions.

"I grew up in an atmosphere of bigotry," Walsh said. He explained that he attended a Catholic high school for boys. There was only one African American boy in his entire school.

Segregation was worse in the south with the "Jim Crow" laws which kept the races "separate."

In 1955, the Montgomery Bus Boycott began after Rosa Parks refused to give up her seat in the "colored" section of the bus to a white

person. This act of defiance became a symbol in the Civil Rights Movement and the mark on the timeline of where it all began. She collaborated with civil rights leaders including Dr. King, who at the time was a new pastor at the Dexter Avenue Baptist Church in Montgomery, Alabama. African Americans stopped riding the buses, crippling the public transportation in the city.

King advocated a non-violent form of protest, learned from Mahatma Ghandi, called passive resistance.

"This was a very powerful form of protest," Walsh explained, "and a very dangerous form of protest." He said people died from this. In spite of being teargassed or clubbed, protesters did not fight back.

African Americans were prevented from protesting and they were prevented from voting. Sure, they could vote if they were registered, but the government had devised several deterrents for registration:

They issued a "poll tax" which had to be paid before the person could register to vote. African Americans in the south were some of the poorest in the country.

They were told they needed to pass a kind of "pop quiz" to prove they were smart enough to vote. They could have been asked to recite the Preamble to the Constitution (and this was way before School House Rock put the jingle in the minds of young people). Or they might have been asked to tell how many supreme court judges there are in the state/country/both.

In 1965, Dr. King and other leaders felt the time had come to do something about this. Selma, Alabama was chosen because of its low number of registered African American voters. Only 200 were registered in a place that was predominately African American. On March 6, 1965, King and others began the march to Montgomery to register their protest against such practices.

Dr. King and others realized that this issue was so much bigger than the state of Alabama. It really had implications for the entire country. A call was sent out to churches throughout the nation to send more protesters to Montgomery.

"Alabama was never a place I wanted to go," Walsh said. But when sign-up sheets began appearing on his college campus, Walsh made the decision to go. His roommate who was from South Carolina "begged me not to go," he said. His roommate was convinced that someone would die.

Someone did. An auto worker and a white mother of five who had come to Alabama to support voting rights for African Americans, Viola Liuzzo was killed while helping to ferry protesters back to Selma from Montgomery.

Walsh joined the marchers in Montgomery and was there when Dr. King delivered his speech.

Walsh said he remembered mailing a letter to his mother just before leaving on the bus to Alabama, telling her of his decision to go. His mom, understandably, was upset by his decision. She told him in a return letter that "of all the damn fool things, this one takes the

As a direct result of Selma, Congress passed the Voting Rights Act of 1965.

Registered African American voters in Selma went from 200 to 9,000.

This year marks the 50th anniversary of these events. Many of those who were there, marching with Dr. King, are returning to Selma and Montgomery to remember. Walsh said that he had considered going to Montgomery to pay his respects and to reminisce, but ultimately decided not to go. Instead, he chose to speak to an American history class of freshmen and sophomores who have just begun to discuss the Civil Rights Movement.

"This was my Selma," he said.

One thing Walsh noted when speaking to the students, in the movie Selma at the end where Dr. King is delivering his speech, the only part that was used was the lyrics of the "Battle Hymn of the Republic." Movie makers ran into a copyright issue and were only able to use the portion that is considered Public Domain. Walsh read the speech to the students, who listened with rapt attention. He apologized in advance to the students explaining that when he reads the speech aloud, he often gets choked up.

Included below is an excerpt from the speech delivered by Dr. King and read by Walsh.

I come to say to you this afternoon, however difficult the moment, however frustrating the hour, it will not be long, because "truth crushed to earth will rise again."

How long? Not long, because "no lie can live forever."

How long? Not long, because "you shall reap what you sow."

*How long? Not long:* 

*Truth forever on the scaffold,* Wrong forever on the throne,

Yet that scaffold sways the future, And, behind the dim unknown,

Standeth God within the shadow,

Keeping watch above his own.

How long? Not long, because the arc of the moral universe is long, but it bends toward

*How long? Not long, because:* 

Mine eyes have seen the glory of the coming of the Lord:

He is trampling out the vintage where the grapes of wrath are stored;

He has loosed the fateful lightning of his terrible swift sword;

*His truth is marching on.* 

He has sounded forth the trumpet that shall never call retreat:

He is sifting out the hearts of men before His judgment seat.

O, be swift, my soul, to answer Him! Be jubilant my feet!

*Our God is marching on.* 

Glory, hallelujah! Glory, hallelujah! Glory, hallelujah! Glory, hallelujah!

His truth is marching on.

## Arboretum Spring Plant Sale scheduled for March 13-29

Friday the 13th may keep trembling triskaidekaphobics indoors, but, the Spring Plant sale will have them flying out the door and making a beeline to the Boyce Thompson Arboretum (BTA).

The sale begins with a members-only shopping preview where BTA's most dedicated supporters are allowed first-pick of the colorful, rare and interesting plants. The seasonal sale opens to all Saturday, March 14 and continues daily through March 29 during regular business hours of 8 a.m. to 5 p.m. No admission is charged if you're there only to buy plants during the sale, and don't enter the Arboretum grounds.

What's new in the Spring Plant Sale for 2015? Pollinator plants, colorful fruit trees including a dwarf fig ideal for small spaces, plus, perennially popular desert lavender. Poke around the rows of plants and you might even find a rarity such as cork oak trees, recently featured in the Arboretum's newsletter. The cork oak is a tree well-suited to Gila and Pinal Counties and, with only two available at \$50 each, they are expected to sell quickly.

"Its spring and buyers will see a lot of

color," said Certified Nurseryman Preston Cox, who chooses plant sale stock, and oversees Master Gardener volunteer crews propagating plants onsite at BTA. "Milkweed, for example; the varieties of asclepias are important plants for pollinators such as queen and monarch butterflies, and, we'll have varieties including

bloodflower, which blooms as colorfully as the name suggests, and pine leaf milkweed."

He continued, "We always get requests for desert lavender, so, we're ready to answer that demand. We have plenty of those in five-gallon pots and priced at \$20. This year, we also concentrated on fruit trees, and, have several varieties of fig including white kadota and brown turkey; one fig tree I'll suggest to anyone trying to green-up a small space is the Violette de Bordeaux, a dwarf varietal designed so it does not reach the height of a standard fig, making it ideal for someone who wants a fruit tree sized for a patio or small yard space."

What tours and classes are on BTA's calendar for the week ahead? Plan your

visit to include a daily guided tour of the main trail at 11 a.m. or a special wildflower walk March 12, 14, 15, 19 and 21; call ahead to enroll in the "build-a-terrarium" class March 12 or the "wine bottle wind chime" workshop March 26. Geology for beginners is the subject of a guided walk March 13 and 21. There's a class in advanced photography composition taught by Gold Canyon artist Sue Tatterson March 15; registration is \$40.

Or, specifically for children, there is a special day with tours for Home-Schoolers March 11; on Saturday, March 14, Brownie Girl Scouts have a badge workshop, there's also a Trailblazer hike for kids age 5-12; and, in the afternoon Kathy and Tom McDonald of Smiling Dog Landscapes in Gold Canyon guide the edible and medicinal desert plants guided walk at 1:30 p.m. Complete details on these and more posted at ag.arizona.edu.

What could be better than the walks and workshops, plants for sale and plants for viewing? Taking it all in at a substantial savings. Annual membership is a bargain at \$50 for a year for two people, and that includes a pair of one-time-use guest passes to bring friends or family for a



visit. Until then, daily admission to the gardens and trails of \$10 includes guided tours at 11 a.m. every day of March and April; as well as themed nature walks most weekends. Read the complete event schedule at ag.arizona.edu/bta.
