

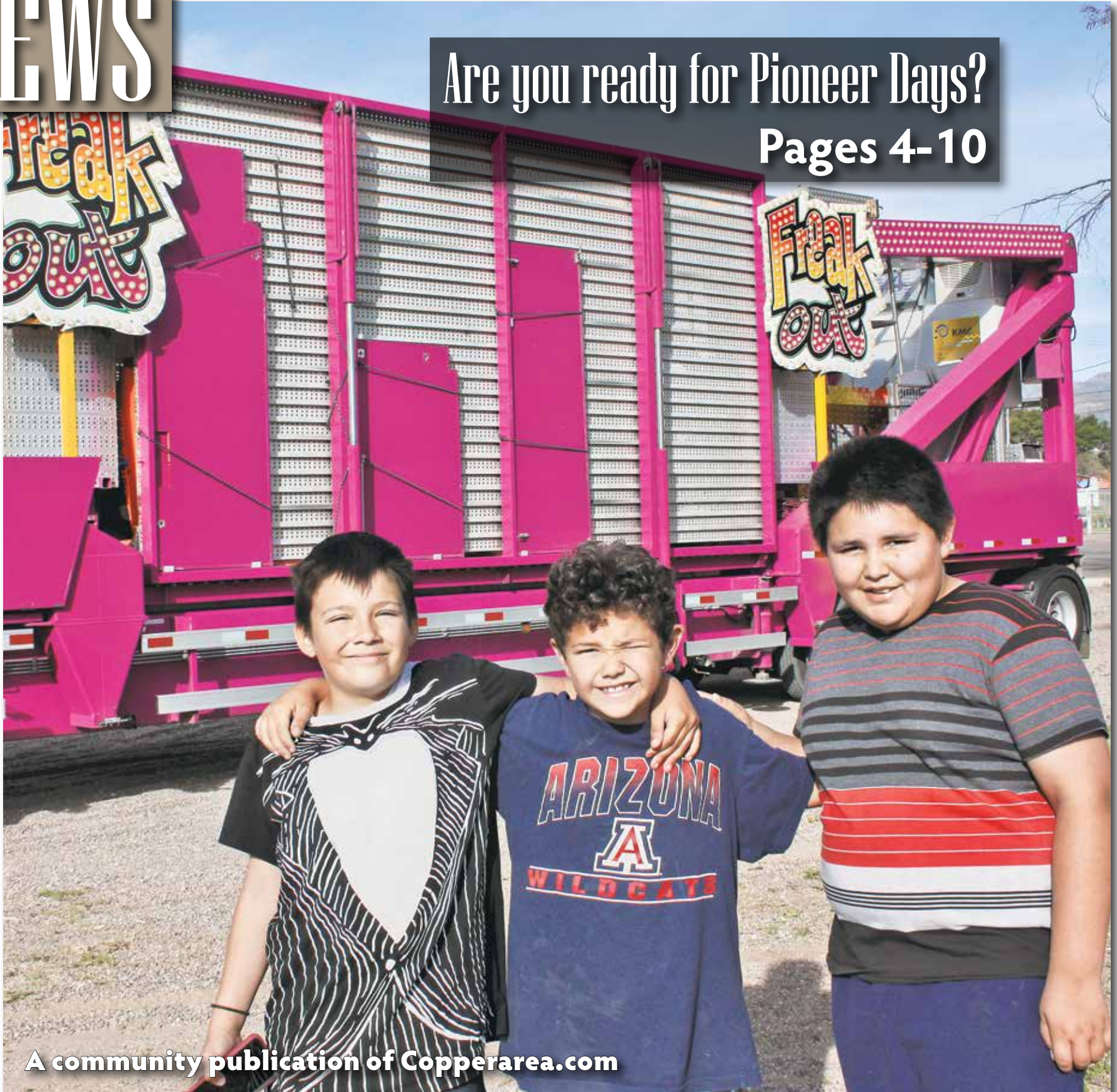

# Mary Lou Hunsaker



Mary Lou Hunsaker passed away quietly Sunday morning, March 3, 2020, at the age of 98. She was at home surrounded by attentive and loving family.

Mary was born in Palo Pinto, Texas on May 11, 1921 to Richard and Wilma Dalton. She was the oldest of five siblings. All of whom preceded her in death. She was also preceded in death by her first

husband Verner Coppin (1942) and her second husband Rollo Hunsaker (1990). She was preceded in death by a daughter, Mary and a grandson, Michael.

About 1959, Grandpa went to work in Ray at the Kennecott copper mine, leaving Granny there with the six children to work the farm, of course he came home to help on weekends. They moved the whole family to Ray

in 1961. When Kennecott decided to oust the residents of Ray around 1965, Granny and Grandpa chose to move their house to Bidegain acres. During this time Granny worked at the company hospital. She worked there for 8 years.

Mary Lou volunteered her time and talents with many organizations. Granny volunteered her time and talents as a cook at church girl's camp for multiple years, also as a cook at the 4-H camp. She did a lot of 4-H work from project leader to community leader to judge of cooking exhibits. She served in many church callings at both ward and stake levels. Granny taught English to several people enrolled in the community ESL Project. She also fostered many young children in her home. Some of her hobbies

were working with ceramics, embroidery and reading.

Her greatest joy was watching her grandchildren or great-grandchildren participate in sporting events or musical presentations. Granny was always eager to participate in anything that came along. She loved to travel the country and visit her extended family. Oh, how she loved her family. She loved visiting with friends and loved ones.

Mary is survived by Art (Sharron), Richard (Irean), Kay, Peggy (Virgil), Betty (Larry). Granny had 22 grandchildren, 62 great-grandchildren with one in the oven (as Granny would say) and 14 great-great-grandchildren with one in the oven.

Services for Mary Lou were held Friday, March 6, 2020 at the Church of Jesus Christ of Latter-day Saints in Kearny, Arizona. She was laid to rest at Mountain View Memorial Gardens in Mesa, Arizona. The family was assisted with exceptional service by Griffith Mortuary.

## Chief Villar resigns; Gila County provides Chief Leadership for Hayden

Police Chief Tamatha Villar resigned from the Hayden Police Department in February to take a position with another agency.

State law requires that a municipality have a police chief and town clerk; all other positions are at the discretion of

the town government. The Gila County Sheriff's office is filling the police chief position. At this time the Town of Hayden is not planning on filling the Chief position due to budget constraints.

The Hayden Police Department has also accepted the resignation of another officer and there could be another officer leaving the department, explained Mayor Dean Hetrick.

Gila County has assigned Lt. Virgil Dodd to provide the Chief of Police duties for the Town of Hayden.

"The Council voted to operate the police department with only five officers," said Mayor Hetrick. He further explained that revenues continue to be reduced due to the ongoing strike at ASARCO.

# Presumptive positive case of COVID-19 identified in Pinal County; may signal community spread in Arizona

Pinal County Public Health Department last week confirmed a presumptive positive case of COVID-19. The case, a healthcare worker in her 40s, lives in Pinal County and is currently in stable condition in a Maricopa County hospital. She is not a known contact of any confirmed COVID-19 cases and has not traveled to any areas where COVID-19 is spreading widely. For this reason, Public Health is treating this case as its first instance of community spread. On Friday, two more cases were identified in Pinal County, both from the same household as the current Pinal County case. State and local public health are currently investigating the cases.

“Community spread refers to the spread of an illness for which the source of infection is unknown. Just like during flu season, if you get symptoms, you need to stay home and take care of yourself,” said Dr. Shauna McIsaac, director of Pinal County Public Health Department. “Similar to the flu, most people will only have mild symptoms that do not require a visit to a healthcare provider or hospital. Individuals who are older or have underlying health conditions like chronic lung disease are at higher risk of more severe illness. Occasionally, a young, healthy person will have severe disease. Unfortunately, this woman is one of those people,” she added.

“We are moving into a public health strategy that is just like seasonal flu. We know that healthcare workers are exposed to people with flu and other infectious diseases all the time and therefore are at higher risk, which is why they wear personal protective equipment,” said Dr. Rebecca Sunenshine, medical director for disease control at Maricopa County Department of Public Health. Now that there is community spread of COVID-19, just like during flu season, it is important for everyone, especially healthcare workers, to stay home when they are sick to avoid exposing others. “We are no longer recommending quarantine of exposed healthcare workers who don’t show any symptoms because we need our healthcare workforce during this response,” Dr. Sunenshine added.

COVID-19 is a respiratory infection with symptoms including fever, cough, and shortness of breath. The vast majority of people with the disease have mild symptoms and will not require medical intervention.

COVID-19 is believed to spread mostly through respiratory droplets produced when a sick person coughs or sneezes. Currently, there is no vaccine or treatment, but treatments are being studied and a vaccine is currently under development. Individuals with COVID-19 should be provided with supportive care

including fluids or fever-reducing medication.

Since receiving the presumptive positive test result, Pinal County and Maricopa County have been working together to interview close contacts of the case and recommend symptom monitoring.

Overall recommendations to prevent the spread of COVID-19 and other diseases spread through respiratory droplets are:

- Wash your hands often with soap and water for at least 20 seconds. If soap and water is not readily available, use an alcohol-based hand sanitizer.
- Avoid touching your eyes, nose, and mouth.
- Avoid close contact with people who are sick.
- Stay home when you are sick.
- Cover your cough or sneeze with a tissue, then throw the tissue in the trash.
- Clean and disinfect frequently-touched objects and surfaces like door knobs, light switches, and electronic devices using a regular household cleaning spray or wipe.

Symptoms of COVID-19 are thought to appear within two to 14 days after exposure to the virus and consist of fever, cough, runny nose,

and difficulty breathing. Those considered at risk for contracting the virus are individuals with travel to an area where COVID-19 is spreading or individuals in close contact with a person under investigation for COVID-19.

If you recently traveled to an area where COVID-19 is spreading and have developed fever with cough or shortness of breath within 14 days of your travel or have had contact with someone who is suspected to have COVID-19, stay home and call your healthcare provider. If you do not have a healthcare provider, you may need to be seen at your local hospital emergency room/urgent care center. Please call the emergency room/urgent care center to get instructions before going in.

## Delays on State Route 77 in Winkelman scheduled to begin March 16

Motorists who use the Gila River Bridge on State Route 77 in Winkelman should expect intermittent delays starting Monday, March 16.

Crews will need to close the bridge occasionally for 15 to 20 minutes during daytime hours while bridge girders are placed on the east side of the new bridge.

The work is expected to take up to 10 days, with three to six girders placed per day.

Law enforcement will help direct traffic during the work.

Drivers should proceed through the work zone with caution, slow down and watch for

construction personnel and equipment.

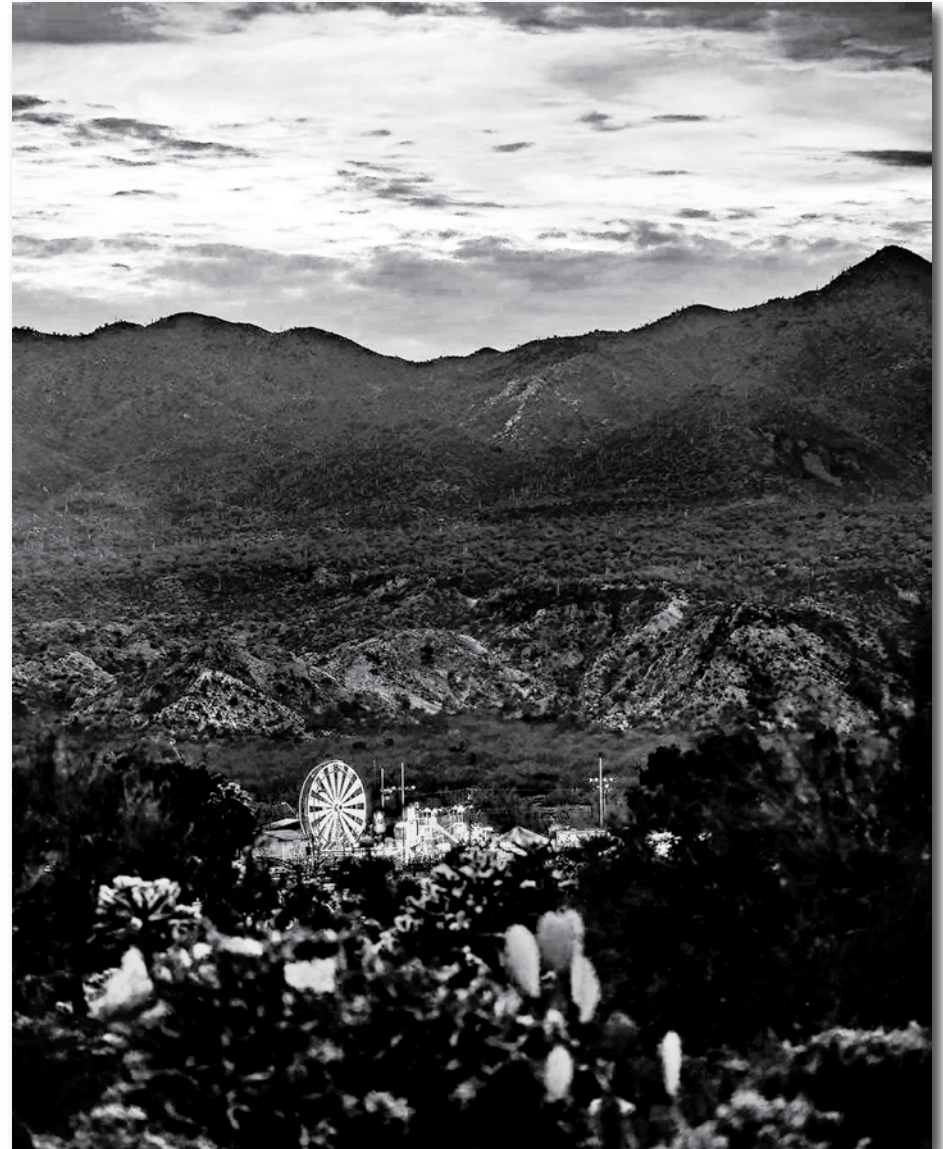

A principal residence does not include a home used as an investment property, as a recreation home or a home 15% or more of the total area of which is used in a trade or business. 2. The First-Time Home Buyer/Three-Year Requirement Each purchaser must be a first-time home buyer. Any person who has not owned his or her principal residence at any time during the three years prior to closing a loan under the Program is considered a first-time home buyer. This requirement does not apply to qualified home improvement loans, qualified rehabilitation loans, loans to qualified veterans or loans relating to residences located in certain federally designated targeted areas (“Targeted Areas”). 3. The Purchase Price Requirement The maximum purchase price of a home may not exceed 90% (110% in Targeted Areas) of the average area purchase price for the applicable jurisdiction for the type of home being financed, whether it be new construction or an existing home. The purchase price requirement does not apply to qualified home improvement loans. The purchase price limits may change over time. For Pima County, purchase price limits currently are: Purchase Price Limits – Pima County (Tucson MSA) 1 Unit Non-Targeted \$283,348 Targeted \$346,315 2 Units Non-Targeted \$362,818 Targeted \$443,445 Other jurisdictions may have other purchase price limits; please consult with Community Investment Corporation to obtain other limits. 4. The New Mortgage Requirement Except for a purchaser acquiring a qualified home improvement loan or a qualified rehabilitation loan, a purchaser will not be eligible for a mortgage credit certificate in connection with the acquisition or replacement of an existing mortgage. 5. Income Requirements Pursuant to the Code and State law, a purchaser’s income may not exceed 115% (100% for families of less than three) of the greater of the applicable county or statewide median gross income, except that in Targeted Areas the purchaser’s income may not exceed 140% (120% for families of less than three) of the greater of the applicable county or statewide median gross income, provided however, that in any case, the purchaser’s income shall not exceed 150% of the statewide median income limit determined by the State. The position requires the ability to assist with repairs in the Water Distribution System and read water meters. This position requires the ability to assist with maintenance repairs at the Wastewater Plant. The position also requires the person to perform duties at the Kearny Lake and restroom cleanup. This is a part-time position, with the possibility of becoming a full-time position. Within one year of the date of hire, the Town is requiring a Water Distribution Grade 1 Certification, and within the next four years a Grade 1 Water Treatment Certification, a Grade 1 Collections System Certification and a Grade 1 Wastewater Treatment Plant Certification. With completion of the above certifications, pay rate adjustments will be made when certifications are obtained. **A valid Arizona driver's license is required, a copy of the person's motor vehicle driving record is to be turned in with the application.** Application forms are available at the Kearny Town Hall, 912-C Tilbury Drive, Kearny, AZ. The Town of Kearny is an EEOC employer.
