



New Combs' principal likes small district, big-city feel

On Feb. 10, the J.O. Combs Unified School District governing board approved the hiring of Brooke Davis as the new principal at Combs High School, beginning with the 2016-17 school

Davis, whose educational career spans 26 years, has spent the past nine years in Englewood, Colorado, including the last three as a high school principal.

During a recent phone interview, Davis compared favorably her current position with the one she's about to embark. She called her professional experience in Englewood "the best" she's had and enjoys working in a small district, finding similarities between her current district and the J.O. Combs USD.

A self-described small-district person with a big-city feel. Davis received input from college friends who live in the area and suggested she research the district, the high school, and the local community.

"The appeal to me of what Combs had is the family orientation," Davis answered when asked what attracted her to the position. "That is very important to me. I'm very much a relationshipcentered person and I'm looking forward to the community aspect that Combs has."

After earning her bachelor's degree in Broadcast Journalism, Davis worked in advertising where she felt unfulfilled with many extra hours on her hands. A former collegiate basketball studentathlete at New Mexico State University, she applied at an Albuquerque area high school to coach the freshmen girls' basketball team to minimize her abundance of free time. Pinal County hosts annual mock trials for middle schools, high schools

The Pinal County Juvenile Court Community Advisory Board (CAB), with sponsorship from the Pinal County Attorney's Office, hosted its 13th Annual Mock Trial Competition on March 11, 2105.

Over 200 middle school and high school students and their coaches competed during the day long competition at Pinal County Superior Court in Florence. Students had the opportunity to compete for best witness, opening statement, closing statements, cross examination, direction examination, and witness as they showcase their prosecution and defense skills.

Schools competing included: Casa Grande Junior High School, Cactus Middle School, Villago Middle School, Freedom Christian Academy, Picacho Elementary, Legacy Traditional School, Circle Cross Middle School, Magma Ranch K-8, Poston Butte High School, Miami High School, and Apache Junction High School. There were a total of 18 teams competing.

Miami High School had two teams who took home both 1st and 2nd place in the high school division. Middle School Division #1 ended with Cactus Middle School receiving 1st Place and Casa Grande Middle School coming taking 2nd place. In the Middle School Division #2, the two Picacho teams tied for 1st place against each other and

Whirlwind month ends

for new QC principal

Over the course of a month, Paul Gagnon filled out the application, went through the interview process, was offered and subsequently accepted his new position, and then attended the Queen Creek Unified School District board meeting where his hiring as the new Queen Creek High School principal was approved.

Gagnon, who has been the Page High School principal for the past five years, will begin his duties starting with the 2016-17 school year.

"It has been a whirlwind process," Gagnon told the *Ledger*. "But it is something my wife and I really talked about and thought about a lot to make sure this was the right move. Queen Creek attracted me for a lot of personal reasons but professionally as well."

Family was among the chief personal reasons. Gagnon's parents live in Tucson, where he was born, raised, attended Palo Verde High School, and the University of Arizona. His in-laws live in Tempe.

The opportunity for their four children to attend great schools in the area was also attractive to Gagnon and his wife, Cori.

Professionally, he saw similarities between Page High School and Queen Creek, including a similar curriculum and participation in professional learning communities.

"Queen Creek is just doing it at a higher level," Gagnon acknowledged. "There is clearly a staff here that is amazing and doing great things with students. There is a great opportunity to expand that with some of the ideas I have."

One of his ideas includes the implementation of AVID, an acronym for Advancement Via Individual Determination.

AVID is a college-going program that takes students who are in the middle academically and may not have the foundational skills to be in advanced placement and honors classes. AVID puts them in those classes and teaches them what it takes to get into college.

Continuing to enhance an already established college-going culture is one of Gagnon's goals in his new job.

"I'm looking forward to being at bigger school where we have students who have a lot of that aspiration built in," he said.

Prior to his stint as principal at Page, Gagnon served as an English and History teacher at the school. In between his time as teacher and principal, he earned a Master of Teacher Education degree from Eastern Oregon University and a Master of Education Administration degree from Grand Canyon University.

He served as an assistant principal and athletic director at Cottonwood Middle School for two years immediately after earning his degrees and before being recruited back to Page High School as the principal.

He was varsity assistant baseball coach and the boys' varsity soccer coach while at Page as a teacher. Under his leadership as soccer coach, the school made its first and only state tournament appearance.

Gagnon has been briefed about the Bulldogs' athletic department excellence and knows it goes hand-in-hand with the school's academic reputation.

"Having a successful athletic program improves the (culture) of the school," Gagnon said. "It makes it so students want to attend Oueen Creek."

"My goal as principal is to put our students in the best position to succeed, especially academically," he added. "Because I know athletics, for example, are super important, but if they don't perform (academically) that scholarship can be taken away."

Gagnon believes academics, the arts, athletics, and more, including CTE, which he says is near and dear to his heart, are all important to Queen Creek's continued success.


"I love CTE because it gives students those life-long skills that they can take with them," he said. "How many programs can a student walk away with a CNA certificate? Or an ASE certification for auto mechanics? Students can put that on a résumé and get a job right away. There are so many opportunities."

After working for 12 years at only two different schools, Gagnon is looking forward to making the move to a community he knows his family will love.

What is he most looking forward to in his new job?

"Working with the staff at Queen Creek," he responded. "It sounds like it's a great staff and I'm getting the chance to meet all of them on April 8."

"There is so much support around here," he continued. "What struck me during the interview is the people here are so positive and I'm a positive person. I'm anxious to work with staff and help them take their game to the next level in the name of helping our students achieve whatever their goals are."

Vercoe, Kern lead Broncos to win

Senior outfielder Keegan Vercoe hit a fifth-inning grand slam, providing starting pitcher Aaron Kern with far more run support than he needed in the Broncos' 9 -2 win over Douglas last Thursday.

Kern, who was named Player of the Game, earned the complete-game win after allowing only five hits and two runs, both unearned. He finished with nine strikeouts and issued only one walk. The senior righthander kept the Bulldogs' lineup at bay until Vercoe, an Azusa Pacific University commit, and the rest of the Broncos' lineup exploded for six fifth-inning runs, breaking a 1 - 1 tie.

"Aaron went out there and competed," Poston Butte head coach Chris Holcombe

said after the game. "We really liked how he pounded the (strike) zone and staved consistent with throwing strikes. I think he only walked one guy the whole game. Anytime you throw strikes you're going to be successful."

Poston Butte scored its first run on an error to take a 1 - 0 lead in the third before Douglas got the run back in their half of the fourth. Freshman Cameron Vercoe broke the tie with an RBI-base hit in the bottom of the fifth with another run scoring on an error to make it 3 – 1. The Broncos followed those two runs by loading the bases, setting up Keegan Vercoe's blast.

"It was the third time through the lineup for our guys," said Holcombe, accounting for the big fifth inning. "Our guys had seen all of the (Douglas starter's) pitches and knew what he had, what he didn't have, and were able to key in on certain pitches. They did a good job of being patient, getting good pitches to hit, and taking advantage when he left pitches over the middle of the plate."

The Broncos' closed out the scoring in the bottom of the sixth, adding two more runs on RBI hits by Cameron Vercoe and Dylan

Berringer.

then she realized her love for working with students and decided to earn her certification at the University of New Mexico. She continued coaching, moving up the ranks to head JV coach and then assistant varsity coach.

She eventually moved to Colorado where she was an English teacher and the girls' volleyball, basketball, and soccer coach.

During her 26-year career she's gone from being a high school freshman basketball coach to a high school principal and "everything in-between."

"I think it's very important for a principal to have comprehensive knowledge of all systems within the high school," Davis said. "Not only to support student achievement, but (also) the socialemotional piece that comes with high school students." Davis is a self-proclaimed "do-it-all" principal who is known to mop floors, clean, and get students to the bus in addition to her more traditional responsibilities of providing leadership and supervising.

One of Davis' "in-between" jobs included a stint as an athletic director. What level of importance do athletics, the arts, or other extra-curricular activities have in lives of students in her view?

"They're all incredibly important," she responded. "I want a home away from home for every student. School is that place where (students) get to find, try, test, and learn all those soft skills that we want students to have that practically apply to their learning, such as time management, organization, and collaboration."

"All of those are 21st-century skills learned through sports, clubs, band, choir, or whatever it is," she added. "They are all incredibly important because it teaches students how to work with others."

Davis says she learned time management as a student-athlete at New Mexico State and those skills carried over to her job in advertising, allowing her time to also coach the freshmen girls' basketball team.

"The things we are going to do at school need to practically apply to life," Davis said. "That comes in the classroom as much as in the sports arena, the concert hall, or the theater."

The new Combs High School principal will be on campus approximately once per month until the end of the school year in Colorado, which precisely coincides with Combs' school year. She will move to the area permanently after that.

Davis was asked what she's most looking forward to at Combs and responded by recalling the day of her interview, when she was sitting the school's front office and nearly 25 students came through – unaware of who she was or what she would eventually be – and almost all of them smiled at her and said, "hello."

"Those students took the time to welcome a stranger," she said. "And I said to myself, 'I want this job.' So let's meet each other at the door, and let's grow and go together."





Lemon Cheesecake Bars

Serves 16 Recipe adapted from Kraft

- 1 1/2 cups crushed Nilla wafer cookies
- 2 tablespoons margarine, melted
- 2 packages (8 ounces each) reduced fat cream cheese
- 1/2 cup sugar
- 1/2 teaspoon lemon zest
- 1 tablespoon freshly squeezed lemon juice
- 1/2 teaspoon vanilla extract
- 2 eggs

Heat oven to 350°F. Mix cookie crumbs and margarine; press onto bottom of 8-inch square pan sprayed with cooking spray.

Beat cream cheese, sugar, lemon zest, juice and vanilla in large bowl with mixer until well blended. Add eggs, 1 at a time, mixing after each just until blended. Pour over crust.

Bake 20 to 25 min. or until center is almost set. Cool completely. Refrigerate 3 hours before serving.
