
My Dad was always willing to give anyone he knew a helping hand, and was known by many people for his big beautiful heart and love that he showed to us all.

Pinal County Citizens on Patrol Posse seeks volunteers

The Pinal County Sheriff's Office Citizens on Patrol (C.O.P.) Posse is an organization of concerned citizens working within the community to assist the Sheriff's Department in crime prevention.

Two years ago, a Citizens on Patrol Posse unit was established in the Oracle/SaddleBrooke station of the Pinal County Sheriff's Office (PCSO). An attempt was made last year to start up a unit in San Manuel but there was little interest. Recently a unit was opened in San Manuel which included a COP member and assigned vehicle for the San Manuel substation. The COP Posse program is looking for interested residents to occupy positions at the San Manuel and SaddleBrooke offices.

Gene DeLauder is the current C.O.P. Posse member assigned to the San Manuel substation. The substation is part of the Baker Region which includes SaddleBrooke, SaddleBrooke Ranch, Oracle and San Manuel. Gene has lived in San Manuel for 20 years and has been a posse member for a year and a half. He is a field training officer and treasurer for the Pinal County C.O.P. Posse which is a non-profit 501(c)3 and can receive donations. Gene enjoys what he does, interacting with people and serving his community.

"Posse members serve as the eyes and ears for the Sheriff's Department," said Gene. "We do not carry guns or arrest people."

C.O.P. Posse members observe and report suspicious behavior to deputies. They also assist with traffic control at accidents or special events. To become a Posse member, one must pass an extensive background check, have basic computer skills and be able to write reports. Approved members will attend a week-long training academy that includes classes in knowledge of laws and regulations, CPR and basic first aid, radio codes, directing traffic, etc. If you are interested in volunteering for the C.O.P. Posse contact Lieutenant John Farrell, Baker Region Manager, at (520) 404-7217.

Lt. Farrell says that the COP program is looking for interested residents to help populate both the San Manuel and SaddleBrooke offices.

"I have been a volunteer in the COP program for over 10 years and have enjoyed helping my community over

Mammoth-San Manuel Unified School District to return to in-person instruction for elementary

After more than one full year apart, students in the Mammoth-San Manuel Unified School District will see their teachers in person next week – elementary students only. Grades 6-12 will remain with online learning.

On Wednesday, March 3, the Arizona Governor issued an Executive Order to reopen all schools for in-person instruction by March 15. On Tuesday, March 9, the Mammoth-San Manuel Unified School District Governing Board voted to return to in-person instruction for Pre-K-5 grades on March 22 following spring break. All students PreK-12 will also be offered the opportunity to stay at 100% online instruction for the remainder of the school year.

The elementary in-person learning (first-fifth grade) will focus on math and reading for a half day on Monday, Tuesday, Thursday and Friday and other subjects will be done online at home. Interventions will occur on Wednesdays. The student's

classroom teacher will be reaching out to parents to discuss matters, and any changes from in-person to online and vice-versa will need to be done through the teacher. (The school cannot have students showing up to school for in-person if they are not expected due to classroom capacity and social distancing.)

All 6-12 graders will continue with their virtual learning online from home. (The Governing Board will be revisiting this at the April board meeting).

"Due to the continuation of the COVID," school officials communicated on Facebook, "we will be strict in following our safety measures. Please understand this is for the safety of all. You will receive by mail and email the necessary safety measures, guidelines for pick up and drop off, meals, etc. Please keep an eye out for these and make sure your email and phone numbers are updated with the school."

Oracle's Mountain Vista School to return to full-time in-person learning March 24

Oracle School District administration has made the decision to return to full-time, in-person learning on March 24. Earlier this month, the school opened in a hybrid model, but following the March 3 Executive Order by Governor Doug Ducey, the district elected to go back to full-time instruction.

"In a nutshell," Superintendent Crystle Nehrmeyer explained, "the Governor's Executive Order says that elementary schools must return fully in-person or in a hybrid model by March 15, or after Spring Break. If a family requests continued online learning for their child, the school is required to provide continued online learning. Likewise, if a family requests full, in-person instruction for their child, the school is required to provide full, inperson instruction."

The District's Cares Program is on-site supervision, not instruction and therefore does not meet the requirements of the Executive Order if a family requests full, in-person instruction.

The district does not have the resources to provide all three types of learning: fulltime, in-person; online only; and hybrid learning. So to comply with the Executive



that whole period. We are the eyes and ears for the deputies helping them cover more territory looking for problems. We now aid in traffic control replacing a deputy to be freed up to protect the community. We respond when requested for traffic accidents, missing persons (especially children) and event security (like the SaddleBrooke Covid-19 shot

event). Recently we tweaked the training program so that we can allow more solo patrols. This creates more visible patrol time.

"During the beginning of your training, you patrol with a Field Training Officer (FTO) who guides you through things you need to know as a COP. You are also trained in Sheriff's defensive driving.

You patrol in a Sheriff's vehicle and use a radio that connects you with the Dispatch operator. You will be in a great group of volunteers who enjoy being part of something extremely useful to their community.

"There is a special feeling you experience in knowing you are helping your community to stay safer and you will enjoy participating with the other members of your group. Please consider giving this program a try. You are only required 16 hours a month on patrols and a monthly meeting. You will also receive training in CPR and first aid." The U.S. Department of Housing and Urban Development (HUD) requires Pinal County to publish a five year Consolidated Plan and an Annual Action Plan outlining the use of HUD funds for the Community Development Block Grant (CDBG), HOME Investment Partnership (HOME), and Emergency Solutions Grant (ESG) programs. This public hearing is to adopt a substantial amendment to the FY19-23 Consolidated Plan and the associated FY19 Annual Action Plan to include ESG and CDBG-CV funds.

Pinal County has received an allocation of \$156,877 of ESG funding. ESG funds are new to Pinal County in the fiscal year 2021 and were therefore not included in the original Consolidated Plan. The FY2019-2023 Consolidated Action Plan Amendment #2 is to accept comments on the plan revisions and inclusion of ESG funds beginning in FY2021. Pinal County is seeking input on the proposed amendment.

Pinal County has received an allocation of \$1,497,324 of CDBG-CV funding. CDBG-CV funds are funds allocated under the third round of the Cares Act to prevent, prepare for, and respond to the coronavirus. Pinal County would like to invite the public to a public hearing to provide comments and the Board of Supervisors will vote on the proposed plan amendment to the FY19 Annual Action Plan. Pinal County has identified the following projects for the use of CDBG-CV funds:

- 1. \$1,067,324 Renovation of an existing building to serve as Public Health and Emergency Management storage of emergency supplies, food, personal protective equipment, and refrigeration for vaccinations.
- 2. \$55,000 City of Eloy installation of air purifying equipment in community buildings.
- 3. \$65,000 Town of Mammoth economic development project.
- 4. \$32,500 Town of Mammoth installation of air purifying and water equipment to community buildings.
- 5. \$7,000 Town of Mammoth transportation services for seniors and persons with disabilities.
- 6. \$20,500 Town of Mammoth improvements to the public swimming pool.
- 7. \$250,000 Pinal County Administration for CDBG-CV funding.

Any person who has not owned his or her principal residence at any time during the three years prior to closing a loan under the Program is considered a first-time home buyer. This requirement does not apply to qualified home improvement loans, qualified rehabilitation loans, loans to qualified veterans or loans relating to residences located in certain federally designated targeted areas ("Targeted Areas"). 3. The Purchase Price Requirement The maximum purchase price of a home may not exceed 90% (110% in Targeted Areas) of the average area purchase price for the applicable jurisdiction for the type of home being financed, whether it be new construction or an existing home. The purchase price requirement does not apply to qualified home improvement loans. The purchase price limits may change over time. Copper Area News is committed to providing our readers with as much information as possible. This graph shows the positive cases as of press time on March 9, 2021. We have also included a graph showing the daily counts for the past week. Statewide, positive case counts have reduced dramatically, as the number of people vaccinated has increased.

New data reported this week is the number of residents who have been vaccinated per zip code. We will update that on a weekly basis.

There are a few points we would like our readers to consider when following this data.

- 1. This will continue to be a rolling total of positive cases. It does not reflect recoveries or deaths. The Arizona Department of Health Services does not break out this data.
- 2. If you see a reduction in numbers from day to day it is most likely due to a data entry error or mis-coding of a zip code (at the state level).
- 3. This is all zip code based data; most of our zip codes include unincorporated areas. There is no way to track exactly which areas each of the positive cases are. Example, Kearny and Winkelman each have small communities in their zip code that are not in the Town's incorporated boundaries.
- 4. If you live in Gila County, please follow the Gila County Health and Emergency Management, Facebook. They have maintained their data on recoveries and current positive cases.
