Maria Santos Marquez, 96, died peacefully on March 9, 2015. She was born on June 28, 1918 to Ignacio and Angelina Flores in Douglas, Ariz. Santitos, as she was known by, was a loving sister to her 15 brothers and sisters. The Flores family made their home in Phoenix and the surrounding areas.

She was concerned that the Land Exchange Bill passed by Congress in December would not require a NEPA by Resolution Copper by way of the U.S. Forest Service and that valuable cultural and environmental issues would not be studied at Oak Flat because of that. She is correct on only a FEW items. True, it is not a NEPA if the U.S. Government does not own the land, BUT! An EIS (which is basically the same thing as a NEPA done at the private level and still headed by the Forest Service) is still required by the Federal Government before the Land Exchange is fully approved and the land belongs to Resolution. Essentially, the SAME THING will be done, just with different wording attached: EIS instead of NEPA. The EIS will study the water, the cultural significances (if any), the biological factors, and the rest of the environmental aspects of the land at Oak Flat. It isn't going to be ramrodded down anyone's throat and I think Senator McCain should be congratulated on getting this legislation through instead of excoeriated.

That is one thing that really bothers me about the Opposition to the Resolution Copper project. They get one small fact out there and embroider on it to make it look ominous and awful without fully stating what will ACTUALLY be done, just to get the public upset about it. If the Opposition bothered to tell the truth, we wouldn't have to refute them all the time!

Guest Editorial: Is #Arizona Balanced?

In the wee hours of a Saturday morning, the Arizona Legislature approved a new budget. The Governor lauded it as fiscally responsible, but is it strategically wise as we look at what it means to Arizona today and in the future?

This morning we await word on the Budget Packet that passed in the early morning hours of Saturday, March 7, after a long night of discussions on the Arizona Senate and House floors. The stated goal was to balance revenues and spending without a tax increase and provide Arizona with the first 'structurally balanced' budget since 2007.

Responses to the Budget are mixed with some lauding its fiscal responsibility while

others decriing the manner and long term impacts of the manner of cuts that were made to get there.

The \$9.1 B Budget has its share of proponents and opponents:

Fiscal Responsibility: According to Budget Proponents

- Balances the budget and forces government to live within its means
- First structurally balanced budget since 2007
- Eliminates the structural deficit by 2017
- It sets priorities: Child Safety, Classrooms, Public Safety
- \$326 million in spending reductions
- Overall 2.3% reduction to government spending
- Protects taxpayers: No tax increase

Fiscal Responsibility: According to

Budget Opponents

- Focuses on cost cutting versus strategic investment to increase revenues
- Reduces Healthcare Provider payments under Medicaid by up to 5% or a "total \$127 million over two years which mean a loss of another \$588 million in federal matching funds from Arizona's economy over that time," (Assistant Senate Minority Leader Steve Farley, D-Tucson, Source)
- Repeals the Job Training Tax in January 2016 thus de-funding the Job Training Fund.
- Sweeps Job Creation and Job Training funds at the Arizona Commerce Authority
- \$11.2 M in cost shifts to Municipalities and \$29.7 M to Counties

Child and Public Safety: According to Budget Proponents

- \$849 million for Child Safety
- \$1.5 billion for Public Safety
- 16% of the general fund budget is for Child Safety/Public Safety
- Delays construction of new prison beds for a \$25 million savings and allows counties to bid for housing new prisoners

Child and Public Safety: According to Budget Opponents

- The budget makes Arizona the most stringent state in terms of benefits for poor families with children.
- Limits parents raising children to a one-year lifetime benefit from the Temporary Assistance for Needy Families program.
- Cuts \$2 million for a rate hike for foster-care families, as well as \$2.2 million for emergency placement of children in group homes.

Classrooms First: According to Budget Proponents

- In total, schools will have more than \$10 billion including state, federal, capital and local funds
- Nearly 20% increase in general fund investment in K-12 since 2010
- 49% of state general fund budget will go to education (K-12 and universities combined)
- Protects classroom funding
- Teach for America: \$500,000 in new permanent funding

Classrooms First: According to Budget Opponents

- The budget cuts from education in several areas while adding money for inflation and enrollment growth, for an overall increase of \$102 million. Opponents argue it amounts to a net loss of nearly \$100 million because inflation and enrollment growth are mandatory components of K-12 funding every year. When other cuts are included — such as \$117 million from additional school

aid and \$22 million for higher payments to schools that post improving test scores — the funding picture is a net loss.

• The budget spares JTED, from a cut in state aid. But it puts them on a path for reduced state support in the future.

Higher Education: According to Budget Proponents

- Budget includes more than \$600 million in general fund dollars for universities
- 7% of state general fund budget
- Protecting rural community colleges from reductions
- Source: Office of the Arizona Governor

Higher Education: According to Budget Opponents

- Reduction of \$99 M for Arizona Universities
- Eliminates all funding for Community Colleges in Maricopa, Pinal and Pima counties
- Provides no funding vehicle for the university infrastructure needed to support Universities in achieving the 2020 Vision Goal of growing research revenue from \$1B to \$2B per year by 2020.

The Governor has said that our last election sent a strong message for "Arizona to live within its means" and this budget is the result. After this series of cuts, it will be interesting to see if this is what the people of Arizona truly asked for. The end result is a budget that is structurally balanced and strategically imbalanced if Arizona is to continue to grow its jobs and tax bases (revenue) while improving our education quality and our quality of life.

Here's my 2 cents:

Arizona's state sales-tax rate is currently 5.6 cents on the dollar, giving the state an average sales-tax rate, including local levies, of 8.16 cents on the dollar.


A 1 cent state sales tax increase (based on past estimates) generates roughly \$1B per year. A 2 cent increase would generate \$2B.

Continual belt tightening due to revenue constraints puts improvements to our state infrastructure on the back burner year after year. Perhaps it's time to pitch in 2 cents on a dollar to get us back on the growth track and maintain the resources we already have. Here are just a few ideas...

1 Cent for Infrastructure Lease Purchase Financing to Support

- Research Facilities and equipment at our Universities so that they have what they need to attract outside investments in research in our state.
- Classroom or other educational facilities or equipment at our community colleges.

Medical marijuana grow facility in Oracle?

On Feb. 18, the Pinal County Board of Supervisors voted to amend a text of the county zoning ordinance regarding open cultivation of medical marijuana. A request had been made by Sean Dugan owner of the Sidewinder Dairy in Casa Grande to allow the use of 10 acres of his farm land for an outdoor medical marijuana grow site. The County Planning and Zoning Commission had voted 9-1 to deny the ordinance change. The Pinal

County Attorney's Office and some other organizations across the county were also opposed to the amendment and outdoor grow facilities in general. At the hearing a number of people voiced their opposition to the site. Letters in support were also presented at the meeting.

Dugan was represented by Jordan Rose of the Rose Law Group. Rose said, "It's not about medical marijuana, it's about private property rights." The Board of Supervisors voted 3-2 in favor of the text amendment although they modified the size of land that can be used to five acres. Voting in

favor of the amendment were supervisors Smith, Miller and House. Chairperson Cheryl Chase and District 1 Supervisor Pete Rios voted against it. The ruling will

have county wide implications.

In Oracle, the Oracle Neighborhood Watch held an emergency meeting on Tuesday, March 2, claiming that the board of supervisors had approved a five acre cultivation site in Oracle. Around 40 people braved the rain to attend the meeting. At the meeting, Oracle Neighborhood Watch Coordinator Ron Thompson informed those in attendance about an alleged grow site that is planned for Oracle. He prepared a chart with input from the audience on the pros and cons of an open grow site being allowed in Oracle. Items in the positive were much fewer than the negative list which included land values devaluating, increase in insurance rates, 10-foot tall wall unsightly, lighting would adversely affect Oracle Dark Skies, a negative impact on tourism, and an increase in crime.

Over halfway through the meeting Alicia Bristow informed everyone that no open grow facility had been proposed for Oracle. She then got up in front of the audience and spoke about a group of people in Pinal County that have organized in opposition to the text amendment change. The

Constituents' Opinions Guide Vote Against Open Grow

During the Board of Supervisors meeting on Feb. 18, an issue regarding a medical marijuana outdoor cultivation amendment was on the agenda for a public hearing.

The hearing was specifically to decide whether or not the county should modify its zoning ordinance regarding the open cultivation of medical marijuana. It came down to the applicant – Sidewinder Dairy in Casa Grande wanting the board to amend the text of the county ordinance to allow up to 10 acres for farmers to cultivating marijuana. This was not an issue about medical marijuana use in this state. The voters approved medical marijuana in 2010.

After several hours of discussion, the Chairwoman Cheryl Chase and I voted against the text amendment for the open grow of marijuana. The minutes of the meeting reflect my reasons for opposing open grow as follows: "Supervisor Rios made a couple of comments so he wouldn't have to explain his vote. His first concern to the text amendment to the ordinance is whether it's 5 acres, 10 acres, 50 or 100 acres. It's an arbitrary number. He expressed concern that a multi-national company can sue in court and if they prevail the county would lose its ability to control the number of acreage. Secondly, open cultivation is open to anyone, not just farmers." Those were my basic reasons for opposition. Plus the ordinance currently allows for indoor cultivation of marijuana for medical use. Even though both Chase and I opposed the text amendment it passed on a 3 - 2 vote.

No sites have been approved for open grow. That will require another process to come before the board, again with public input, for a Special Use Permit. No one has applied for a SUP at this time. I led the charge against the Medical Marijuana Dispensary in both Dudleyville and Oracle. The Dudleyville site failed and about a year later the Oracle site was approved on a 3 - 2 vote, again with myself and Chase voting NO. I support the use of medical marijuana by ill people, especially those that suffer from cancer and find medicinal benefits from its use. It is the state law. I will however, continue to oppose medical marijuana dispensary sites and open grow sites where the majority of my constituents do not want them in their communities and neighborhoods.

the ballot during the next election in 2016. The referendum petition needs to gather 8,000 signatures

by March 20. If successful the people in Pinal County will be able to decide if outdoor cultivation of medical marijuana should be permitted in the county.

San Manuel Swimmers compete at State Championship Meet

The Arizona Age Group State Championship Swim Meet was held March 5-8 at the Oro Valley Aquatic Center. Tabitha Kellam (11), Evan Apuron (11), Riley Stewart (11), and Nate Fister (12) achieved qualifying times in events at USA Swimming sanctioned meets to allow them to compete at the meet for swimmers ages 14 and under. Additionally, Ben Fister (9), Joey Castellanos (9), and Mason Stewart (9) qualified to swim on the 12 and Under Relays. Swimmers were allowed to swim up to a maximum of six events at the meet, if they achieved the qualifying times. Sea Lions Head Coach Alex Gort expressed pride in the fact that many of the swimmers were at the young end of their respective age groups and this year provided valuable experience for the future.

Nate Fister qualified in the 50-yard Freestyle and swam a personal best time of 28.88 to finish 27th.

Tabitha Kellam qualified in the 200-yard Breaststroke and the 400-yard Individual Medley (IM). Both grueling events took place on Friday and Tabitha was able to swim several seconds faster in each finishing 22nd in the 200 Breaststroke (2:52.64) and 28th in the 400 IM (5:31.75).

Evan Apuron and Riley Stewart both qualified

in many events and had to select their six best to compete at state.

Riley Stewart entered the distance and breaststroke events. In a spectacular 1650-yard Freestyle, Stewart went over a minute faster than his previous best time and finished 14th with a time of 20:29.57. Stewart finished the 200-yard Breaststroke in a time of 2:54.83 and a 20th place finish. Stewart qualified for the Consolation Finals (ninth-16th place) in the 50-yard Breaststroke and finished 16th that evening. In a timed finals session, Stewart broke the six minute barrier in the 500 yard Freestyle with a time 5:56.67 going 20 seconds faster than his previous best and finished 23rd, among the best of the 11-year-olds. Stewart finished off the meet with a 23rd place in the 100 Breaststroke and 18th place in the 1000-yard Freestyle.

Evan Apuron entered all the butterfly events along with some IM and freestyle events. In what turned out to be a grueling Friday, Apuron let the state know he was the best 11-year-old butterfly. After preliminaries and finals in the 200 Butterfly and 50 Butterfly against considerably bigger 12-year-olds, Evan finished fourth place in both events with tremendous time improvements. In a remarkable period of two weeks, his best time in the 200 fly dropped

from 2:45.8 to 2:31.4 to 2:23.42. His 50 fly time of 29.20 is one that many high school swimmers would be proud of. At the rest of the meet, Apuron continued to swim his best when it mattered most. He finished 10th in the 200 IM (2:23.76), 17th in the 100 Freestyle (1:00.69), ninth in the 100 IM (1:07.26), and 10th in the 100 fly (1:04.99).

The Sea Lions competed in four 12 and Under relays at the meet with help from some 9-year-old boys that helped the teams qualify. The team of Riley Stewart, Ben Fister (9), Nate Fister, and Evan Apuron finished 16th in the 400 Freestyle Relay and 19th in the 200 Freestyle Relay. In the 200 Medley Relay, Joey Castellanos (9) swam the Backstroke leg, with Stewart (Breast), Apuron (Fly) and Nate Fister (Free) and the team finished 20th. In the 400 Medley Relay, Mason Stewart (9) swam the Breaststroke leg with Riley Stewart (Back), Apuron (Fly), and Nate Fister (Free) swimming to a 17th place finish.

Two more San Manuel Swimmers will be competing at the Eight and Under Championship Meet to be held on March 21-22 at the Peonix Country Day Pool in Paradise Valley. Johnny Smallhouse (8) and Anya Zovko (7) are both scheduled to compete in several events at

the meet.

Sea Lions will begin practice in San Manuel on April 1 for the summer season. Registration will be at the pool on weekdays 4 p.m. to 5:30 p.m. beginning April 1. Contact Alex or Wendy Gort at 896-2190 for more information.
