Copper Corridor residents hunker down in preparation for a pandemic

With the threat of COVID-19 looming ever closer, residents and businesses in the Copper Corridor are preparing for the worst.

What exactly is COVID-19 and why is this such a big deal? According to the Centers for Disease Control, coronavirus disease 2019 (COVID-19) is a respiratory illness that can spread from person to person. The virus that causes COVID-19 is a novel coronavirus that was first identified during an investigation into an outbreak in Wuhan, China.

The virus that causes COVID-19 probably emerged from an animal source, but is now spreading from person to person. The virus is thought to spread mainly between people who are in close contact with one another (within about 6 feet) through respiratory droplets produced when an infected person coughs or sneezes. It also may be possible that a person can get COVID-19 by touching a surface or object that has the virus on it and then touching their own mouth, nose, or possibly their eyes, but this is not thought to be the main way the virus spreads.

Patients with COVID-19 have had a mild to severe respiratory illness with fever, cough and shortness of breath. The virus can cause pneumonia, organ failure and death in the most severe cases.

Federal, state and local officials are calling for social distancing to help control the spread. All schools in Arizona have been closed for the next two weeks. This closure is likely to be extended as the number of infected cases increase. Arizona isn't one of the "hot spots" but the virus is expected to affect more than 70,000 in Arizona.

Officials have also limited the number of people allowed in a group to 10, prompting other closures and changes to businesses. Restaurants are encouraged to go to curbside or delivery only and close to inside dining. Likewise, bars are being encouraged to close.

The Roman Catholic Diocese of Tucson, of which all Catholic churches in Pinal and Gila counties are members, has canceled or suspended all parish-based public gatherings for the next three weeks (until April 6), including:

- No public Masses after March 16, 2020.
- The Sunday Mass obligation is dispensed for all Catholic people residing in or visiting the territory of the Diocese of Tucson. Catholics are urged to observe Sunday in accord with our teachings, which may include spending additional time on Sunday in prayer, observing a Catholic Mass via television or internet, or other pious practices.
- Confirmations scheduled during this time period are suspended and will be rescheduled
- There are to be no public Church events or gatherings, such as parish religious education programs, Stations of the Cross, Communion services, Quinceañeras, parish missions, dinners, etc.
- Mass of the Holy Oils, "Chrism Mass," will be celebrated privately with Holy Oils to be distributed privately to priests.
- Weddings should be restricted to 10 persons, and if Mass is celebrated only the bride and groom, if Catholic, are to receive Holy Communion.
- Funeral Masses should be restricted to 10 persons, and the congregation should not receive Holy Communion.

If planning to attend a funeral, please check with the church or funeral home before going. Funerals at St. Francis of Assisi and St. Helen's Catholic churches are being postponed. The Tri-Community (Mammoth, San Manuel and Oracle) Knights of

COVID-19

With everything changing quickly in response to the COVID-19 (Corona Virus) many of the municipalities and school districts are closing and or reducing human connections to reduce the spread of the virus to the greater Copper Corridor region. These efforts are being put into place to flatten the curve in order to not put additional stress on the health care system.

As per recommendations by the CDC, the President of the United States and Governor Doug Ducey, everyone is asked to social distance themself and avoid being in groups of more than 10 people. Local restaurants and retail establishments, especially restaurants in Pinal, Maricopa and Pima Counties are asked to limit their operations to no more than 10 people in their establishments and for restaurants to switch to curbside or take out orders in order to limit person to person interactions.

It is important to know that all police and fire systems will operate as usual across the region. The CDC has issued many new protocols for how EMS handle calls to both the safety of the patient and first responder. Should you have symptoms of COVID-19, it is recommended you call your primary care physician before calling 911 or going to the emergency room. Should you need to call 911, please identify if you are experiencing respiratory distress.

Schools: Governor Doug Ducey has ordered all schools to be closed for through March 27; they are expected to re-open on March 30 unless an extension of the closure is needed. Districts are also learning how this will affect state wide assessment testing and sports schedules.

The AIA Executive Board voted to maintain the State Championship schedules for spring sports at this time.

Hayden-Winkelman School District is

continuing free food services to anyone 18 and younger in the community. Beginning Wednesday, March 18, HWUSD schools will provide meals FREE for anyone 18 and under. Breakfast and lunch will be delivered daily Monday-Friday from 10-11 a.m. at the following locations: Winkelman Pregnancy Center, Hayden Senior Center, Pinitos Park, Indian Hills, Dudleyville Lionel Ruiz Multigenerational Center, Central Arizona College Marquee, Redwood Inn Mammoth, Dripping Springs Cooley Ranch turnoff and Kearny Park by swimming pool

You are encouraged to pick up your sack breakfasts and lunches and take them home to keep up with recommended guidelines of social distancing

Superior Unified and Ray Unified have not announced any official food distribution plans. Superior is considering a drive up option for students to pick up a cold breakfast and lunch each day. Both Superior and Ray are currently on spring break at this time so food service would not start until Monday, March

Central Arizona College has moved all classes for this semester to all online classes and all campuses are closed through March 23,

Hayden: The Town of Hayden has announced that the dining room of the Senior Center has been closed and will remain closed until it is recommended to open. Those who visit the Senior Center for their meals can either pick up a meal at the Senior Center or request a home delivered meal. Home delivery meals will continue as scheduled. Superior: The Town of Superior has declared an Emergency allowing the Mayor to act by proclamation in order to combat the spread of the virus. The Superior Public Library and Senior Center are closed until further notice. All Senior Center meals will go to a home delivery service; to request a home delivered meals please call the Senior Center at 520-689-5182.

The Town of Superior has closed Town Hall to public access; staff is working by appointment only and all meetings are being switched to an online or phone meetings. Please call ahead to Town Hall to arrange for any meetings regarding building permits or funeral services.

Should there be a public safety emergency residents are encouraged to call 911 however

for non-emergency related matters requiring police services, residents should call the non-emergency number 520-866-5111.

For the time being the transfer station will remain open and all fees are being waived. Residents who are experiencing any type of public works emergency should call the Town Hall at 520-689-5752 to submit a work order. Sea Lion swimmers compete at Age Group State Championship Meet

On March 5-8, the Age Group State Championship Meet was held at the Oro Valley Aquatic Center for Swimmers 14 years old and younger. Two members of the Sea Lions Swim Team competed. Ethan Erickson (12) and Cooper Dale (12) achieved qualifying times at USA Swimming sanctioned meets to allow them to compete at the meet. It was the first State Championship Meet for both swimmers.

Cooper Dale swam his fastest ever (5:48.48) 400 Individual Medley (IM) on his way to 26th place finish. Cooper swam such an aggressive race that his first 100 (the Butterfly portion of the IM) was faster than his best 100 Butterfly time.

Ethan Erickson qualified to swim 5 events at the Championship. In every event, he achieved his fastest time. Ethan swam the 400 IM more than 13 seconds faster than he ever did before on his way to a 19th place finish (5:34.98). In every Breaststroke event (50, 100, and 200), Ethan swam fast enough in morning preliminaries to advance to finals in the afternoon. In finals, Ethan finished in 11th place in the 200 Breaststroke (2:52.08), 13th place in the 100 Breaststroke (1:17.62) and 13th place in the 50 Breaststroke (35.94). Ethan also swam his quickest 50 Freestyle to finish 28th (28.73).

Coach Alex Gort was proud of the accomplishments of the Sea Lions.

"It was the first State Championship Meet for Cooper and Ethan," Gort said. "They

both swam excellent 400 IMs showing that have mastered all the strokes and have the endurance for longer races. Ethan finished in the top 16 in the State in three events in his first season competing in USA Swimming. I am excited about the future for both boys."
