



# Women stand up for abused and neglected children in Gila County

Globe, AZ —March o6, 2020 - March is Women's History Month and CASA of Gila County is expressing their deepest gratitude for the women who are standing up for abused and neglected children in Arizona. Nearly 83% of Court Appointed Special Advocates (CASA) in Arizona are female — these women are making a difference in children's lives across Arizona, giving them a voice in court and advocating for their best interest.

"How wonderful it is that nobody needs wait a single moment before starting to improve the world," a famous quote by Anne Frank.

One person in a child's life who isn't paid to show up means the world to a child in foster care. Today, there are over 14,000 children in Arizona who have been removed from their homes due to abuse and/or neglect.

"Children in Gila County desperately need a stable and caring adult in their life during the time that they are in foster care," said Emily Nader, CASA of Gila County Coordinator. "We are in dire need of volunteers from our community to be a caring, consistent adult on their case."

In Gila County, only 43 out of 170 children in foster care have a CASA advocate (only 25%). Studies have shown that a child in foster care that is assigned a CASA

How can you make a difference? Become a CASA volunteer, TODAY! Court Appointed Special Advocates are everyday community members who donate their time to be the voice for a child. CASA volunteers visit with the children regularly. They follow the progress of the child's court case, speak with important people in the child's life, and report their observations back to the court so the judge can make informed decisions on behalf of the child.

No specific background or training is needed to become a CASA volunteer. Anyone 21 years of age or older, who can pass a thorough background check and complete 30 hours of free training, is encouraged to apply.

# Pinal County continues to lower tax rate FY20/21

FLORENCE, AZ - Pinal County is proud to be able to lower the tax rate for another year. On Aug. 19, 2019, the Pinal County Office of Management and Budget proposed to the Board of Supervisors a primary property tax rate of \$3.7900 per \$100 of valuation. The proposal stemmed from an overall Pinal County Strategic Plan, Strategic Priority #4 - Financial Health. The goal, maintain a structural balance while investing in the County's future and reducing the primary property. Objective 4.2: Reduce the primary property tax rate at or below \$3.7500 by fiscal year 2020/2021. Director of the Pinal County Office of Management and Budget, Angie Woods stated, "Not many counties in the state have a strategic plan in place for primary property tax rate goals. This has been a great success for us and we are very satisfied with the outcome."

To get a better idea of what happens to a taxed one dollar

bill in Pinal County, here are some insights. In the fiscal year 2019-2020, the Pinal County portion of the tax levy was roughly 26 cents. In the fiscal year 2010-2011, the tax levy was up 31 cents. The rate reduction over the past five years results in a significant amount of savings estimating \$22 million in primary property tax levy reduction from the start of the fiscal year 2015-2016 tax rate at \$3.999.

"Over the last several years, my fellow Board Members and I voted to decrease the property tax levy. By doing so, this \$22 million goes back into the pockets of the residents in Pinal County," Supervisor Goodman said. "The Board of Supervisors and staff are working more efficiently with our taxpayer dollars as well as maintaining our reserve for a rainy day."



# Food supply pinched!

Residents of the Copper Corridor may have noticed that their local grocery store shelves have been rather empty. There has been a mad rush to buy paper products like toilet paper, paper towels and of course hand sanitizers and cleaning supplies. The panicked buying started when the warning of the potential for shelter in place orders and personal quarantines due to the COVID-19 virus were publicized.

For local grocers in the area, their supply chain has been overly stressed with resupply trucks not being able to make their deliveries due to a shortage of warehouse workers and an increased demand across the state for resupply to the grocery stores.

Governor Doug Ducey has activated the Arizona National Guard to assist grocery warehouses to load trucks and restock stores. For Norm's in Kearny and Save Money Market in Superior, they rely on the Basha's distribution warehouse for their weekly grocery supply. Their orders have been delayed over the past two weeks. Smaller supplies have come in from other distributors. On an average, it takes two semi-trucks a week to keep a grocery store filled. Due to the panicked buying of consumers across the state it will take 12 semi trucks to refill the store.

Do not be alarmed if you see National Guard Vehicles and personnel arriving into town to restock grocery stores. Grocery store resupplies are expected to be delivered this week.

Readers may also note a lack of grocery store sales flyers in their newspapers this week. Don't worry. They will be back as soon as supplies start flowing again.

# Governor Ducey orders dining rooms

The COVID-19 Virus continues to shake up the world. At the local level executive orders and declarations of emergencies have been made at the county, state and local levels. Local elected leaders and the business community are bracing for what what is predicted to be a very deep recession, one that will affect many hourly workers in the hospitality industry, the hardest as the jobs they have been working at may not come back if these closures and restrictions last too long.

In Pinal County there are currently 20 cases: seven are still active and 12 have recovered. The number of positive test results are expected to grow over the next two weeks. Statewide there are 234 active cases and two people have died. Overall the spread in Arizona has been deemed moderate, according to the Arizona Department of Health Website. Gila County has not had any positive tests confirmed despite 23 tests being completed: nine have been negative and 14 are pending.

Currently, Pinal County, the Town of Kearny and the Town of Superior have declared emergencies. Their emergency declarations allow the Chairperson of the Board of Supervisors, or the Mayors to act swiftly in regards to the emergency.

In an effort to flatten the curve of the virus or to stop the spread Governor Doug Ducey issued several executive orders for residents and business owners to follow. In an earlier Executive Order, the Governor forced any event over 50 people to be cancelled. The CDC and President Trump reduced that number to 10 in their recommendation guidance on helping to stop the spread of the COVID-19 virus. Governor Ducey ordered all bars, gyms and movie theaters to close and every restaurant was forced to close their dining rooms and only offer take out/ carry out options. This included patios at restaurants that also had to shutter. Over the weekend many visitors to the region were found eating in their cars or waiting outside local restaurants for their food to be carried out to them. The order did allow local restaurants with liquor licenses to sell sealed package alcohol beverages to their patrons to go. This was an exception to the normal rule which only allows establishments with Class 6 Liquor Licenses to sell package liquor. When the order was enacted on the evening of Thursday, March 19, these orders only affected Pinal, Pima and Maricopa Counties. As of press time, this

order to close dining rooms, gyms and movie theaters affected 11 of Arizonas 15 counties, the order applies to all counties where there is an active COVID-19 case. Gila County does not have any active cases at (press time-Monday night), so restaurants in Hayden, Winkelman, Globe and Miami are not affected.

The Executive Order issued also halted all elective surgeries in the state of Arizona and the expiration on drivers licenses are also delayed for both regular drivers licenses and commercial drivers licenses.

School Districts are all ordered to remain closed for an additional two weeks, and at this time schools are scheduled to re-open on April 10, 2020. During this closure districts are expected to provide remote instruction to their students. Many local schools are sending home packets or creating online access for instruction for Junior and Senior High Students. This is bringing up the conversation of lack of internet access and technological equipment for rural students. The state is not forcing districts to make up the hours, and the federal government has indicated that they will not require the mandated federal testing. Local schools are also providing breakfast and lunch to students at all local school districts.

The closure has also affected the High School Spring sports seasons. Currently districts are not holding practices or games, however the Arizona Interscholastic Association (AIA) has voted to host the State Championship tournaments later in the Summer should the ban on public events be lifted.

Central Arizona College has announced that they will remain closed and have moved all courses to an online format. In a recent press release the district announced that graduation ceremonies and other academic awards event have been cancelled or will be moved to a digital format.

Many wonder if Governor will order a shelter in place order such as the Governors of California and New Mexico. In a press conference last week, the Governor indicated that he was not planning to issue a shelter in place order. On Monday evening, March 23, 2020 the Governor issued another executive order which outlined which occupations were deemed necessary and essential and should continue to operate. The order prohibits a city or town from issuing any order that restricts a person from performing an "essential function"

# closed; schools remain shuttered

as designated by the Governor, DHS Director or DEMA; requires any order restricting persons from leaving their home to be consistent with DHS advice and be coordinated with DHS prior to issuance; and defines essential functions. The business categories everything from health care, human services such as long term care facilities and shelters. Essential Infrastructure Operations including food production, distribution, sales and landscaping companies as an examples. Governments are required to maintain their operations and most retail services include hardware stores, beauty and barber shops, grocery and pharmacy stores, parks, trails, golf courses and restaurants as long as they only offer take out services.







# Hayden-Winkelman USD's Meals on Wheels Program

Hayden-Winkelman Unified School District began its "meals on wheels" program for all children 18 years of age and younger. Five days a week, the district will be delivering over 320 meals to hungry children throughout the Copper Corridor.

Hayden -Winkelman Food Service **Director Barbara Martinez coordinates** this massive feed the children effort.

"Our goal is to feed as many children as possible during this unprecedented time. We don't care what school district you attend, what school colors you wear, if you are hungry, we will feed you. Parents or children can show up at the stop and tell us how many meals you need, and we hand them out. It's as simple as that," stated Director Martinez.

"The school district has mobilized it workforce to prepare and deliver the meals. It is a team effort and it makes us feel better that we are helping our community, parents and children during

these stressful and uncertain times," added principal Pam Gonzalez.

"The District plans to continue providing breakfast and lunches for children as long our schools are shut down. I believe this will also mean throughout the summer months. Between the copper strike and the coronavirus, I am certain that families are struggling and it the role of our public entities to ensure meals our being provided to our children. # A Little Bit of State History: Valentine, AZ

We all know the story of St. Valentine and how Valentine's Day started but did you know there is a town in Arizona named Valentine?

Valentine is a small village located in Mohave County in northern Arizona. It is about 26 miles north east of Kingman on State Route 66. The area that became Valentine was first known as Truxton named after a railroad siding that became a small town with a post office. The town grew around the railroad station and the Truxton Canyon Training School which served as the school for the nearby members of the Hualapai Indian tribe, located within the Indian Agency. It was also a boarding school for other tribes in Arizona.

In 1910, the Truxton post office, town and the school were renamed Valentine. not after St. Valentine but after Charles Gordon Valentine, the new Commissioner

of Indian Affairs. C.G. Valentine was 36 years old, a native of Massachusetts and a graduate of Harvard when appointed as Commissioner. He served from 1909 until

In its heyday, Valentine would have a population of a couple of hundred residents. It was a small tourist stop on Route 66 before the I-40 section bypassed it. It would become known for its heart shaped postal stamp and Valentine, Arizona cancellation postmark in February as visitors would flock to the post office and thousands of people from all over the country and from overseas would mail their valentines to Valentine to be post marked. It is believed that the tradition began in the 1940s and its popularity grew over the years promoted by the post mistresses.

On Aug. 15, 1990, tragedy struck that would be the end of the Valentine Post Office. The contract post office was being operated by Jacqueline Ann Grigg and her

sister-in-law Sheli for the past 11 years. On this day Jacqueline was murdered during a robbery. She was shot while sitting in a chair knitting. The murderer got away with \$40 cash and \$800 in worthless money orders that had not been validated. He was arrested two days afterwards in California. He was sentenced to Life in prison. She was survived by her husband, Fred and three

children.

Soon after her death, her broken-hearted, widowed husband dismantled the building used as the post office and left town. This ended the tradition of thousands of people sending their valentines or visiting the post office for its heart shaped Valentine's Day postmark from Valentine, Arizona. The Valentine postal

The Valentine postal stamp is now at the

Kingman, Arizona post office. If requested they will stamp your letter with the cupid heart that says Valentine, Arizona and its zip code although it is postmarked Kingman. They get some requests, but not like in the days of the Valentine post office when tourists flocked to town in February and they processed more mail than at Christmas.

Valentine is virtually a

ghost town these days with fewer than 40 residents reported in the last census.

# MVD Update: Office appointments required

PHOENIX - In order to safely and efficiently serve customers during the ongoing health situation, the Arizona Department of Transportation Motor Vehicle Division will limit office visits to only those customers who need essential services that must be done in person.

Two-thirds of MVD services are available online, yet many of the nearly 12,000 daily customers statewide visit offices to process transactions that could be accomplished through ServiceArizona. com. Beginning Monday, March 23, appointments will be required for any in-office services. Walk-in customers will be directed to access services online or by phone, or if necessary, to make an appointment to return.

**Authorized Third Party** offices are not affected by this change and may have services available.

Additionally, in compliance with Governor Doug Ducey's executive order of March 19, expiration dates for customers whose license or permit expires between March 1 and Sept. 1 have been extended for six months. MVD will automatically update affected customers' motor vehicle records to reflect that change. Customers may also request a duplicate license through ServiceArizona.com, but this is optional.

"These extraordinary measures are needed because the safety of MVD customers and employees is our first priority," said MVD Director Eric Jorgensen.

Beginning Monday, March 23, a new statewide customer service phone call-in system at 602-712-2700 will begin operations between 7:30 a.m. and 4:30 p.m. Customers may set up office appointments for essential services that cannot be done

on the phone. But in the vast majority of cases, customers will be assisted with those services remotely. A list of services that can be done entirely online can be found at ServiceArizona.com. Many transactions can also be done through the U.S. mail.

In many instances, the MVD staff member will help the customer access his or her AZ MVD Now account to process some


