



## ASU Herberger Institute facilitates planning for Kearny

Following the fire along the Gila River this past summer, local leaders and community members began looking at ways to further protect the town from fire and create a recreational area that would be good for both residents and visitors to the area. Last week Chingwen Cheng and her students hosted a design project facilitation at the Church of the Good Shepherd in Kearny.

Cheng is the Assistant Professor of Landscape Architecture at the ASU Herberger Institute for Design and the Arts. She explained that local resident Gerry Kaufhold contacted the school to see how they school could help local leaders develop a plan for the river area that would protect the town from fires and other natural disasters as well as create more recreational areas along the river.

The afternoon facilitation included using various activities from dropping candle wax on maps of the area where locals felt needed more fire prevention, planning of recreational green belts using tiles and painting. Each station allowed the participants to work as group to provide input for the students of the Herberger school. The students will then analyze the public participation process, layer that with their knowledge and present plans and ideas for what can be done in the areas along the Gila River.

## Public comment open on ASARCO tailing expansion

The Army Corps of Engineers has announced that it is soliciting comments on the draft Environmental Impact Statement (EIS) for the Ray Mine Proposed Tailings Storage Facility. The storage facility is near Ripsey Wash, the Gila River and other unnamed washes in the area. The comment period is open from Jan. 29, 2016 - March 14, 2016.

The Corps' regulatory division is soliciting comments from the public, federal, state and local agencies, Native American tribes and local agencies. The draft EIS has been prepared to evaluate the effects of the proposed project not the natural and human environment. This comment period is the appropriate time for the public to express their concerns or support for the new tailings facility. 


miss from advancing to the state semis.
