Anthony Sigala and Juan "Johnny" Lopez have been charged with aggravated assault and manslaughter. The two turned themselves in at



Arizona Water wants EPA, Asarco to protect the groundwater near Hayden, Winkelman

On Feb. 21, 2014, Arizona Water Company, which owns and operates the water system in Hayden and Winkelman, sent the following letter to John Hillenbrand, project manager for the United States Environmental Protection Agency. A copy of the letter was also sent to the *Copper Basin News*.

The *Copper Basin News* requested a response from Tom Aldrich of Asarco. His comments are included below. Arizona Water Company's letter

Arizona Water Company ("Arizona Water") is very concerned about the serious threat to local drinking water supplies caused by pollutants from the ASARCO mining operations in the Hayden and Winkelman area.

Arizona water, a public service corporation, relies on local groundwater supplies to provide water service to residents and businesses in the Town of Winkelman. In December 2013, ASARCO began quarterly sampling of Arizona Water's wells to assess the threat of pollution in local groundwater.

Arizona Water requests the following as the Phase II Remedial Investigation and Feasibility Study ("RIFS") is developed:

- 1. Provide Arizona Water with all monthly progress reports ASARCO submits to EPA pursuant to the Administrative Settlement Agreement and Order on Consent
- Provide all groundwater quality data gathered or compiled in connection with any phase of the RIFS for this site
- 3. Provide Arizona Water with all future drafts of the RIFS for Arizona Water's review, input and comments.
- 4. Provide copies of reports from the previous EPA investigations of ASARCO's mining operations in the Hayden/Winkelman area, including, but not limited to, the Preliminary Assessment.
- 5. Add PCBs on the list of substances analyzed in groundwater samples in the Phase II RIFS.
- 6. Form a Community Advisory Group including EPA, Arizona Water and ASARCO to encourage community involvement for timely distribution of information. The Community Advisory Group should conduct regular meetings to review the progress and findings of the Phase II RIFS.
- Require ASARCO to create and maintain a public information repository such as a community website,

where all information on the investigation and related matters is readily available.

It is critical that EPA determine the fate and transport of the pollutants from ASARCO's mining operations and their effect on Arizona Water's groundwater supplies, the only source of drinking water for Winkelman. Arizona Water strongly urges EPA and ASARCO to take all actions necessary to protect the groundwater for public drinking water supply purposes.

Asarco's Response

EPA has previously stated the drinking water supply for the Towns of Hayden and Winkelman meet drinking water quality standards.

Each year the ADEQ samples public water supplies. Those results are presented in the Consumer Confidence Report which is issued by the operator of the public water system.

The Consumer Confidence Report for Asarco's PWS #04-012, which gets its water from the Hayden Well Field indicates that the water meets water quality standards.

The wells for the Arizona Water Company are roughly one mile upstream on the Gila. The link for the Consumer Confidence Report for Winkelman is found on the Arizona Water Company web page (link below). The report states that the Arizona Water Company provides groundwater to its Winkelman customers from wells located throughout the Winkelman area. The water supplied by Arizona Water Company complies with all state and federal safe drinking water standards.



Only three weeks until Pioneer Days 2014

Of course, there is going to be a weather change, it is almost Pioneer Days. Excitement is brewing because the carnival pre-sale tickets are in and the pre-sales have begun. The sheet of 40 tickets can be purchased for \$25 and is the same price as in previous years. Instead of bracelets Mega Punch Cards are available, eight ride punches for \$15. Gloria Ruiz at the Winkelman Town Hall, Nancy Hinojos at the Hayden Town Hall and the chamber office will be available to sell tickets until March 14.

Sorry for the error in the deadline date for t-shirt pre-sales which is actually March 10. The t-shirts are dark grey and have a Conestoga wagon on the front with the words Pioneer Days 2014. The deadline for ads on the back is also March 10. Ads are \$40 and include the individual name or business name and a t-shirt. All extra t-shirts are \$12 each up to XL with \$1 for each X above that. Jean Slater and Nancy Hinojos are in charge of the t-shirt ads and sales.

We are all so used to an empty Pioneer Park that is accessible

to drive around, but once the carnival starts to set up vehicle traffic gets in the way. Those attending can park at the Little League Park and walk over to observe, but just driving around is a nuisance especially at night. There are some rules that have to be emphasized and will be repeated again prior to Pioneer Days. One comment we are sure to hear is, "Why? We've never had to do this before." The front entrance will be closed at 4 p.m. on Thursday and Friday; 11 a.m. on Saturday and noon on Sunday. It is an insurance rule that there is not to be any motorized vehicles which includes bicycles, skateboards, scooters, etc., inside Pioneer Park once the carnival starts their rides. Wheel chairs, strollers and hov-arounds are exceptions. Parents and children can feel safe and children can enjoy their excitement by not having to lookout for vehicles. There will be a vehicle at the front gate for handicapped riders. For those who are performing at the bandstand you must park your vehicles on the outskirts of the carnival, not any closer than the office door of the Frazier Shows Office, and use a dollie to carry

in your equipment.

No dogs are allowed even if on a leash or tucked inside a jacket! There have been complaints of fresh dog poop and the health department frowns upon animals near food vendors. Service dogs are allowed.

Parade applications are available at the chamber office or from Margaret Gaston. There is no fee but the parade committee has one request, turn in applications by Thursday, March 20 with a complete description of the parade entry. This information has to be typed and ready for the judges. Late entries will not have any comments by the Master of Ceremonies as they pass the judges stand. The parade starts on Allen and goes to Upton, then down Alden. Entries will stop at the Judges stand in front of the Pinal County Building. The parade will proceed down Tilbury all the way across the tracks to Beuford and Industrial. The businesses on Airport Drive must not be blocked.

Anyone who has lived or worked on Santos Ranch, Crescent Ranch or other ranches in this vicinity are requested to enter the parade either horseback, on a float, or any other clever entry.

The Junior and Queen candidates are out and about selling tickets. They have been meeting weekly and will be introduced at the Women's Expo this Saturday when they present their fashion show.



esa photographer Rim Vidziunas has earned an avid online following who appreciate his stylized images of Boyce Thompson Arboretum and the Sonoran Desert -- plus eclectic subjects ranging from classic cars to macros. He's probably even more wellknown amongst the Arboretum's 5,000 fans on Facebook - where Rim shares photos with heightened color and effects he produces via 'HDR' post-processing software.

March brings the chance to see enlarged versions of his works in the Arboretum visitor center gallery, where Rim's the featured exhibitor - plus opportunities to learn his camera and software techniques in a classroom setting. He'll teach 'basic work-flow' and file management for digital photographers March 12 from 2-4pm, a Wednesday class that's ideal for novice/beginner photographers, and with low enrollment of \$30.

He also coaches a more specialized and technical users group March 17 from 10am til noon (more complete descriptions are at ag.arizona.edu/bta/photoclass). Call BTA staff during daytime business hours at 520-689-2723 to enroll in the Wednesday class. Friends and guests have also marked March 16 their calendars for Rim's meet-theartist gallery reception that Sunday from 10am-1pm.

"I knew I was destined to become a photographer

since I was a kid -- I was 11 years old when I snapped my first pictures of our German Shepherd with a Kodak Brownie box camera. In the darkroom, magically, images appeared, literally right before my eyes - and passion for photography was born. Perhaps it's ancestral, my family's history is rooted in Lithuania where my name, Vidziunas has the Latin root is-vysti which means to see more clearly with perception."

"My approach to photography remains to 'get it right in-camera.' Shooting in the RAW mode allows postprocessing to adjust the white balance, increase or decrease exposure, clarity, sharpen my images, adjust color -- in short, to add painterly or artistic touches, and be an artist with a camera via post-processing."

"I use HDR for tone mapping merging three exposed (+2,0,-2) images to make an artistic statement, add drama or a mood about how I'm feeling about the subject. For instance, in a photo of the Drover's Shed at the Arboretum to make it appear a storm is brewing – or HDR applied to my Dodge Power Wagon picture makes dull rust colors 'pop' and brings out detail."

"My favorite places at BTA? I find the Demonstration Garden and Cactus Garden among the most compelling. Recently I'm exploring macro-photography with an old Nikon Micro-Nikkor 55mm lens mounted on a modern D7000 camera body. That lens was manufactured in 1984, my 92-year-old father gave it to me and yes, you can use old Nikon film camera lenses on new Nikon digital cameras with amazing results."

Rim doesn't work the East Valley art show circuit, but his photos be seen (and prints in a wide array of formats and media ordered) at photographybyrimgaudas.com. For his Arboretum gallery show, prints will be matted, framed and available in sizes ranging from 4x6 to 12x18, and priced from \$50-\$200.

"I'm honored and humbled to be approved as a gallery exhibitor as a way to bring attention to my work and to the Arboretum, and to give others the opportunity to enjoy my images and imagination; I'm not planning other gallery exhibits during 2014, in part because I so much

enjoy teaching occasional classes at BTA, and also being the volunteer coordinator for the new Adobe Photoshop

PASTOR'S CORNER

Shuffling Forever

I don't play poker. The last time I did, I lost all my spending money to a clever kid with a smirk on his greedy face. Since then, I try to work on sure bets. I don't bet on dice or football or that I (rather than my wife) am right. So it may sound like a contradiction for me to say that I'll bet you that you will never shuffle a deck of cards into any one pre-chosen order. I raise this challenge to prove beyond a shadow of a doubt that we have a Maker. We did not evolve; we were made. Let me explain.

For order in complexity to exist, three things must exist prior to the order: energy, a mechanism, and intelligence. For any one pre-chosen order of a 52 card deck to come into existence what is necessary is a person who has eaten lunch (chemical energy), who has arms, hands, fingers, and eyes (mechanisms), and who is smart enough to guide the mechanisms to sort out the deck (intelligence).
