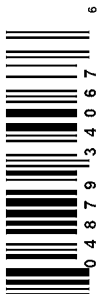

## Court determines ASARCO must pay bonuses

Senior U.S. District Judge Stephen M. McNamee issued a decision last week to enforce an arbitrator's award that ASARCO must pay a negotiated quarterly bonus based on the price of copper to the hundreds of employees hired after June 30, 2011. The company had denied the benefit and with this ruling the company will be forced to pay the bonuses.

The award is estimated to be worth more than \$10 million. The unions represent 2000 workers at five ASARCO locations in Arizona and Texas won the arbitration in December 2014.

The Region 28, National Labor Relations Board issued a fourth consolidated complaint against the company for unfair labor practices. Those complaints include unlawfully implementing portions of it's "last, best and final" contract proposal.

At press time there were no comments from the company on the expected pay outs of the bonuses or other complaints made against ASARCO to the NLRB.

The revenue bond is a responsible way to fund this infrastructure development.

As a taxpayer and a resident of Pinal County I wish to thank the president and the members of the CAC Governing Board for doing the right things.

# Oak Flats aka Chi' Chil Bildagoteel designated a historic district by Federal Government

A press release issued by Representative Paul Gosar office on Monday announced that Chi'Chil Bildagoteel most commonly known as Oak Flats campground in the Tonto National Forest has been registered as a historic district by the Federal Keeper of the Record.

In late 2015, the Keeper of the Record returned the original application to the Tonto National Forest due to several inaccuracies in their application. In early February 2016, the Tonto National Forest

re-submitted the application, this time indicating the place was an unnamed address near Superior, Arizona vs Kearney, Arizona as their original application stated. They also did not include the information that this area is most commonly known as Oak Flats to the public in the application. A request for a full copy of the nomination application has not been fulfilled at press time.

According to early reports, the public had until Friday, March 4, 2016 to submit comments in favor or against the designation. Gosar's press release indicates that on Friday, March 4, at

approximately 3:59 p.m. Mountain Standard Time the Keeper of the Record submitted a letter to Rep. Gosar stating that the area would be designated even though Representative Paul Gosar and Representative Ann Kirkpatrick both requested that the comment period be extended to allow the public to make comments. Both Representatives have requested that the application be denied and asked for an extended comment period.

The designation will create additional processes in the federal environmental permitting for the Resolution Copper mine

project. This designation does not reverse the Southeast Arizona Land Exchange which was passed in 2014. The land exchange was requested by Resolution Copper to develop their mine east of Superior.

There is currently a bill in both the US House of Representatives and US Senate to reverse the Land Exchange called the Save Oak Flats bill. At press time it does not appear that the bill has received much traction in this Congress. The House bill was introduced by Rep. Raul Grijalva and the Senate bill was introduced by Senator Bernie Sanders.

# Senior Olympian from Mammoth wins medals

Frances Amparano Sharrah of Mammoth recently competed in the Arizona Senior Olympics in Phoenix. She came home with seven medals competing in the 65 – 69 age group. She placed in every event she entered winning two silver and five bronze medals.

Frances has qualified for the National Senior Olympics in three events: the 100 meters, javelin and the running long jump.

“I really want to go this year,” she said. She has qualified before but was unable to go due to commitments in her life. She plans on training hard for the Nationals which will be in Alabama in June. She feels that she has been representing all of the communities, Mammoth, San Manuel, Oracle, Hayden, Winkelman and Kearny.

She has competed in seven Arizona Senior Olympic games, coming away with medals in all of them. She has brought home 13 Gold, 6 Silver and 3 Bronze medals. Frances grew up in Mammoth and attended San Manuel High School where she was a stellar athlete competing in basketball, volleyball, tennis, track and badminton. She graduated in 1966. This was before Title IX and there were limited opportunities for women

athletes after high school.

Frances was one of the first women to go to work in the mine at Kennecott’s Ray operation. She became a haulage truck driver. She said that she has written a book about her experiences as one of the first women mine workers and is looking for a publisher. She has always been physically active. She ran marathons in Kearny and won one in 1986. At age 48 she went back to school at Pima Community College. She tried out for the track team and ran on the 1500 meter relay team competing against women in their teens and early 20s. After turning 50 she entered her first Arizona Olympics competing in seven events, winning six Gold medals and one Silver.

Frances says she stays physically active to stay healthy. She has three daughters, nine grandchildren and 11 great-grandkids. She wants to see her great-grandchildren graduate high school. She has been an aerobics instructor and her goal is to organize a fitness workshop for kids, inspiring them to exercise to stay healthy. She would also like to set up a senior workout to get local senior citizens active in physical fitness.

Congratulations Frances! Thank you for setting an example for the youth and seniors in the community. Hope you make it to the Nationals. We’ll be rooting for you.

# San Manuel swimmers compete at Senior State Championship Meet

The Arizona Senior State Championship Swim Meet was held March 3-6 at the Southwest YMCA Pool in Goodyear, Arizona. To swim at the meet, swimmers must achieve qualifying times at a USA Swimming Sanctioned Meet. The meet brings the best swimmers of any age to the Championship meet format which holds preliminaries in the mornings with the fastest 24 swimmers advancing to the finals in the evening.

Four San Manuel swimmers competed in the meet. Darien Apuron (14), Gianna Sweeney (14), Will Newman (16) and Jacob Christian (17) completed in the meet representing 3 different swim clubs.

This was the first time that Darien Apuron attended the Senior State Championship Meet and she was the first swimmer to represent the San Manuel Sea Lion Swim Team at the meet. She swam some of the toughest events, achieving a personal best time in the 400 Individual Medley (IM) to place 84th, survived a tough 200 Butterfly to finish in 77th place, and improved her best time by over 30 seconds in the 1650 Freestyle for a time of 19:49.3 and a 31st place finish.

This was the first time attending the meet

for Gianna Sweeney and Jacob Christian who represented the Flying Fish Arizona Swim Team (FAST) from Oro Valley. Sweeney swam personal best times in nearly every race which included the 1000 Freestyle (55th place), 200 Breaststroke (65th place), 100 Breaststroke (55th place) and was a member of three FAST relay teams – the 200 Free Relay (17th place), the 200 Medley Relay (24th place), and the 400 Free Relay (22nd place). Christian swam the 500 Freestyle to a personal best time of 5:12.73 to place 70th. Christian was also a member of the FAST 400 Free Relay that finished in 17th place and achieved a Sectional Championship Qualifying time.

Will Newman swims with the Tucson Jewish Community Center (TJCC) swim team and has attended Senior State in previous years. This year he had a grueling schedule, swimming the maximum allowed 6 individual events. Newman swam the 1000 Freestyle (30th place), 200 Breaststroke (51st place), 100 Butterfly (26th place), 500 Free (64th place), 400 IM (32nd place) and the 200 Backstroke (13th place). Additionally, Newman swam on TJCC Relays – the

200 Free Relay (13th place), the 200 Medley Relay (9th place), the 400 Free Relay (28th place) and the 800 Free Relay

(15th). Newman had already qualified for Sectionals in the 100 and 200 Butterfly

# Miner track teams finish first, second at season opening meet

The San Manuel girls' and boys' track teams finished first and second, respectively, in their season-opening meet. The Miners hosted six teams, all of them competing in their first multi-meet of the year.

"(We) looked good overall for their first outing of the season," San Manuel head coach Maria Lopez said in an email. "The newbie tracksters competing shook off nerves and performed well."

The Miners girls' team took first ahead of Santa Cruz and Globe, which tied for second.

Even though three USA Swimming Clubs are

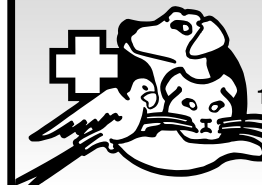

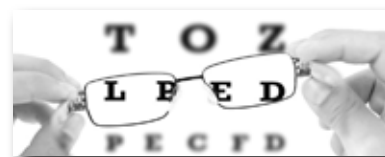

The District 1 Supervisor said that containers will be located at Mammoth Public Works Yard, 104 North Main Street, the Waste Management Landfill, 8195 North Highway 77, in Dudleyville and the Oracle

Transfer Station on American Avenue in Oracle. The County is currently working on a recycle site in Kearny, a location should be named soon.

“Many of you noticed that back in January, Right-A-Way disposal removed the recycle bins located throughout the area,” Supervisor Rios stated. “This was due to misuse - household trash was being

dumped into the bins. After working alongside with our Public Works Department it has been determined that the county has limited funds to provide recycle pick-up to local citizens.”

You may dispose your recyclables during hours of operation at the following locations: Mammoth Public Works Yard Monday through Friday 7:30 AM to 3:00 PM, the Dudleyville Landfill is open Monday through Friday 8:00 AM to 3:30 PM and the Oracle Transfer Station Monday through Friday 8:00 AM to 3:00 PM.

“People are recycling more than ever and we are glad citizens are doing their part to reduce the amount of trash being disposed in our local landfills,” Supervisor Rios said. “I must emphasize to PLEASE follow guidelines when recycling and only dispose of recyclables in these dumpsters.”

Items that can be recycled include primarily glass bottles and jars, steel and tin cans; cardboard; paper products; newspaper; plastic containers; aluminum cans and foil.
