Upon approval of the landfill closure plan, Waste Management will construct a transfer station facility prior to the termination date. More information will be available post-approval of the April deadline. What does this mean? The public will still have their regular

residential services and have access to utilize their FREE dump vouchers for the Transfer Station.

In an effort to provide more services, we in Pinal County will be increasing the issuance of free vouchers from 3 to 6 per calendar year in the near future. As additional information is confirmed, my office will work on keeping the public informed.



COVID-19 VIRUS UPDATE



To our Valued Members:

In response to the recent events and concerns regarding COVID-19 (coronavirus), we are taking steps to help minimize the spread of any and all viruses and illnesses. Arizona Governor Doug Ducey issued an executive order Monday that defines which businesses and operations are considered essential amid the state's COVID-19 outbreak. CVRMC steps up precautions in pandemic response

Cobre Valley Regional Medical Center (CVRMC) has moved to the next level of precaution in its "COVID-19 Response Plan."

There are currently two entry points at the hospital, the Main Entrance and the Emergency Entrance. The following is the new protocol for everyone entering the hospital facility or CVRMC clinics:

- All Patients, Visitors, and Employees will be screened (temperature tested) at all entry points – hospital and clinics.
- If it is determined that a Visitor or Employee has a temperature, they will not be allowed to enter the hospital or clinic
- If it is determined that a Patient has a temperature, the patient will be provided the correct PPE upon entry. If you are a patient coming in for services, please be proactive and cover your mouth and nose before you reach the entrance.
- At all entry points hospital or clinic, Visitors and Patients will be given a "Screening Form" that will be checked off by Entry Staff. All Visitors and Patients MUST have this "Screening Form" visible to staff at the hospital.
- If you are in the hospital or clinic without a "Screening Form," you will be asked to go through the screen process at the entry points or you may choose to leave.
- Patients are currently allowed one Visitor at a time. The

Visitor will be issued a "Pass" with the patient's room number at the Main Entrance of the hospital during business hours, 6:30AM – 8:00PM. After 8:00PM, the pass can be picked up at the Emergency Entrance. The Visitor must return the "Pass" at the entry point that they came in through. This will allow the next Visitor to pick up the "Pass."

Key members of CVRMC continue to have several daily meetings regarding COVID-19. Daily discussion includes supplies, equipment, bed count and personal protective equipment (PPE). Reports are given daily regarding current supplies, equipment, staffing, and PPE availability.

CVRMC has four licensed ICU beds, but in emergent situations, the hospital is equipped to surge up to 14 ICU beds and 36 in-patient beds for a total of 50 beds. Information on bed capacity is reported on a daily basis, the status of current patients, and plans are in constant evaluation should a surge occur.

PPE protects healthcare workers as well as patients and visitors from viral and bacterial infections that can enter through the skin, eyes, nose and mouth. PPE includes facemasks, gloves, face shields, gowns and goggles, to name a few items.

Currently, all healthcare facilities, including emergency responders, are in need of PPE. Not only facemasks, but gowns, gloves and goggles, too. CVRMC is tracking the inventory and utilization rates of these items on a daily basis and is in constant contact with suppliers for availability.

The Center for Disease Control and Prevention (CDC) is

Arizonans ordered to stay at home, stay healthy and connected through April 30

On Monday, Governor Doug Ducey issued a Stay at Home order in an effort to add another level of social distancing. This order came after a letter signed by several Mayors of Arizona asked the Governor to issue the Stay at Home order.

Town of Superior Mayor Mila Besich joined Mayor Ana Tovar of Tolleson, Mayor Coral Evans of Flagstaff, Mayor Ginny Dickey of Fountain Hills, Mayor Valorie Molina of Guadalupe, Mayor Mark Mitchell of Tempe, Mayor Kate Gallego of Phoenix, Mayor Regina Romero of Tucson, Mayor Thomas McCauley of Winslow, Mayor Alexis Hermosillo of El Mirage and Mayor Sandra Moriarty of Sedona in preparing and signing the letter. The Governor issued his Executive Order about 90 minutes after the letter from the Mayors made it into the news. In a written statement to local media outlets, Mayor Besich stated, "Our rural communities, do not have enough EMS or healthcare resources to manage the realities of the COVID-19 virus. We ask the Governor to

act with urgency to protect all Arizonans."

The Stay at Home order starts at 5 p.m. on Tuesday, March 31, 2020 and will remain in effect until April 30. The order does allow essential workers to get to and from work or to volunteer and allows people to tend to errands such as picking up prescriptions, grocery shopping or doing any other task or errand at an "essential business". Bars, gyms and movie theaters are still closed across the state and restaurants may continue their operations with take out and delivery orders. The order also encourages Arizonans to get out and exercise and recreate in the outdoors, such as biking, hiking, walking or enjoying local parks. Another focus added into this order included a reminder and encouragement for everyone to stay connected digitally, via their phones and the internet.

The Governor's orders did not change any of the essential businesses that are allowed to be open during the "Stay at Home" order. This new order continues to recommend social distancing and also limits groups from gathering of more than 10 people. One of the big questions being asked of the Governor's office, is why are beauty services such as salons, barbers, nail salons and spas considered essential along with golf courses, pawn shops, and gun stores. The order also does not require employers to provide an employment letter proving that a person is employed by an essential business. In neighboring, California, residents are not allowed to leave their city or county boundaries and they must also have a letter proving that they are an essential

mplovee.

Local leaders have been growing concerned by the high use of the public lands in the area, which are now becoming high use areas for camping and outdoor living for those wanting to avoid living in the more urban areas during this time of social distancing. The Tonto National Forest closed many congregate camping locations including the Picket Post Trailhead on the Arizona National Scenic trail but did not close the Oak Flat Campgrounds. Picnic areas at Roosevelt lake and areas in the Pinal Mountains and Sierra Ancha mountains have been closed.

School closures affect JTED programs

Arizona's public schools have all had to adjust for the realities of schools closures due to the COVID-19 Virus Pandemic. The precautionary methods to help flatten the curve of the outbreak in Arizona has called for social distancing and the realities of implementing the strategy has been difficult for all schools but it proves even more difficult for the Joint Technical Education programs such as the Cobre Valley Institute of Technology and the Pima Joint Technical Education District, since the courses taught at those schools require some on the job training and clinical testing.

Both schools have deployed an online program. Students can access their coursework and engage with their teachers.

The challenge comes when students need to complete the actual job training. For nursing students in these programs, the ability to complete the job training components are non-existent at this time due to the COVID-19 virus, and it is unclear how the State licensing department will handle the clinical aspect. With the high demand for health care workers, these students are the future

workforce and may be needed much sooner rather than later. In a normal course, the students in the Certified Nursing Assistant program would do their on the job training at a nursing home or at a local hospital, but that part of their program is not available right now due to the virus.

This policy and technical lessons for other industry trades such as cosmetology and welding are also affected by the school shut down and social distancing procedures. Cosmetology students are not able to practice their technique or work hours at the school salon during this crisis. Interim Superintendent Mike O'Neal explained that CVIT is waiting on clarity from the state.

"If we need to have our students come back next year to complete the clinical and on the job training, we will do that at no extra cost," O'Neal said.

School districts across the state are waiting on policy revisions and graduation requirements now that the COVID-19 virus has affected the rest of the school year. Schools should be receiving more official word from the State of Arizona during this week.





the authority in guiding healthcare facilities in the best practices for controlling and preventing the spread of disease. The appropriate use of PPE is a major part of the regulations put forth by the CDC and outlines "Strategies for Optimizing the Use of Facemasks."

These strategies are broken down into Conventional, Contingency and Crisis capacities. As hospitals across the nation are experiencing a crisis in their PPE, a last resort is to use homemade masks, even though the CDC and CVRMC do not acknowledge it as confirmed, tested PPE. Many hospitals are referring to these masks as "comfort masks" and will be used in non-clinical areas of the hospital.

CVRMC has requested homemade masks from members of our community in preparation for a "Crisis Capacity" situation. Lee Ann Powers took the lead on this effort and has mobilized many amazing community members to cut and sew the "Olson Mask," a pattern

that is being used by many other hospital facilities who are in short supply. CVRMC leaders in Infection Control and Nursing will determine the best utilization and distribution of these homemade masks.

Other efforts include the making of several "face shields" through the use of a 3-D printer by Copper Rim, third-grade teacher, Jeff Battese. Mr. Battese has made several for the San Carlos Apache Healthcare Corporation as well as CVRMC. In being proactive, CVRMC is also reaching out to mining companies, construction companies, and other organizations that may have excess PPE -N95 masks, surgical masks, gowns, goggles, etc.

Again, the surge capacity of the hospital is 50 beds (14 ICU). If this disease should spread quickly, the number of needed beds may surpass the number of beds available. This is why social distancing, limiting personal contact, covering your cough and sneeze, washing your hands, and staying at home

unless it is an emergent situation are critical actions. These behaviors help to slow down the spread of the disease to people at high risk who may need hospitalization. Patients who are hospitalized for other medical conditions need to be considered in this bed count, also.

What is Hyperbaric Wound Therapy?

Hyperbaric oxygen therapy involves breathing pure oxygen in a pressurized room or tube. Hyperbaric oxygen therapy is a well-established treatment for decompression sickness, a hazard of scuba diving. Other conditions treated with hyperbaric oxygen therapy include serious infections, bubbles of air in your blood vessels, and wounds that won't heal.



In a hyperbaric oxygen therapy chamber, the air pressure is increased to three times higher than normal air pressure. Under these conditions, your lungs can gather more oxygen than would be possible breathing pure oxygen at normal air pressure.

Your blood carries this oxygen throughout your body. This helps fight bacteria and stimulate the

release of substances called growth factors and stem cells, which promote healing.

Conditions for Treatment

Hyperbaric oxygen therapy is used to treat several medical conditions. And medical institutions use it in different ways. Your doctor may suggest hyperbaric oxygen therapy if you have one of the following conditions:

- Anemia, severe
- Brain abscess
- Bubbles of air in your blood vessels (arterial gas embolism)
- Burn
- Decompression sickness
- Carbon monoxide poisoning
- Crushing injury
- Deafness, sudden
- Gangrene
- Infection of skin or bone that causes tissue death
- Non-healing wounds, such as a diabetic foot ulcer
- Radiation injury
- Vascular wounds
- Skin graft or skin flap at risk of tissue death
- Wounds that won't heal

During Hyperbaric Therapy

Hyperbaric oxygen therapy typically is performed as an outpatient procedure and doesn't require hospitalization. If you're already hospitalized and require hyperbaric oxygen therapy, you'll remain in the hospital for therapy. During hyperbaric oxygen therapy, the air pressure in the room is about two to three times normal air pressure. The increased air pressure will create a temporary feeling of fullness in your ears — similar to what you might feel in an airplane or at a high elevation. You can relieve

that feeling by yawning or swallowing. For most conditions, therapy lasts approximately two hours. Members of our health care team will monitor you and the therapy unit throughout your treatment.

After Hyperbaric Therapy

You may feel somewhat tired or hungry following your treatment. This doesn't limit normal activities.
