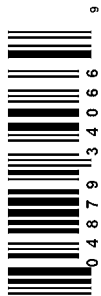

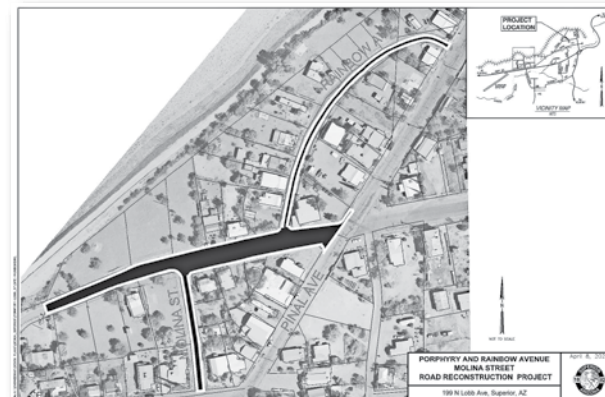


Town of Superior to begin much-needed roadwork in Porphyry area

During the week of May 10, work will begin on the Porphyry, Molina, and Rainbow area to the west of Pinal Ave.

This area was in very poor condition, and utility work has exacerbated the problem, so the area will require complete removal and replacement of the road surface. Access to the area may be limited to local traffic intermittently, and residents may be asked to move their vehicles to allow for construction activities.

This is Phase 1 of the project to repair Porphyry. The next phase, resurfacing the rest of the street, will commence when the Pinal Regional Transportation Authority funding becomes available. This remains tied up in court, but it is hoped that it will become available early next fiscal year, and that the work can begin shortly thereafter.

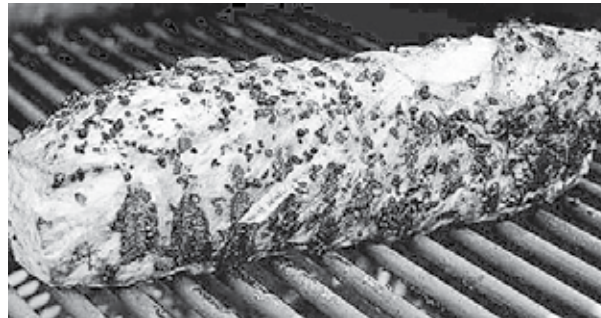
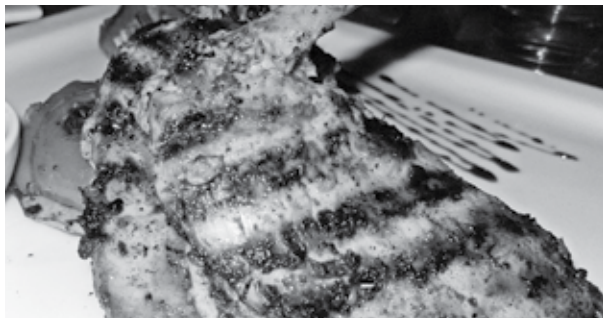

As locals, it is often easy to overlook our local hotel/motel business in our community, because we often do not think of needing to rent a hotel or motel room.

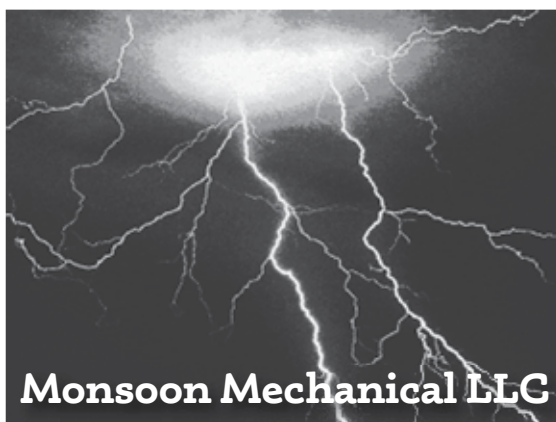

Lady Panthers suffer first losses of the season

The Superior softball team had some tough games last week, starting their week off by facing San Manuel on April 13. This game marked the girl's first loss this season, with a final score of 1-12.

"We struggled on the mound, as well as on the plate, but I'm proud of our young ladies for not giving up and learning what it takes to win as a team," said coach Alfonso Lopez.

On Friday, April 16, the girls played a close game against Chandler Prep. Starting the second inning tied 1-1, Chandler Prep pulled forward, holding 10 points by the end of the third inning. The Panthers started the sixth inning with only three points, but finished it with seven points. By the end of the seventh inning the Panthers were able to score two more times, closing the point difference, but they were unable to walk away victorious – final score 9-10.

"We've had injuries, and with a small squad," stated coach Lopez "players are put into positions they are not accustomed to, but they stepped up when asked, and they gave us a hundred percent."

The baseball team continued its hot streak with two more wins last week. Their first win came against San Manuel, where Adam Navarrete pitched the complete game, only allowing one hit to get past him.

"We played a good game overall," coach Manuel Ortega commented, "[We were] able to get everyone in the game which is the best part." The final score was 15-0.

On Friday, April 16, the boys played Tempe Prep for the second time.

"Last time we played them we lost 3-0. We knew it was going to be a huge game, and a must win," stated coach Ortega.

Matthew Cruz pitched the whole seven innings, giving up 1 ER, 5 hits, and 6 KS. The Panthers were able to avenge themselves, and secure the victory against Tempe Prep, with a 4-3 final score.

Building Permit Required 1. It shall be unlawful to erect, construct, reconstruct, alter or use any structure or building without first obtaining a building permit from the Town of Superior; except that no building/use permit shall be required for any repairs or improvements of a value not exceeding \$1,500 dollars (market value labor and materials or actual receipts for cost of materials can be provided) except that those items listed in this section below are completely exempted from permit requirements for single family residential dwellings and manufactured/mobile homes. 2. For non-residential uses a permit is required regardless of the dollar value of the improvement when there are applicable building code requirements. 3. For the purpose of determining the value of any such repair, alterations, or improvements, the normal retail value of materials and labor performed shall be used. Even though no permit is required for repairs or improvements having a certain value or listed below, such repairs, improvements, or alterations shall comply with all other provisions of IRC2018 4. Re-establishment of a discontinued non-residential use shall not require a permit for the same use, provided that the discontinued use was established through the permitting process in place at the time of establishment, and that no new construction is proposed. B. Work Exempt from permit for Single Family Residential Dwelling and Manufactured/Mobile Home Only. 1. Re-roofing (when no structural changes are proposed or any reinforcement is required to add heavier roofing materials), re-siding or replacement of exterior trim. 2. Replacing or adding gutters or downspouts. 3. Replacing or adding soffit, gable, or roof ventilation. 4. Replacing existing windows or doors with no structural changes. 5.

Decks less than 30-inches in height above the lowest grade within 5-feet of deck edge. 6. Replacing like for like or repairing existing plumbing fixtures such as toilet, tub, sink, garbage disposal, water heater, or faucets. 7. Replacing existing appliances or internal light fixtures. 8. Replacing like for like or repairing existing furnace, air-conditioner, cooler, heat pump, or heater. 9. General landscaping including lawn sprinkler systems, subject to water conservation requirements, and retaining walls up to 4-feet in height. 10. If any of the following applies as permit is required: a) Located on a corner lot and greater than 3 feet in height; b) Located within a designated FEMA Flood Hazard Area; c) Located within a designated wash. 15. Painting, interior or exterior, and wallpapering. 16. Concrete walkways, not in Town right-of-way, and patio slabs. 17. Replacing cabinets or countertops. 18. Window awnings supported by an exterior wall which do not project more than 54-inches. 19. Swings and other playground equipment accessory to a single family dwelling. 20. Water Tanks supported directly on grade if the capacity does not exceed 5,000-gallons and the ratio of height to diameter or width does not exceed 2:1. 21. One-story detached accessory structures provided the floor area does not exceed 200-square feet and has no utilities. Floodplain regulations may apply. 22. Shade cloth structures constructed for nursery or agricultural purposes, not including service systems. 23. Temporary motion picture, television and theater stage sets and scenery. 24. Oil derricks. 25. Gas: a) Portable heating appliance b) Replacement of any minor part that does not alter approval of equipment or make such equipment unsafe. c) Portable fuel-cell appliances that area not connected to a fixed piping system and are not interconnected to a

power grid. 27.
