

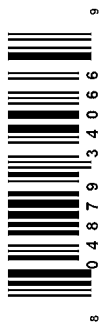

# Panthers split games in double

It was a busy week of baseball for the boys of Superior, who began last week with a double-header at home against Mogollon.

The first game began with Mogollon scoring 6 runs in the first two innings, while the Panthers weren't able to score their first run until the fourth inning. The Panthers began to score more runs towards the end of the game, but weren't able to close the score gap, falling short by 2 runs. The final score of the first game was 6-8.

During the second game, the boys came out swinging from the first inning, scoring 2 runs, keeping a 2-2 score until the third inning. In the third inning, Mogollon pulled forward, scoring 1 run, then scoring another run during the fourth inning, setting the score to 2-4. After a fifth inning that saw no runs for either team, the Panthers started the sixth inning, playing a strong defense, and keeping Mogollon from scoring any runs. When it was time for the boys to take the plate and bat, they were able to score 5 runs past the Mustangs, putting the Panthers into the lead. The boys played another tough inning of defense for the seventh, only letting one run past them,

ending the game with the win, and a final score of 7-5.

The boys ended their week with another home game, this time taking on Coolidge. Carrying the same energy from their previous game, the Panthers came out swinging hard during the first inning, scoring an impressive 8 runs. The boys kept Coolidge at a distance, not allowing them to

# Superior Community Working Group to meet May 4

SUPERIOR, AZ, April 24, 2023 —The next Community Working Group (CWG) meeting for the Resolution Copper

mining project, located near Superior, Arizona, will be Thursday, May 4, 2023.

The group will meet off-site to tour the new Superior Multigenerational Center. The center, located on the site of the historic former Superior High School, will house offices for the town government, the library, and the Superior Enterprise Center (SEC).

The multigenerational center will also bring a gym, commercial kitchen, and other amenities to meet Superior's growing needs. The SEC has a mission to catalyze and diversify Superior's economy through workforce training and business services, with a focus on helping entrepreneurs and small businesses. It is the

result of a collaboration between the non-profit Rebuild Superior, Inc., the town government, and Resolution Copper, a nearby proposed mine.

The CWG focuses on potential environmental impact issues, science and policy, economic development and growth, and the pros and cons of the proposed development of the Resolution Copper mine, which could become one of the world's largest copper mining ventures. Members include residents and stakeholders from the Town of Superior, Queen Valley, and nearby communities. Topics include environmental stewardship, transportation, education, health, safety, natural resource issues, air quality, community investments,

recreational changes and other related subjects.

About Resolution Copper The Resolution Copper project is a proposed underground mine 60 miles east of Phoenix, Arizona, near the town of Superior. The project is a joint venture owned by Rio Tinto (55%) and BHP (45%). The ore deposit lies nearly 7,000 feet below the earth's surface. It represents one of the most significant untapped copper deposits today. The mine has the potential to supply nearly 25% of US copper demand.

FAIR HOUSING RESOLUTION A  
RESOLUTION OF THE MAYOR AND  
TOWN COUNCIL OF THE TOWN OF  
SUPERIOR, ARIZONA, ADOPTING  
A FAIR HOUSING POLICY, MAKING  
KNOWN ITS COMMITMENT TO THE  
PRINCIPLE OF FAIR HOUSING, AND  
DESCRIBING ACTIONS IT SHALL  
UNDERTAKE TO AFFIRMATIVELY  
FURTHER FAIR HOUSING. WHEREAS,  
the Housing and Community  
Development Act of 1974 as amended,  
requires that all applicants for Community  
Development Block Grant funds certify  
that they shall affirmatively further fair  
housing; and WHEREAS, the Civil Rights  
Act of 1968 (commonly known as the  
Federal Fair Housing Act) and the Fair  
Housing Amendments Act of 1988 declare  
a national policy to prohibit discrimination  
in the sale, rental, leasing and financing  
of housing or land to be used for the  
construction of housing or in the provision  
of brokerage services, on the basis of  
race, color, religion, sex, disability, familial  
status or national origin; and WHEREAS,  
fairness is the foundation of the American  
system and reflects traditional American  
values; and WHEREAS, discriminatory  
housing practices undermine the strength  
and vitality of America and its people:  
NOW THEREFORE, BE IT RESOLVED  
THAT the Mayor and Town Council of  
the Town of Superior, hereby wish all  
persons living, working, doing business  
in or traveling through this Town know:  
That the discrimination in the sale,  
rental, leasing and financing of housing  
or land to be used for construction of  
housing, or in the provision of brokerage  
services on the basis of race, color,  
religion, sex, handicap, familial status  
or national origin is prohibited by Title  
VIII of the Fair Housing Act Amendment  
of 1988; and That it is the policy of the  
Town of Superior, Arizona, to implement  
programs, within the constraints of its  
resources, to ensure equal opportunity  
in housing for all persons regardless

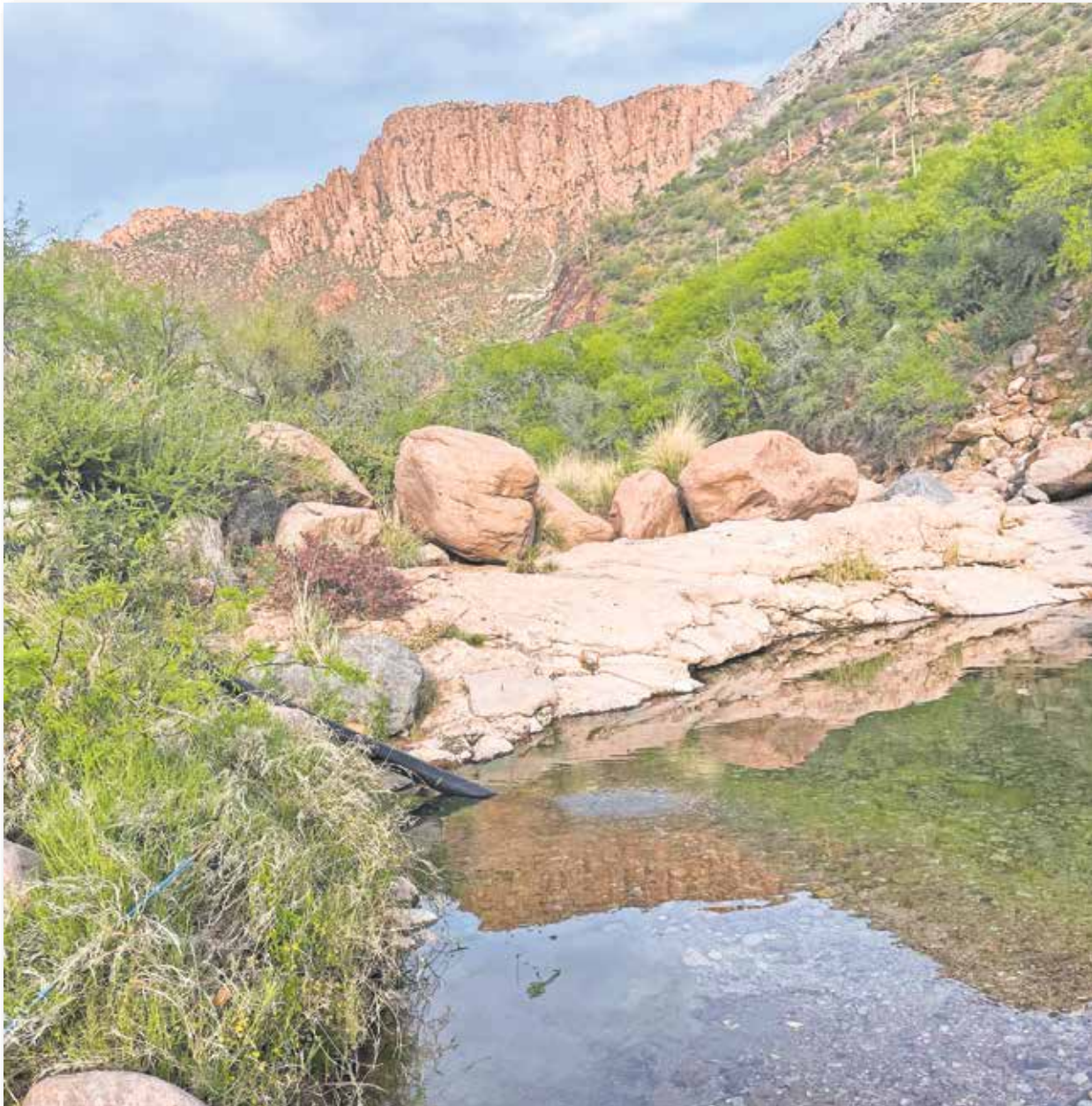

## Queen Creek discharge 'flow' test releases water in the Creek until the end of April 2023

The Town of Superior is working with Arizona Water Company and additional stakeholders to conduct a water discharge ("flow") test in the Queen Creek during the month of April 2023 to better understand how water moves through the stream channel. For a limited time, the town will release safe, highly treated water into the stream channel just north of the bridge where South Magma Avenue crosses Queen Creek.

"We hope to improve flow through the creek, and studying the creek is the best way to achieve that goal," said Superior Town Manager Todd Pryor in a press release to the Superior Sun. "The flow test will help us evaluate how the creek responds to augmented flows."

Chlorine is removed from the water to make it safe for plants, animals, and the ecosystem, Pryor explained. The water is being released to the creek at a flow rate of 65 gallons per minute (GPM), providing sound scientific data to inform long-term restoration efforts.

This work is part of a multi-year plan to rehabilitate Queen Creek. The Town has secured a grant to create a pipeline from a nearby abandoned drinking water collection system and pipe it to a discharge point upstream of Magma Avenue.

"We also plan to complete the pipeline project started in 2001 by previous Town leaders. It will bring water from the wastewater treatment plant to the US 60 park, where it will supply water for riparian area restoration projects. We are pleased to be able to finish the great work envisioned by our predecessors," Pryor added.

"We have also received a grant to clean the invasive woody species in Queen Creek from above the Magma Bridge to the US 60 park. This will benefit the creek's health, as well as improve fire safety by removing overgrown fuels," he said.
