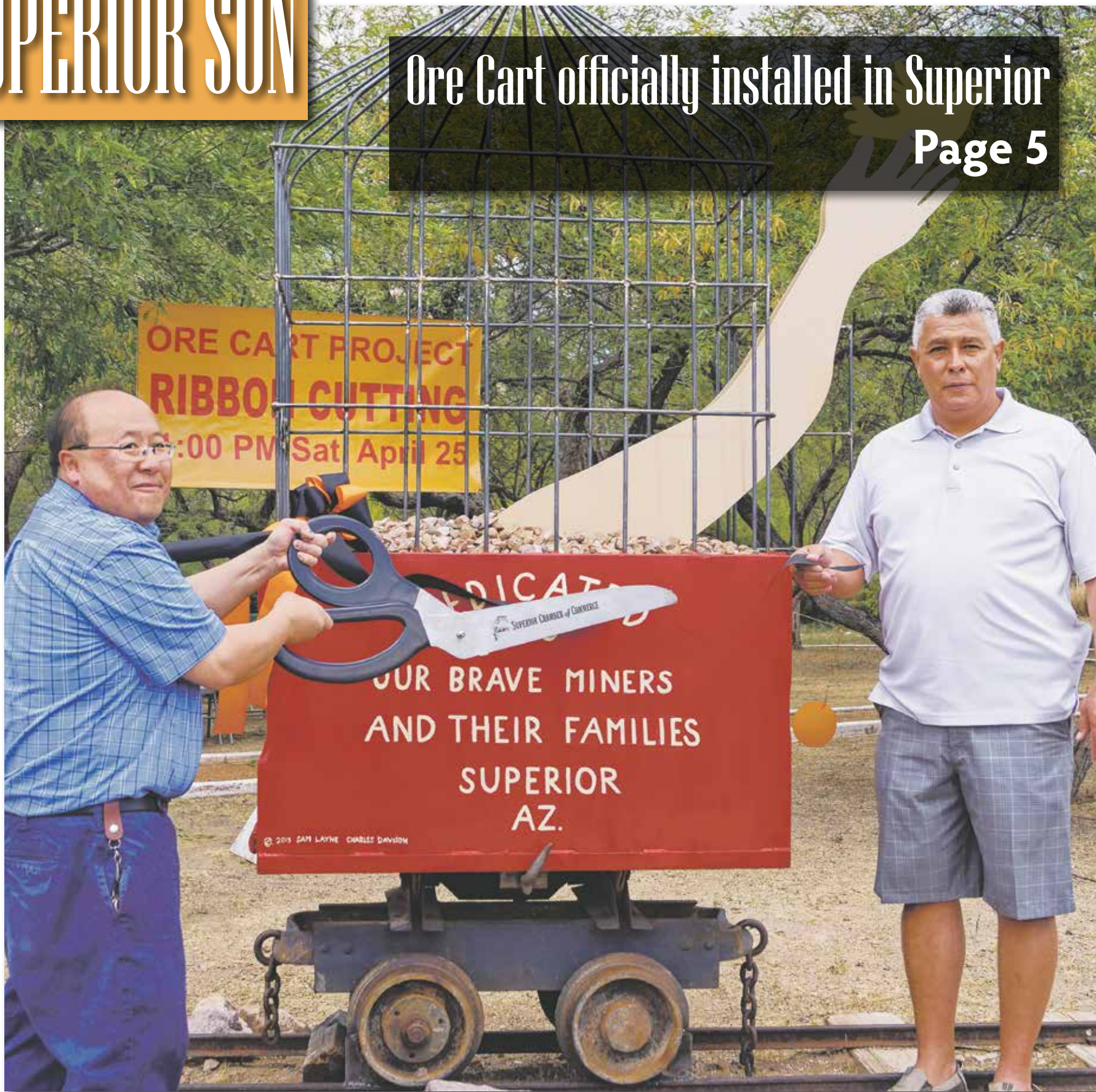
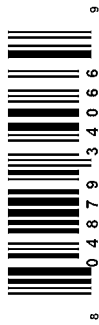

# CAC budget presented to governing board

Pinal County, AZ – Central Arizona College presented its proposed budget for the 2015-2016 fiscal year during the April 21, 2015 Pinal County Community College District Governing Board meeting.

Governing Board members were shown a breakdown of Pinal County's current sources of revenue. CAC receives only 14% of local tax revenues. This means that for every \$1 of a taxpayer's tax bill, only 14 cents is allocated to support the county's community college district. School districts receive the largest portion at 41% and

the county government receives 25%.

"Since 2008, state funding has been reduced by 65%. This year's threat of removing all funding is a sign of the future. Rather than funding community colleges, the state is moving toward a system that is entirely locally controlled," stated Chris Wodka, CAC Chief Financial Officer. "The College needs a sustainable funding source to plan for the future."

The Primary Tax Rates for fiscal year 1994-1995 through fiscal year 2014-2015 were shared during the meeting. In years when the College did not need to levy the full amount, it did not. However, over the last four years CAC has made cuts and deferred maintenance of at least \$43 million at the Signal Peak Campus alone where major remodeling and repairs are needed for science labs, residence

halls, the gym and library. Since 2012 the College has made significant reductions including but not limited to: closing of the Coolidge and SaddleBrooke centers; shifting to a four-day work week to save on utilities and part time wages; staffing limitations at the new campuses, reducing the number of vice presidents; decreasing employee benefits; closing the Signal Peak Campus Pool; eliminating the Police Training Academy; and reducing scholarships.

"This is not a sustainable trajectory. We are left with two options: we must borrow or raise revenue," explained Wodka. "While the college could borrow money, the taxpayers would pay interest and the college would lose operating dollars."

CAC is proposing to create a "pay-as-you-go" program that would allow the college to refurbish SPC

in phases starting with the science labs.

"With an increase in Science, Technology, Engineering and Math (STEM) programming it is critical for the college to improve our facilities to provide a quality education for students that will prepare them for tomorrow's workforce," stated Doris Helmich, President.

CAC's administration is proposing an increased tax levy that would sustain the college and invest in Pinal County's future.

With the proposed tax levy, the increased cost to a property owner whose home is assessed at \$100,000 would be \$86.04 per year. This equates to \$7.17 per month or \$1.65 per week. Even with this proposed increase, CAC's tax rate would be below many of the local school districts who do not serve

First came Mammoth's Ore Cart, "Skeleton Crew Graveyard Shift." It was installed at the Miners Memorial Park on Hwy. 77 in Mammoth.

Many years later the second Ore Cart in the Copper Corridor's Ore Cart Trail was installed in Winkelman at the junction of Hwy. 77 and Hwy. 177. This one, called "A Penny For Your Thoughts," was installed in time for Winkelman's Centennial Celebration.

In January, Oracle's "Sailcart" which celebrates the history of Oracle's name, shared with a clipper ship of the same name, was installed in front of the Post Office.

This past weekend, Superior became the newest realized

point on the Ore Cart Trail map as its Cart, designed by artists Sam Lane and Chuck Davison, was installed at the Caboose Park and Superior History Trail.

Many turned out to witness the occasion hosted by the Superior Historical Society/Bob Jones Museum and the Copper Corridor Economic Development Coalition and is sponsored by Resolution Copper Company; Evelyn Cooksley in memory of Bud Cooksley; and an anonymous donor from the Legends of Superior Trail (LOST).

## Lopez, Lady Panthers shutdown top-ranked Lady Cats

One week after defeating two-time state champion and fourth-ranked San Manuel, junior pitcher Ivie Lopez and her Superior teammates knocked off the top-ranked Ray last Friday, 6 – 2. The loss was the Lady Cats' first in sectional play and ended their ten-game winning streak. The win was the sixth-ranked Lady Panthers' fourth-straight.

"Absolutely," Panthers' head coach Martin Navarrette answered when asked if his team is peaking at the right time. "It's the best time to be peaking – going into the playoffs – and I expect big things going in."

Lopez held a Lady Cats' team, which entered the game hitting .421 as a team and averaging almost 10 runs per game, to only one earned run on just six hits. She struck out 10 while allowing one walk. She was dominant.

"Ivie pitched excellent," Navarrette said. "She hit her spots, pitched inside, and took the bat out of their hands."

Ray starting pitcher Stormee Galka was equally effective against a potent Superior lineup, holding them to only two runs during the game's first five innings. Galka helped herself on the mound, turning a couple of double-plays to get out of jams.

Lady Panthers' junior Gabby Salcido went deep in the sixth, giving the Lady Panthers' a 3 – 1 lead before the flood gates opened with three Ray errors leading to three more Superior runs to make the score 6 – 1 heading into the final inning.

Hunter Flanagan, who along with Cierra Navarrette, was playing in her final home game on Senior Day. She went out in style, going 3-for-4 with two RBI. Navarrette went 1-for-4.

"They've been starters for four years," Coach Navarrette said about his two seniors, one of them his daughter. "They're team leaders and mentors in practice to the other girls. They're competitors."

Both players spoke briefly after the game about their varsity experience.

"It's awesome, especially with the teams we've had during my four years," Navarrette said. "It's said to be leaving, but I'm glad won our last game on Senior Day."

Said Flanagan, "This is probably our best team since we've been here. I'm really comfortable leaving these girls because they're such a great team and I've had so much fun."

Last Friday's win puts the Lady Panthers' right in the middle of the state title conversation. They have to be considered one of only a handful of teams – including San Manuel and Ray – that are legitimate

## Steve Estatico named superintendent

In a special open public meeting on Friday afternoon the governing board at Superior Unified School District voted unanimously to enter into negotiations with Steve Estatico to become the new school superintendent for the district.

Estatico has been the principal at High Desert Middle school in Globe. Originally from Pennsylvania, Estatico began his career in education in Superior where he served in the position of teacher, athletic director and dean of students.

Board President Cindy Benson will lead the negotiations and the board is expected to approve the employment contract at the regularly scheduled board meeting on May, 6. The board interviewed four candidates for the position during a day long executive session. The Arizona School Board Association assisted the district with the selection process.

The hiring process began in March following the board accepting the resignation of Patrick O'Donnell who has been with the district since 2013. Upon approval of the contract, Estatico will begin his position as superintendent on July 1, 2015.

After watching his team benefit from some shoddy defense by the Lady Cats, Coach Navarrette knows his own team's defense is the key to winning the title.

"If we eliminate the errors I don't think there is any team that can beat us," he said. "If keeping hitting the ball and pitching the way we are (then) we're going to be tough to beat."

Five of the nine teams in Section VI are ranked in the top 15, according to the AIA rankings. So the Lady Panthers are battle tested after having played in the toughest section with one of the most difficult schedules in the state, regardless of division.

Can they parlay their regular season success into a state championship?

Only time will tell but it sure looks like they're playing at that level, especially recently.

the entire county as CAC does.

"Taxpayer support to the college is an investment in the economic development of Pinal County. An educated workforce attracts industry to an area thus sharing the tax base and lowering taxes," stated Helmich.

An Economic Modeling Study completed in December 2014 shows that CAC and its students add \$212.7 million in income to Pinal County each year. For every \$1.00 spent, taxpayers see a return of \$1.30 in the form of higher tax receipts and avoided social costs. State and local governments see an annual rate of return of \$6.90 and students gain \$6.00 in lifetime income.
