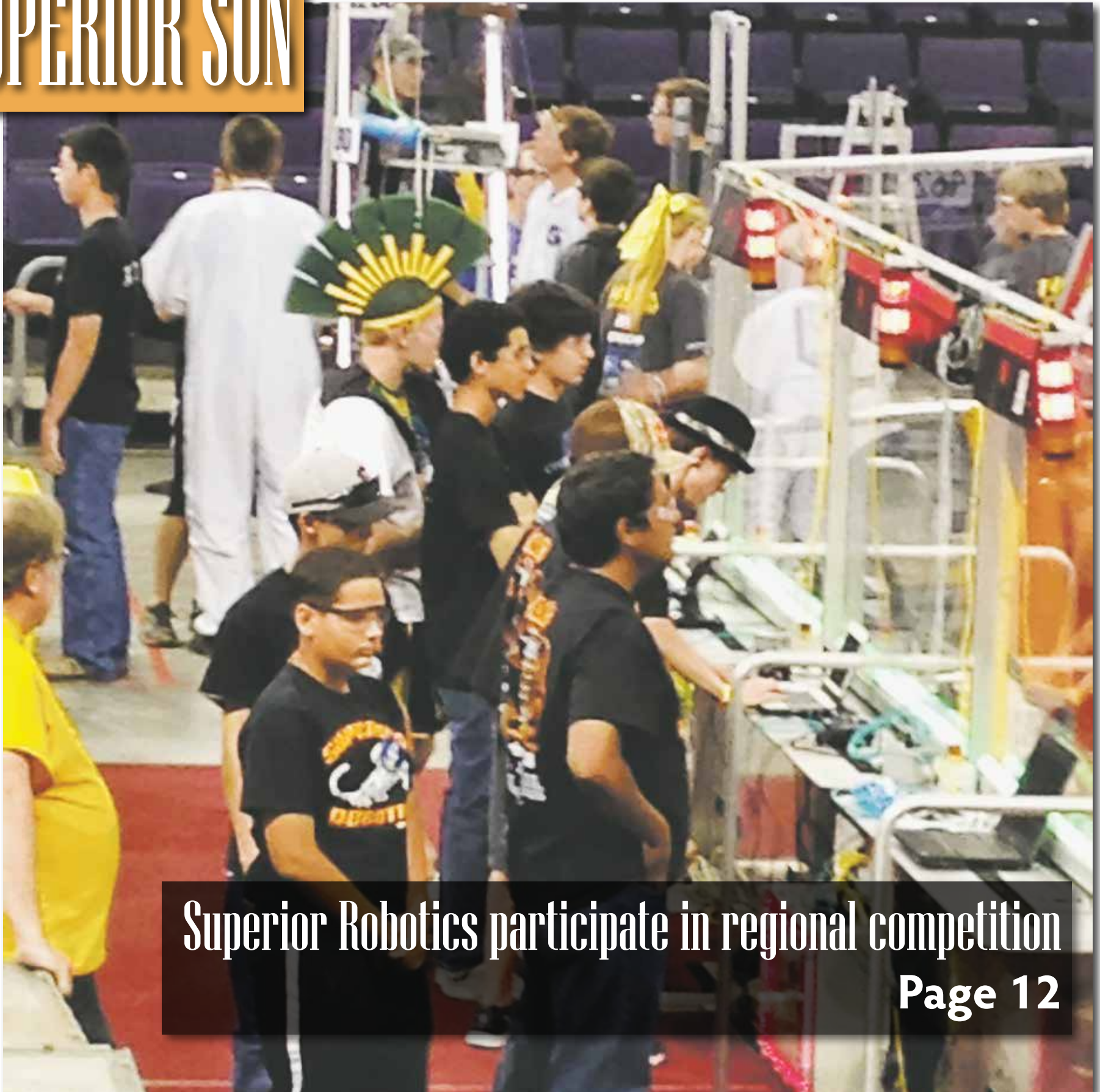
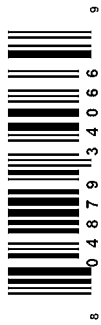

# Miami prepares for final Boomtown Spree

The last and final farewell Boomtown Spree will kick off Saturday, April 18, 2015 on Sullivan Street in Miami as a one day event beginning at 9 a.m. and ending at dusk. Featured at 10 a.m., a parade will begin at the Bullion Plaza Museum and head East down Sullivan ending at the old YMCA building. Parade applications can be picked up at the chamber and RAM Specialists located at 1165 W. Live Oak St., Miami. Also featured will be all day musical entertainment, food and other vendors and a car show. There may be a mining exhibition but no contest. The theme for the final one day event is Muck & Mayhem. T-shirts from past events will be on sale at bargain prices and a t-shirt designed by an MHS art student named Tucker will be the final T-shirt available. T-shirt orders for this year will be taken as

only a limited number will be available at regular price.

The Boom town Spree began May 11, 12 and 13, 1939 by a committee of prominent businessmen to bring back memories of Miami's heyday of the mining related industry. All of the businesses in Miami participated with store fronts decorated with mining tools and clothing. The businessmen started a beard competition early each year so their beards would be in full show by Spring.

The event waned and eventually was stopped. Then in 1993 it was brought back again by interested Miami businessmen. It flourished for many years but the last three day event was held in 2012 for the second year at the site of the old Plaza Ballroom located in front of the Bullion Plaza Cultural Center and Museum. Since then

a stalwart few remaining members of the association have attempted to bring back the three day event. Lack of volunteers and enthusiasm has finally taken its toll, hence farewell to Boomtown.

Some of the premier events in the past have been the parade, the mucking and drilling competition, children's mining events, stair climb, Copper Crawl 5 K, 13K and the bed races. Miami was on the circuit for mining and drilling competition and it eventually became the state

championship which will now be offered to the town of Superior.

Unfortunately the Town of Miami ceased its co-sponsorship after two of its major organizers were employed elsewhere. RAM Specialist and its employees, along with several other businesses in the area tried to keep it afloat, but the decline in funds and organizers has finally reached a point where only a one day event will be possible this year and then it will fade-out once again.

# Flood Control to begin survey

Pinal County Flood Control, in cooperation with the Superior Police Department, will begin conducting a survey of Superior to identify water flow patterns in town. The process will require both aerial and ground surveys of the existing washes and drainage areas. The surveyor will be placing large markers at specific locations in and around town. These markers are used in the aerial survey to pinpoint specific locations so that the maps produced can be verified for scale and accuracy. This Flood Survey is the first step in a long term project to improve drainage in Superior and to minimize flooding.

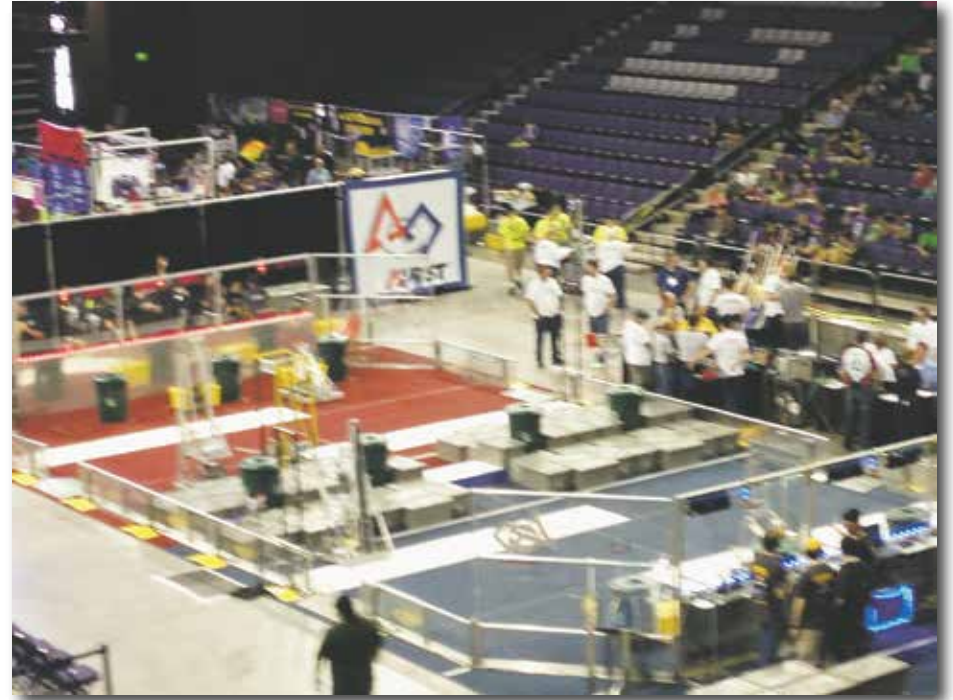
