

Ortega found guilty in killing of his wife, attempted murder of brother-in-law

Globe, Arizona - Gila County Attorney Bradley D. Beauchamp announced that on May 6, 2014, 38 year-old Guillermo Ortega, III was found guilty by a jury of six women and six men of Second Degree Murder, Attempted Second Degree Murder, and four counts of Aggravated Assault following a seven-day jury trial.

According to Chief Deputy Shawn C. Fuller, who prosecuted the case, evidence was presented that on April 28, 2013, at approximately 5:45 p.m., Ortega attacked his ex-wife with a knife following a brief domestic violence-related dispute the two had in her home, which was located in Hayden. During the attack the victim suffered fatal injuries to her neck.

While the victim was being attacked, her brother, who was inside the home, heard a struggle and came to her aid. The defendant then attacked the victim's brother with the knife and attempted to kill him by stabbing him in the chest and the neck. After the attack the defendant fled the scene and was apprehended several hours later in Pinal County.

Ortega's sentencing is scheduled to be conducted in Globe on June 2, 2014, at 3:30 p.m., before the Honorable Robert Duber II. Ortega is facing a mandatory prison sentence of up to 46 years.

County Attorney Beauchamp commended the Hayden Police Department, the Department of Public Safety, the Golder Ranch Fire District, the Kearny Police Department, and the Pinal County Sheriff's Office for conducting the investigation that led to the successful apprehension and prosecution of Ortega.

Superior man charged in theft at San Tan Valley Walmart

A Superior man faces multiple burglary and theft charges after being caught removing unpaid merchandise from a retail store, the last in what Pinal County Sheriff's Office is describing as "habitual."

On Friday, April 25, 2014, Michael Lopez, 41, Superior, was arrested in San Tan Valley after allegedly stealing from the San Tan Valley Walmart.


At 8:32 a.m., an Asset
Protection Agent with
Walmart reported she
witnessed Lopez drive into
the parking lot in a white
pickup truck and park in row
11. She reported the vehicle as
the same white pickup truck
he has previously used to
commit numerous thefts from
Walmart, the latest of which
being on April 22 (where it
was purported \$554.78 dollars
of merchandise was stolen and
never recovered).

After entering the store,

Lopez, who is known to her from several previous thefts, was observed filling a shopping cart with \$743.56 dollars worth of various merchandise and appeared to be getting ready to flee the store without paying.

When a PCSO deputy arrived, he observed Lopez pushing a shopping cart full of merchandise through the parking lot. Lopez noticed the deputy arriving and pushed the cart towards his patrol vehicle and began to briskly walk away. Lopez was chased on foot and taken into custody without incident. Lopez, according to Sgt. Pat Ramirez, **PCSO Public Information** Officer, during the interview admitted to all allegations and previous thefts from the surrounding area Walmarts. The Walmart Asset

Protection Agent reported Lopez has 14 previous thefts from local area Walmarts, to

include in the cities of Mesa and Apache Junction.

The truck Lopez used to commit these crimes has been seized.

Lopez was booked into the Pinal County Jail in Florence for six counts of burglary and six counts of organized retail theft. Additional charges of burglary, shoplifting (felony), shoplifting (misdemeanor)

Animal Control addresses community

The Pinal County Board of Supervisors has entered into an inter-governmental agreement to provide animal care and control services to the Town of Superior on an as needed basis. Pinal County Animal Care & Control leaders met with various leaders of the perspective cities in an effort to improve services and develop recommendations to foster a community-wide collaboration in order to deliver the highest quality, cost-effective animal care

Preschool enrolling

The Superior Unified School District is enrolling children in their Pre-school program. Superior Pre-school is designed for children ages 4-5. Participating children will need to be pottytrained. A Birth-certificate, Immunizations record, and proof of residency are required for registration. Parents will need an appointment for their child.

There will be two Pre-school sessions each day. The students will receive a meal as part of their participation; breakfast for the morning or lunch for the afternoon. Activities will provide opportunities for children to be better prepared for school and life.

Superior Schools understands that both research and common sense tell us high quality child care makes a difference. Children in high-quality child care settings fare better in school, and develop better language and social skills. Quality child care settings include: safe,

and control services.

The primary function of Pinal County Animal Care & Control is to develop a rabies control program, this program is especially important to the rural areas of Pinal County due to the ever present wildlife living in the area. The Arizona Department of Health Services reported 70 lab confirmed rabies positive animals in the year of 2013. peaking in May and June. Rabies is a preventable viral disease that is fatal once symptoms appear.

Rabies is preventable through vaccination of pets and preventing your pets from free roaming. It is illegal to own or house an unvaccinated dog over the age of three months in the State of Arizona; it is also illegal to allow dogs to roam freely. In addition to the potential health threat, free roaming dogs create a road hazard that may result in injuries to your community members and pets.

Your perspective city has agreed to launch a proactive approach to ensure your community is pet friendly, safe, and disease free. Through coordination with Pinal County Animal Care and Control the city hopes to bring a mobile spay and neuter clinic, vaccination / license clinic, and continued education for citizens and local law enforcement to the city.

It is the community's responsibility to do the right thing, if you locate a roaming dog in your neighborhood notify the owner. If the dog is repeatedly loose, behaving aggressively, when a dog injures a human, another dog or is in contact with wild life notify vour local law enforcement agency.

The results of responsible pet ownership are a safer neighborhood and

healthier life for the dog. Roaming dogs cause driving hazards, even on the most isolated roads, there are infectious diseases that are easily spread through direct and in-direct contact (some of these diseased cannot be cured), parasites, injury to or from other animals, and legal consequences.

As much as your dog may love to roam, you are doing the dog and your community a disservice by allowing this. Instead, exercise with your dog by walking on a leash: take your dog to an enclosed field or large back yard to play.

Before enforcement, we are asking for community members to step-up and become responsible pet



The quarterfinal game versus Ray was the fourth game played between the teams. The Lady 'Cats won three of those games. Of the Panthers' six losses on the season,


three came against Ray. But none hurt more than the last one.




