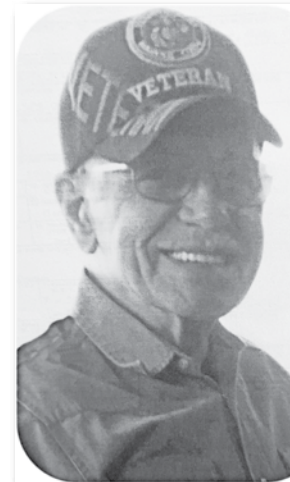

Rose Marie (O'Neil) McKee

Rose Marie (O'Neil) McKee died on April 25, 2023, in Casa Grande. She was born July 10, 1940, in the Kennecott Copper Company Hospital in Ray, AZ. Her parents were Raymond John and Balvina Cobo O'Neil. She passed away from complications of liver disease.

Rose Marie grew up in the mining town of Hayden, Arizona where her father worked for Kennecott Copper after World War II. Her mother worked in the US Post Office, retiring as Postmaster.

They moved to San Diego in 1941 where her father worked for the US Government painting camouflage on government buildings and factories. Her sisters JoAnn and Beverly were born at the US Navy Hospital. When her father was drafted to fight in the Pacific, her mother returned to Hayden with her sisters. Rose Marie was already living there with her grandparents, Frank and Aurora Cobo. She lived with them for five years.

She loved working outdoors with her grandfather helping him raise his bees and building the hives, tending his flowerbeds and especially eating fruit from his trees. They raised apricots, figs and grapes!

She attended the Hayden schools. Her special moments include being chosen as fairy princess by her classmates in 4th Grade and making butter in class and taking samples to the teachers and principal. She graduated from the 8th grade and played several piano pieces for the ceremony. In 1958, she graduated from Hayden High School as Senior Class President and was editor of the school newspaper, the "Wolf Call."

During her high school years, she worked at the Rex Theater, was a typist for the Justice of the Peace and was selected to assist in starting the town's first library.

She attended ASU, living in the first air-conditioned dorm, Wilson Hall, working as Assistant Head Resident all 3 1/2 years. In the summers, she attended summer school, employed by ASU, and also the National Science Foundation. At that time, the Russians were ahead of the US in the space race. The government sent science teachers to college to learn about space. ASU was one selected, they lived in Palo Verde Hall with their families.

She graduated in 3 1/2 years in January 1962. It was difficult to find a job mid-year but was hired by the San

Simon School District teaching 2nd Grade. She met her future husband there, John McKee, who was the science, agricultural teacher and FFA advisor.

At the end of 1962, John had already been selected by the Arizona Governor as a volunteer for the Peace Corps. He was sent to Iran for two years. She went to her hometown of Hayden to teach 2nd Grade for 3 years. Upon John's return, he enrolled at his alma mater, U of A to get his master's degree. In June, 1965, they were married at St. Joseph's Catholic Church in Hayden. Traveling to San Francisco for their honeymoon. Upon their return, they settled in Eloy where John was hired as an agricultural and science teacher at Santa Cruz Valley Union High School, also as the FFA advisor.

When Mr. Horace Chesley, the elementary school superintendent, heard that Rose Marie was a teacher, he called her and said he needed a 3rd grade teacher, she was interested. Of course she said yes. He then asked if she was related to a Percy O'Neil. Rose Marie said he was her great uncle. Mr. Chelsey said that he and Uncle Percy had been friends years ago. He hired her over the phone. Rose Marie always said that she never had to do an interview or give a resume in all her jobs. She retired in 2001 after 29 years of teaching 2nd, 3rd and mostly 1st Grades which she loved.

Their son, Jeffrey John was born in 1969 and daughter, Jennifer Marie in 1972. They made many friends in Eloy, moving to Casa Grande in 2013. They moved to be closer to her mother.

Rose Marie loved her students and was equally adored. She always met up with them as adults, grateful to see the ones who became teachers themselves.

Rose Marie and John traveled for many years crossing the Atlantic Ocean and the Pacific twice. Her favorite countries were France, Belgium, Scotland, and Eastern Canada. They also loved Alaska and Hawaii. She did not like Russia. She also wanted to see Australia before she couldn't travel anymore. She always read about the countries before they went. They always drank the different coffees and ate the country's delicacies and spoke to the locals.

Rose Marie was a lifetime member of Beta Sigma Phi and treasured the friendships of their sorority sisters.

She loved her family deeply. She was preceded in death by her parents, maternal grandparents, Frank and Aurora Cobo and Raymond John and Balvina O'Neil, mother-in-law, Mary Ellen McKee, sister, JoAnn and brother-in-law Bob Brady.

Survivors are her husband, John McKee of Casa Grande; children, Jeffrey and wife Sheila McKee of Peoria, Arizona, Jennifer and husband, Jeremy Bold of San Diego, California; sister, Beverly and husband Ron Sharp of Casa Grande; her grandkids, Lance, Kyle, Madison, Brandon, Sam and Kaitlin; and niece, Stephanie Dawson of Sherman, Texas.

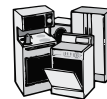

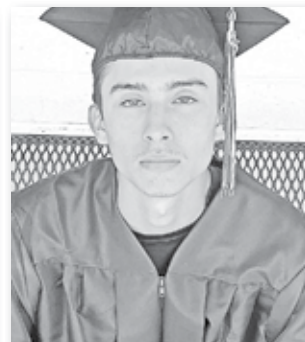

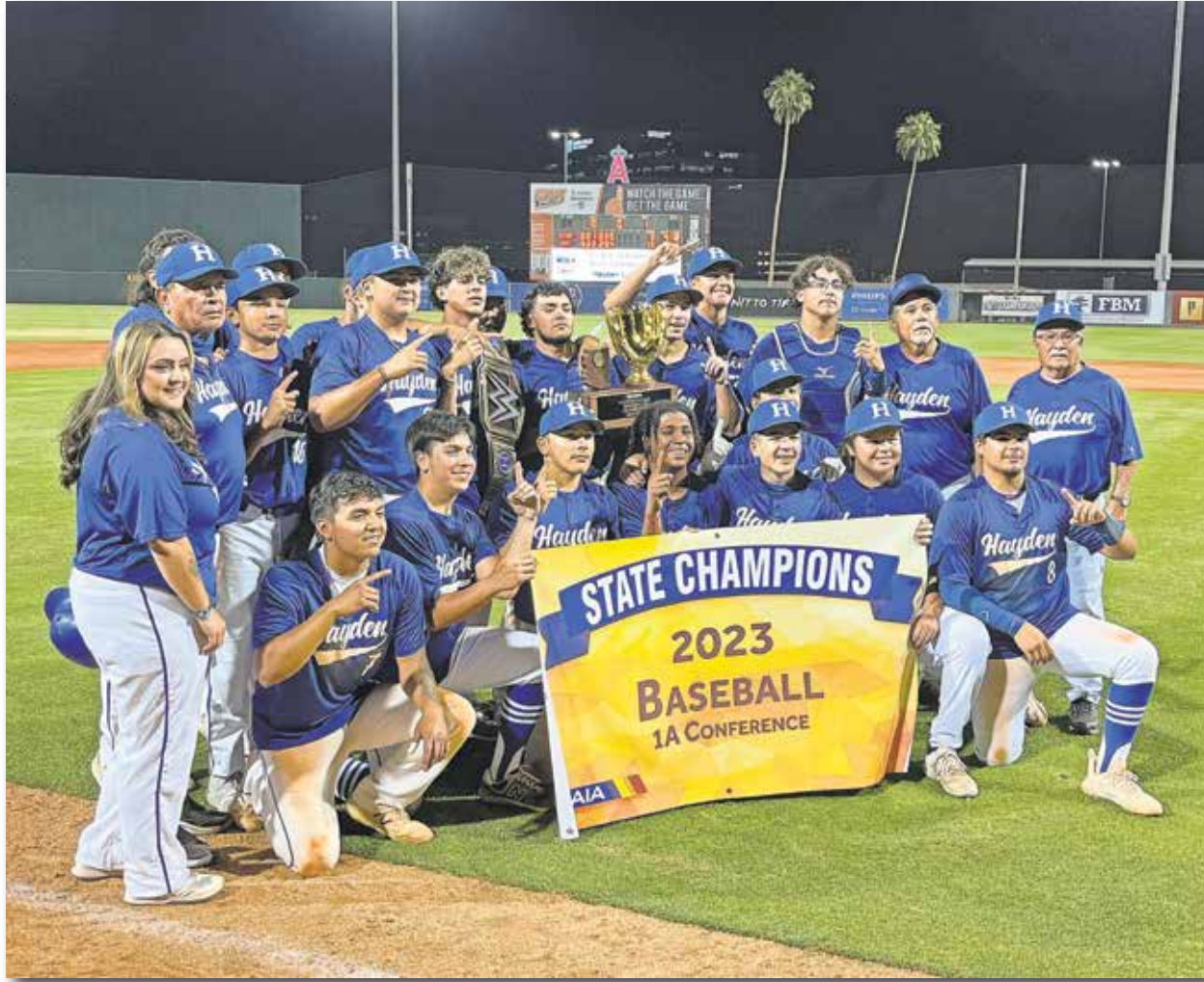
The Lobos claimed their final victory of the season, with a final score of 13-3, giving the boys the title of 2023 1A Arizona State Baseball Champions.

I teach them lots of life skills that their going to deal with after high school."

Coach Lorona would like to thank his incredible and dedicated coaching staff for helping with a great 26 wins, 4 losses season. He would also like to thank the Hayden-Winkleman Unified School District for allowing him to continue to coach the Lobos, and the community for it's continued support of the athletic program.
