FLORENCE -- Pinal County Treasurer Dodie Doolittle said her office has received calls regarding a tax scam targeting some local residents.

"Our office has been contacted by residents saying they have received messages from a person claiming to be with the Treasury Inspector General for Tax Administration," Treasurer Doolittle stated. "They are told that their address is under Federal investigation. I am forwarding on a statement from the Office of the Inspector General regarding this scam and how to report if you receive a call from these scammers."

From the Office of Inspector General:

There are numerous telephone and email scams in which individuals claim to be employees of the Treasury Department. These scammers often state that they are from the "Department of Legal Affairs," offer grant money in exchange for you wiring a small payment, or threaten to arrest you within a short period of time unless payment is made. Do not provide personal information or payment to these individuals. Their actions are crimes under Titles 18 and 31 of the United States Code, and the Treasury Office of Inspector General is working to stop them.

If you have received a call or an email that you suspect is fraudulent, report it to OIGCounsel@oig.treas.gov with a

description of the communication.

If the call or email contained claims related to the Internal Revenue Service (IRS) or taxes, you must report it to the Treasury Inspector General for Tax Administration (TIGTA) at <http://1.usa.gov/1Xuggjr> or 1-800-366-4484.

When reporting a suspicious call, telephone carriers require that you provide the exact date and time that you received the call(s) and the geographic location and time zone where you received the call. For example: "I received a suspicious call from telephone number XXX-XXX-XXX to my home phone in Tallahassee, Florida (Eastern Time Zone) on October 23, 2015 at 9:23AM claiming that there is a legal action against me from the Treasury Department of Legal Affairs."

Pinal Airpark named Airport of the Year

FLORENCE -- Tails rise from the desert like shark fins from the water.

Drivers on Interstate 10 can usually spot the tails from many of the aircraft stored at Pinal Air Park, but nothing else. It leads to the mystery of what is really on the west side of I-10. A secret training base? Testing grounds for new aircraft? Or perhaps a site for the CIA?

Built in the early 40's, the then named "Marana Army Air Field" trained pilots for World War II. The field was no longer used and decommissioned in 1948 when it was taken over by Pinal County. Since then, Pinal Air Park has been used primarily as a maintenance center for commercial aircraft and a storage facility for unused commercial aircraft.

In 1975, Evergreen Aviation became the

sole tenant for the maintenance facility. The company erected a guard post just outside the entrance of Pinal Air Park turning away those who did not have business at the facility.

"When I was elected in 2012 I took a trip out to the airport to see what was going on out there and I was turned away at the gate," stated Chairman Todd House. "Here it is, we own the air park and I couldn't even enter it."

Chairman House joined thousands of people who have been turned around after exiting I-10 at Pinal Air Park Road and for Airport Economic Development Director Jim Petty, limiting access was a major problem at the property.

"There was a lot of activity through Evergreen's business at the air park," Petty

said. "But once we started looking closer entire facility, we find out more and more Federal Aviation Administration (FAA) compliance problems. One of those was exclusive use by Evergreen."

Exclusive use was just one of five major compliance issues for Pinal Air Park. Not allowing public access to the facility was another issue. The Board of Supervisors took a major step forward to erasing those problems when in 2013 they adopted the fourth amendment to a 1992 lease with Evergreen Maintenance. The amendment cured the many FAA identified compliance issues.

"I can say there is no longer a manned guard post at the entrance," Petty said.

"I can also say there is more than one

business operating there. But to get FAA grants, you must abide to 39 grant assurances they look for in an application. But thanks to the Arizona Department of Transportation's Aviation Group, we have been able to take care of some problems that needed to be addressed immediately."

Thanks to three major grants from ADOT's Aviation Group, Pinal County has been able to repave the 6,850 foot runway, complete a taxiway overlay and develop a master plan for the air park.

There has been so much progress at Pinal Air Park that on Tuesday, May 3, it was named ADOT's 2016 Airport of the Year at the Arizona Airports Association annual conference.

Former Kearny teacher sentenced to more than 100 years in prison on multiple child sex counts

Former Kearny teacher, Louis Elvira, was sentenced to 112 years in the Department of Corrections after his recent conviction on nine counts relating to the molestation of a child.

In March, a Pinal County jury found the 58-year old Kearny man guilty on all counts, including two counts of sexual conduct with a minor, child molestation, five counts of sexual exploitation, and one count of public sexual indecency.

Back in 2011, the defendant inappropriately touched a 6-year-old child and then made the child perform a sexual act on him. A month later, a friend discovered a laptop belonging to the defendant with images of child pornography. Kearny Police confiscated the computer as part of their investigation and discovered multiple images of children under 15-years-old on the laptop.

After the child reported the incident, the defendant quit his job with the school and fled the state. Kearny Police caught up to him in Indiana and had him extradited back to Pinal County.

"Because we have such a high conviction rate, we have now decreased the sex offender per capita ratio to the absolute lowest in the state. The next highest county is now more than 300% higher in sex offenders per capita than Pinal County making Pinal the absolute safest in the state for our children. It is

incomprehensible that this man forced a child to do what he did and then fled the state. I would like to thank our local law enforcement officers and those in Indiana who assisted with this case and brought the defendant back to Arizona to face his charges. A jury of his peers convicted him thanks to the courageous actions of a child who reported his criminal behavior to authorities," said Pinal County Attorney Lando Voyles.

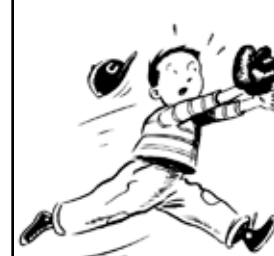

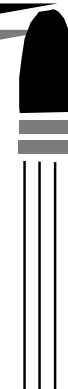

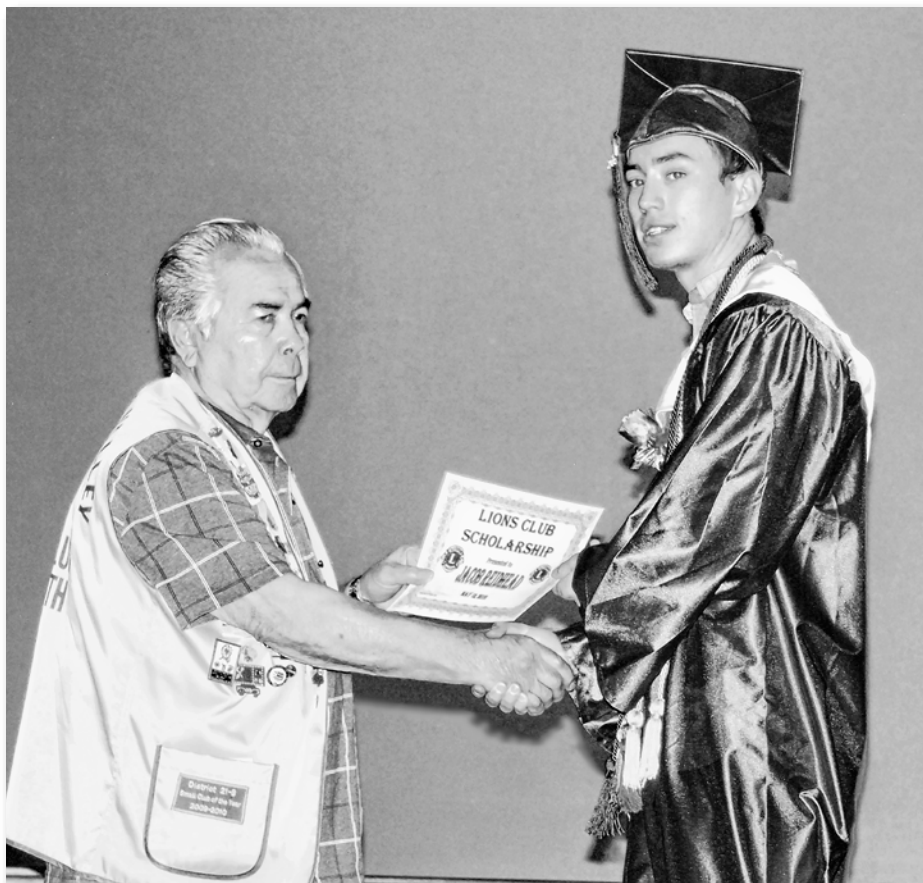
McBride received the SaddleBrooke Community Outreach Scholarship (\$1,500 for four years or \$6,000); the Central Arizona College Academic Scholarship
