RICO money donated to PCCI over the years by Sheriff Paul was used to pay for tutoring for Pinal County foster children/youth. A large percentage of the children in the foster care system are behind in school because of abuse, poor attendance, lack of follow through with homework, poor parent participation and frequent moves within the foster care system. Sylvan offers a reduced rate to PCCI for foster children, which has enabled PCCI to serve more children.

It's not unusual to see a 8th grade foster student on a first grade level. PCCI collaborated with Sylvan Learning Center and to make a long-term difference in these children's lives. With the help of RICO funds, these children hopefully will move on to become successful and productive, tax paying members of our society. Our State Officials see tutoring as a luxury and does not provide funding for foster children even though they are considered Wards of




The 2013-14 Ray High School Classroom Awards Assembly was held last week in the RHS auditorium.





The undersigned, who desires to form a corporation under the laws of the state of Arizona, hereby adopts the following Articles of Incorporation. ARTICLE I - CORPORATE NAME The name of this Corporation shall be: DESERT SKY HOLDING, INC. The Corporation may in its own name invest in funds in real estate, mortgages stocks, bonds, or any other type of investment, and may own real or personal property ARTICLE V-INITIAL BUSINESS The character of the affairs and business that the corporation initially intends to conduct in this State is to take all such actions as may be appropriate to accomplish the purposes set forth above. ARTICLE VI- SHARES total authorized shares of the corporation shall be one hundred thousand (100.000 common shares with a par value of one cent (\$.01) each. Said shares shall be issued when paid for in case, services, real estate or personal property and shall be issued as fully paid for and forever non-assessable. Neither this provision nor any other provisions in these Articles shall eliminate or limit the liability of a director for any of the following: A. The amount of a financial benefit received by a director to which the director is not entitled. B. An intentional infliction of harm on the corporation. C. A violation of A.R.S. 10-3833 (liability for unlawful distributions). D. An intentional violation of criminal law. For purposes of this provision, "Director" shall include trustees or person who serve on a board or council of the corporation in an advisory capacity. ARTICLE XII - INDEMNIFICATION The Corporation shall indemnify any person against expenses, including without limitation, attorney's fees, judgements, fines and amounts paid in settlement, actually and reasonably incurred by reason of the fact that he/she is or was a director, officer, employee or agent of the Corporation or is or was serving at the request of the Corporation as a director, officer, employee, or agent of another corporation, partnership, joint venture, trust or other enterprise, in all circumstances in which, and to the extent that, such indemnification is specifically permitted and provided for by the laws of the State of Arizona as then in effect.
