Mayor, two others no show for council meeting again

Thursday night, the Superior Town Council held an important meeting to set the Home Rule election so that the town could continue its funding. The Home Rule is a confusing circumstance but the gist of it is, if a special election is not held confirming Home Rule, then the State steps in and says only a percentage of the money the town has brought in for that year can be used to pay the bills. If Home Rule is not passed (there is no tax involved for the Townspeople), then the Town doesn't have the capability to pay for Police or Fire Services or even the sewer plant that is important to every single citizen of Superior! So a quorum of at least four members was needed at Thursday night's meeting to get the Home Rule Election scheduled, and once again Mayor Valenzuela, Councilman Tameron and Councilman Aguilar were absent. Fortunately, the other three council members and Vice Mayor Lopez showed up and got the election scheduled.

Mayor Valenzuela, Councilmen Tameron and Aguilar also did not show up to the regular Town Council meeting two weeks ago, April 14. It might have been because the Recall Petitions for the Mayor had just been presented to the Town on the 11th. I can understand being upset that things are not going your way. But deciding to stay away

Roadside memorial crosses removed by ADOT

Governor Doug Ducey's Administration and the Arizona Department of Transportation have commenced removing memorial crosses and religious markers from the side of State Highways. This removal started two weeks ago along State Route 177 and East of Superior on US 60. No notification either personally or via local newspaper was provided to families of the loved ones who were killed at those sites.

Most families of the deceased consider these memorial sites sacred and holy. When folks questioned ADOT they were notified that they could pick up the crosses and other religious items at the maintenance yard in Globe. When family members went to claim religious items, many of the figurines were found broken and many crosses were missing.

ADOT and Governor Ducey ARE within their legal rights to remove all un-permitted objects from State Right of Way. The issue is that highway deaths have been marked by memorial crosses for almost a hundred years. These crosses also serve as a notice to other drivers to be more cautious while driving. Why is the Ducey administration having them removed now?

The Governor's executive staff has indicated that they will be removing memorial crosses from all rural state highways. Most of our rural highways are in extremely bad condition, seems to me that highway crew's time could be better utilized repairing our roadways versus desecrating sacred ground.

Superior softball's Fab Five honored on Senior Day

The Superior softball team's own version of the "Fab Five" was honored last Wednesday before playing the final home game of their high school careers. Gabby Salcido, Pinky Thomas, Keanna Torrres, Ivie Lopez, and Ariana San Miguel helped take the Lady Panthers' softball program from worst-to-first since their arrival on campus four years ago.

"These seniors that we have, they've been big since they were freshmen," Superior head coach Martin Navarrette said. "They came up playing club ball and brought it over to the high-school level."

"They've been outstanding," he added. "It's going to be a big loss to have these girls graduate and move on to college."

The "Fab Five" originated as the nickname for the 1991 University of Michigan men's basketball team recruiting class that is considered by many to be "the greatest class ever

recruited."

But the Wolverines never won a National Championship with their "Fab Five." The Lady Panthers own one state title and are the odds-on favorite to win their secondstraight Division V State Championship.

"I didn't even know how we were even going to go to the championship game because we started from the bottom," Salcido said after last Wednesday game versus Ray. "But we (did). I love my team, I love my girls, and I wish I (wasn't) going to leave, but I'm excited for the future."

Salcido's future includes continuing her softball career after accepting a scholarship offer from Paradise Valley CC. The Lady Panthers' future figures to benefit from the legacy left behind by their version of the "Fab Five."

"I think they set the bar high," Navarrette said about the five graduating seniors. "I think all the younger girls – little league and junior high – see the expectation and it should drive them to improve and get better."

Lady Cats hold off defending champs; win section title

The then third-ranked Ray softball team entered last Wednesday's regular season finale against then top-ranked and defending State Champion Superior with a chance to win the Section V Championship.

In similar big games during previous seasons, the Lady Cats have been on the short-end of these types of games, but this year has been different as evidenced by their 7-5 victory that made them the Section V Champions and the eventual No. 1-seed in the Division V State Playoffs.

"We played as a team and that's how we won," Ray head coach Rikki Galka said after the game. "We needed this win. We needed this win against this team. It's been a head-game for us since last year."

Player of the Year candidate Stormee Galka pitched six-and-a-third innings, allowing only one run during the first six. But in the seventh inning, the Lady Panthers touched up the Maryville University commit for four runs, leaving a feeling that another heartbreaking loss in a big game was forthcoming.

Rikki new her star player, and daughter, was tiring so she made the pitching change, calling for freshman phenom Daniella Hinojos to close out the win.

"We needed this win," Stormee answered when asked what it was like to finally break through after several disappointing losses in similar situations. "I know it helps build confidence in our team whenever we beat a team like this because whenever we lose and go into games like this our confidence is low."

Ray jumped out to an early lead by scoring four runs in the third inning off Superior ace Ivie Lopez. The Lady Cats extended their lead in the fifth after Ema Alverado's squeeze bunt scored Janae Ruiz

Superior answered with a run on an RBI-single by Salcido in its half of the fifth, before Ray scored two more runs to make 7-1 in the sixth.

Ray held a 7 – 5 lead in the Superior seventh with the bases full of Lady Panthers' runners and only one out. Superior's next hitter flied out right and the runner at third tried to tag up but was thrown out at the plate to complete the game-ending double play.

The loss ended Superior's 15-section game winning streak that dated back to last season

"This was a good test for us, being down like that," Superior head coach Martin Navarrette said. "It showed what kind of heart our girls (have). I think that's going to be very important going into the playoffs this year."

These two teams are the class of the division and are favorites to meet for the Division V Championship later this month. Ray won this battle, but the war is not

over.

"Last year we went in as the No.5 seed," Navarrette said. "We went through the best teams and we had the toughest road (to the championship). So we've done it once (and) I don't see any reason why we can't do it again."






