

# School Board seats open throughout the Copper Corridor

Are you concerned with our local schools having effective leadership and quality educational programs? If so, it is a great time to consider stepping up and running for election for the available positions on local school boards.

All governing board positions listed below have a term expiration of Dec. 31, 2022. The seats will be on the November 2022 ballots. Open seats include:

- Oracle – two seats with a four-year team each, which are currently held by Gary Terrell and Jeri Taylor; 73 signatures are required.
- Ray – three seats, which are currently held by Jason Wernett (two-year term), Jonathan Ramirez (four-year term) and Tino Flores (four-year term); 11

signatures are required.

- Mammoth-San Manuel – three seats, two with four-year terms, currently held by Terry Newman and Louis Madrid, and one with a two-year term, currently held by Michael Carnes; 15 signatures are required.
- Superior – four seats, one with a two-year term and is currently held by Henry Gutierrez; two with four-year terms that are currently held by Ricardo Provencio and Ignacio Magallanes; and one with a four-year term that is currently vacant; 11 signatures are required.
- CVIT – one seat (Superior School District) with a four-year term currently filled by Louie Rabago; 11 signatures are required.

The first form to file is the Candidate Statement of Interest. It can be downloaded here: <https://bit.ly/3JKLK8K>. This one does not need to be notarized and can be submitted in person, by mail or email to the Pinal County School Office ([mkrumrey@pinalco.org](mailto:mkrumrey@pinalco.org)).

Several locals have filed their intents to run already: Jeri Taylor for Oracle and Louis Madrid for Mammoth-San Manuel were the first to file. Also intending to run are: Donna Pedota (Oracle), Wendy Biallas-Odell (Oracle), Gary Terrell (Oracle), Augustine-Lou Hing (Superior), Ericka Vasquez (Superior), Hector Aparacio (Superior), Henry Gutierrez (Superior)



# Supervisor Cavanaugh to offer Copper Corridor farewell town hall; redistricting has resulted in change of Supervisors



On May 7, 2022, join Supervisor Kevin Cavanaugh for a farewell Town Hall in the San Manuel Community Center at 4:30 p.m.; 111 W. Fifth Ave., San Manuel, AZ 85631.



Redistricting requires that populations of Supervisor Districts be within 10% of each other, and District 1, formerly comprising the Copper Corridor, Coolidge and parts of Florence, was less than half the population of the largest district – San Tan. Redistricting also requires that districts be as compact as possible, so the County Management Team devised a map splitting eastern Pinal County into north and south sections. Supervisor Cavanaugh will now be responsible for portions of Coolidge, Queen Creek, the Ak-Chin, Gila River Indian Community, local members of the Pascua Yaqui Tribe, and the City of Maricopa.

Initially recognizing a need for broadband in the Copper Corridor to drive economic growth, Cavanaugh worked with County Managers to develop a plan utilizing existing fiber cable to bring new infrastructure to the Corridor. The project had been stalled when Supervisor Cavanaugh took office, and he pressed in and helped to allocate funding for the project. He has assisted District 1 businesses in navigating difficult planning and zoning situations (keeping several businesses from giving up on Pinal County entirely), supported economic and community development projects, and aided municipal departments in securing necessary resources.

The Town Hall on May 7 in San Manuel will be an opportunity for Supervisor Cavanaugh to thank residents for the privilege to be their voice in County government. Updates will be provided on projects which will be transferred to the new District Supervisor. The entire Copper Corridor, from SaddleBrooke Ranch to Superior, is invited and encouraged to attend.





# Ray Mock Accident – Preventing

**M**any times, we hear or read about a tragedy in our local newspaper or see something broadcast on the nightly news that catches our attention. It's terrible, but it is something that has happened to someone else. We have the option to turn the page or change the channel. Having an impaired/distracted driving crash hit so close to home makes a tremendous impact. In the Ray Mock Accident, the community pulled together to simulate a horrific two-car drunk driving accident where students play an active role to show how devastating this scenario can be.

The crash is staged, bodies are bloodied, and the Kearny and Hayden Police Departments arrive and observe the horrific carnage and evaluate the situation, immediately emergency crews are dispatched. Whenever an accident occurs in most rural communities the arrival times of emergency help varies from a few minutes up to about 20 minutes. Every minute someone's life could be on the line. This scenario had one student dead on arrival and the others needed immediate medical attention. Time is of the upmost importance. During this incident the Jaws

of Life are used to take off the roof of one of the vehicles so that they can retrieve one of the injured students. Every injured person is given proper care and concern from everyone helping. The emergency technicians, firemen and rescue crews all work so well together communicating and corresponding to allow a smooth flow of help for each injured person on the scene.

While the first responders help the injured, officers from the Hayden and Kearny PD performed a mock field sobriety test on one of the drivers, Mikenna Seller. The police officers determine the driver is intoxicated; she is placed under arrest and put in the police car to be taken to jail and booked. The driver is charged with Driving Under the Influence (DUI) and faces possible other charges depending on the injuries of the others involved in the accident and property damages.

Once the emergency crews are there everything seems to happen so fast, people are running everywhere. The people who can travel to the hospital by ambulance do so. In this particular accident two people had to be taken by helicopter to the hospital. The first helicopter to arrive is Air Evac, they were in and out with

the patient in minutes. Then Native Air arrived shortly after for the next patient. After the patients who could be saved were taken to the appropriate hospitals the Superior Funeral Home arrived to pick up the deceased student and shortly after cleaning up the scene of the accident began.

The participants of the Ray Mock Accident were Tracon Naranjo (deceased victim), Johnavon Pace (distracted driver), Mia Barragan (passenger in DUI vehicle), Jack Warren (passenger in distracted vehicle) and Mikenna Seller (impaired driver).

Coordinators for the event were Darrien Matthews of Arizona Youth Partnership (AZYP); Christopher Villaverde Jr. of the

Superior Fire Department; Tiffany Ortiz who provided make-up for the mock injuries; Pinal County Sheriff Mark Lamb who provided the commentary for the audience.

The participating departments included: Superior Fire Department; AZYP; Kearny Volunteer Fire Department; Hayden Police Department; Superior Funeral Home/Griffith Mortuary; Kearny EMS (Cobre Valley Ambulance); Winkelman Volunteer Fire Department; PHI Air Medical (Air Evac 7 – Miami, AZ/Pinto Valley Base); Kearny Police Department/EMS/Fire Dispatchers; Pinal County Sheriff's Office; Southwest Towing; Getsome Motorsports; Governor of Highway Safety's Office; Pinal County Medical Examiner.

25 game against St. John Paul II Catholic. The girls came out swinging, scoring 3 runs in the first inning, then 6 in the second inning. The Lions struggled to break through the Lady 'Cats defense, and were only able to post 3 runs throughout the entire game. The final score of the game was 13-3. Leading at the plate was McKenzie James with 3 hits and 2 RBIs, followed by Madison Kenny with 2 hits and 3 RBIs. Jocelyn Ruiz led from the mound collecting 8 strikeouts.

The following day, the Lady 'Cats hosted Leading Edge Academy of Gilbert. Coming out swinging once more, the girls took it further during this game, scoring 9 runs in the first inning, followed by 4 runs in the second inning, and 5 runs in the third inning. The fourth inning was their lowest amount of runs, with only 2. LEA was only able to collect 4 runs for the entire game, resulting in the final score of 20-4. Bella Wernett lead from the plate with 2 hits, and 4 RBIs.

The Ray baseball team had a light schedule last week,
