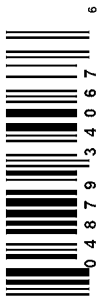

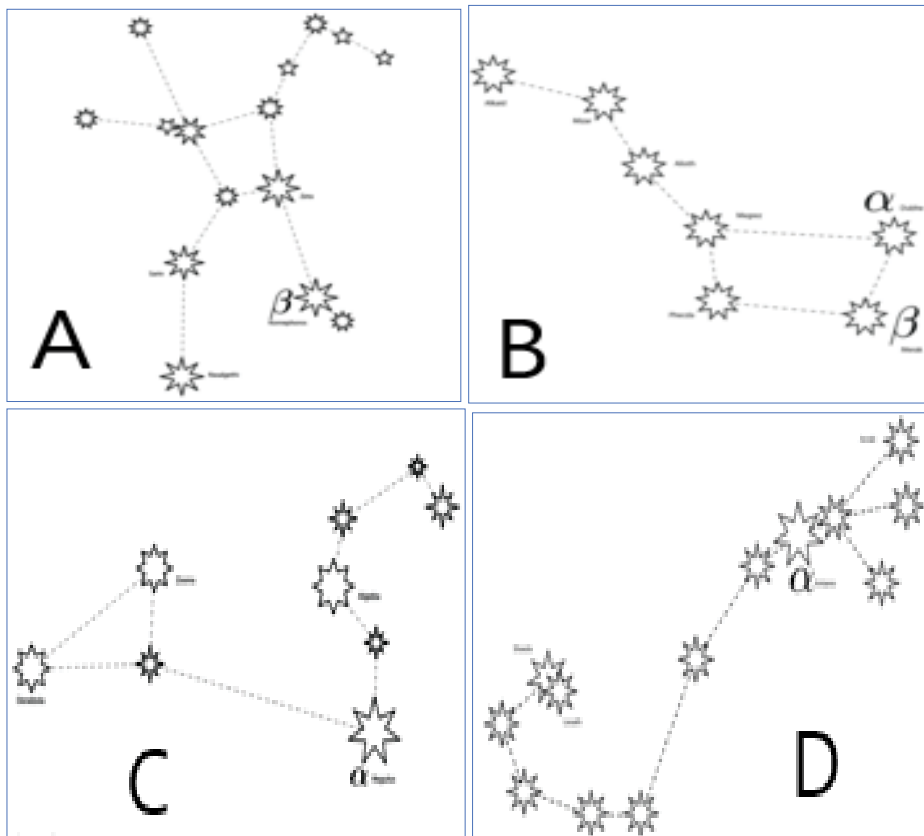

### STAR PATTERN MATCH

Match the letter of the illustration to the description of the constellation:

\_\_\_ **Leo** is imagined as a resting lion. Its brightest star Regulus seems to be the “dot” at the bottom of a backwards question mark that forms the head.

\_\_\_ **Scorpius** includes the giant red star Antares (the “heart” of the scorpion). The shapes in this constellation remind us of the pincers and tails of the arachnids that are out in warmer months.

\_\_\_ **Hercules** represents a mythological hero. Unlike the more well-known Orion, which is visible in winter and has several bright distinctive stars, Hercules shows up in the summer. It appears close to Vega, the fifth brightest star in the night sky.

\_\_\_ **Ursa Major**, or the **Big Dipper**, is easily recognized year-round and its stars are often used to help observers find other stars. For example, one of its stars will lead you to Vega and on to Hercules. Currently, if the Dipper had holes in the bottom, it would be pouring water on LEO's head as it rises.

## San Manuel MBB wins AIA Sportsmanship Award

The San Manuel boys' basketball team recently concluded one of the most successful seasons in school history and followed that achievement by being chosen as the winner of the 2020 Arizona Interscholastic Association 2A Conference Boys Basketball Sportsmanship Award.

The award "is reserved for a school that exhibits ethical behavior, fair play, and integrity as determined by information collected from (AIA) Varsity game officials," as written by Brian Gessner, the AIA State Commissioner of Officials, in a letter to San Manuel MBB head coach Damon Lovato.

"It's an honor and a reflection of the boys buying into our program day in and day out," Lovato told the *San Manuel Miner* during a phone interview. "Our program and our culture never changed."

The Miners were selected by the referees, which made the award even more credible, according to Lovato.

"It's not a popularity contest," Lovato said. "It is impartial referees and how they view your program – home and away – our facilities, and how our players carry themselves."

Lovato had an interesting response if



the award sets the standard for future to classes to emulate.

"A plaque doesn't create that, it's part of our culture already," he said. "I feel that's been instilled from day one. Even if we didn't receive the plaque, sportsmanship is still the standard and expectation within our program. Others now know what we've already known about ourselves, and that is rewarding."

# Oracle Firewise Brush Dump Open Again

The Governor has mandated Arizona residents to stay safe, stay home. The Arizona Department of Forestry and Fire Management predicts a potentially active fire season. The Oracle Fire District and the Oracle Firewise Board are very concerned about the potential fire danger in the community and surrounding areas with the lush green vegetation and the high temperatures of summer heat creating a potential wildfire situation. The Brush Dump is open to allow Oracle residents an opportunity to dispose of the brush properly and create a safer area around their home.

By a permit with the Arizona State Land Department and another permit to burn the brush, OFD accepts tree trimmings, grass and brush. Leaves need to be removed from plastic bags and the plastic bags need to be removed from the Brush Dump by the person who brought the leaves. Green cactus, garbage, lumber and other construction materials, stumps, paper, plastic, metals, fluids, paper and animal carcasses are not accepted and disposing of these items in the brush dump could jeopardize the permit which allows the burning of the brush. This is strictly a brush disposal site!

Those wishing to take brush to the brush dump must pick up the key and pay the fee for using the brush dump at the Oracle Fire Station, 1475 W. American Avenue from 7 a.m. – 5 p.m. daily. The fees are as follows: \$3 for one load (the back of a truck or a trailer), \$5 for both the back of a truck and a trailer, \$10 for a dump truck. There is now a plexiglass pass through in office window to make the exchange of the key for the fee easy and safe for all participating. It would be greatly appreciated if the correct change was brought to the Fire Station. The fees collected pay for the costs incurred when the brush

dump is burned as well as other community projects such as the cost of the Oracle Emergency Notification System, AED units that have been placed at the school and several nonprofits through out Oracle, etc. By using the Brush Dump, residents help in qualifying Oracle as a nationally recognized Firewise Community.

# Governor announces reopening of some businesses

On Monday, Governor Doug Ducey announced that barber shops, beauty salons and non-essential retail stores may open on Friday, May 8, with increased sanitation protocols and physical distancing requirements in full force. Restaurants can also open their dining rooms on Monday, May 11. Restaurants may only be able to use a portion of their dining capacity and staff will be required to wear face coverings.

Other services such as massage, aesthetics and nail salons were not reopened on this round of opening.

Ducey indicated in his press conference that the Stay at Home order is set to expire on May 15, 2020. During

his press conference he shared data that indicates that hospitals are not seeing an increase in COVID-19 or influenza symptoms.

These openings come with the requirements for physical distancing, increased sanitation and personal hygiene to be in order. Movie theaters are not expected to open until July, in part because the major film producers will not have new releases available until July.

Local businesses in the Copper Corridor will be preparing for their reopenings. In Superior, the local business community and the Town of Superior have signed on to a safety pledge.
