LETTER TO THE EDITOR

Questions raised regarding unorthodox landing zone for medical helicopter

On June 5, there was an incident at the Mammoth Community Center. My prayers go out to the family involved.

A helicopter had to be called in, and, because procedure wasn't followed, many children and adults were put in harms way. The Town of Mammoth was not involved in anyway, so I am told.

A meeting was scheduled and posted at the Mammoth Fire Department for June 12 at 10 a.m., at the Mammoth Town Hall. I showed up at the Town Hall just before 10 a.m. and was told by the receptionist that there was no meeting scheduled. I went up to the Fire Department and I was told that the meeting was to be held at the Town Hall. I went back to the Town Hall and people were gathering for the meeting.

The Town Manager came out and told us she had been ordered not to participate in the meeting; she was in tears. The manager told us we were free to use the meeting room if we wished. I was talking to the Town Manager in her office, when the Vice Mayor, Regina Medina, stormed into the hallway, yelling at the Town Manager; something to the effect that "I told you not to get involved" and that we, the citizens of Mammoth, could not use the hall.

Since the meeting was canceled, I asked Rick Sanchez to reschedule for the next day and he refused, so I asked Mr. Ponce and he said he would.

On June 6, the second meeting was held at the Mammoth Fire Department at 6 p.m. In the meeting it was brought out by witnesses that the children were hiding, behind cars and trees, from the flying debris. Rick Sanchez and a Mammoth police officer were directing traffic, and Rick Sanchez was directing the helicopter pilot. No warning was given to the pool manager, so that he could get the children out of harm's way. "The dust was so thick that I could not see anything," stated one witness. The children were within two hundred feet of the helicopter. Thank God, no eyes were put out and no one was injured.

The Mammoth Fire Department, volunteers did no wrong as far as what came out in the meeting. Neither did the helicopter pilot Only one person was responsible for putting the children in harm's way and that is the person who directed the helicopter pilot to land at the Community Center and not the soccer field. The soccer field is the designated spot for landing, and, from what I understand, a member of the Mammoth Fire Department was at the soccer field waiting for the helicopter.

The incident has to be fully investigated and the person responsible should be reprimanded and/or discharged. The results should also be sent to Pete Rios.

On June 5, there was a budget meeting at the Town Hall at 6 p.m. The Mayor wants to cut employee hours of work from 40 a week to 32. I told them I wanted a Layoff that would take us back to where we were before they started hiring and raising wages.

The last time they cut the hours of work, only the senior employees worked 32 hours. The Family worked 40-plus overtime, in many cases. Senior employees were doing the labor work, while the Family were driving the equipment. I really believe that they wanted the senior employees to

quit so the Family would move up in the line of flow.

When I told the Mayor and the Manager that I wanted to cut back, the Manager's response was "We don't have to lay off by seniority," and the Mayor stated something to the effect "That's right. Some of the employees don't know how to finish cement."

We all know that they went all the way to Tucson to hire his brother-in-law, because no one in this area knows how to finish cement. Oh, he is way down on the seniority list. Maybe that's why they don't want to lay off by seniority.

Funny thing, when I went down to the Town Hall to look at all the applicants that applied for employment with the Town of Mammoth, they couldn't find them.

Why do they have laws against hiring family? Because, things will happen to violate people's rights, just like they are happening here.

Got swarms? Leave them BEE!

This is the time of year that honeybees are splitting up and moving around to establish new honeycombs. A clustered swarm of many bees may appear frightening, but most spring swarm clusters of European honey bees—the common honey bees here in our area—are extremely docile. It takes quite a bit of aggravation, such as being hit by sticks and stones or squirted with a hose, to create defensive behavior.

Free Estimates The reason a bee swarm looks like a clump of bees is because all of the workers are gathered around the queen, forming a clump. The queen is not the strongest of flyers, and so will need to rest at some point, perhaps on a branch, fence, or the side of a house. Meanwhile, 'scout bees' will be sent out to look for a suitable new place for the colony to live.

Are swarms dangerous?
They are focused on finding a new nest, not on attacking. That said, it is important to keep your distance from swarming bees, because if the bees feel threatened, then it is possible they will attack. A swarm may stay around for

a few days, depending on

how quickly the scout bees find a suitable new home. This could happen very quickly, even within a day.

If the bees don't find a new nesting location, they may begin producing beeswax and forming combs at the spot where the cluster formed, such as a tree limb, the overhang of a house, or another unusual place. These "exposed comb" colonies may exist until fall (or year-round in warmwinter areas), but robbing bees, hungry birds, and inclement weather usually put an end to these colonies and their combs very quickly.

So, the point is...let them be and they will most likely just fly away to a new place. A swarm requires a large cavity, 4-9 gallons in size, to establish a new comb, so unless they have that where you see them they will leave. If you anger them by spraying water or knocking the swarm they will very well retaliate!

We have responded to several homes in Mammoth where the same swarm is slowly moving from property to adjacent property trying to find a new home. Pinal Rural Fire and Rescue will remove a swarm if it has stayed for several days, but usually we will just "wait and see" if it moves again.

Once it stays, and makes no sign to be leaving after 4-5 days, we will take care of the swarm for you. But, please, remember all the



good honey bees do as they pollinate and create honey before you just try to destroy the swarm. If a swarm stays for more than 3-5 days, call PRF&R at 520-465-5300, and we will help you remove the swarm.

Pinal Rural Fire Rescue forming district

Pinal Rural Fire Rescue is forming a new fire district. The new district will be known as the Pinal Rural Fire Rescue and Medical District. Pinal Rural has filed an Impact Statement with the Clerk of the Pinal County Board of Supervisors which is the first step in the process of transforming from a 501 (c)(3) to a Special Tax District per Arizona Revised Statutes 48-261.

The creation of a fire district will allow Pinal Rural Fire and Rescue (PRF&R) to provide dedicated service by a permanent fire district. It will allow for capital planning based on a known annual budget. Added revenues will allow PRF&R to hire shift firefighters and provide the ability to pay stipends to local volunteer staffing.

Property owners living in the district will be assessed a secondary tax of \$3 per \$100 of assessed value of their property. There is little difference in the tax fees and the current subscription fees. The new district will allow property owners to get fire insurance and/or have a positive impact on fire insurance fees. In some cases the savings in fire insurance premiums exceeds the tax assessed. Once the district is approved and set up, board members will be elected from property owners in the district. Mars and Saturn will be on view, the asteroids Ceres and Vesta, plus star clusters, nebulae and galaxies. During the evening, the Milky Way will rise over the eastern horizon.

Tunes range from the Beatles to Van Morrison to the Stones, usually with a bit of jazz and country tossed in. 

Wildfire destroys one home,

At approximately 4 p.m. on Thursday, June 12, the Oracle Fire Department received a call of smoke being seen in the area of John Adams and Paseo Encino streets. An engine was sent and arrived within five minutes. They observed a brush fire near some homes. The firefighters that had responded saw that the fire would get away from them and immediately ordered outside resources contacted through the state dispatch system. They ordered engines and brush trucks. Coronado Fire ordered more engines and a helicopter equipped with a water bucket. The helicopter would be used later as their eye in the sky.

"My firefighters did exactly what they were supposed to do," said Oracle Fire Chief Larry Southard. "We've been planning for this type of fire for many years. Even though

system and Coronado Fire." The fire rapidly Oracle Fire Chief went around a house and jumped Paseo Encino igniting more dry brush. It then

jumped John Adams Street and began climbing a slope pushed by the wind and headed for a home at the top of the hill. The house caught fire. As more firefighters and resources arrived a decision was made to contain the fire. "We decided early in the fire to draw a line at Cody Loop Road and to do whatever it took to not let the fire jump across Cody Loop," said Chief Southard.

Fourteen different agencies responded. At one point 85 firefighters were on the ground. Traffic and evacuation quickly became a major problem. Pinal County Sheriff Paul Babeu sent 30 deputies to Oracle including himself. The affected fire area was quickly blocked off. Pinal County deputies and the Oracle Fire Department worked

effectively together to evacuate six to eight homes in the

The fire was effectively contained by 7 p.m. It covered four acres in the John Adams/Paseo Encino/Cody Loop area. One home and several sheds burned down. The home was owned by Barbara and Ron Chatham. Six homes were impacted by the fire although damage was limited to their yards. Four of the homes were saved by the firefighters actions, two of the houses were saved as the result of following the Firewise program. The house that burned down did not have a defensible perimeter of 30 feet as recommended by the Firewise program. The home owners were new to the area and had been planning on using the program to clear brush around their home.

A power pole burned down and a gas meter was put out of commission when plastic parts melted leaving two homes without power or gas. Oracle fire crews remained on the scene overnight. Thirty-nine firefighters spent the night at the Mountain Vista gymnasium in case they were needed. On Friday morning crews were at the scene of the fire removing debris and uncovering hot spots underneath the rubble which were then doused with water. Firefighters remain on alert in the area including the Wildland Fire Crew out of Florence. The cause of the fire was investigated by Golder Ranch Fire Department and the point of ignition appears to be a small cotton

cloth with linseed oil. It was left out to dry on a line. It apparently ignited and hot embers fell on the nearby grass. The breezy conditions then accelerated and spread the fire. No other details were available.

During the fire, three fire fighters overheated and had to sit in an ambulance to cool down and rehydrate. Their blood pressure was monitored until it was felt they could go back on the line. There were no other injuries to firefighters or to civilian personnel reported. Oracle's Community Emergency Response Team (CERT) members brought bottled water and Gatorade for the firefighters. About five hours into the incident they delivered 27 pizzas to 75 hungry firefighters.

Fire Chief Southard said, "I am very proud of my crew. They did an excellent job! I am extremely pleased with the neighboring fire departments and agencies that came to help us and would like to thank them. I made a neighborhood tour with Bud Bristow this morning. We visited with the affected homeowners who indicated how appreciative they were for our efforts. I've heard nothing but praise for Oracle firefighters and CERTs. We've had a number of people come into the station today eager to get on the Firewise program."

Reporter's Note: As a witness to some of the firefighting, I was impressed by everyone's professionalism and the way the incident was managed. The tenacity of the

firefighters in fighting the fire was enlightening. Fighting a fire in 100 degree temperatures while wearing the heavy protective gear is demanding physically and mentally. Not to mention that these people put their health and lives on the line to protect our communities. If this isn't a wake up call for people in Oracle to be Firewise, I don't know what is. 
Elks plan Tri-Community happenings


