

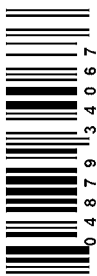

# ADOT reminds drivers to 'Pull Aside, Stay Alive' when encountering dust storms

PHOENIX – Coming soon: Spectacular sunsets and brief heat relief from monsoon moisture.

Also coming soon: Low- or no-visibility on roadways caused by dust storms.

Monsoon season is returning to Arizona and the Arizona Department of Transportation is reminding drivers how to stay safe on roadways when dust storms arrive.

ADOT's top tip: Do not drive into a dust storm. Towering, dense, blowing dust can drop visibility to zero, as if every motorist is driving blind. Just as dangerous are the small dust channels that can whip across roadways in an instant, affording drivers little or no opportunity to avoid them. In such events, ADOT has developed the following "Pull Aside, Stay Alive" dust storm safety driving tips, which can help travelers survive a storm.

- Avoid driving into or through a dust storm.
- If you encounter a dust storm, immediately check traffic around your vehicle (front, back and to the side) and begin slowing down.
- Do not wait until poor visibility makes it difficult to safely pull off the roadway – do it as soon as possible. Completely exit the highway if you can.
- Do not stop in a travel lane or in the emergency lane. Look for a safe place to pull completely off the paved portion of the roadway.
- Turn off all vehicle lights, including your emergency flashers. You do not want other vehicles approaching from behind to use your lights as a guide, possibly crashing into your parked vehicle.
- Set your emergency brake and take your foot off the brake.
- Stay in the vehicle with your seat belt buckled and wait for the storm to pass.
- Drivers of high-profile vehicles should be especially aware of changing weather conditions and travel at reduced speeds.

ADOT uses an array of tools to alert motorists to severe weather events that can impact travel, including posting messages on overhead signs, the 511 travel information line and social media. During dust storms, ADOT's Traffic

Operations Center staff is in constant communication with crews and law enforcement officers in the field, as well as partnering agencies, to keep current information flowing to travelers.

That information will improve soon. Later this year construction is scheduled to begin on a first-of-its-kind dust detection zone on Interstate 10 between Eloy and Picacho. The \$12.8 million project, funded in part by a FASTLANE grant from the Federal Highway

Administration, includes placement of multiple short-range dust-detection units between mileposts 209-219, plus one long-range unit.

# Statewide Fire Restrictions now in effect on State Lands

Phoenix - The increase in wildfire starts, coupled with hot temperatures and dry fuels, forces the Arizona Department of Forestry and Fire Management to go statewide with fire restrictions.

As of today, northern Arizona will now be under Stage 1 restrictions, to include, Apache, Coconino, Mohave, and Navajo counties.

Beginning at 0800, those northern Arizona counties will follow suit with the rest of the state. Restrictions on campfires, smoking and fireworks will be in place. Target shooting is never allowed on state lands.

“We are in the heart of fire season and heading into the midst of the Arizona summer. Nearly 20 wildfires are actively burning around the state today, resources are spread very thin, and we need to be proactive. We do not want another

Sawmill or Lizard in the state,” said State Forester Jeff Whitney.

With these latest restrictions, the entire state will now be under Stage 1 restrictions on state-owned and state-managed lands.

Restrictions apply to the following state-owned and state-managed lands within the above-mentioned counties including:

- All State Trust lands outside incorporated municipalities.
- All Game and Fish Commission Wildlife areas and department properties outside incorporated municipalities.
- All State Parks outside incorporated municipalities – State Parks will remain open with campfires allowed in developed campgrounds.
- All Department of Transportation highway, right-of-way property outside incorporated municipalities, not owned by federal land management agencies.

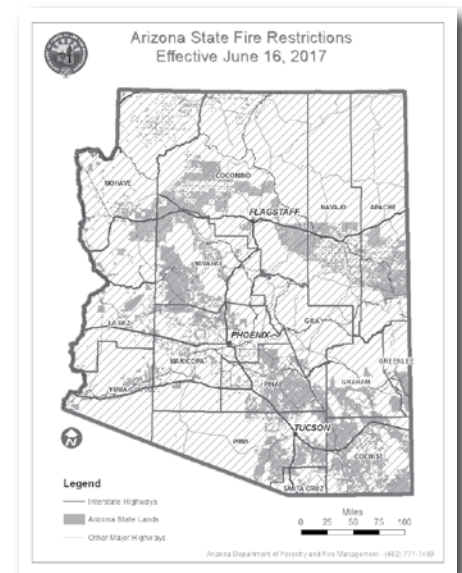
Restrictions include:

- Building, maintaining, attending, or using a fire, campfire, charcoal, coal, or wood stove, other than in a developed campsite or picnic area is prohibited. Exemptions include, a device solely fueled by liquid petroleum or LPG fuels that can be turned on and off. Such devices can only be used in an area that is barren or cleared of all overhead and surrounding flammable materials within three feet of the device.
- Smoking is prohibited unless it is within an enclosed vehicle or building, a developed recreation site/improved site or while stopped in an area at least three feet in diameter that is barred or cleared of all flammable materials.
- Fireworks or another incendiary device are prohibited.
- Welding or operating acetylene or other torch devices with an open flame is prohibited.

Exemptions include:

- Any federal, state or local law enforcement officer or member of an organized rescue or firefighting organization in the performance of an official duty.
- All land within a city boundary is exempted unless otherwise stated in a city ordinance.

All exemptions to these restrictions must be approved by the State Forester.



If local authorities have imposed stronger restrictions than those listed above, than the local restrictions shall apply.

These restrictions apply to all permit and lease holders and other authorized users of state-managed lands. These restrictions do not apply to private lands under ARS § 37-1303. Restrictions are effective at 0800 on Friday, June 16th, and will continue until rescinded.

# soap alternative leads sisters to form company

The White Bell Soap Company was started by two Oracle sisters, Diana White and Bethany Bell. The business offers handcrafted goat milk soap and soy candles.

"The company started as a fun and useful way to spend time together," said Diana White.

Both families have members with skin sensitivities. Bethany and Diana experimented with goat milk soap to successfully address the sensitivity problems. After years of trial and error, they were so thrilled with the results that they wanted to share it with others.

The White Bell Soap Company is a family affair with both families involved in the work needed to make their

products. Bethany has a herd of eight Toggenburg goats on her property in Benson, Arizona, four of which are in milk. The goats are milked daily by either Bethany or one of her sons, Partner age 9 or Preston 7. Testing is done by Diana, her husband Jason, daughters Rachel 6, Natalie 4, Bethany, her husband Jesse, Abby 3 and Marshall 10 months. Family members also help with processing, packaging and sales.

Goat's milk is renowned for its gentle cleansing and skin nurturing abilities. The White Bell Soap Company makes its soap through the "careful mining of goat milk, lye and oils." Raw goat's milk is blended with olive, coconut and castor oils as well as unrefined shea butter to create a simple soap that works. Their soap does not contain sulphates, phosphates, parabens or dyes. The soap comes in 20 different scents.

"We love our soap and you will too!"

Crafted soy candles are also available. The candles are made with 100% USA sourced soy wax and cotton wicks that are free of heavy metals or lead. Their soy candles typically burn twice as long as traditional candles. They are available in a variety of scents. Special orders are available.

# Sea Lions mark second win at home; Adrian Garcia named 'Beast of the Week'

The Sea Lions Swim Team hosted a swim meet in Mammoth against the Parkside (Florence Anthem) Piranhas on Saturday June 17. The Sea Lions won the meet with 981 points, while the Piranhas finished with 582 points. While the Piranhas won nearly half of the races at the meet, the Sea Lions outscored them with depth. Since the top 6 places score points, the battle for points took place in the trenches. There were approximately the same numbers of swimmers from each team, so the fact that the Sea Lions swimmers competed in all the events that they were capable of completing made a big difference in the final score.

The 11-12 Boys age group illustrates how the Sea Lions won the battle in the trenches. Parkside has some very good 11-12 boys, however in every event in the age group the Sea Lions finished 1st and 2nd, and in some races 3rd and 4th. The order changed as each Sea Lion showed their strength in different events. Mason Stewart (11), Joey Castellanos (11), Ethan Kellam (11), Adrian Garcia (11), Emerik Zovko (12), and Robert Sanz-Anton (12) all had top two finishes at the meet.

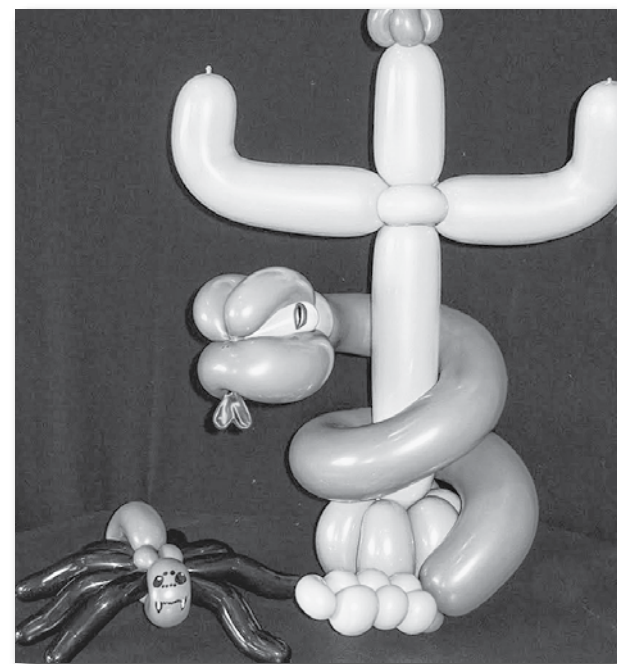
