# Truth in Taxation Hearing Notice of Tax Increase

In compliance with Section 42-17107, Arizona Revised Statutes, the Town of Hayden is notifying its property taxpayers of Hayden's intention to raise its primary property taxes over last year's level. Hayden is proposing an increase in primary property taxes of \$11.064 or 4.0%.

The proposed tax increase will cause Hayden's primary property taxes on a \$100,000 home to increase from \$808.00 to \$808.00.

This proposed increase is inclusive of increased is inclusive of increased primary property taxes received from new construction. The increase is also exclusive of any changes that may occur from property tax levies for voter approved bonded indebtedness or budget and tax overrides.

# HWUSD to lower tax rates for property owners

It's good news for taxpayers in the Hayden-Winkelman School District.

Hayden-Winkelman School District is debt free and will have lower tax rates.

Local property owners and business will get a happy surprise as they open their property tax bills this fall. On July 1, 2015, the HWUSD will make its final bond payment which will result in significantly lower property taxes.

"The District is very grateful to the

community and ASARCO for having the patience and support through these very difficult times," said Superintendent Jeff Gregorich. "Many times over the past two decades, we have faced enormous financial problems as a School District and community, but we overcame the challenge that I believe has only made us more resilient and committed to keep our school district open and strong for our children and theirs."

A.R.S. 15-905.01 requires any School District that budgets for the Small School Adjustment funds to publish a Truth in Taxation notice and hold a Truth in Taxation Hearing.

"The required notice leads the taxpayer to believe that their property taxes will increase," Gregorich said. "The truth is that while the total levy for the Small School Adjustment will increase in FY2015-16, the District's total tax rate

will not increase next year."

He added, "The small school adjustment has been levied for several years now and has helped the District continue to offer quality educational programs to serve our students and community. The additional funds allow small districts like ours, the ability to have the needed resources to operate our schools during ongoing state budget reductions."

# Truth in Taxation Hearing Notice of Tax Increase

In compliance with §15-905.01, Arizona Revised Statutes, Hayden-Winkelman Unified School District is notifying its property taxpayers of Hayden-Winkelman Unified School District's intention to raise its primary property taxes over the current level to pay for increased expenditures in those areas where the Governing Board has the authority to increase property taxes for the fiscal year beginning July 1, 2015. The Hayden-Winkelman Unified School District is proposing an increase in its primary property tax levy of \$ 141,964.00.

The amount proposed above will cause Hayden-Winkelman Unified School District's primary property taxes on a \$100,000 home to increase from \$140.21 to \$308.48.

These amounts proposed are above the qualifying tax levies as prescribed by state law, if applicable. The increase is also exclusive of any changes that may occur from property tax levies for voter approved bonded indebtedness or budget and tax overrides.

Athletic Department "Pay to Play" Put on Hold

Despite many schools across the state implementing registration fees for athletic programs at schools, the

Ray Governing Board decided to forego consideration of "Pay to Play" implementation next year upon the recommendation by Ray Athletic Director Jeff Cude. The discussion took place at the Governing Board meeting June 11.

A recent online survey indicated that 70 percent of respondents favored "Pay to Play" but only a small number of people participated in the survey, stated Cude, and "that's not enough respondents for making an informed decision," he said.

In its place, the athletic department will conduct 2 or 3 department-wide fundraisers to offset the loss of revenue Pay to Play would have generated for the program. A golf tournament is one fundraiser currently being considered in August at the Queen Valley Golf Course. More information on exact date, location and times will be shared as details develop.

# CAC facing cuts following vote to reduce tax levy

Pinal County, AZ – During a special meeting on June 9, 2015, the Pinal County Community College Governing Board listened to community concerns during a call to the public and discussed the tax increase passed in May.

The Board voted to reduce the tax levy from \$2.76 to \$2.30. This amount reflects a decrease of 46 cents to the CAC portion of the total county tax bill.

Since 2006, CAC has seen a reduction of 80% in state funding and has received no capital funding since 2008. Capital funds are used for new construction and renovation of facilities. CAC already faces at least \$43 million in deferred maintenance for its aging facilities. The College faces increased operating expenses each year.

With this vote to reduce the tax levy and budget, the College is forced to make difficult decisions on its priorities. The College is evaluating its most critical needs regarding facilities, technology and staffing.

#### 08-09 Free Blood Lead and Urine Arsenic Testing Offered

Cobre Valley Superior Clinic (CVSC) and the Arizona Department of Health Services (ADHS), is offering free confidential blood lead and urine arsenic testing to those eligible. Statistics will be shared with the ADHS and the Center for Disease control. Children up to 6 years and pregnant women living in high risk zip codes should receive a blood test. Urine arsenic testing will also be available for children 6 years of age or older who drink from a private well. Ask for a risk assessment questionnaire if living just outside of high risk areas. Lead poisoning can cause learning disabilities, behavioral issues and interfere with growth in children. Arsenic can cause gastrointestinal upset, skin changes, and kidney malfunction. # Kearny River Fire rages past Kearny; area receives national attention

Last Wednesday, phones started ringing and the town fire emergency alarm sounded. A fire was reported near the corrals in Kearny. What responders and residents didn't know was that this fire would grow quickly to be the first major fire of the 2015 fire season.

The Kearny River Fire at press time has burned 1,428 acres and is 80% contained. The fire damaged five structures and one vehicle; of the five structures, two were primary residences, one was an abandoned home and two were out buildings used for storage.

The fire skirted town along the Gila River and forced evacuations throughout the community. A Red Cross shelter was originally opened in Superior due to the proximity of the fire to the Ray School District where the shelter was originally going to be housed. The cause of the fire is still under investigation. There is expected to be an announcement later this week providing more information about the cause and ongoing investigation. The fire is believed to have started near the corrals and on the other side of the Gila River.

Residents came to the aid of the neighbors and helped to free animals at the corrals and surrounding areas. Thankfully there was a minimal loss in livestock and domestic animals; animals roamed free until their owners could gather them. Many neighbors tied goats to their trees to keep them safe from the fire.

The fire received statewide and national media coverage for the quick spread of the fire but also for the unique resources used to control the blaze such as the all women's hot shot crew from the Perryville Prison and the Copper Basin Railway who watered down the tracks and desert surrounding the tracks to help stop the fire.


Other agencies that assisted the Kearny Fire Department included: Bureau of Land Management, USDA Forest Service, Apache Junction Fire Department, Arizona Public Service, Arizona Department of Agriculture, Avra Valley Fire District, Canyon Fire District, Caminos Fire and Rescue, Eloy Fire District, Globe Fire Department, Golder Ranch Fire District, Havden Fire Department, Jerome Fire Department, Oracle Fire Department, Picture Rocks Fire Department, Pinal County Sheriff's Office, Queen Valley Fire District, Regional Fire and Rescue, Smithco, Superior Fire Department, Tri City Fire District and Winkelman Fire Department. The Arizona Department of Corrections also sent crews from Globe, Florence, Flagstaff and Winslow. The Arizona Rangers with Bill Lohr also assisted in traffic control and evacuation in the community.

David Ozell, who serves as the town's Public Information Officer, explained to the *Copper Basin News* that after an all agency briefing one of the primary comments was the improvement of communications and response time in this incident compared to the Shipman fire two years ago. "We have made many improvements," he said.

Residents are being advised to remain vigilant with the fire and also keep an eye out for wild life coming into town from the burned areas. Many animals including rattlesnakes have been seen in yards.

## Health effects of smoke from wildfires

FLORENCE - The Pinal County Public Health Services District is alerting residents in the Kearny and surrounding area about the health effects of ambient smoke from the Kearny River Fire.

Please take time to read the following information from the Arizona Department of Health Services.

Although a wildfire may be very far away, people should pay attention to ambient smoke.

Wildfire smoke is a mixture of small particles, gases and water vapor. The primary health concern is the small particles. These small particles can cause burning eyes, runny nose, scratchy throat, headaches and illness (i.e., bronchitis). They can also worsen chronic heart and lung disease (i.e., asthma, emphysema and COPD).

Avoid breathing smoke if you can help it. If you are healthy, you usually are not at a major risk from smoke. People at risk include those with heart or lung diseases, children and older adults.

The Arizona Department of Health Services has developed many materials to aid in preparedness and health concerns during a wildland fire. The brochure contains a color-coded scale that ties visibility to health impacts, as well as a list of things to bring if evacuation is necessary, including food, water, medical supplies, documents and identification cards, and pet supplies.

Use common sense to protect yourself and your family. If it looks smoky outside, it is not a good time for outdoor activities. It is also a good time for children to remain indoors. Use the following visibility guidelines to determine air quality conditions, identify health effects, and determine the exertion levels based on the visibility range:

#### Visibility Range: 10+ miles

Health Category: Good Health Effects: None

#### Visibility Range: 5-10 miles

Health Category: Moderate Health Effects: People who are usually sensitive should consider reducing prolonged or heavy exertion.

#### Visibility Range: 3-5 miles

Health Category: Unhealthy for sensitive groups

Health Effects: Sensitive people should reduce prolonged or heavy exertion.

#### Visibility Range: 1.5-3 miles

Health Category: Unhealthy Health Effects: People who are sensitive should avoid prolonged or heavy exertion. Everyone else should reduce prolonged or heavy exertion.

#### Visibility Range: 1-1.5 miles

Health Category: Very unhealthy Health Effects: People who are sensitive should avoid all physical activity outdoors. Everyone else should avoid prolonged or heavy exertion.

#### Visibility Range: 1 mile or less

Health Category: Hazardous Health Effects: People who are sensitive should remain indoors and keep activity levels low. Everyone else should avoid all physical activity outdoors

Generally speaking, the worse the visibility, the worse the conditions. To use the visibility guidelines, face away from the sun, determine the limit of your visibility range by looking for targets at known distances (miles). The visibility range is the point at which even high contrast objects totally disappear. This is not the point at which you can see the smoke.

People who are sensitive include those with heart or lung disease, older adults and children.

If you are advised to stay indoors, keep your windows and doors closed. Run your air conditioner, if you have one. Avoid using anything that burns inside, such as wood and gas stoves, candles and cigarettes.

Air filtration devices that use HEPA filters can reduce the level of particles indoors.

Do not use an air cleaner that works by generating ozone.

If you have asthma or other lung diseases, be vigilant about taking the medications prescribed by your doctor.

If you are supposed to measure your peak flows, make sure you do so. Call your doctor if

your symptoms worsen.

The same particles that cause problems for people may cause some problems for animals. Don't force your animals to run or work in smoky conditions. If your pet has heart or lung disease, follow the same visibility guidelines as for sensitive people.

irefighters came from throughout
Arizona to take on the Kearny River
Fire. I did my best to talk with some
of the crews, usually when they came back
to town to get water. Safford, Globe, Pine/
Strawberry. Florence, which sent a full fire
truck in case the blaze should enter the
town. All the crews were glad to chat. They
were covered with dirt and ash, and their
eyes looked raw. The heavy garb looked
very uncomfortable in the heat of the day.

An all-woman team came from the Department of Corrections in Perryville. All the men spoke about how good and how tough the women were. "They simply take the heat better than us," one firefighter said.

I am thankful for all these people. But I stand in awe of our own Kearny Volunteer Fire Department. They tackled the fire on behalf of their families, their friends. They have spent countless hours in training and

have superbly cared for their equipment. They left their jobs and families, quick as a wink, and rushed to don their garb and begin the fight.

At one point, I personally thought they might be winning. The initial black smoke was turning to a brownish-gray and the volume of smoke was down. But then there was a small, almost imperceptible shift in wind direction, and the fire popped south along the water treatment plant, then quickly roared around it and the southern perimeter of the town. You know the rest of the story.

And I am thankful for the Kearny Police Department and the Volunteers in Patrol. Chief Corso seemed to be everywhere at once. The police and the volunteers worked long and hard, day and night. It is difficult to manage an evacuation. People were deeply concerned for their lives and for their belongings, and tempers
