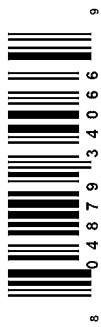

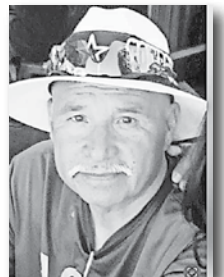
Raymond worked for the City of Mesa for 15 years and the Mesa Public Schools. Raymond enjoyed spending quality time with his family by cooking, grilling and

Veteran and artist creates mural on VFW Memorial at Superior Cemetery

A new mural has been created at the VFW Memorial at the Fairview Cemetery in Superior. The mural was the inspiration of Alfonso "Sonny" Cruz. Sonny, a Vietnam Veteran, has always shared great pride for his military service and the recognition of others who have served.

"Our hometown has been deeply affected by the consequences of war, as were our neighboring communities," he said.

Cruz has utilized art to reduce the symptoms of post-war Post Traumatic Stress Syndrome. Over the past several years, he restored a classic car as a tribute to his military service. The car features memorabilia as well as a history of his military service. He often displays the vehicle during the Dia de Los Muertos event in Superior and other car shows.

Another project is called the healing wall.

"The healing wall is a tribute to all branches of the armed services. The mural depicted is a visual representation and symbol of respect and appreciation for all comrades, friends, and brothers who gaucher for life and freedom," explained Cruz.

Cruz's latest project is coordinating a mural on the VFW Memorial at the Fairview Cemetery. The mural is being painted by Myron Starr of Peridot, he is the son of a Vietnam Veteran. A few local

veterans wanted to make contributions to the art work, and while Cruz had intended to fund most of the project himself including some support for Myron Starr, who agreed to volunteer his time and skills. After seeing the mural, more people suggested they wanted to be able to make donations.

Public Hearing Regarding Use of CDBG Funds



The Town of Superior is expected to receive approximately \$225,123.00 in FY23 federal CDBG funds from the Arizona Department of Housing Regional Account (RA). CDBG funds must be used to benefit low-income persons and areas, alleviate slum and blight or address urgent need. Based on citizen input as well as local and state planning objectives several potential projects have been selected to be forwarded to the State of Arizona with a request for funding. Graffiti removed from Devil's Canyon

In May, Natural Restorations received a grant from Resolution Copper to remove graffiti in Devil's Canyon and along Magma Mine Road. The Dedicated Restoration Team removed 498 square feet of graffiti for this project.

They removed graffiti that could be seen from your vehicle driving through the canyon, graffiti you could see when you stopped at the pull-off areas, and graffiti in the canyon not visible from your vehicle. They also removed graffiti along Magma Mine Road.

The Dedicated Restoration Team has removed 42,451 square feet of graffiti from rocks and boulders across Arizona. The team includes Nicole and Justin Corey, and three military veterans: Justin Ballard is a U.S. Air Force vet; Ryan Morin is a U.S. Army vet; and Garrett Cline is a U.S. Navy vet.

Natural Restorations is an Arizona-based 501(c)(3) nonprofit organization founded in 2015 by husband-and-wife team, Justin and Nicole Corey. They host volunteer events and contract military veterans for their Dedicated Restoration team. In addition to graffiti removal, they have removed over 1.5 million pounds of trash and replanted over 52,000 cacti, trees and plants in burn scars. They have provided over 16,200 hours of contract work in nature to the military veterans on their Dedicated Restoration Team across 130 projects and hosted over 100 volunteer events to get community members, including youth, involved.

A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF SUPERIOR, ARIZONA, SUPPORTING FREE APPLICATION FOR FEDERAL STUDENT AID. WHEREAS the Arizona Mayors Education Roundtable is a unique, nonpartisan, collaborative action group committed to achieving the statewide postsecondary attainment goal of 60 percent. According to the National College Attainment Network, one of the best indicators of postsecondary enrollment and persistence is completion of the Free Application for Federal Student Aid (FAFSA); and WHEREAS submitting the FAFSA often the first step in the financial aid process - provides students with opportunities to access federal and possibly state and/or institutional resources to pay for college and career training programs; and WHEREAS Arizona ranks 49th in the nation for the percentage of high school seniors completing the FAFSA. As of April 21, 37.4% of the 2023 high school class has completed the FAFSA (National College Attainment Network FAFSA @ Tracker), fairness is the foundation of the American system and reflects traditional American values; and WHEREAS, More than a dozen states have either adopted or are considering universal FAFSA policies that expand access to financial aid and help make college more affordable for students. These policies tend to provide support and options for students; include waivers, opt-out, and no-harm provisions; and obligate local education agencies to oversee implementation; WHEREAS, Seven states - Louisiana (2017), Illinois (2020), Alabama (2021), New Hampshire (2021), Texas (2021), California (2022), and Kansas (2028) - have adopted FAFSA completion, or a suitable alternative, as a requirement for high school graduation. The year after the state mandated financial aid planning for high school graduation, Louisiana's FAFSA completion rate increased 26%. High school graduation and postsecondary enrollment rates have also increased, and the state currently ranks second in the nation, behind Tennessee for FAFSA completions. NOW THEREFORE, BE IT RESOLVED THAT given the evidence and growing trend to require FAFSA completion for high school seniors, the Mayor and Town Council of the Town of Superior, hereby resolves to:

1. Promote the Arizona Promise Program and FAFSA completion resources.
2. Support FAFSA completion events and workshops in their communities.
3. Call upon the Arizona State Board of Education to make FAFSA completion a high school graduation requirement while ensuring that students are supported through the financial aid process and no harm comes to students who formally opt out.
