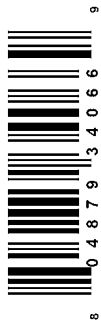

## **Resolution Copper to construct pump house as part of long-term water resource plan**

Resolution Copper is proud to announce a contract awarded to Oddonetto Construction, a contractor from Globe, to begin development of a pump house on Resolution Copper property in Superior.

Construction will begin Monday, June 1 and will take place on weekdays from 6 a.m. to 4:30 p.m. and is expected to last until early August. Part of the company's long-term water resource plan, the work will upgrade existing infrastructure that brings water from the Arizona Water Company and supplies to Resolution Copper's current facilities. Resolution Copper is working closely with Oddonetto Construction to safely construct the pump house. During peak construction, the project will employ approximately 16 to 18 local workers from the local Copper Triangle area, including the San Carlos Apache Reservation.

"With everything we do, safety is our first priority, and we are committed to performing this work safely, efficiently and with the needs of the community in mind," said project director Andrew Taplin.

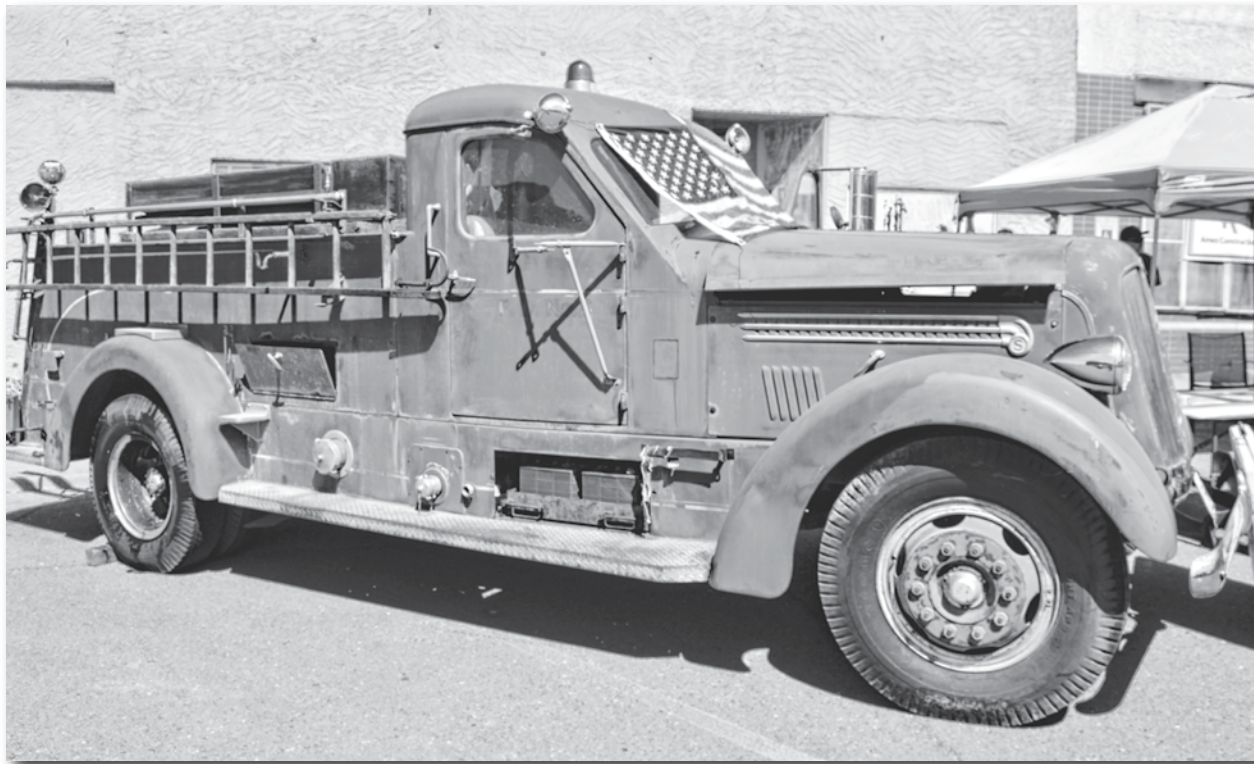
