Sea Lions open 2018 season

The Sea Lions Swim Team traveled to Parkside (Florence Anthem) for the first swim meet of the 2018 Summer Season against the other six teams in the Central Arizona Swimming League. The Sea Lions won the meet with 565 points, Parkside finished 2nd with 481 points, Coolidge finished 3rd with 249 points, San Tan Valley finished 4th with 181 points, Eloy finished 5th with 23 points, Florence finished 6th with 15 points, and Globe finished 7th with 11 points.

This is the most competitive that the season opener meet has been since starting with a League wide meet several years ago. The score was virtually even between the Sea Lions and Parkside after the Backstroke events (roughly halfway through the meet). The Sea Lions made the most of the second half of the meet with some great swims in the Long Freestyle, Breaststroke and Sprint Freestyle events to expand the winning margin to 84 points.

The Sea Lions have a group of 11-12 boys that finished 1-2-3 in every individual event. Joey Castellanos (12) won all

five individual events while teammates Johnny Smallhouse (11), Martin Madrid (11), Vicente Curry (12), Ethan Kellam (12) and Mason Stewart (12) added to the scoring. The boys took 1st and 3rd in both the Medley and Freestyle Relays, in a demonstration of their team depth.

Evan Apuron (14) and Riley Stewart (14) showed that they were the fastest two swimmers at the meet regardless of age group.

Tabitha Kellam (14) was the only Sea Lion swimmer at the meet that entered the maximum number of events and won them all. The Sea Lions 13-14 Girls were unbeatable; Tabitha was part of a strong team that included Rianna Estrada, Briana Castellanos, and Hannah Smallhouse. In every individual 13-14 Girls event, the Sea Lions finished 1st, 2nd, 3rd, and 4th. With the 4 best swimmers in the age group it was no surprise that both relays were easily won by a large margin.

This was the first swim meet for Athan Riekofski (10), Ethan Erickson (10) and Alyssa Riekofski (15). All three participated in all the events that they were capable of completing and earned ribbons.

Ethan Erickson was named Sea Lions Beast of the Week. He swam every event in his age group, which is a great goal for any first year competitive swimmer, but doing it at his very first meet ever was something special. Ethan swam against the best 9-10 year olds in the League and was fast enough to come home with individual ribbons in the Butterfly and Backstroke. Ethan also had to swim two legs in both the Medley and Freestyle relays with Athan because the Sea Lions were a little short handed in the 9-10 Boys age group at the meet.

Coach Alex Gort was pleased with the win.

"We had many very good swims and came on strong at the end of the meet when the other teams started to fade," he said.

AMR provides free CPR training

Thanks to AMR and the Oracle Fire Department, **Tri-Community members** are better equipped to save lives.

Late in May, local EMS provider American Medical Response (AMR), which operates as Tri-City Med, provided coaching to local residents, teaching them how to save lives through compression-only CPR. The event was part of AMR's nationwide observance of National Emergency Medical Services Week.

Compression-only CPR allows bystanders to keep life-saving blood flowing through a victim's body just by pressing on the chest in a hard, fast rhythm. Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

All drinking water for the Town of Mammoth comes from two active wells, Well #4 (55-651263) and Well #5 (55-801443)

Source Water Assessment Program (SWAP)

The ADEQ has completed a Source Water Assessment for the Town of Mammoth. Based on the information currently available on the hydrogeologic settings of and the adjacent land uses that are in the specified proximity of the drinking water sources of this public water system, the department has given a low risk designation for the degree to which this public water system drinking water sources are protected. A low risk designation indicates that most source water protection measures are either already implemented, or the hydrogeology is such that the source water protection measures will have little impact on protection.

You can help protect our water source by practicing good septic system maintenance, limiting pesticide and fertilizer use, and by properly disposing of hazardous household chemicals

Everyone can help young kids stay safe around water this summer

SAN MANUEL (June 4, 2018) – Pool weather and summertime go hand in hand. Especially since pools are everywhere—in your backyard, apartment complexes, neighbors' homes. As the weather gets warmer, more and more families are using their pools or attending pool parties.

But along with water fun, water safety should also be top of mind, considering the reality of tragic headlines associated with unsupervised young children around water, such as the recent case of a 4-year-old Peoria boy who drowned after using chairs to open a pool gate. These incidents are terrifying, and First



Things First encourages all adults to play a role in watching young children around water and helping them stay safe this summer.

The Drowning Prevention Coalition of Arizona has three main safety tips for parents and caretakers of kids under 5 around water: block, watch and learn.

Block

- Make sure your pool and/or spa has an effective barrier, such as a fence to help guard against unauthorized access.
- Your pool or spa should have a barrier regardless of whether they are covered.
- Door and windows leading to the pool areas should be locked.
- Fence gates should have self-closing, selflatching mechanisms. Latches need to be out of reach of young children.

Watch

- Never leave your child unattended in or near any water source such as a swimming pool, hot tub, spa, bathtub, water-filled bucket, pond or canal. Not even for a second.
- Keep toys, tricycles and other children's play things away from the pool or spa.

- Don't consider your children to be
- "drownproof" because they have taken swimming lessons.
- Don't allow barriers, such as fences or walls to give you a false sense of security regarding your child's safety. There is no substitute for adult supervision.

Learn

- Learn how to administer CPR, mouth-tomouth resuscitation and other lifesaving techniques. To administer CPR correctly you must be properly trained.
- Know how to contact your local emergency medical services. Keep a cellphone handy. Post the emergency number in an easy to see place.
- Learn to swim and teach age-appropriate children to swim.



Michael Reddish and Jeff Egan trained the Girl Scouts of Camp Whispering Pines. The Girl Scout leaders were trained in how to safely facilitate a low ropes course. The ropes course is designed to build courage, confidence, and teamwork but can be dangerous if not used properly. Mike and Jeff went through each element with the Girl Scout leaders and taught them about facilitation, safety, and bringing out the confidence in these young scouts.

They built this ropes course in the Forest

Service several years ago. It was one of the first ropes courses built in Forest Service land in the entire USA! They used special fittings, sterilized drill bits, and only local mulch to strengthen the health of the trees and forest they were building in.

Several of the girls were trained last year and helped to lead in building confidence and strength in the leaders who will be conducting these activities. Mike and Jeff both felt that this was the strongest group of Girl Scout leaders yet and everyone is very excited about the upcoming summer.



The culmination of the low ropes course is 'The Wall' where the entire group must make it over the 12-foot high wall.
