Icymae Stearns Lawson

Icymae Stearns Lawson died Tuesday morning July 7, 2015, at the Gold Canyon Hacienda Assisted Living. She was the beloved wife of 65 years of Merle Lawson (deceased in 2012) of the Lawson family in Dillon Beach, CA; mother to Gloria Duby (husband Albert W. Duby) of Putney, Vermont, and Nancy Vogler (husband Carl W. Vogler, Sr.) of Superior, Arizona; grandmother of five and great-grandmother to seven.

Icymae was born in 1925 to Charles and L. Gertude Stearns in Wirt, Oklahoma. Her dad was an oil field worker and she grew up in the oil fields of Oklahoma and Illinois. In 1940, her family moved to Pomona, California. After the war she attended the University of California in Davis in the fall of 1945 and came to

Dillon Beach where she met Merle who had recently been discharged from the US Navy. They were married in 1946, working the Lawson Ranch at Dillon Beach and then starting Lawson's Landing in 1956. They retired to Arizona in 1988 making their home first in Florence and then in Casa Grande where they golfed and traveled. But they always came back to the Landing for their summers of fishing and clamming and fish stories.

Icymae loved to read and travel and spent many vacations fishing and camping in Mexico as well as several world cruises with her husband. She was a wonderful homemaker and great cook as well as a woman of high integrity and honesty. Even throughout her last 10 years fighting Alzheimer's,

she always maintained her ready smile and pleasant ways.

At her request, no services will be held but her ashes will be spread at the mouth of Tomales Bay where she caught many salmon with Merle.

Superior Council learns more about 'Save Oak Flats' group



It was standing room only at a special meeting of the Superior Council where a documentary about the group Save Oak Flats was introduced.

It was standing room only last week as a crowd attended a July 9 special meeting of the Superior Town Council to hear an update on the Rio Tinto legislation and some of the concerns of the people wanting to save Oak Flats. Mayor Jaime Valenzuela made it clear at the onset of the meeting that the presentation was for information only; there would be no rebuttal and no call to the public. Former Mayor and long time superior resident Roy Chavez spoke and introduced some of the people in the audience.

A preview of a documentary film, American Battle Cry, directed by filmmaker Ezekiel Kelly was shown. The film is about the fight to save Oak Flats. It talks about the concerns of environmentalists, the public and Native American tribes for whom the Oak Flats area is sacred and a large part of their

culture. One scene was shot from a drone over the San Manuel mine, which showed the craters and fissures that are left by using the block caving method of mining.

Roger Featherstone gave a brief update about ongoing efforts to save Oak Flats. Roger talked about a bi-partisan bill that has been introduced in Congress to repeal the federal land exchange portion of the defense bill that passed last year. He said that the Tonto National Forest helped the San Carlos Apaches nominate Oak Flats for the National Register of Historical Places as a traditional cultural property. Oak Flats has been named as one of 11 of the most endangered historical places by the National Trust for Historic Preservation. One of the other endangered sites is the Grand Canyon.

Roy Chavez said, "It ain't over" when speaking about the fight to save Oak Flats. "It's much greater than Superior;

Superior's Lopez throws one-hitter in tournament opener

Superior Little League Senior Softball pitcher Ivie Lopez threw a one-hitter in her team's five-inning 11 – 1 victory over higher-seeded Blythe on July 13 in the first round of the Senior Softball Arizona State All-Star Tournament, which is being played at the Copper Sky Recreation Center in Maricopa.

Coming up with glittering performances in big games is nothing new for Lopez, a member of the 2015 state champion Superior High School softball team. She was the winning pitcher in the Division IV state championship game, throwing a four-hit complete-game shutout against defending back-to-back champion San Manuel in the Panthers' 3 – 0 victory.

The Superior LL Senior Softball Team

defeated Maricopa on July 3 to win the District 4 Championship and earn a berth in the state tournament. Superior, the No. 5 seed, is one of four teams vying for the state championship along with Blythe, Sunnyside, and Queen Creek.

Blythe is the tournament's highest seeded team at No. 2. Queen Creek is a six-seed and Sunnyside is No. 14.
