Mayor Offers State of the Town of Kearny

irst and foremost, allow me to thank everyone for making the efforts to stay safe and use your God-given ability to make good decisions in preserving the safety and welfare of yourself and your family.

The Town Council decided to forego attempts to push limiting regulations onto the residents of Kearny, and instead, placed trust and faith in the good people of this unique community. Rather than imposing limiting restrictions on how you choose to live your lives, we decided to stay out of your business, stay away from limiting restrictions, and give you the ability to live your lives as you decide.

Data from the Arizona Department of Health Services (ADHS) website

shows cases of COVID in Kearny's zip code; however, the data shown can be misleading. The problem is Kearny's zip code includes the town limits and large areas outside the town limits, including Kelvin and Riverside. As of Thursday, July 9, there are 19 positive COVID cases in the 85137 zip code, and 13 positive COVID cases in Kearny town limits. Ten of the positive cases were reported within the previous week. This suggests people are failing to make physical distancing a priority.

When people ask me how we are keeping the community safe, I advise them: keeping yourself safe is your responsibility. I advise them: follow guidelines from the Centers for Disease Control (CDC). I advise them: avoid gatherings of people, maintain physical distancing, and the best practice is to stay home. Many positive COVID cases in Kearny include people that participated in large group gatherings.

Keeping yourself safe is your responsibility, and not the responsibility of government.

The COVID situation adversely impacted every city, town and state in the United States. While Kearny's budget has been tight for years, the unpredictable streams of incoming revenue from the COVID situation made the reality more alarming. Reduced amounts of incoming revenue forced the Town to create two separate and different budgets for the new fiscal year. One budget reflects slightly lower income, while another budget reflects significant reductions in revenue caused by COVID. The result of COVID economics may be an alarming reduction in the Town's revenue in future budgets, and with that, a reduction in the Town's capacity to provide the same services expected in prior years.

Rather than painting a misleading picture of idealistic images, I choose to disclose the harsh reality to the residents of Kearny. COVID had not been kind to the Town of Kearny's budget. Spending to support the Kearny Ambulance has created a financial hardship for the Town.

I have made many hard decisions and advocated many unpopular positions during my years as Mayor. Any reputable application of leadership, especially genuine and transparent leadership, often requires disclosing the "hard to swallow" reality of difficult and painful situations, rather than painting idealistic images of rehabilitated lakes, community movie nights, and other "feel good" things.

When people ask me where I am each day, I advise them I am at Kearny Town Hall nearly every day, working with staff to ensure the priorities of the Town are sustainable. Rather than knocking on doors, I instead choose to follow the guidelines for the Centers for Disease Control (CDC) and avoid unnecessary contact with people during this pandemic. I choose to respect the safety of the residents of Kearny.

Throwing money into rehabilitating Kearny Lake cannot be a priority. The Lake is defectively designed. The water inlet and outlet are too close together, which doesn't allow water to circulate, which prevents the circulation of oxygen throughout the Lake. Installing aerators at the Lake is a very short-term and cosmetic solution that

would last only a few short years. Aerators are expensive, and aerators don't resolve

algae blooms or high concentrations of

Total Dissolved Solids in the water. Kearny Lake has a history of golden algae blooms. Golden algae prefer saline water, which makes Kearny Lake a perfect breeding ground for this strain of algae. Golden algae are renown for killing fish. The algae, coupled with Total Dissolved Solids in the water, cause fish to asphyxiate. The expense of stocking the Lake could quickly result in an even more expensive clean-up process to remove dead fish.

Even if water from an outside source was pumped into Kearny Lake, high concentrations of Total Dissolved Solids cannot be abated. It is a common feature of groundwater pumped from wells in the Arizona desert. Fortunately, Kearny maintains an efficient filtering plant that provides clean water to residents: a filtering plant that will soon undergo scheduled evaluations, system analysis and upgrades; and a filtering plant that will never have the output capacity to meet the water demands of Kearny Lake.

A short-term, cosmetic solution to the problems at Kearny Lake is estimated to cost nearly \$500,000. A longer-term, more permanent solution, is estimated to cost nearly \$1 million. No grant funding program can be expected to award the Town half a million dollars for a short-term solution that cannot be sustained for more than a few short years. Promises of securing such grant funds are unrealistic. Respectfully Submitted,

O'Halleran hosts town hall – K-12 education and COVID-19

On Monday night, Representative Tom O'Halleran and Joe Thomas, president of the Arizona Education Association, hosted a telephonic town hall to discuss COVID-19 and what it means for K-12 education.

He opened the Town Hall with comments about current legislation, CARES Act funding and the new HEROES Act that members of the House have approved and now awaits Senate approval.

Thomas also spoke about his background, growing up in rural Oklahoma in towns much like those in the Copper Corridor.

Both men spoke on the loss of Hayden-Winkelman teacher Kim Byrd, expressing their condolences to the family and to her students.

Mrs. Byrd's death from complications of COVID-19 and the revelation that she shared a classroom this summer with two other teachers, who also contracted COVID-19, while teaching online summer school has garnered national attention. On Monday, according to the Arizona Republic, President Donald Trump was asked during a news conference about Mrs. Byrd's death and how he would respond to parents who are worried about sending children back to school. His response was to say that the schools need to be opened. He did not speak about Mrs. Byrd. Currently, Arizona schools will be going back on Aug. 17, per Arizona Governor Doug Ducey's Executive Order.

Following the opening remarks by O'Halleran and Thomas, the phone lines were opened up for questions from those attending the teleconference.

David, a school board member from an elementary school district was concerned about obtaining proper PPE for teachers and funding for school districts.

Kathleen, a parent from Winkelman, expressed her concern about the lack of technology for rural schools. Students are being left behind, she said.

Beatrice, who is the mother of a third grader, was concerned about sending her son back to school. What measures are the schools taking, she asked. There is only one teacher for a whole bunch of kids but no teacher's aides.

"They need more workers in the schools," she said.

Thomas agreed.

"We absolutely need more teachers," he said. Arizona, he added, has the highest student to teacher ratio in the country.

Parents demand better and kids should have a quality educational experience, he

Rep. O'Halleran said that looking at business and industry response to COVID-19 shows that they had to hire more people to allow for social distancing, checking temperatures, etc.

Schools, he said, had to set the same protocols as businesses and industry.

"We will overcome this," he added, "through the strength of the American people."

Superior Mayor Mila Besich also attended the town hall meeting. She expressed her concern that in the ongoing rush to open schools, rural school districts were being left behind.

Rep. O'Halleran thanked Mila for being on the frontline of rural communities. He spoke about the HEROES Act, which he was urging the Senate to approve. Provisions in the bill would provide more funding to rural communities in this time of COVID-19, especially for broadband services to aid districts with distance learning.

"It can't be done on the cheap," he said. Thomas said that the government needs to make sure that all the schools are

included.

The final question for the meeting came from a teacher, Suzanne, who wanted to know what happens if a teacher tests positive for COVID-19.

Her fellow teachers, she explained, are "very nervous about returning to the classroom."

Social distancing is hard. Masks aren't required. Temperatures won't be taken and even if they are, she said, a lot of parents have no qualms about giving the child a Tylenol and sending them to school.

"Will teachers have protection (for their income) if they become sick?" she asked. Unequivocally, O'Halleran stated,

"Teachers are essential workers." Congress is working on a bill to officially give that status to teachers and childcare workers. As such, they will have protections in the form of unemployment payments in the likelihood that they become ill.

Thomas said that the Arizona Education Association has several advisories on their website (ArizonaEA.org/coronavirus) that addresses these concerns for teachers, including extra time off for being sick,



ASARCO resists, won't terminate new permanent hires

Last week, Copper Area *News* reported that the **United Steel Workers** closed the picket lines and that the striking workers

The letter also indicates that ASARCO believes that the courts will rule in their favor, that the company has negotiated in good faith to an impasse and that this strike was solely based on economic conditions.

AIA announces delayed start to fall sports season

As the increasing number of COVID-19 cases makes Arizona one of the worst hot spots in the nation, the Arizona Interscholastic Association announced last Friday that the high school fall sports season will be delayed up to three weeks.

The AIA's preliminary plans to make modifications are in accordance with Governor Ducey's executive action to delay the start of in-person schooling until Aug. 17, which will serve as the start of the AIA fall season, at least for now.

In an email to media members, AIA Sports **Information Coordinator** Seth Polansky wrote, "plans are in place to finish all fall sports seasons on time and in full with modifications. Some of these ideas, among others, will be taken to the leadership of each conference," before adding "nothing is finalized yet."

According to the email, football in the 2A-6A conferences would play an 8-10 game schedule, commencing on Sept. 7, three weeks later than the original Aug. 21 start of the season. 1A football, which includes Copper Area schools Superior, Hayden, Ray, and San Manuel, "is currently looking at modifications, if necessary."

Golf and badminton would start Aug. 24 and Aug. 31, respectively. All other fall sports would

begin the week of Sept. 7. One idea being floated

around social media to prevent a complete cancellation of the fall season, if necessary, is moving some fall sports, including football, to the spring.

That is not an option, according to AIA Executive Director David Hines.

"It doesn't make sense for us to look at that because there's a lot of other things going on that kids are involved in activities," Hines said in a Q&A video posted on YouTube. "Another piece of that is coaches; not all of our coaches are teaching at the schools. When they are hired to coach a sport, they're hired to coach a particular season. They [may not] be available at a different time during the season."

Hines estimated that he

has been a part of 100 meetings since schools closed in mid-March, as plans have changed and changed again.

"This thing is moving at such a pace that every time you think you might have a plan a new day comes about, and we have to rethink the plans that we have," he said.

Superior Principal Billy Duarte is an AIA Committee member who has been involved in those meetings and can attest to the ever changing discussions taking place about moving forward amid the pandemic.

"Nothing is set in stone because of all the variables," Duarte told Copper Area News, echoing Polansky's words in the email.

San Manuel Athletic **Director Damon Lovato** acknowledged the

anxiety of the unknown among student-athletes, parents, coaches, and administrators, but believes the AIA has been as transparent as it can during these unprecedented times.

"The AIA has been very good at communicating with the schools throughout this whole process," he said. "They've been very clear about where we stand."

Some schools, mostly on the reservations, have already cancelled their entire fall sports seasons, causing other schools to scramble and find replacement games. The AIA will assist those schools in finding alternate games if the decision is to reschedule other opponents. Teams whose

schedules are affected may simply play a reduced number of games. Nothing is off the table regarding scheduling as a result of the delay.

For those wondering about fan attendance whenever competition resumes on fields and courts, Hines addressed the subject in the YouTube video.

"That's a governor and CDC decision," he said. "Bottom line is Governor Ducey and our state has a planned approach, a phased approach to kind of coming back to some type of normalcy.

"Currently, we are in Phase I. Phase II allows groups of up to 50 then in Phase III it opens up where now you can have

One Copper Corridor family is taking that painful journey.

Jax Ethan Formo was born on April 17, 2020 to Hyrum and Camille Formo, weighing 7 pounds, 8 ounces. He has a very proud big sister, Madelynn Odelia Formo.

On Thursday, May 28, Jax was admitted to University Medical Center in Tucson and then was transferred to Phoenix Children's Hospital. He has been diagnosed with Williams Syndrome which is a rare genetic disorder that can cause a wide variety of health issues and developmental delays. In Jax's case, it has caused severe heart problems; left coronary ostial stenosis and heart failure. Jax is awaiting a heart transplant.

Jax has undergone several surgical procedures but with Williams Syndrome, anesthesia tends to alleviate bad reactions thus Jax is always high risk. Currently, Jax is stable, placed with a ventilator, a feeding tube and is being sedated to help keep him from not moving too much and also keep him comfortable.

"We pray a healthy, strong heart is gifted to our little boy. Pray it comes to Jax very soon and we can move towards his recovery," his grandmother, Laura Lopez said.

Jax is listed at level 1A, the highest level due to his condition.

Currently, because of COVID-19, the family and friends of Jax cannot plan any type of tournament because of disallowing large gatherings. Instead, the family has organized a raffle. The family's permanent residence is in Oracle and monies would assist in travel, lodging, meals, etc. during Jax's stay at Phoenix Children's Hospital.

more people involved," he continued. "Those decisions will be based on the current numbers in Arizona, the current numbers going on around each county because our schools are really encouraged to pay attention to their county health departments across the state. That will really dictate if we're going to be able to have some fans around."

Hines understands the importance of competition for student-athletes, including the mental aspect of it. Of course, the unfortunate experience of the absence of the spring championship season is still fresh in everybody's mind too. Still, the No. 1 priority remains the safety of the students.

"It is our intention that everything we can do to have the opportunity to participate and compete, we're going to be able to do that with the understanding that the governor sets the priorities of what we can and can't do," he explained.

There remains concern among some coaches about the difficulties of

overcoming the challenges this pandemic presents in a return to playing.

"I am concerned," Superior football head coach Ryan Palmer said. "We can set any guidelines and precautions we want, but the reality is that it is hard to social distance in schools and in sports.

"My current understanding is that the more time that passes, the more knowledge and guidelines will be available. I hope our student-athletes, especially the seniors, get to play this season. They are dedicated and work hard. I know they want a chance to showcase their talents and abilities on the playing field."

It should be noted that any proposed modifications by the AIA for the fall season are contingent on students being schooled in-person sooner rather than later, which is a hotly debated topic the Copper Area is all too familiar with. What if schools do not re-open?

"That takes us right out of the mix," Hines said.
