

LETTER TO THE EDITOR

'Modest' compensation?

Thanks to the Miner and John Hernandez for reporting on Pete Rios' statements about Bloom Dispensaries at the July 2 Pinal County Board of Supervisors meeting. The statements made by Supervisor Rios and the response by Bloom's CEO indicate to me that this proposed dispensary operation is, at best, suspect as a legitimate medical establishment.

Bloom responded that handing out an eighth of an ounce of marijuana was a "modest" compensation for testifying at the meeting, given that a patient's monthly


allotment is 50 times that amount. In other words, a monthly allotment of the medicine they are offering to an individual patient would cost over \$2000 and would amount to over four ounces. That's a lot of reefer for one person to consume in a month, and certainly not affordable for the typical Pinal County patient.

Claiming that the handout was modest compensation is an invalid argument, especially for a medical establishment.

Comparing this compensation to political parties offering rides to the voting centers is also an invalid argument. No political party has ever paid me to vote, even if they offered me a ride. And certainly, I can think of no other medical lobby that would provide drugs in combination with a free ride to physically go somewhere to testify about a particular drug interest.

Bloom's CEO needs to clear his head, and several of the other Pinal County Supervisors need to reconsider what sort of establishment they have inflicted upon the the community of Oracle.

LETTER TO THE EDITOR

Leading by Example?

I constantly hear how bad the Obama Administration is because of all of the scandals and I certainly agree that former President Jimmy Carter's legacy as the worse President in history is in jeopardy but I don't think that's the real story here. I think the real story is that we accept scandals so easily and believe this kind of behavior is normal. Let me briefly explain what I mean by recounting an incident that happened to me in recent months. This story is true and from my forty-four years of experience in education I think it is more common than one might think.

In March I resigned, as Business Manager, from the Cobre Valley Institute of Technology which serves Globe, Miami, Hayden, Superior, and San Carlos. I told the Governing Board that I would not compromise my credibility by continuing to work in the School District. (Strangely, they never asked what I meant by that statement.) There were a number of issues that brought me to this point but one in particular crossed a line I could not tolerate. An employee was paid \$2,121.00 out of a Federal Program for supposedly overseeing the implementation of a grant for three of our member Districts. The problem was that this employee was not entitled to this money and the Superintendent knew that prior to approving payment.

The following information should clarify this point.

The employee's regular job description already covered overseeing Federal Projects. This meant that the employee was paid twice to do the same job.

There was nothing in the Federal Project that authorized the payment this employee.

The Superintendent, Pete Guzman, was told repeatedly, by me, not to make the payment because it was not a legal expense and he authorized the payment anyway.

Outside Auditors determined that the payment was an "ineligible expenditure" and stated in the exit report that the stipend may have to be paid back to the State. They also said that the employee's documentation of work performed was "not complete and approved".

I made a request to the Board President to place this item on the agenda because the Superintendent, Pete Guzman, refused my request. To his credit the Board President put the item on the agenda.

At a regular meeting of the Governing Board they refused to do anything about the situation and simply killed the matter by voting on the Superintendent's recommendation to table the issue.

The Department of Education has been looking into the incident for some time but there has been no indication that they want to get involved. Their position is that the amount is too small to worry about. They don't seem to be too concerned

with the moral or legal implications. The last I heard from the Arizona Department of Education is that they can't find any information on the Audit. I'm not joking.

Throughout this entire ordeal I was made to feel that I was the problem. I was given the impression that I was making a big deal out of nothing and it would all go away if I would just shut my mouth. It was clear that if I wanted to continue to be a part of the fraternity then I needed to get in line with the Superintendent and Board. I was told that this was a distraction from all the good things that we were doing. In short the, "end justified the means ".

Is all of this a bit strange or I am going crazy? These folks are your neighbors, friends, and relatives. They are just like you and I, except they chose to condone something they knew was wrong. There

was not one good reason for them to allow this to happen! Doing the right thing would have been so easy but for some reason they decided to ignore the problem. How can they have so little regard for the truth? How can they be so much like the Obama Administration?

Dreams come true for former Hayden baseball player

Ever since he was five years old, former Hayden High School baseball player Hyrum Formo dreamed of playing professional baseball. After graduating in 2010 from Hayden and playing for Pima Community College in Tucson, Formo was selected in the 27th round by the Tampa Bay Rays organization in the June 2013 Major League Draft.

Formo, a pitcher, is in his second minor league season with the Rays. He started this season playing for the Rays' advanced rookie league team in Princeton, West Virginia. In four starts so far this season, he is 1-0 with 15 strikeouts in 17.2 innings pitched. His strikeout to walk ratio is a remarkable 15 to 1.

Reaching the major leagues took more than talent for Formo, who was throwing in the low 90's in high school (he throws in the mid 90's now). Typically, a high school player who throws that hard should have no trouble attracting college recruiters and team scouts, but that was not the case for Hyrum. It took hard work, determination and perseverance to realize his dream.


"I was that kid did well and everything," Formo said.
"I wanted to go on (and play at the next level) but there wasn't anyone around to see me play. I just had to go on and do it myself. I didn't quit."

Formo credited his parents for his success. His father, Robert, coached him throughout his youth. Along with Julie, his mother, the couple would travel most summers across the country so Hyrum could participate in tournaments and play competitive baseball. As expected, his parents "are very, very proud" of his accomplishments.


"I think they deserve everything in the world," Formo said about his parents. "If it wasn't for them I wouldn't be where I'm at."

Playing professionally is a dream come true for Formo. He knows it's not easy to play in a small town and get recognized. He believes there are several local area players who deserve a chance to play at the next level. Hyrum says he returns home when his season is over and has spoken to local coaches about his willingness to work with kids and share his knowledge.

"I want to help the kids (in the Copper Corridor)," he said. "I want to help out those kids who want to make it to the next level."



Oracle boys ranch to be converted to holding facility?

The Sycamore Canyon Academy located next to the Peppersauce Canyon campgrounds may be housing unaccompanied illegal immigrant children for the Federal Government. The academy is part of Rite of Passage, a national provider of programs and opportunities for troubled and at risk youth from social services, welfare agencies and juvenile courts.

The Pinal County Sheriff's Office stated Monday that it had received information that 40 to 50 unaccompanied alien children are to be sent to the facility. Pinal County Sheriff Paul Babeu shared the information with the public at a political rally which included some members from the town of Oracle. The Sheriff has said that he has major concerns from a public safety standpoint about the facilities capacity to handle the incoming migrants.

Ike Shipman, Program Director at Sycamore Canyon Academy, in a statement to the Miner said:

"Sycamore Canyon Academy, at the urgent request of the U.S. Department of Health and Human Services, Office of Refugee Settlement (ORR), will provide safe and temporary care to a small number of unaccompanied youth from Central and South America. These children will be temporarily placed at the campus by

the ORR until they can be properly placed with an appropriate sponsor or repatriated to their home country. Sycamore Canyon Academy is working closely with the federal refugee program and appreciates the support we have received for this humanitarian effort.

"Sycamore Canyon Academy is not taking a position on the immigration debate in any way. We believe it is for others to decide. Our mission is to improve the lives of youth, and we will continue to fulfill our mission by focusing on our work with children.
