this foundation of our teaching I have the ability to tell you the truth. So with great respect I share with you this

First, Yes our Apache people were a nomadic group of people who traveled by clan to harvest seasonal food.

Second, change came, boundaries were drawn and a year of exploring our earth revealed that rich copper and more land was taken. Now we live within what is 1.8 million acres that was cut down drastically. Much, much change has occurred for the good and the bad. Boarding schools began to break up the family bond, re-location to employ our people in the urban-environment. In the midst of all this change, grandmother reminded us not to fear but to cling close to God that our worship to protect what our culture and tradition has already laid out; our own foundation. To keep up with change, stay in school, keep away from people who may mislead you for their own gain and rob you of your way, prayer and dance. Be aware of what alcohol abuse could lead to and it will destroy you! Today we see that drug abuse has already destroyed many of our beautiful people.

Third, Tribal government established another change which included a political agenda. Real issues facing our tribe or made up issues inspired by false information from our own tribal members who make a living on destroying and hunting people with their words. Another change that is highly influenced by money and special favor, this always keeps a one sided picture. Our tribal members face money concerns within the boundaries of our homeland. This is why I am taking the steps to clarify and make my statement that Oak Flat has no sacred significance to our Apache people. Yes, Acorn can be harvest there among many other areas on and off the reservation. Oak Flat does not influence nor determine the outcome to our on-going battle against our social ills, drug abuse, alcohol abuse, unemployment, housing issues, crime issues and education issues. I support the quiet elder members who have said "Oak Flat is not sacred. There are no sacred songs or sacred prayers that say Oak Flat is a Holy Place". These very elders also ask "Why is there a Holy Ground over there, WHY? That is not good".

Fourth, it has been said many times we are reminded by the statements that come from our sacred sweat that "Change will ultimately happen". Along with that statement, a true warning is also said "Do not let this change make you crazy!" Protect the sacred core of our people, culture, tradition, language. Protect our livelihood so that we continue to be strong and to welcome change

I am a daughter to our creator God. I am a daughter to my parents who co-created this gift to my family as mother and grandmother. We must continue to let honesty generate peace, to let courage promote fairness and to keep praying for unity. So be mindful of respecting each other's uniqueness as we welcome others hand of

# Arizona Department of Health to host open house on July 9

Superior - The Arizona Department of Health Services (ADHS) will be holding an Open House from 3 p.m. - 6 p.m. on Thursday, July 9 in the multipurpose room at JFK Elementary School, 1500 Sunset Dr. in Superior, 85173, in order to raise public awareness on receiving free lead and arsenic tests.

ADHS will be offering free voluntary lead testing for up to 50 residents of Superior. All residents that are 0-6 years of age, and, pregnant women, are welcome to participate.

The free testing event will be held at the Superior Clinic on Friday, Aug. 7, and Saturday, Aug. 8, from 9 a.m. - 4 p.m. Residents will have their blood drawn by the phlebotomists provided by Superior Clinic/Cobre Valley Medical Center. Residents, six years of age or older, will have an opportunity to have their private well water and urine samples analyzed for heavy metals through ADHS' Biomonitoring project.

The biomonitoring project is part of a four state consortium (with Utah, Colorado, and New Mexico) summary statistics will be shared with them, and with the CDC.

All participants will receive a letter with their test results and, if necessary, recommendations for reducing exposures. ADHS representatives will be available to speak with participants about their results. Names, contact information, and test results will be kept confidential.

# Kearny River Fire deemed suspicious; PCSO seeking tips from public

The Pinal County Sheriff's office is still taking tips regarding the Kearny River Fire. Last week in a press release issued by PCSO, it was announced that the 1,400-acre blaze was suspicious in nature and human caused.

At this time no arrests have been made and the fire remains under investigation.

The blaze burned for three days and forced the evacuations of 300 Kearny residents. Five structures were lost early on in the fire. There were no major injuries.

"We believe the fire was started near the livestock corrals in the northwest part of the town," Sheriff Paul Babeu said. "At this point, we have ruled out accidental causes for the Kearny River Fire and are now looking at who was seen in the area when the fire started."

State and local fire crews are still monitoring remains of the fire and say it is 100% contained.

# Oak Flats nominated as sacred site

During late 2014, the officials within the Tonto National Forest along with the San Carlos Apache tribe filed the nomination paperwork to designate the Oak Flats campground as a culturally and historically significant site. The nomination application is now at the desk of the the Keeper of the Record at the National Register of Historic Places, National Park Service.

The nomination application process has gone through multiple layers of federal government review prior to it being finalized by the United States Keeper of the Record in Washington D.C. The application was submitted by to the Forest Supervisor, Neil Bosworth. Once

it was reviewed by the forest supervisor it was sent the regional office of the Western Forest Service in New Mexico. The application process allowed for Pinal County Supervisor Pete Rios to submit a letter from his office to support the nomination or offer comments against the nomination. Following

In December, Supervisor Rios wrote a letter of non-support for the application and included letters from local residents who opposed the nomination of Oak Flats as a culturally significant site. Those letters and comments were to be included with the nomination application that was sent to the regional forest service offices in New Mexico. The application was received by the National Register in Washington D.C. in May. The National Register took comments for and against

the nomination through Monday, June 29, 2015. At press time is was unknown when the Keeper of the Record would decide on this nomination application.

The listing application is named Chi'chil Bildagoteel Historic District; the address for the application is listed as restricted and the town of reference is listed as Kearny (spelled Kearney), Arizona in the online listing. In addition to this nomination, the National Trust for Historic Preservation has also named the Oak Flats as one of America's top 11 endangered places. It was listed along with the Grand Canyon. According to the Trust's website, the organization has used the list of America's 11 Most Endangered Historic Places to raise awareness about the threats facing some of nations greatest treasures.

Since the Southeast Arizona Land Exchange and Conservation act was approved by Congress in December 2014, groups opposing the land exchange and the Resolution Copper project have continued to fight the project. The San Carlos Apache Tribe has been allowed to maintain a camp at the campground and install holy crosses in the campground. Those opposing the mine maintain the site and are planning to caravan cross country to Washington, D.C to continue to build their opposition. In mid June, Arizona Representatives Raul Grijalva and Ruben Gallego along with 10 other members of Congress introduced a bill to repeal the Southeast Arizona Land Exchange and Conservation Act. The bill has not been assigned to a committee at this time.

# Superior Schools: when to go, what you need and how to dress when you get there

Superior - Superior Junior and Senior High Students, and, the family and friends who love them, should take heed of this article, which is offered as a means of making their entry into the new school year as painless as possible.

School begins on Tuesday, July 28. Preregistration will be held on Thursday, July 23, noon - 1 p.m. for Seniors, 2 p.m. - 3 p.m. for Juniors and 3 p.m. - 4 p.m. for Sophomores. Then on Friday, July 24, 7th and 8th graders pre-register at 10 a.m. -

noon, followed by Freshman at 1 p.m.- 2 p.m.

To register, students need to bring a copy of their birth certificate, current immunization record, proof of residency such as a utility bill or rental agreement and picture ID for their parent/guardian. Any students interested in participating in extracurricular activities are required to have a current sports physical on file, before tryouts. Forms for the sports physicals are available in the junior-senior high school office.

To help you plan your wardrobe for the

school year, here is a list of what not to wear while on campus: do not wear spaghetti straps, thin strapped tank tops, cutaway tops and vests, low cut tops, crop tops, halter tops, off the shoulder or cut out shoulder tops, sleeveless tops and rompers, open back or cut tops, short skirts or short shorts.. friendship. I am my mother's clan and I am born for my father's clan. Please accept my statement of truth. Let it be known from this day forward that I will support valid issues that threaten our tribe. I will support our neighboring communities genuine concerns of water, environment and employment as that will also affect us here at home on the reservation. Furthermore, let it be known that I will support truth and fact and encourage all of you to call on your elders and the elders of our community as it is their voice that should be represented and respected - a voice that has not been at the forefront of the tribes endeavor. May

we pray that the sacredness of our culture will no longer be exploited and the true representation, honor and integrity be restored to our ceremonies.

Finally, I call upon our leaders to respect the wisdom of our elders, and return the holy ground crosses as they have asked. As Apache people we were always taught to respect our elders and spiritual leaders, and as leaders of our tribal government, I ask that you honor the voice of the people of the San Carlos Apache Tribe.


