Mulch Matters

ulching is one of the simplest and most beneficial practices you can use in your garden. Mulch is any material that is placed on top of the soil, not mixed with the soil. Mulches can either be organic such as grass clippings, straw, shredded leaves, bark chips, and similar materials; or inorganic such as stones, decomposed granite, and plastic. Inorganic mulches are generally used for permanent landscapes. Both organic and inorganic mulches can be beneficial to your soil and plants.

Why go to all the trouble of spreading mulch? Just 2 - 4 inches of mulch spread on top of the soil will:

- Protect the soil from erosion
- Prevent soil compaction that happens from the impact of raindrops in heavy rains
- Conserve moisture by reducing evaporation from the soil surface, reducing the need for frequent waterings
- Acts as an insulator, keeping plant roots warmer in winter and cooler in summer
- · Reduce weed growth
- · Keep fruits, vegetables and feet clean instead of muddy
- · Enhance soil fertility

Organic mulches also improve the condition of the soil. As they slowly decompose, they provide organic matter which helps keep the soil loose. This improves root growth, increases the infiltration of water, and also improves the water-holding capacity of the soil. Organic matter is a source of plant nutrients and provides an ideal environment for earthworms and other beneficial soil organisms. Gravel or rock mulches also reduce water loss but don't add fertility to

At the Oracle Community Learning Garden, we are working towards mulching all of the bare soil - not just the garden beds - using whatever organic materials are available. So far we've used straw, horse manure, finished compost, wood chips and shredded plant materials from neighbors' yards. It just feels good to divert materials from the landfill while enriching and protecting soils and conserving water. And a lot of our recent monsoon rain is now stored in the soil instead of having run off the property.

While mulch is a pretty simple concept, there are a few mulching rules of thumb to think about.

Most organic mulch - straw, wood chips, and tree bark are examples - is carbon-rich. If mixed with the soil next to your plants instead of placing on top of the soil, it could reduce soil nitrogen due to more rapid decomposition. Nitrogen use is much slower if mulch is not mixed in with soil. If your property is hilly, you'll need to anchor the mulch so that it doesn't wash away. This can be done by making basins or berms and covering them with mulch to slow the runoff. Don't mulch up against the base of be plant - keep it a few inches out from the plant base or tree trunk to prevent

Meet the President: Kennedy Ivy heads the San Manuel Revitalization Coalition

On July 18, the Miner caught up with the president of the San Manuel Revitalization Coalition. Kennedy Ivy has been a resident of San Manuel for the past three years. Originally from San Diego, Kennedy and his wife made their way to Arizona after he got out of the Navy. While working in Catalina, Kennedy heard from his coworkers about how San Manuel was a good place to raise children. In the process of starting his own family, Kennedy made the move to San Manuel.

While working for a resident, he was told about a group of locals who were getting together and discussing town issues while looking for a resolution. After accepting the invitation to join the conversations, Kennedy stayed involved and was eventually asked if he'd like to be the president. The group began to evolve, and turned into a community development corporation. Now the San Manuel Revitalization Coalition is a 501(C)3, with more than 200 participating members.

At the beginning, the group put out a "needs assessment survey", discovering the two biggest problems were drug use and lack of activities for the youth. The SMRC started working with the Arizona Youth Partnership, and with them, they've been able to host small conferences that

help teach the youth how to make good choices and healthy living skills. Starting in August, they will begin a "too good for drugs" program for youth fifth through seventh grades. The program will span the course of 10 weeks, and will be every Friday.

"We're just trying to keep these programs going," Kennedy said, "so that the kids have a healthy outlet for something."

A few months ago, the SMRC leased the community center on Fifth Avenue from the county. With the community center they have been able to host family movie nights, and community meetings.

"Our biggest accomplishment so far, has been taking over the community center," Kennedy said. "It's great to just have a place where everyone can congregate and get to know each other."

The county just recently broke ground for renovations to the Fifth Avenue park, where they will be installing new equipment.

The SMRC is also in the process of trying to revive the San Manuel Farmers Market. If you would like to contribute to San Manuel Revitalization Coalition's mission for making a better community, come to a community meeting. Community meetings are held on the last Saturday of every month, with a start time of 10 a.m. at the San Manuel Community Center, 111 Fifth Avenue, across from the public library.

Pinal County Supervisor Cavanaugh awards non-profit grants; prioritizes funding for those offering food, shelter, social services

Each year the Pinal County Board of Supervisors sets aside \$100,000 for each district to grant to local nonprofit organizations for the benefit of Pinal County residents. The County staff reviews the grant applications and scores them based on a rubric, rating each organization with a score of 1 to 5 in several different categories.

This year District 1 Supervisor Kevin Cavanaugh awarded \$8,000 (8%) towards education projects,

\$20,000 (20%) towards Economic Development projects, and \$39,500 (39.5%) towards projects relating to food, shelter, and social services. Supervisor Cavanaugh reserved approximately one-third of the funds for requests anticipated during the balance of the fiscal year.

The Superior Chamber of Commerce is excited to bring back two of the town's most popular events: the Superior Burro Run and the 33rd Annual Apache Leap Mining Festival. On Saturday, Oct. 23, the teams will race down Main Street and out onto Forest Service trails, navigating together to see who has the best partnership and the fastest feet. Each course will conclude back on Main Street, where spectators can watch the teams dash across the finish line.

Spectators are encouraged to attend this exciting event, which will also feature a beer garden, live music and other entertainment, as well as trained burro adoptions from the Bureau of Land Management (BLM).



Support Local: Oracle Community Center

n April 2020, COVID-19 brought much of Arizona's economy to a screeching halt. All businesses not deemed "essential" were ordered closed by Arizona's governor Doug Ducey.

The lockdown continued for nearly two months. When Gov. Ducey finally gave the go ahead to reopen, businesses slowly began the road to recovery. Even those listed as "essential" had a challenge with this economic recovery.

Many small businesses and non-profits in Arizona didn't survive the lockdown. The businesses that did survive are hanging on as best they can. *Copper Area News* wanted to give something back to the local business community as a thank you for supporting us through these troubled times. Our newspapers (Copper Basin News, Superior Sun and San Manuel Miner) have been featuring local businesses and non-profits since the beginning of 2021, encouraging our readers to Shop at Home, stay local and support our local businesses. To date, Copper Area News has featured 84 businesses in the Copper Corridor.

As the COVID-19 Pandemic took its toll, businesses, families and even local non-profits had to adjust their strategies to keep their missions moving forward while working through the pandemic. Meetings were moved to Zoom and fundraisers had to become creative as in-person events were not allowed. Harder still for some organizations, major events — including annual events — had to be canceled.

The Oracle Community Center has been a foundation of the community for more than 40 years and continues support the community even through this pandemic. The last year has been tough on the community center as they had to cancel the last two Oracle Oaks Festivals.

However, the Oracle Community Center Board President Steve Chaves has confirmed that next year the Oracle Oaks Festival is back on as normal. Another sign that things are returning to normal: they are currently looking for volunteers.

"We are always looking for volunteers," said Chaves.

Volunteers are needed for planning next

year's Oaks Festival as well as board members to help guide the direction of the community center.

Yet another sign of getting back to business: the Monday lunches are back on as of last month. But rather than every Monday, they are now twice a month, on the first and third Monday. The next lunch date is Aug. 2.

Chaves told the Miner that the community center was built, physically, by the community. The community put in the labor and materials to build it. For many years, the community center was, on paper, a senior center. But the center is back to being a non profit community center.

This year's major project is renovating the kitchen. Recently, the OCC received a donation from the SaddleBrooke Rotary Club to help purchase a much needed new stove.

"The community center is open to the community, and it is a great rental space for parties and special meetings," said Chaves. Coming Aug. 14 will be another community yard sale. More information will be published in the *Miner* as it becomes available.

The community center's Free Little Pantry is still available for folks who need a little help (and for those with a little help to give, the lockers are open for donations).
