

## Safe and efficient progress at the pump house construction site

After six weeks of work, Oddonetto Construction, a contractor from Globe has completed 65 percent of the pump house construction ahead of schedule and most importantly injury free.

Since June 1, the Oddonetto team has been safely constructing the pump house on Resolution Copper property in Superior. In collaboration with the Resolution Copper environmental, health and safety team, the construction site is inspected regularly to keep workers and the environment safe.
