Sheriff speaks out on immigration

If a citizen breaks the law and no law enforcement action is taken, what message does that send to everyone else? This is exactly what's happening with our immigration laws in America. That's why my deputies encounter many criminal illegals who admit to being deported as many as 15 times. The laws apply to American citizens, but if you're an illegal from a foreign country — it appears the laws do not apply and there are few if any real

consequences.

The very hope of 60,000 unaccompanied juveniles from Central America was realized when they were welcomed with open arms. What message does this send the millions of future illegals in Mexico and Central America? If you make it to the border and say you're fleeing violence — you're home free. Think again if you believe that the majority of these kids will be returned to their home countries.

The 11 to 20 million illegals currently in the U.S. should be proof enough that this will never happen.

This undermining of the rule of law for immigration is deliberate. President Obama has circumvented Congress, even threatened further executive orders to provide outright legal status to 11 to 20 million illegals.

Two whistleblower federal agents alerted me that the Department of Homeland Security was transferring 40 to 60 illegal, unaccompanied minors to the Sycamore Canyon Academy in Oracle on July 15. We then contacted the academy, which confirmed the "refugees" were coming and they were hiring 30 additional staff in preparation. It now appears that the public outcry against this secret movement delayed or permanently stopped the transfer.

Carl Shipman, director of the Sycamore Canyon Academy, issued a press release on July 14 confirming "at the urgent request of the HHS Office of Refugee Resettlement, we will provide safe and temporary care to a small number of unaccompanied youth from Central and South

America."

Critics attempt to shift focus or blame to the protesters or to me for sharing information with local residents. We should have never been placed in this situation in the first place. DHS Secretary Jeh Johnson promised to notify and coordinate with local officials prior to sending these "refugees" to communities across the Southwest. This never happened. This was done in secrecy and we still have no response to our legitimate public safety and public health concerns.

The most humanitarian response would be to place these children on planes, return them back to their country of origin and reunite them with their families. If we fail to do this, we invite future waves of refugees. There are over 40 million children under the age of 18 in Mexico, and based on this refugee claim, they would easily qualify for asylum given the cartel violence. Would President Obama turn away these children? Not a chance.

We in CVIT agree that everyone is entitled to their own opinion, but we also believe in operating based on facts not individual opinions. It is very clear that Mr. Barwick's view of facts and opinions is blurred. As many of your readers know, school districts' board proceedings are public and easily verifiable. There is nothing to hide. There are three major errors in Mr. Barwick's letter: 1. I did not ignore his concern about

the stipend and asked for advice from state officials before making a decision, 2. The Board took action on this issue on regular meeting on April 24, 2014, the board took my recommendation to take no action unless ADE in the future decided otherwise, they did not table it, 3. Auditors in the exit report said that the stipend may have to be paid back if ADE made that determination in the future, not Mr. Barwick. I would be more than happy to sit down with Copper Basin News to provide documentation: emails, and board minutes, to verify these three major errors. The funding that comes from state and federal government is spent according to a previously approved budget. At no time has a CVIT audit shown that any money, state or federal was not allocated according to the approved plan. The federal grant system has changed in the past few years and accountability has become even stricter. We work directly with the Arizona Department of Education to ensure that we stay in compliance with the regulations. Mr. Barwick's concerns were addressed by the Arizona Department of Education officials, investigated, and found to be invalid. That is a fact. The bigger question here is if Mr. Barwick was ready for all the changes that come with moving forward. It is difficult to accept that an informed professional would make accusations about a reputable organization and call it "normal behavior". The answer is Mr. Barwick knew that CVIT was moving in a more positive direction concerning his position by eliminating the business manager's position and contracting license accounting firm it saved CVIT \$28000.00.

The CVIT administration is working hard to provide students in our communities with as many educational

opportunities as possible. I would like the readers to reflect on this fact. We are getting ready to begin the 2014-2015 school year with eight central programs which are for college credit and industry certification. All tuition fees are free to the students. Students are also provided with books, uniforms, and supplies for their classes. We are giving young people a chance to become employable, respected members of society and have a good start in life. Last year, we graduated 42 students from two year programs in electrical and instrumentation, welding, nursing assistant, medical assistant, cosmetology, fire science, pre-engineering geology, and graphic design. We allocated \$324,000.00 directly to the Globe, Miami, San Carlos, Hayden-Winkleman, and Superior school districts to enhance the career and technical education programs. The CVIT governing board has also approved financial support for highly achieving students to attend national competitions. CVIT partners with educational institutions and industry to provide our students with the best educational options available. Our main goal in CVIT is to take care of our students. We appreciate all the support we receive from our communities. We will continue to operate with honor, integrity, and continually strive to improve and meet the needs of our number one concern, our students.

Before the last election, a number of citizens of Kearny approached me and asked me to put my name forward as mayor. With the kind help of many people I was chosen mayor and took office.

Kearny has had a rocky path. The continuing rural recession, the Shipman Fire and the fire at Buzzy's, the loss of The Bank of the West, and ASARCO's management and labor still working without a contract – these and other things have made our lives difficult in Kearny.

Yet in all of this, the Town of Kearny has a balanced budget (the envy of some of our surrounding communities). We have a popular town manager in Anna Flores,

a new town clerk in Cathy Woolery, and a revitalized public safety department with the assistance of Sergeant Dave Blue from Arizona's Department of Public Safety, who is serving as our interim chief of police.

After seven years without any salary adjustments for the cost of living, we were able to provide small percentage increases to all town employees. With the help of ASARCO, Resolution Copper, Capstone, the Ray Federal Credit Union and many others, our swimming pool has stayed open and even increased the length of its season. By September, we should have a new chief of police.

In all this, the town council (which sets policy) and our town manager (who administers the town), have done the heavy lifting. I have tried to bring a positive influence, to make sure that productive dialogue takes place, the citizens are heard, and response is made to their needs.

For my part, I have also worked closely with Central Arizona Governments to help provide grants for our infrastructure, especially to benefit our water sources and the Kearny Town Lake,

and I serve on the group that recently established a revolving loan fund to provide assistance to businesses and new business starts. I am working to provide better broadband services. The recent "Three Mayors" group (Kearny, Hayden, and Winkelman) is creating, with the help of the Copper Basin Chamber of Commerce, a flow of communications and support for all three towns.

There are many live issues right now. A way needs to be found to keep our golf course (a staple for townspeople and winter visitors) and provide it with water and a solid growth plan. The council continues to work on infrastructure, water issues and economic development. Although we have a very small tax base we have managed to avoid raising taxes. New business development would help all of us, with more employment and a larger economic base.

I have learned much, and I have built relationships


with businesses and people in government who can help benefit our town. I want to continue working with the town council and town manager for a safe and prosperous community. Please make your voice known on primary election day, Tuesday, Aug. 26.



Judge Arnold Estrada announces candidacy for Justice of the Peace

Mammoth - Judge Arnold Estrada recently announced his candidacy for re-election as Justice of the Peace for San Manuel, Mammoth and Dudleyville, also known as Precinct #4. "It is important that we have someone who knows the issues that affect our community," Estrada said, "plus the management skills, respectful personality, and sound judgment to run a court."

Estrada has served nearly 8 years as a justice of the peace and received extensive judicial training from the Arizona Judicial College. He is responsible for deciding cases but also for managing the

administration of the justice court; and as a cost saving measure he performs the same functions as the city judge for Mammoth.

"As an active member of our community, I have seen, first hand, the problems our community faces every day; but as a Judge, I have the privilege of helping to protect our community and especially our senior citizens, the young, and the vulnerable," said Estrada.

Before becoming a judge in 2006, he served in the Pinal County Attorney's Office for several years, focusing on elder abuse issues, where

he gained the attention of former Governor Janet Napolitano, who honored Estrada with a Distinguished Service Award. He also became a member of the Arizona Crime Prevention Association and the Eastern Pinal Regional Coalition Against Domestic Violence, and he graduated from the National Crime Prevention Institute and served as a mediator for the state Attorney General's Office.

During this time, Estrada is also credited with helping to bring a dialysis center to the area and worked to secure RICO funding for organizations

in Eastern Pinal County, including numerous school programs, such as the Mammoth Trumpeters, after school programs, baseball, softball, and archery.

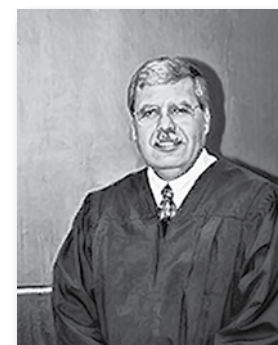

Oracle's peaceful protest makes national news

The small town of Oracle, Ariz. became known nationwide last week as it became a focal point of the immigration debate. A pro-

test of unaccompanied illegal immigrant children being housed at the Sycamore Canyon Academy was organized by Oracle resident Robert Skiba after he was told by Pinal County Sheriff Paul Babeu that they would be housed there and that a bus with 40 or more children would be arriving on Tuesday, July 15. Babeu

said he was told by two friends of this that worked for ICE about the plan to house the children at the Sycamore Canyon Academy in Peppersauce Canyon a popular picnic and camping area on weekends in the Catalina Mountains above Oracle.

A group of 80 or more gathered at a junction on the road that leads to Peppersauce Canyon. The other road leads to the small former mining town of San Manuel. It has frequent traffic. The protesters were slowing down the traffic on both roads. On the road to the Sycamore Canyon Academy, traffic was slowed to a halt. Two school buses loaded with kids on their way to a nearby YMCA camp were halted and then allowed to pass. I wonder what the kids were thinking after being greeted in Oracle by a group supporting the children waived to them and held up signs saying welcome in Spanish and English. Everyone laughing after they realized it was a group of children headed to the YMCA camp in Marana School District buses. The bus that Sheriff Babeu said was coming never arrived.

The gathering at the junction included most of the TV news stations from Tucson and Phoenix. They were interviewing Pinal County Sheriff Paul Babeu, Robert Skiba and people who were there, most of them from out of town. There was a heavy police presence in the area. The evening before Sheriff Babeu was telling people at a political rally in SaddleBrooke that there could be between 500 to 700 people at the protest.

Border hawk and author of controversial Senate Bill 1070 (the show me your papers bill) Russell Pearce was there including other politicians among them gubernatorial candidate Frank Riggs and congressional candidate Adam Kwasman. Pearce and Riggs were escorted by members of the Arizona State Militia out of Tucson (not affiliated with the Arizona government). Some of them were armed.

A few individuals were interviewed and asked why they were at the protest. Colonel Kratos of the Arizona State Militia said, "We are here for security and nothing else." I asked him who the militia was providing security for and he answered, "At the request of the individuals I cannot tell you."

Andi from Florence who was with the protesters said, "I feel like the kids are caught in the crossfire. The president is not doing anything about it. The kids are being used as pawns. I think it is sad. I don't like the ugliness directed at the kids but at the same time, it sends a message."

James Montano from Oracle said, "My grandmother was born in Guaymas, Mexico. We all came in legally. If they had asked us it might have turned out differently. We don't like it being forced on us by the Federal government. We don't take this lightly. No one here is trying to be a negative activist but enough is enough."

at the entrance to Mt. Lemon Road off American Ave. a group of people waiving welcome signs in Spanish and English lined the road. Although their numbers may not have been as large as the protesters they seemed to have more Oracle residents at the scene than the protest group. Most of the people showing support also came from out of town. The Angel Project out of Tucson was one of the groups that showed up. They attend events aimed at dealing with hate groups. Some of the interviews included Chris

with the Somos America group out of Phoenix. He said, "We heard about the sheriff tipping off people about the protest. I didn't want to see the same thing that happened in Murrieta, Cali. happen here."

Holly from Marana said, "They are children, children on a bus. People are ugly about it and I don't understand it. All they want is a chance."

Joel Smith with Humane Borders said, "I came to show my support for the children. I want to stand up against racism and xenophobia. This is America!"

Gabriel, a kid from Oracle,

was with his grandmother. He said he was glad he came. While holding a poster with a heart drawn on it he said he would welcome these kids and talk to them and play with them if they came to his school.

Overall the protest was peaceful. There was one incident where a group of mariachis and some supporters walked up the public road playing music. The group Mariachi Luz de Luna walked down the middle of the road toward the protesters. People walking with them held up a sign with the words that are on the base of the Statue of Liberty, "Give me your tired, your poor/your huddled masses yearning to breathe free/the wretched refuse of your teeming shore/send these, the homeless, tempest tossed to me/I lift my lamp beside the golden door!"

The protesters then began blocking the mariachis from advancing. The mariachi group tried to walk around the people blocking them. They were soon surrounded. Exple-

tives were directed at them and a few people shouting, “Go back to Mexico”, even though the members of the group were Americans. The protesters began jostling the band members and their friends. The music stopped. Protesters were shouting and there was some pushing when the trumpet player from the band began playing the Star Spangled Banner and band members began singing. Most of the protesters then stood at attention and some of them started singing along with the mariachis. When the music stopped the protesters again started shouting and there were confrontations among individuals. There was some pushing and shoving and people being held back. The Pinal County Sheriff’s

deputies then stepped in and got everything under control.

The name of the trumpet player was Ruben Moreno. He even played the Marine Hymn when a protester confronted him and identified himself as a Marine. Moreno is also a Marine. The two Marines exchanged their views on the immigration issue and parted ways. The big protest that Sheriff Paul Babeu said was going to happen never materialized. He got his television cameras like he wanted but not the publicity he thought he would. Another protest was attempted on Saturday with even fewer people showing up. The counter protesters did not bother organizing as they knew there would be no bus. They instead started a “Have

a Heart” campaign and will be organizing to gather supplies to help the refugees that are probably in Sycamore Canyon as we speak.

Now the public should seek answers on how and why this publicity stunt was organized and how much did it cost the tax payers.
