Isabel has accomplished so much in her life she

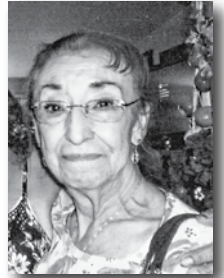

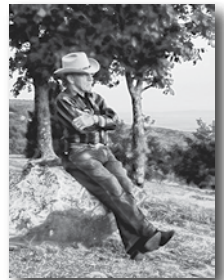
Lee and Pat have 20 grandchildren and 26 great-grandchildren.

Resident registers complaint against town clerk

I am filing this Formal Complaint with the Mammoth Town Council at the July 17, 2014 meeting.

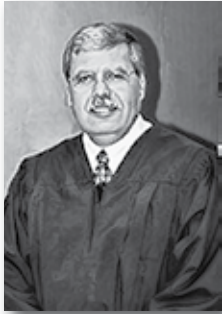

Complaint made about treatment of Mammoth librarian

I wanted to take a moment to file a formal complaint against the town manager Patsy Large. On Thursday July 10, 2014 at 3 pm I witnessed very unprofessional behavior by our current town manager. I have been volunteering at the Mammoth Town Library for the summer reading program, which meets on Tuesday and Thursday's from 3 - 4:30 pm. Since the library has had such a great turn out, the librarian Letha Miller signs the children in and then we get them ready for that day's lesson.

On July 10, 2014 Letha had brought in a blacksmith to complete a demonstration for the children. In order to keep the children protected Letha had safety goggles for them to wear. We had them lined up from the library door past the checkout desk and Letha was in the process of handing out the safety goggles when town manager Patsy Large stormed in. Patsy stormed past myself and Diane Theobald, who were standing in the doorway, walked up to Letha, handed her a check, and yelled at her that "if you ever go over my f***** head again, you had better have another job lined up." She then turned and stormed out.

My jaw fell to the ground. Children were saying things like "ohhhh" and "burn". They had overheard the whole thing. How could our town manager have decided to act so irresponsible, and in front of a room full of children? I have been told it was because "Letha went over Patsy's head in order to obtain a signature on the check for the blacksmith".

After leaving the summer reading program I immediately called Mayor Barcelo, and called councilman Barcelo. I spoke

to both the Mayor and the Councilman that same evening and expressed my concerns as was assured something would be done. I have yet to hear anything back from them as to the resolution.

Three things; first, If Letha needed a signature on a check for a vendor that was already promised payment, why couldn't our town manager take the two minutes to call the vice mayor to get that signature? Secondly, does the Town of Mammoth approve publicly humiliating and harassing town employees as an approved practice? Third and MOST IMPORTANT, I DO NOT CARE WHO WAS INITIALLY IN THE WRONG. You do not SCREAM, CURSE, and REPRIMAND town employees in front of the general public and especially children.

As someone who has managed 20+ employees, I can tell you, you never, never, NEVER publicly reprimand one employee in front of anyone else. Even the Town Council recognizes this, which is why there is an executive session at every council meeting. I have had employees go over my head, and while it is infuriating and I can sympathize with Patsy, there is a way to handle things, and the way she chose to handle it was WRONG.

Something needs to be done to show that this type of behavior will not be accepted. At the very least, Patsy needs to publicly apologize to Letha and all the children present for her actions. I would like to know what the resolution to this situation is.

Sheriff speaks out on immigration

If a citizen breaks the law and no law enforcement action is taken, what message does that send to everyone else? This is exactly what's happening with our immigration laws in America. That's why my deputies encounter many criminal illegals who admit to being deported as many as 15 times. The laws apply to American citizens, but if you're an illegal from a foreign country — it appears the laws do not apply and there are few if any real consequences.

The very hope of 60,000 unaccompanied juveniles from Central America was realized when they were welcomed with open arms. What message does this send the millions of future illegals in Mexico and Central America? If you make it to the border and say you're fleeing violence — you're home free. Think again if you believe that the majority of these kids will be returned to their home countries. The 11 to 20 million illegals currently in the U.S. should be proof enough that this will never happen.

This undermining of the rule of law for immigration is

deliberate. President Obama has circumvented Congress, even threatened further executive orders to provide outright legal status to 11 to 20 million illegals.

Two whistleblower federal agents alerted me that the Department of Homeland Security was transferring 40 to 60 illegal, unaccompanied minors to the Sycamore Canyon Academy in Oracle on July 15. We then contacted the academy, which confirmed the "refugees" were coming and they were hiring 30 additional staff in preparation. It now appears that the public outcry against this secret movement delayed or permanently stopped the transfer.

Carl Shipman, director of the Sycamore Canyon Academy, issued a press release on July 14 confirming "at the urgent request of the HHS Office of Refugee Resettlement, we will provide safe and temporary care to a small number of unaccompanied youth from Central and South America."

Critics attempt to shift focus or blame to the protesters

or to me for sharing information with local residents. We should have never been placed in this situation in the first place. DHS Secretary Jeh Johnson promised to notify and coordinate with local officials prior to sending these "refugees" to communities across the Southwest. This never happened. This was done in secrecy and we still have no response to our legitimate public safety and public health concerns.

The most humanitarian response would be to place these children on planes, return them back to their country of origin and reunite them with their families. If we fail to do this, we invite future waves of refugees. There are over 40 million children under the age of 18 in Mexico, and based on this refugee claim, they would easily qualify for asylum given the cartel violence. Would President Obama turn away these children? Not a chance.

Knowing how divisive an issue like immigration has become, you have to question what were the motives of Sheriff Babeu when he chose to disclose what he supposedly heard from a "whistleblower." Did he choose to bring this information to county management and the Supervisors so the county could help in developing a safe plan of action? No, he went straight to his base to stir the flames of passion regarding young immigrant children. This does not support law enforcement's motto of "To Serve and Protect."

This has the markings of a person who cannot comprehend the consequences of

such an act. There are a lot of "what ifs" I could bring up. But the only one that frightens all of us is — what if this political stunt resulted in injuries and possibly a fatality?

Who then is on the hook for Sheriff Babeu's quest for more camera time?

The Sheriff?

The County?


The Taxpayers?

Yes to all three. Let's say something bad did happen. The county would most likely be sued for letting this happen, even though the Board of Supervisors cannot

dictate how the Sheriff does his job. Who pays the settlement? You, the taxpayers do. The county does have insurance, but an act like this would probably mean our liability premiums would skyrocket.

While the taxpayers dodged a huge bullet to the pocketbook on Monday, you have to wonder when is the next time the Sheriff will want to get some time in front of the camera? Who will be left on the hook for his actions? You, the taxpayer.

Lack of 2013 audit explained to Mammoth residents

This is to inform the citizens of Mammoth as to why the audit for 2013 has never been completed.

The audit began in June 2013 and was never completed because the bank accounts did not reconcile to the general ledger. It appears that there were missing grant documents, missing invoices supporting documentation and deposits with no supporting documentation.

The missing invoices amounted to approximately \$469,106.25.

Undocumented credit card charges: approximately \$5,110.22. These charges ranged from grocery store, restaurants and Lego Shop at Home to pizza. Grant ledger with no invoices. Approximately \$25,802.38. Deposits with no support. Approximately \$14,571.40. Expenditures with no invoices. Approximately \$28,567.00. In June 2013 there was \$543,157.25 that was not accounted for.

There is also a matter of an account that had over \$600,000.00 in it. When I ask about where the money is being spent, one of their smart replies is "We bought cement. I understand that there is maybe \$100,000.00 left in the account.

If you will total the above figure \$543,157.25

with the approximate \$500,000.00 you will now have over a MILLION DOLLARS unaccounted for. One million dollars unaccounted for, in just over a year. I wonder how much it will be if they are elected for another term.

This is what happens when your elected officials decide that they do not have to give, or even show, receipts to you, the public, or even Council members.

The Town Manager is NOW working on a budget for the Fiscal Year 2015. How can she and her cohorts balance the budget when she cannot even submit the paperwork to have the 2013 audit completed. Remember the audit was started in June, 2013 and here it is July, 2014 and still no completed audit, but, yet, they are balancing the budget with only one meeting.

Call the Auditor General and ask why the Town of Mammoth does not have an audit every two years.

Believe me, heads are going to roll, and, yes, people will probably be going to jail. What they are doing is illegal and it is going to stop. Oh sure, they will say "I didn't know what was happening." or "Nobody told me about it." Nothing but excuses,

but, then again, the jailhouses are full of people with excuses.

One of our police officers, not Chief anymore, invited me to investigate him and I did. I went one step further and investigated all the things that I thought were wrong here in this Town (money unaccounted for, illegal meetings and more). Now, I am not alone in this investigation.

Citizens of Mammoth, you have the right to go to the Town Council Meetings and ask questions all through the meeting. Do not let them fool you. They have been getting away with it too long. Go to the meeting and take your Town back.

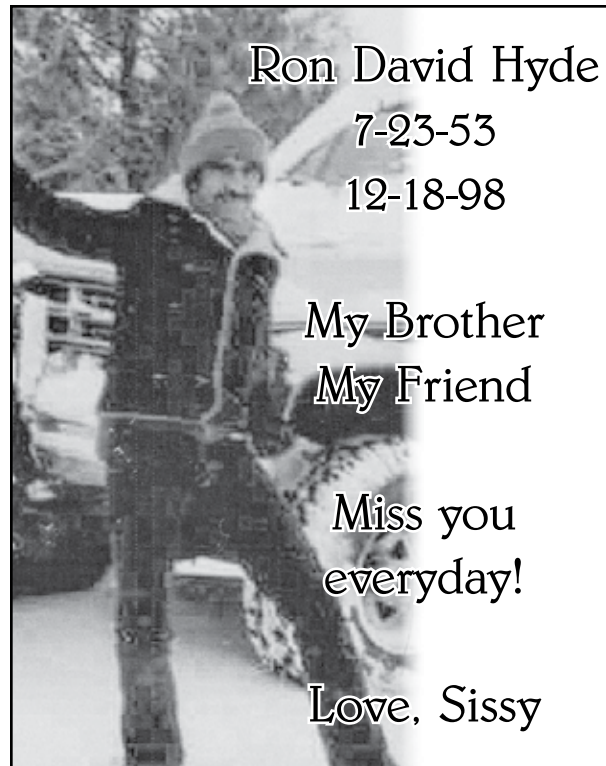

Protests and more gubernatorial candidates

Before jumping into the next group of candidates for governor, I would like to comment on the protest of the unaccompanied immigrant children that put Oracle on the national news on Tuesday, July 15. The protest by all appearances was orchestrated by Sheriff Paul Babeu. It was political theater to take his border security message nationwide and promote his

fundraising campaigns. Part of it worked and most of it has backfired. The media is hammering him. Pinal County and Arizona are national jokes. This political stunt could have gotten someone hurt. He needs to be held accountable. Pinal County Supervisor for District 1, Pete Rios has come out and commented on the issue and even visited the announced statewide Tea Party protest on Saturday, July 19 that was to be held at Peppersauce Canyon.

The planned protest turned out to be a bust with a small attendance. The bill for the cost of all the police presence on both days should be sent to Babeu and the Tea Party.

It has come out in the news that on the same day as the protest on July 15, it was

announced that Immigration and Customs Enforcement (ICE) is not renewing their contract with the Pinal County Jail to hold detained immigrants. The jail was named one of the 10 worst immigration detention facilities in the country by the Detention Watch Network in 2012. Poor oversight and a miscalculated contract were costing Pinal County nearly three million dollars a year. More than 100 jail workers could lose their job.

During all this Babeu has been running around the state and country promoting his border agenda, his political ambitions, receiving awards and campaigning for others. He has pandered to the right wing of the Republican Party especially the Tea Party faction. It is time he become the sheriff for everyone in the county. There needs to be more law enforcement and less politics. His officers'

do a good job under trying conditions, he shouldn't make their job harder or embarrass them.

As for Bob "Paul Revere" Skiba, he did not need to expose Oracle to those militia members and racists from out of town.

Oracle protest makes national news, protest remains peaceful

The small town of Oracle, Ariz. became known nationwide last week as it became a focal point of the immigration debate. A protest of unaccompanied illegal immigrant children being housed at the Sycamore Canyon Academy was organized by Oracle resident Robert Skiba after he was told by Pinal County Sheriff Paul Babeu that they would be housed there and that a bus with 40 or more children would be arriving on Tuesday, July 15. Babeu said he was told by two friends of this that worked for ICE about the plan to house the children at the Sycamore Canyon Academy in Peppersauce Canyon a popular picnic and camping area on weekends in the Catalina Mountains above Oracle.

A group of 80 or more gathered at a junction on the road that leads to Peppersauce Canyon. The other road leads to the small former mining town of San Manuel. It has frequent traffic. The protesters were slowing down the traffic on both roads. On the road to the Sycamore Canyon Academy, traffic was slowed to a halt. Two school buses loaded with kids on their way to a nearby YMCA camp were halted and then allowed to pass. I wonder what the kids were thinking after being greeted in Oracle by a group supporting the children waived to them and held up signs saying welcome in Spanish and English. Everyone laughing after they realized it was a group of children headed to the YMCA camp in Marana School District buses. The bus that Sheriff Babeu said was coming never arrived.

The gathering at the junction included most of the TV news stations from Tucson and Phoenix. They were interviewing Pinal County Sheriff Paul Babeu, Robert Skiba and people who were there, most of them from out of town. There was a heavy police presence in the area. The evening before Sheriff Babeu was telling people at a political rally in SaddleBrooke that there could be between 500 to 700 people at the protest.

Border hawk and author of controversial Senate Bill 1070 (the show me your papers bill) Russell Pearce was there including other politicians among them gubernatorial candidate Frank Riggs and congressional candidate Adam Kwasman. Pearce and Riggs were escorted by members of the Arizona State Militia out of Tucson (not affiliated with the Arizona government). Some of them were armed.

A few individuals were interviewed and asked why they were at the protest. Colonel Kratos of the Arizona State Militia said, "We are here for security and nothing else." I asked him who the militia was providing security for and he answered, "At the request of the individuals I cannot tell you."

Andi from Florence who was with the protesters said, "I feel like the kids are caught in the crossfire. The president is not doing anything about it. The kids are being used as pawns. I think it is sad. I don't like the ugliness directed at the kids but at the same time, it sends a message."

James Montano from Oracle said, "My grandmother was born in Guaymas, Mexico. We all came in legally. If they had asked us it might have turned out differently. We don't like it being forced on us by the Federal government. We don't take this lightly. No one here is trying to be a negative activist but enough is enough." Teresa from Goodyear said she came because she wanted to,

"see our border secured and our government work on immigration reform."

William from Oracle who was protesting the arrival of the kids set up at the counter protest area carrying a sign that said "deport now". He said, "I don't want them here. They don't need to come here. They need to do it the right way."

At the counter protest area at the entrance to Mt. Lemmon Road off American Ave. a group of people waving welcome signs in Spanish and English lined the road. Although their numbers may not have been as large as the protesters they seemed to have more Oracle residents at the scene than the protest group. Most of the people showing support also came from out of town. The Angel Project out of Tucson was one of the groups that showed up. They attend events aimed at dealing with hate groups. Some of the interviews included Chris with the Somos America group out of Phoenix. He said, "We heard about the sheriff tipping off people about the protest. I didn't want to see the same thing that happened in Murrieta, Cali. happen here."

Holly from Marana said, "They are children, children on a bus. People are ugly about it and I don't understand it. All they want is a chance."

Joel Smith with Humane Borders said, "I came to show my support for the children. I want to stand up against racism and xenophobia. This is America!"

Gabriel, a kid from Oracle, was with his grandmother. He said

Dreams come true for former Hayden baseball player

Ever since he was five years old, former Hayden High School baseball player Hyrum Formo dreamed of playing professional baseball. After graduating in 2010 from Hayden and playing for Pima Community College in Tucson, Formo was selected in the 27th round by the Tampa Bay Rays organization in the June 2013 Major League Draft.

Formo, a pitcher, is in his second minor league season with the Rays. He started this season playing for the Rays' advanced rookie league team in Princeton, West Virginia. In four starts so far this season, he is 1 - 0 with 15 strikeouts in 17.2 innings pitched. His strikeout to walk ratio is a remarkable 15 to 1.

Reaching the major leagues took more than talent for Formo, who was throwing in the low 90's in high school (he throws in the mid 90's now). Typically, a high school player who throws that hard should have no trouble attracting college recruiters and team scouts, but that was not the case for Hyrum. It took hard work, determination and perseverance to realize his dream.

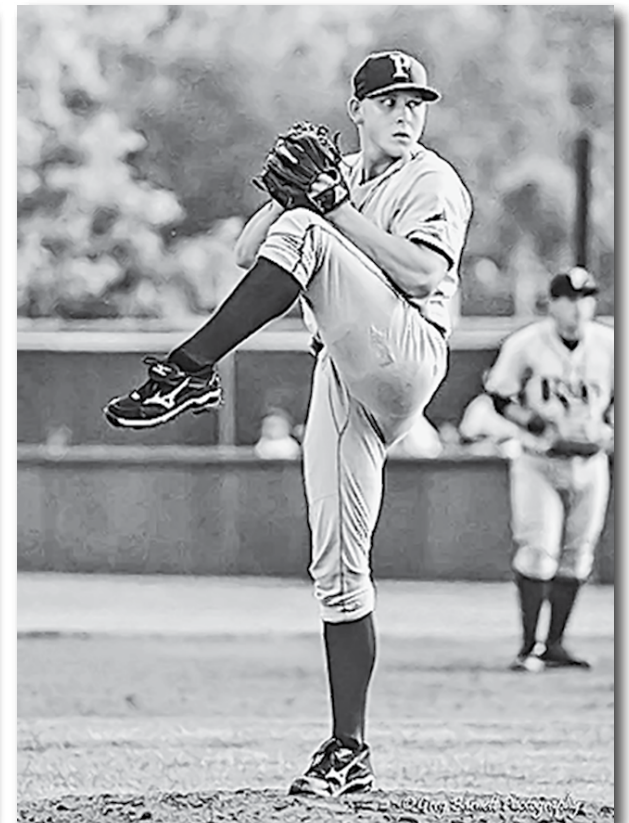
"I was that kid did well and everything," Formo said. "I wanted to go on (and play at the next level) but there wasn't anyone around to see me play. I just had to go on and do it myself. I didn't quit."

Formo credited his parents for his success. His father, Robert, coached him throughout his youth. Along with Julie, his mother, the couple would travel most summers across the country so Hyrum could participate in tournaments and play competitive baseball. As expected, his parents "are very, very proud" of his accomplishments.

"I think they deserve everything in the world," Formo said about his parents. "If it wasn't for them I wouldn't be where I'm at."

Playing professionally is a dream come true for Formo. He knows it's not easy to play in a small town and get recognized. He believes there are several local area players who deserve a chance to play at the next level. Hyrum says he returns home when his season is over and has spoken to local coaches about his willingness to work with kids and share his knowledge.

"I want to help the kids (in the Copper Corridor)," he said. "I want to help out those kids who want to make it to the next level."

he was glad he came. While holding a poster with a heart drawn on it he said he would welcome these kids and talk to them and play with them if they came to his school.

Overall the protest was peaceful. There was one incident where a group of mariachis and some supporters walked up the public road playing music. The group Mariachi Luz de Luna walked down the middle of the road toward the protesters. People walking with them held up a sign with the words that are on the base of the Statue of Liberty, "Give me your tired, your poor/your huddled masses yearning to breathe free/the wretched refuse of your teeming shore/send these, the homeless, tempest tossed to me/I lift my lamp beside the golden door!"

The protesters then began blocking the mariachis from advancing. The mariachi group tried to walk around the people blocking them. They were soon surrounded. Expletives were directed at them and a few people shouting, "Go back to Mexico", even though the members of the group were Americans. The protesters began jostling the band members and their friends. The music stopped. Protesters were shouting and there was some pushing when the trumpet player from the band began playing the Star Spangled Banner and band members began singing. Most of the protesters then stood at at-

tention and some of them started singing along with the mariachis. When the music stopped the protesters again started shouting and there were confrontations among individuals. There was some pushing and shoving and people being held back. The Pinal County Sheriff's deputies then stepped in and got everything under control.

The name of the trumpet player was Ruben Moreno. He even played the Marine Hymn when a protester confronted him and identified himself as a Marine. Moreno is also a Marine. The two Marines exchanged their views on the immigration issue and parted ways. The big protest that Sheriff Paul Babeu said was going to happen never materialized. He got his television cameras like he wanted but not the publicity he thought he would. Another protest was attempted on Saturday with even fewer people showing up. The counter protesters did not bother organizing as they knew there would be no bus. They instead started a "Have a Heart" campaign and will be organizing to gather supplies to help the refugees that are probably in Sycamore Canyon as we speak.

Now the public should seek answers on how and why this publicity stunt was organized and how much did it cost the tax payers.

who have met Bennett that he is a nice guy and compassionate.

My concerns with Bennett was how he pandered to the "birther" movement by saying that he would take President Obama's name off the ballot for the 2012 election if the state of Hawaii did not provide a long form of his birth certificate to his office. It was just plain wrong for a secretary of state to do this. He recently made a comment about the kids fleeing violence in Central America that he would order the arrests of ICE employees bringing in the children to Arizona, which would be illegal. Then there is his association with Richard Stephenson, a wealthy businessman and a major player with the right wing political group FreedomWorks which is closely tied to the Koch brothers who have never seen an election they wouldn't try to buy.

Bennett sits on the board of the Cancer Treatment Centers of America, a for profit company. Since becoming secretary of state in 2009, Bennett has received a salary of \$2,000 a month for his services on the board. He has also received campaign donations from other board members. Richard Stephenson founded the company in the 1980s. Stephenson sits on the board of the Tea Party political group FreedomWorks in which the filthy rich Koch brothers have an interest. Stephenson was also involved in the mysterious secret donation of \$12 million to a FreedomWorks Super PAC through two "shell" corporations that were formed six weeks before the 2012 election and provided donations to Tea Party politicians. There is nothing illegal about this nor is it a conflict of interest with Arizona's weak

conflict of interest laws and the Citizens United ruling that blocks transparency in many political donations, but it brings up the question of ethics and how much influence the TeaParty/Koch brothers will have on Arizona politics if Bennett is elected governor.

Scott Smith is a businessman and former mayor of the City of Mesa. He was elected mayor in 2008 and re-elected in 2012 but left the position to run for governor. He was appointed president of the US Conference of Mayors in 2013. In an interview with a Tucson newspaper he said that his main priorities if elected will be jobs, education, infrastructure and public safety. He supported Jan Brewer's decision on Medicaid expansion and it has been reported that he backs Common Core and that Governor Brewer may give him her endorsement. He appears to be the

most moderate of all the Republican candidates.

Smith as mayor of Mesa stood up to Joe Arpaio in 2008 when the Maricopa County Sheriff's SWAT team in full paramilitary gear raided city hall and the library in the middle of the night. The janitors armed only with mops and vacuum cleaners were no match for the MCSO. Three alleged illegal immigrants working for a contractor were arrested. Smith condemned the tactics and felt it was politically motivated by Arpaio and Maricopa County Attorney Andy Thomas. If Smith is endorsed by Governor Brewer, he could become a major player in the race.

The Republican primary election is too young to call. Ads are starting to appear on television and the mud slinging is just beginning. I encourage everyone to read up on the candidates and follow the money if you can. Remember it's not what

politicians say but what they do that counts. Look at what they have done in the past as a guide.

Fire near Mammoth destroys home

On Tuesday July 15, 2014, Pinal Rural Fire Rescue received an alarm at 8:22 a.m. from the Pinal County Sheriff's Office that there was a structure fire on S. Drillstone Ave., south of Mammoth. Pinal Rural had its first engine on the scene at 8:29 a.m. and found that a house was on fire.

The Mammoth Volunteer Fire Department assisted with fighting the fire. They provided an engine and four firefighters. Pinal Rural had two engines on the scene. San Manuel and Oracle fire departments were called but were unable to respond due to shortage of manpower and the need to protect their area. Tri City Med responded and assisted with rehab.

"Fighting the fire was a challenge," said Pinal Rural Fire Chief Bud Paine. There were no fire hydrants in the area so engines had to be shuttled to Mammoth to fill their water tanks from the nearest hydrants. One engine would stay and fight the fire while two engines went to refill their water tanks. This played a factor in the rapid growth of the fire. Another factor was that the fleeing

residents had left doors and windows open. This provides a huge oxygen source which accelerated the fire very quickly and made it impossible to do an inside attack on the fire.

Chief Paine would like to let the public know that if they have a home fire, make sure you get out safely but if you have time and it is not a danger to you make sure you shut any doors and open windows on the way out. This will help the responding fire department.

It was determined to be grease that ignited in the kitchen of the house and spread to the attic that resulted in the house being destroyed. Pinal Rural remained on the scene until 6:30 p.m. They returned the next afternoon and made sure there were no hot spots under the debris. No one was injured although a woman who was already on oxygen lost her portable oxygen tank. Paramedics provided her with oxygen and sat with her until the lady's oxygen tank provider delivered a new tank.

Chief Paine would like to thank the Mammoth Volunteer Fire Department for their help, Tri City Med and the Town of Mammoth for letting them fill their water tanks from the hydrants.
