Opportunity to improve transportation safety in Pinal County; Join us at a community meeting to learn more about the safety plan and future transportation safety projects

(Pinal County, AZ) With 530 fatal crashes on roadways within Pinal County between 2008 and 2017, the Sun Corridor Metropolitan Planning Organization, in cooperation with Central Arizona Governments, Maricopa Association of Governments, and Pinal County, is developing a comprehensive Strategic Transportation Safety Plan for the cities, towns, and tribal communities located within Pinal County. The goal of the study is to identify crash trends and safety issues, develop strategies to reduce the number of crashes, and implement solutions for safer travel in the county.

Community members can learn more about the transportation safety plan by attending one of the upcoming meetings. Each meeting will be an open-house format with a brief presentation at approximately 5:10 p.m. Attendees

will have an opportunity to meet with members of the study team for informal discussion on the study recommendations and view crash map data from the study. The same information will be presented at each meeting.

tips, available at azdot.gov/ExtremeHeat, including the following:

For you and your passengers: Have extra drinking water for everyone in the vehicle, including pets, an umbrella for shade and a fully charged cellphone. Pro tip: Take a cooler to keep extra drinking water cold, and consider adding several frozen bottles of water to use for cooling off or to thaw and drink if needed.

If you must spend extended time along a highway due to a breakdown or some other delay, you'll need sun protection. In addition to an umbrella, take sunscreen and a wide-brimmed hat and wear loose-fitting, light-colored cotton clothing.

For your vehicle: Check the air conditioner and coolant levels, top off any vital engine fluids and make sure your battery is up to par. Check your tire pressure, as the combination of underinflated or overinflated tires and hot pavement can lead to a blowout.

Keep your tank at least three-quarters full. Running out of gas, especially in a remote location, is dangerous in extreme heat.

If your vehicle breaks down, call for assistance right away to reduce your wait, and run the air conditioning. If your

vehicle's air conditioner isn't working, roll down all windows.

Here are other recommendations if you are stranded along the highway in extreme heat:

- Avoid parking in tall brush. A vehicle's undercarriage is very hot and can ignite grass and other vegetation.
- DRINK WATER. Make sure everyone, including pets, stays hydrated.
- If the temperature inside your vehicle becomes too hot, everyone, including pets, should exit carefully and seek out or create a shaded area as far away from the travel lanes as possible.
- Be careful walking on the road surface, which can be hot enough to burn skin. Keep your shoes on and try to keep your pets' paws off the pavement.
- Raise the hood and turn on hazard lights.

Real-time highway conditions are available on ADOT's Arizona Traveler Information site at az511.gov, by calling 511 and through ADOT's Twitter feed, @ArizonaDOT. When a freeway closure or other major traffic event occurs, our free app available at ADOTAlerts.com will send critical information directly to app users in affected areas – where possible, in advance of alternate routes.

Supervisor Rios's office spearheads clean up of Dudleyville Gun Range;

Last month concerned citizens reached out to Supervisor Pete Rios about the poor conditions of the Dudleyville gun range.

The land had been used for illegal dumping, which created an eyesore of broken appliances, household debris and other waste material. Although the property is owned by the State Land Department, Supervisor Rios

recognized the importance of caring for the "peoples' land" and accepted the challenge.

Supervisor Rios created an interdepartmental team to address the needs. In partnership with Public Works, Pinal County Environmental Services worked with State Land in receiving permission for right of entry and created a team to clean up the land. The Sheriff's Office was also

a willing participant in achieving success for this project. The land has been cleared by Pinal County and restored to its natural beauty.

Local college supports

As part of a regional consortium of community colleges and industry partners, Central Arizona College will receive \$1.2 million in federal funding to develop industry-recognized apprenticeships in manufacturing. Pima Community College will lead the \$4.23 million federal grant to develop Arizona's consortium project, named the Industry-Recognized Apprenticeship Model in Manufacturing, or i-RAMM.

Under i-RAMM, Central Arizona College, along with education partners Pima Community College, Estrella Mountain Community College, GateWay Community College, and Mesa Community College, will work with industry to develop apprenticeships that are competency-based and blend classroom and on-the-job experience.

In 2018, a total of 5,223 vouchers were issued, but only 2,983 of those vouchers were redeemed.

and ATMA) will provide assistance to the consortium by offering workforce credentials, certifications and technical assistance for apprenticeships at employer sites and promote opportunities to their members in Arizona and nationwide. In collaboration with the Arizona Commerce Authority Office of Economic Opportunity, the model will be expanded to other participating employers and colleges in the Arizona Advanced Technology Network (AATN).

“CAC is pleased to collaborate with our educational colleagues and industrial partners in Pinal County to positively impact the manufacturing workforce,” said Dr. Jackie Elliott, CAC President. “This enhances the work we have done as a member of the AATN to develop Automated Industrial Technology program curriculum, which is a result of our work with Pima and the Maricopa County Community College District, to address employer’s needs.”

Beginning this fall, CAC will offer a 16 credit Automated Industrial Technology Certificate I and a 16 credit Automated Technology Certificate II. Students who complete these certificates will be able to troubleshoot, maintain, and repair a variety of automated electromechanical, product assembly, process control, and product distribution systems that use programmable controls and other methodologies to accomplish system management. These systems include robotic, mechanical, hydraulic, pneumatic, electrical, and electronic devices. Graduates will gain the skills to define, integrate, install, program, and maintain complex control and production systems.

After completion of the certificates, students may continue on to complete an Associate of Applied Science in Automated Industrial Technology.

President Melissa Day explained that the organization is now officially affiliated with the PTO organization and they will need to pay their charter insurance and a bank account has officially been opened.

The group discussed ways to raise money and how to help support other morale building activities for students and teachers.

The PTO also voted to officially study a change to policy at the school district that would ban students from having their cell phones at school. Parents discussed some of the problems their children face due to the use of cell phones and potentials for cyber bullying. The group decided to continue to study this topic before recommending a policy change to the school board.

The group is in its infancy stages and will be setting an official meeting date. Endangered Gila topminnow to combat mosquitoes in Pinal County; fish will be used to reduce threat of West Nile, Zika viruses

PHOENIX — Pinal County will have a new ally in the battle against mosquito-borne diseases this summer: endangered Gila topminnow.

The Arizona Game and Fish Department (AZGFD) will provide 100-200 of the native fish to the Pinal County Public Health Services District on Friday, June 21 to be held for natural propagation, and later to be stocked into standing urban waters throughout the county.

The project is being done under an Endangered Species Act Safe Harbor Agreement between AZGFD, the U.S. Fish and Wildlife Service and Pinal County to cooperatively reduce a public health threat by using the endangered fish to target mosquito larvae, reducing the threat of mosquito-borne diseases, such as West Nile and Zika viruses.

“This endangered species has proven itself as a solid contender in the battle against mosquito larvae in Pima County and we are now pleased to partner with neighboring Pinal County on this highly effective project,” said Ross Timmons, AZGFD’s project coordinator. “Standing waters of any type are prime breeding habitat for mosquitoes, and that can pose a serious public health threat.”

Pinal County was scheduled to receive the endangered fish at a county health facility in Florence on Friday, June 21. They will later be placed into urban water sources, such as abandoned green swimming

pools, fountains and backyard ponds within the county.

“The Pinal County Public Health Services District’s mission is to cultivate a healthy community, where everyone has the opportunity to reach their full potential,” said Chris Reimus, division manager of environmental health with the District. “Gila topminnow should prove to be an effective tool in the vector control toolbox as a biological control for mosquitoes in habitats such as abandoned urban swimming pools. This innovative program allows us to be effective in our public health mission while also being stewards of our natural environment.”

Research over the past 20 years shows that Gila topminnow are just as effective at targeting mosquito larvae as the use of the exotic mosquitofish, which is a non-native species. While mosquitofish have been used with some success in reducing disease-carrying mosquitoes, their use has unintended consequences for native fish and their ecosystems when they escape confinement.

“This is a great example of how the flexibility of the Endangered Species Act and innovative partnerships can further endangered species conservation and address human needs,” said Doug Duncan, fish biologist with the U.S. Fish and Wildlife Service. “Mosquitofish are a major threat to Gila topminnow, and using topminnow instead of

mosquitofish helps lessen that threat.”

The Gila topminnow is a small, short-lived fish, with a general lifespan of less than a year. As their name suggests, topminnows spend the majority of their time close to the water’s surface feeding on plants, small crustaceans and small invertebrates, including mosquito larvae.

Historically, topminnow were the most abundant fish species in the Gila River basin from western New

Mexico to central and western Arizona. Over time, habitat loss and degradation brought the topminnow to the brink of extinction. It was listed as a federally endangered species in 1967. Since then, AZGFD and its partners have

worked to restore topminnow populations with the goal of delisting the fish.

ORDINANCE NO. 19-210

AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF KEARNY, ARIZONA, AMENDING ARTICLE 10-1, ADDING 10-1-26 TO THE KEARNY TOWN CODE, RELATING TO REGULATION OF SMOKING, SETTING PENALTIES FOR THE VIOLATION OF THIS ORDINANCE AND SETTING EFFECTIVE DATE. BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF KEARNY, ARIZONA, AS FOLLOWS:

Section 1. That Article 10-1 of the Kearny Town Code is hereby amended to add Section 10-1-26 to read as follows:

Sec. 10-1-26. Purpose. (A) The smoking of tobacco or any plant is a positive danger to the health and a material annoyance, inconvenience, discomfort, and a health hazard to those who are present in confined spaces, in order to serve the public health, safety and welfare, the declared purpose of this article is to restrict the smoking of tobacco or any plant within enclosed places, in particular public places and places of employment. (B) Electronic smoking devices, which first entered the United States market in 2007, are electronic inhalers meant to simulate cigarette smoking. Electronic smoking devices use a heating element that vaporizes a liquid solution. Many electronic smoking devices release nicotine, a highly addictive substance, while some merely release flavored vapor. They are designed to mimic traditional smoking implements in their use and appearance. Although the long-term effects of electronic smoking devices may require further study, the United State Food and Drug Administration has found that some devices contain toxins and carcinogens and has expressed concerns about their safety. Use of electronic smoking devices, particularly in places where smoking is prohibited, may interfere with smokers’ attempts to quit by making it easier for them to maintain their nicotine addiction. Children and youth who experiment with electronic smoking devices may become addicted to nicotine and ultimately switch to smoking cigarettes. (C) Therefore, in order to serve the public health, safety and welfare, the declared purpose of this article is to restrict smoking within enclosed places, in particular, public places and places of employment.

Sec. 10-1-26.01 Definitions. The following definitions shall apply in the interpretation and enforcement of this article: (a) Smoke or smoking, as defined in this article, includes the (1) Carrying or placing of a lighted cigarette or lighted cigar or lighted pipe or any other lighted smoking equipment in one’s mouth for the purpose of inhaling and exhaling smoke or blowing smoke rings; (2) Placing of a lighted cigarette or lighted cigar or lighted pipe or any other lighted smoking equipment in an ashtray or other receptacle, and allowing smoke to diffuse in the air; (3) Carrying or placing of a lighted cigarette or lighted cigar or lighted pipe or any other lighted smoking equipment in one’s hands or any appendage or devices and allowing smoke to diffuse in the air; or (4) using an electronic smoking device designed for the purpose of inhaling and exhaling aerosol or vapor. (b) Enclosed public place means any area closed in by a roof and walls with openings for ingress and egress which is available to and customarily used by the public. Enclosed public places governed by this article shall include, but not be limited to, public areas of grocery stores, waiting rooms, public and private schools, doctor’s office buildings, community centers, child care centers public restrooms, all indoor facilities and any public places already regulated by A.R.S. 36-601.01 and restaurant/caferterias, bars, sports bars, bowling alleys and billiard halls. A private residence is not a “public place” (c) Bar shall mean an area devoted primarily to alcoholic beverage service to which food service is only incidental. (d) Employee means any person who is employed by any employer for direct or indirect monetary wages or profit. (e) Employer means any person or entity employing the services of an employee. (f) Place of employment means any enclosed area under the control of a private or public employer. A private residence is not a “place of employment (g) Designated smoking area means any area outdoors which is outside of any enclosed public place and removed from building entrances and exits. Any designated smoking area must be so situated as to allow nonsmoking individuals to conduct normal activity in a smoke-free environment. (h) Employee work area means any areas within a place of employment, which share a common ventilation, heating or air conditioning system. (i) Electronic smoking device or electronic cigarette means any product containing or delivering nicotine or any other similar substance intended for human consumption that can be used by a person to simulate smoking through inhalation of vapor or aerosol from the product. The term includes any such device, whether manufactured, distributed, marketed, or sold as an e-cigarette, e-cigar, e-pipe, e-hookah, or vape pen, or under any other product name or descriptor.

Article 10-1-26.02

Sec. 10-1-26.02. Responsibility of owners, etc. In addition to any other requirements imposed by this article, an owner, manager, operator, employer or other person in control of any place regulated by this article shall: (1) Properly identify all shared enclosed indoor airspace as non-smoking; and (2) Protect entrances and exits from outdoor drifting environmental tobacco or electronic smoking device.

Article 10-1-26.03 Any person found guilty of violating any provision of this Ordinance shall be guilty of a class two misdemeanor.

Section 4. Pursuant to the Kearny Town Charter, ordinances are effective thirty (30) days after adoption.

The District's current budget override is by law required to be reduced by one-third in each of fiscal years 2020/2021 and 2021/2022. The proposed override budget will exceed the 2020/2021 alternate budget by one-third of the override amount (approximately \$111,333) and the District's secondary tax rate required to fund this amount is estimated to be \$0.23 per one hundred dollars of net assessed valuation for secondary property tax purposes. The full budget override amount is estimated to be \$334,000 and would be funded by an estimated \$0.69 tax rate per one hundred dollars of net assessed valuation, which is approximately equal to the current tax rate levied for the existing override. In future years the amount of the increase will be as provided by law.

The election will be a mailed ballot only election. No polling places will be provided. Ballots will be mailed to qualified electors residing within the District no earlier than 27 days prior to the election and no later than 15 days before the election. Ballots must be received or dropped off at one of the designated ballot drop box locations as set forth in the informational pamphlet and/or the ballot no later than 7:00 p.m. on Election Day. The informational pamphlet will be mailed to the homes of qualified electors. If a ballot is lost, spoiled, destroyed or not received by the elector, the elector may receive a replacement ballot at the ballot replacement locations designated by the County Elections Department.

The last day to register to vote in order to be eligible to vote in this election is Monday, October 7, 2019.
