Hearing on new fire district is next Wednesday in Florence

By now, many property owners in the area have received an information letter from Pinal County Special Districts explaining that Pinal Rural Fire & Rescue (PRF&R) is in the process of transitioning from a 501(c)(3) nonprofit Fire Rescue service to a Special Tax District Fire District as permitted under ARS 48-261. People may be asking: why is this being done, and what are the advantages for me? This letter will attempt to answer those

PRF&R is the ONLY 24/7 Fire-Based Paramedic Service between Golder Ranch and Globe. Currently, PRF&R is a subscription service. ALL services are free to subscribers; nonsubscribers are never charged for Emergency Medical Service (EMS) responses. EMS makes up, on average, 75% of a fire department's responses; therefore, it constitutes a large share of PRF&R's services.

The proposed change will create a designated Fire District in an area where there has not been one in the past. It will no longer be a subscription service; instead, all property owners in the district will contribute via property taxes to support the service. There are many benefits of doing so:

- It will provide dedicated service by a permanent fire district that fills in the gap between Mammoth and Dudleyville.
- It will provide a staff of nationally certified first response fire and medical personnel, and will greatly reduce emergency response times in the proposed district.
- Predictable funding will allow for improved capital planning and assure reliability and quality of services in the future. It will allow PRF&R to hire certified shift firefighters and to pay stipends for local volunteer staffing.



Reminder: Comments due for Ray USD November override election

Voters are reminded that the deadline to file comments for or against the Ray Unified School Districts override election will be 5 p.m. on Wednesday, Aug. 6. The comments must not exceed 200 words, they will need to be hand

delivered to the Pinal County School Superintendent at 75 N. Bailey St. in Florence or they can be mailed to PO Box 769, Florence, Arizona 85132. An informational pamphlet will be mailed to each home with a registered voter with the comments are submitted.

The override election was approved by the board in June. If the override is approved by the voters there will be no increase current taxes paid for the schools, the override will allow the existing secondary tax rate to remain in place, it does not allow for an increase. Should voters not approve the override election, the school district will be forced to cut \$110,000 from the budget each year for the next several years. Ray USD

voters have consistently supported the override elections since the 1980s.

Voters will head to the polls on this issue on Tuesday, Nov. 4, during the General Election. The deadline to register to vote in the November election is October 6, 2014. Voters can now register to vote online on the Service

established her principal certification and is presently in her second year as principal.

Gonzalez and Hambly have both exemplified their desire to be a strong leader of the youth and throughout the years developed a passionate drive to enhance the school and students' development.



Town of Hayden to make budget cuts

Last week the Town of Hayden approved its annual budget at \$8.5 million.

With the current amount budgeted the council announced that there will be close to \$600,000 in cuts to the budget. Those exact cuts were not announced publicly during the regular session meeting but will be covered in future meetings. Some of the ideas to cut

the funds were addressed in a work session earlier in the month; some of the suggestions are cutting town employees down to 72 hour work weeks, increasing fees for golf course and ramada use, and also evaluating town positions that could be part time positions.

The council also approved their minutes from several meetings including minutes from May 19, 2014. Arizona State Law requires that minutes need to be completed within 72 hours of a meeting. The minute approvals are now all caught up for the Town of Havden.

The Council also heard a brief presentation from Andrew Taplin, the project manager for Resolution Copper. Taplin updated the council on the project and explained that they anticipate the drilling for the #10 shaft to be completed in October and that crews are starting to ramp up again now that the cooling system has been improved.

Taplin also explained that Resolution

Copper contributed funds to the Hayden-Winkelman Little League, the Hayden-Mammoth softball team, and also was a major sponsor for the San Pedro River Festival. Taplin explained that those contributions are part of their social license to operated in the Copper Corridor region. In other business the council approved the annual service fee for the Spillman system which aids the police department in both local and interagency communications.

A warning to drivers, Pinal will prosecute 'stupid motorists'

Florence – Pinal County Attorney Lando Voyles reminds drivers to drive safely during this monsoon season and to abide by all warning signs, especially on roads closed due to flooding.

Nearly a year ago, on July 28, a Las Vegas-bound tour bus, carrying over 30 people, became stranded in a flash flood near Dolan Springs. We find ourselves in the middle of monsoon season with thunderstorm warnings and heavy rainfall totals building up in short amounts of time.

Even if driving into a flooded area does not cost the operator their life, it may cost them financially. Arizona's "stupid motorist law," ARS 28-910, allows prosecutors to

seek restitution of up to \$2,000 for expenses related to an emergency response by a private or public agency to rescue occupants or remove a vehicle made inoperable due to flooding.

Two conditions allow for this law to apply: if the individual drove the vehicle on a public street or highway that is barricaded because of flooding and temporarily covered by a rise in water-level; or, if the driver is convicted of reckless driving, ARS 28-693, showing a reckless disregard for the safety of persons or property by driving a vehicle into any area that is temporarily covered by a rise in water-level.

The \$2,000 liability may be excluded by insurance policies

and would be in addition to and not a limit of any other liability that may be imposed.

Pinal County Attorney Lando Voyles stated, "When drivers recklessly enter into dangerous areas covered by water or ignore safety signs and barricades warning of increased water-levels, they risk their own lives, the lives of their occupants and that of those first responders charged with rescuing them. Each monsoon season, Arizona experiences flash flooding and in Pinal, if you needlessly risk the lives of occupants by driving into flooded conditions imperiling the lives of rescuers, we will seek the compensation those agencies are entitled. As always, please drive smart and drive safe."


Third annual Superior Prickly Pear Festival set for Aug. 23

to identify the most edible of the hundreds of prickly pears in the state, gather and prepare the luscious purple fruit and the nutritious green pads. Experts will guide visitors in how to turn the pears into tasty salads, entrees and desserts, brew a light melony pale ale and make wine and mead from the fruit.

Events begin at 6:30 a.m. with a choice of two hikes through prickly pear territory, timed so hikers can return in time to enjoy a sumptuous outdoor breakfast prepared by members of the Superior Fire Department. One of the walks will be a tour of Old Pinal City, led by Tonto National Forest Ranger Scott Wood, an expert on the history of the area and its native foods and people. The second hike, led by Lost Trail steward Bill Vogler, will loop from the Picket Post Trailhead to Arnette Canyon.

The firemen's breakfast, on the patio of Porter's Cafe, on Main Street, will be served from 7 to 11 a.m. and will include ham, eggs, pancakes with prickly pear syrup, juice, milk and coffee-all for a suggested donation of \$6. Proceeds benefit the firefighters.

The event will run from 9 a.m. to 4 p.m. (the hikes are earlier) on Main Street in Downtown Superior. The first 100 visitors to register at the Chamber of Commerce office, 165 Main St., will receive a free prickly pear pad.

Superior is located off Hwy. 60, about an hour east of Phoenix and three miles east of the Boyce Thompson Arboretum.

Rural municipal governments are built from the

Ask towns along the Copper Corridor what type of government they have and they will reply the Council/Manager form, under which administration of government functions are handled day-to-day by a hired town manager while an elected mayor sets the agenda for the council enacting the laws and budget.

But in practice, the function of these governments wedged in northern and eastern Pinal County and southern Gila County can vary widely from the model. What changes there are can be attributed to evolution and more recently to budget constraints resulting from shrinking populations and tax bases.

Superior on the northern section of the corridor has a traditionally strong manager in Margaret Gaston, who not only oversees the day-to-day activities of the town but does double duty as head of Superior's Finance and Economic Development. But unlike many Council/Manager governments, Superior has an elected Mayor in Jayme Valenzuela, who exercises broad powers to set the government's agenda, including drafting the annual budget.

While noted for its proximity to the Tonto National Forest and having one of Arizona Highway Magazine's 50 best places to dine in the Los Hermanos Restaurant and Lounge, Superior also has the area's best attended council meetings. Citizens there have great interest in their government and are eager to share their opinions, several Superior executives bragged.

As with all towns in the corridor, Superior has battled a budget deficit. With revenues "stretched thin, Superior employees have had to pitch in and at times to perform more than their job," said council member Mila Besich-Lira. To shore up the budget, the Superior Council earlier this year raised the town sales tax to 4 percent, which when combined with the state 5.6 percent sales tax and the 1.1 percent Pinal County sales tax, brings the total levy to 10.7 percent, making it among the highest in Arizona.

In return for their tax payments, Superior not only has a large fire department combining professional and volunteer firefighters, but also is one of the few area communities offering ambulance service.

The major current in-town project is the widening of US 60 from two lanes to four lanes with a central turn lane. This project will run north through Miami. The town also has applied for CDBG funds for another civic improvement project but won't know if it is approved until July.

Miami, which being incorporated in 1918 gives it the oldest town government in the corridor by more than 30 years. It has the most traditional functioning Council/Manager governments, with Mayor Rosemary Castaneda, who was appointed from within the ranks of the town's seven-member council; and City Manager Jerry Barnes, who not only directs the day-to-day operations of Miami but fills in as head of the Parks and Recreations Department.

Besides being the birthplaces of Nixon Administration US Treasurer Romara Acosta Banuelos and Western film actor Jack Elam, Miami is noted for its frugality. For instance, the city has never had a website, seeing no need for one in a town with fewer than 2,000 residents, said Karen Norris, recently hired as Miami's Clerk. It also has been slow to fill government positions, as its volunteer fire department is currently without a chief. As a result, Miami has kept is portion of the sales tax to

 ${\bf 2}$ percent. Much of the city's revenues comes from contracting fees and enterprise funds.

Mammoth on the southern section of the corridor may seem a tranquil delight for birdwatchers and rock hounds, but its government is quite lively. There has been a certain volatility in management, as three different council members have assumed the vice mayor position in the past year. And the government has spawned at least two online blogs that critique and criticize (some say over criticize) government operations. Both blogs are predicting the next elections to be exciting.

In Mammoth, the town manager duties as mostly performed by the clerk, though some aspects of managing Mammoth government departments have been assumed by some council members. Council members have assumed "commissioner" positions overseeing town departments.

"Salary and location issues make it harder for places like Mammoth to find qualified people to fill administration jobs," admitted Large, who currently commutes to her Mammoth job from Tucson.

While maintaining only a 2 percent sales tax, Mammoth secures revenues through use and property taxes, plus CDBG and Enterprise funds. Through grants from the US Department of Agriculture, Mammoth is upgrading its water quality with the building of a reverse osmosis system that will extract more minerals (local water is extremely hard) and pollutants from

the town's water supply than current technology, Large said. Having more local amenities than other area towns, Kearny has the traditional Council/Manager government with one twist. While council members serve four years terms with half going up for election every two years, the mayor (currently Sam Hosler) runs separately for his job every two years. Council members, however, appoint the vice mayor from their ranks (currently Daniel L. Radcliffe).

Kearny has a strong manager in Anna Flores, who also doubles as head of the Finance and Parks and Recreation departments. She also headed the clerk office until Cathy Woolery was hired on May 1. Management of the town includes the Kearny Airport, which is widely used by small aircraft to fly sportsmen, snowbirds and vacationers in and out of the area year round.

Other Kearny amenities include the Kearny Golf Course and the Kearny Library, which Flores describes as one of the best in Arizona. Kearny also has a municipal ambulance service.

Operating revenues for Kearny come from assorted sources, but primarily the 3 percent sales tax, and taxes on hotels/motels, rental property and construction-related contracting. Flores bragged that Kearny has no business licensing fees.

While Hayden is on paper as having the Council/Manager form of government, it has operated without a hired town manager for some time, though Hayden Clerk Laura A. Romero

same model but are unique in their own way

said one may be hired after the November elections if the 2014-15 budget allows it. Until then the mayor also serves as acting town manager.

Hayden also elects its mayor separately from council members once every four years. Currently, Councilman Tommy Lagunas is serving as mayor. He was appointed at a special meeting in June after the directly elected Mayor Chale Vega resigned after pleading guilty to a felony. Without a manager, more administrative duties are becoming captive to the elective members of the government, signaling to some that the town could revamp into another format. Saving the manager's salary would help reduce the town's budgetary needs.

The major civic attraction in Hayden is the Hayden Golf Course. It also is home to many fine restaurants, said Romero. Major sources of revenue to Hayden include the 3 percent sales tax, a 3 percent use tax, and other levies on hotel/motels, property, utility bills, mining and timber extraction.

New candidates interested in running for the Hayden Council are invited to step forward as at least one current member is considering retiring at the end of term, a town spokesman reported.

With a population of only 353 residents, Winkelman became in 2010 the smallest incorporated town in Arizona. And with its tiny size came declining revenue sources.

Winkelman has a smaller council than the other corridor towns, having only five members, from whose ranks the mayor is appointed. Winkelman has no town manager, though the administrative duties are perform by town Clerk Sylvia M. Kerlock. In the entire Copper Corridor, nobody multitasks like Kerlock, who also heads Winkelman's Finance, Human Resources, Parks and Recreations departments. Kerlock also is the town public relations manager.

Other budget savers include sharing the police department with nearby Hayden. But the town's website is currently down.

Revenues come primarily from a 3.5 percent sales tax, a property tax, contracting fees, licensing fees, and Enterprise funds.

Despite a shortage of revenues, Winkelman has several local projects in progress. ADOT grants are enabling improvements

to Third and Fourth Street. Another government grant is being used to upgrade the town's water treatment plant.

One thing all of these municipalities have in common is that town councils are elected to four year terms but election is staggered so that only half of members stand before the voters every two years.

Within the Copper Corridor are several communities with slightly larger populations than most of the incorporated towns but have not incorporated.

Oracle, with a population of 3,686 residents, has seen incorporation proposals come up three times in the past but they never got anywhere possibly because of a smaller tax base. Since the local mines closed more than a decade ago, the local business community has shrunk to a handful of stores that could not generate enough sales tax revenue to fund government operations, several residents explained.

The same applies to San Manuel, which has 3,551 residents, but not much of a tax base. Both have become bedroom communities for people who work in Tucson and havens for retired people. According to San Manuel Library employee Linda Lee, retirees especially prize the sturdy construction of homes in this one-time company mining town.

But then the same problem has faced San Tan Valley, which with 81,000 residents (as of 2010) is the largest unincorporated community in the state. Sitting in Pinal County just over the border with Maricopa County and Queen Creek, growing from a single subdivision in 2001, the community considered incorporation in 2011 but it never got to a vote. This was partially due to citizen fears that it would greatly raise their property taxes due to a lack of retail businesses to provide sales tax revenues. But the retail base is growing, and there are proponents who are looking into pushing the issue again soon.

Residents of the Copper Corridor do pay property taxes to one agency or another, but the exact percentage of assessed property value is hard to place from year to year due to changing property values and civic needs. For instance, Superior placed a 7.6269 percent on assessed property value for the 2013-14 fiscal year, but that rate will be different once the town's 2014-15 budget is approved and put into effect, said

Superior Manager Margaret Gaston.

Property taxes also can be set by the area's school districts, which get their basic funding from the state, but can raise the levy on real property if voters approve an override for up to 15 percent over the total funding provided by Arizona.

Like town governments, school districts have elected school boards that set educational policy and determine how much individual programs are funded. All the districts have school boards of five members who serve four year terms but elections are staggered so half the members face election every two years.

Of area school districts, the Superior Unified School District and the Oracle Elementary School District currently have 15 percent overrides in effect. The Miami Unified School District last November had a 10 percent override approved by voters last year. Ray Unified School District also has a 10 percent override in effect. The Mammoth-San Manuel Unified School District and the Hayden-Winkelman Unified School Districts have no overrides.

Among projects at local schools, the Superior Unified School District received a \$98,550 grant from the Arizona Department of Education (ADE) to install campus-wide video surveillance systems in both its schools and an interlocking door system at its junior/senior high school to improve school security. Superintendent J. Patrick O'Donnell is also proceeding with plans to make both of its schools nearly energy independent by the installation of solar panels to generate the electricity each school uses. Already installed on the high school, the panels provide 90 percent of the electricity needed, as will the panels to be added to the elementary school.

Oracle Elementary also received a \$9,889 ADE school security grant to install the locks on classroom doors to better protect students from imminent threats posed by outsiders.

At Mammoth-San Manuel Unified School District, funding to boost school security is being sought. According to Superintendent John Ryan, the district's schools have a vandalism problem that he believes can be remedied by security cameras, but the district hasn't the revenues to put the



Movement to improve veterans' resources in Pinal County gathering steam

While Pinal County might be considered rural and far removed from the hustle and rush of larger cities, communities here have contributed their fair share of heroes in the defense of freedom.

Families throughout this unique regional area have sent scores of sons and daughters off to defend freedom for generations. These same sons and daughters later returned to their communities, raised families, started businesses and built community.

While brave men and

women are still fighting in Afghanistan and serving in other posts around the world, troops need continued support while veterans and families at home need attention as well, especially those that are struggling.

A new spirit of cooperation and enthusiasm between veterans' organizations, churches, non profits, community and government leaders are working together to learn how they might better support veterans, troops and military families.

Although the current crisis with the VA has helped to shed light on the some of the issues that veterans face on a

daily basis, in reality, the VA system has been troubled for decades.

One Pinal veteran stated, "This is an opportunity to change things, to make things right at the VA. But only if those in charge will listen, take action and do what's right for the men and women who have served with such dedication and courage."

Despite the problems with the VA, exciting things are happening around Pinal County that will benefit veterans and military families directly in the communities closest to where veterans live.

For the past year and half, Sonnette Chaput has worked tirelessly with the VetCorps and the Pinal Hispanic Council in association with Honoring/Helping/Honoring our Heroes (HOHP) to identify needs of Pinal County Veterans in order to connect them with resources.

Chaput has helped to develop a Veteran Service Directory that lists services state and countywide. The directory is 18 pages long and is available to any organization by calling 520-423-4255.

"We have definitely seen an increase in the number of veterans who are needing and or requesting assistance. We want to be available to assist each and every one of them," stated Chaput.

According to the Veterans' Administration website, there are roughly 26,000 veterans in Pinal County, with approximately 40 percent using VA services. The other 60 percent either does not require services or have not come forward.

HOHP has been working to connect Veteran organizations in Pinal County and has successfully hosted two "Arizona Stand Downs" for the regional area, in 2013 and 2014. According to Chaput, 125 veterans were assisted with services in 2013 and 189 in 2014. A "Stand Down" is

an outreach event that assists and connects veterans with shelter, services, healthcare, employment services.

Together, Chaput, HOHP and the Pinal County Attorney's office hosted the county's first Veterans Stakeholder Forum in October 2013, during which over 87 organizations took part in and discussed critical issues facing veterans in Pinal County.

Critical issues included how to support and service new veterans returning from the Middle East, employment, mental health, homelessness, transportation, family and financial issues and suicide prevention. A second Veterans' Resource Forum is scheduled for Oct. 2014 at the Ak-Chin Casino, exact time and dates will released soon. In addition, a new Veterans' Center will be opening in Elov and Casa Grande, and the push is on for a similar center in San Tan Valley by the

According to Alan Pease, past commander and founder of Post 97, the group plans to reach out to returning veterans who are choosing to settle in the area or who are returning to families.

Pease stated, "One of the most critical and pressing areas where we need help right now is with community volunteers. We need people to step forward all over the



said Paul Lewis, assistant professor in the School of Politics and Global Studies at Arizona State University.

"Council/Manager

government with its strong manager and weak mayor seems best suited for small towns. It is more corporate in structure with the mayor (elected or appointed by the town council from its ranks) functioning as the chairman of the board while the town manager (always hired) functions as the CEO (Chef Executive Officer). The town manager serves as the town government's administrator, running the day-to-day operations while implementing the

directives of the town council. The mayor in these governments still set the agenda and even draft town budgets, but leave the dayto-date implementation to the town manager," Lewis explained.

"This differs from the Mayor/Council form of municipal government where the elected mayor not only serves as the town council leader but also oversees the administration of government functions. This gives the mayor broad powers in directing the municipal government from proposing ordinances to setting policy and hiring the department heads to carry out those policies," he added.

Mayor/Council is more popular in large cities; the classic example being Chicago where Richard J. Daley (1955-1975) and his son Richard M. Dalev (1989-2011) literally ruled the city, molding it to their visions.

There are some variations of these popular municipal government models, Lewis noted. In New Jersey there has evolved the Council/ Administrator form where in the elected council hires an administrator who takes orders from the council members in directing the town affairs. A variation of the Mayor/Council government has the mayor

delegating some of his administrative powers to a hired clerk.

In other parts of the country, small towns that due to declining revenues from a shrinking tax base, the councils have opted not to hire a manager and instead designate one of their number or even take turns overseeing the administration chores.

Even less common is the commission form where the town elects commissioners who allocate the duties of various government departments within their ranks. Mammoth is assuming this form of government.

project in its current budget. Oracle Elementary School District plans to put an initiative on the November ballot to keep its override at 15 percent as the 2014-15 school year is the last year it can keep the maximum before they begin a threeyear spiral to zero.

Concerning the towns that have dropped in population and losing their tax base, there is an option. According to Ken Stroboek. executive director of the Arizona League of Cities and Towns, the option is unincorporation. But there is a Catch 22. Under Arizona law, unincorporation is permitted only after a town has paid all outstanding debts.

Not that any of these bustling municipal governments are even remotely thinking in that direction.

county to assist our veterans who are returning from Iraq and Afghanistan. These are younger veterans who may have served in three or four tours and need assistance with re-entry and the transition back to civilian life."

"Veterans who live in Pinal County have to travel to Gilbert, Phoenix or Tucson, which is an added strain. Eckman lives in San Tan Valley and was a Chief Warrant Officer in Military Intelligence. He is also President of the Encanterra Veterans' Club.

There are many tragic stories of veterans who return home and don't get assistance they need.
