# Home Alone/Guardian Alert Units Available

hat if you were an older resident of our Tri-Community area, lived alone and fell with no one around to provide assistance and your cell phone was in another room and you couldn't reach it? What would you do?

One of the services provided by Triad in Oracle and the surrounding communities is the Guardian Alert Program, formerly known as the Home Alone Unit Program. Triad is collaborative program between seniors, the Pinal County Attorney's Office, the Pinal County Sheriff's Office, Pinal County Police Departments and the Pinal County Fire Departments to keep seniors safe in their homes.

Triad Volunteers will install a pendant system in the home that can be activated for an emergency call to 911 verbally. Seniors requesting this service must have a land line. When the volunteer installs the system, they will evaluate the types of assistance needed and medications taken, and identify a contact person who could assist the resident. A Triad Volunteer will also check on the resident with the Guardian Alert about every six months to ensure the system is working properly. The Pinal County Sheriff's Office stores this information and when they respond to the residence, they have already been provided with this information which is kept strictly confidential.

What if you don't have a landline, only a cell phone? You can still call Pinal County Sheriff's Office at 520-866-5111 and they will include you on a list of persons needing

additional assistance. Again, that information is kept confidential.

Participants in the Guardian Alert program should plan in advance for an emergency such as an evacuation and have the contact information of an individual who can assist them or verbally call out 911 and a sheriff's deputy will arrive as quickly as possible.

Lock boxes may also be requested from the Pinal County Attorney's Office that will house a spare key to be used by first responders in the event of an emergency. These services are free to Pinal County residents, but donations are gratefully accepted.

Other services provided by Pinal County is the Pinal Emergency Notification System (PENS) which requires you to create an account and identify the notifications you desire i.e. road closures in Pinal County, evacuations, etc. This is available for all residents in Pinal County whether you have a land line or cell phone. The Oracle Emergency Notification System is similar and is available to residents of Oracle. To enroll in the Oracle ENS system, contact the Oracle Fire District for an application or go to www. OracleFire.Org for the Emergency Notification System form. For additional information about the Guardian Alert Program in Oracle, contact **Tina Acosta** at the Oracle Fire District, 1475 W. Former Assistant Principal, Crystle Nehrmeyer is the new Superintendent at the Oracle School District. She is replacing Dennis Blauser who has retired.

"Dennis Blauser left big shoes to fill but I am honored to step into his shoes and take the District into the next chapter," Crystle said.

Crystle has been the Acting Superintendent from April 15 through June 30 and officially took over the position July 1. She will also handle the duties of Principal and Assistant Principal. The Assistant Principal position was eliminated as a budget measure.

"The more money we can put into the classroom the better," Crystle said. Crystle has been busy this summer preparing for the new school year. She is excited that Mt. Vista will offer an Art Education Program this year for K - 8. "We have found an awesome Music

teacher this year for K - 8," she said. Mt. Vista will continue to have P.E. and the Tech Academy as well. They will have five new teachers this year: Jose Cardona, Art; Phil Coleman, Music; Mark Parrish, 7th Grade English Language; Tara Garcia, 6th Grade; Debbie Vargas, 6th Grade. Besides athletics, the school will continue to offer math tutoring as well as extracurricular programs including Teens Sew Cool, Rocket Club, Gardening Club and D – Club. D – Club is a leadership group for 3rd grade through 5th grade students. Grades 5 through 8 students will receive Chromebooks to use at school and take home.

"By doing this, it will give us greater curriculum options and allow students to collaborate in new ways," said Crystle. She proudly announced that last year on the AZ Merit assessment, all grades demonstrated growth on reading and writing.

"This was the result of hard work from all our teachers and students," she said. "Our enrollment is strong and we are very happy to grow the Mt. Vista family."




### Vista Church: Seeing the Possibilities

t takes a discerning eye to see what once was and what can be again! Thirty-five years ago, I was assigned to a dying church in a dying downtown neighborhood. Thirty years before, this neighborhood had been a thriving downtown area and the church the largest protestant church in the East Valley. But when I got there most of the businesses were gone. The church building was surrounded by crack houses, drug rehab houses, and houses of prostitution. The first Easter Sunday Sunrise service I preached, we had it indoors in the sanctuary, because it was raining outside. It didn't matter. The roof was so bad the rain was pouring in and we set up a child's play pool across the pews to catch the water. The church and community were in terrible shape and I was told not to expect to

To apply for free or reduced-price meals, households can fill out the application and return it to the school unless the household has already received notification that their children are approved for free meals this year. Application forms are being distributed to all households with a letter informing households of the availability of free and reduced-price meals for their children and what is required to complete on the application.
