Fire danger remains high and fireworks pose huge fire threat

As we inch closer to the 4th of July holiday, the Department of Forestry and Fire Management wants to remind the public that the fire danger remains extremely high and dry conditions persist across the state. Fireworks are a huge fire hazard and have been the cause of many wildfires. With that, we urge the public to be careful and not careless if using fireworks.

As a reminder, fire restrictions and closures are still in place across the state. However, fireworks are never allowed on Arizona State Trust lands or federal lands, at any time of the year.

Even with the recent moisture the state received a few weeks ago, it was not enough to rectify the drought situation or reduce Arizona's fire danger. Vegetation remains dry and can act as kindling and spark a fast moving wildfire.

Fire restrictions and closures will not be lifted until the

"While we want people to enjoy their 4th of July holiday, we also ask that people use extreme caution if they are using fireworks, be obedient of the laws, and of course, the fire restrictions. Under no circumstance are fireworks allowed on state or federal lands, at any time. We will be out patrolling and making sure that everyone is being safe and no one is breaking the law," said State Forester Jeff

Whitney.

Fireworks are regulated in the state under Arizona Revised Statute 36-1606. Under state law, firework sales are restricted to the 4th of July and the New Year holidays with only certain types of fireworks allowed to be sold in the state.

Firecrackers, bottle and sky rockets, roman candles, and any type of aerial fire work are all illegal in Arizona.

According to state law, there are two methods by which police may arrest suspected offenders. The suspect may be physically taken into the department and booked into jail, or the arresting officer may write a citation and release the suspect to appear in court later. Advocates help foster kids reach independence

FLORENCE, AZ - At a time when our country is celebrating its independence, hundreds of kids in Arizona's foster care system are trying to finds theirs without the guidance and direction that traditionally comes from parents.

Teens who enter the foster care system are at a disadvantage when it comes to independence. They are more likely than younger children to be placed in a group home or shelter situation with up to a dozen other youth and limited opportunities for personal growth. This hits hard at a time when most other kids their age are getting ready to drive, graduate high school and date.

There are thousands of teens in foster care in Arizona and every six months more than 500 of them reach the age of 18 and head out into the world on their own. The

community can help. Studies have shown one caring, consistent adult can have a life-changing impact on a child in foster care. That's why the Court Appointed Special Advocate (CASA) Program is so important.

CASA advocates ensure not only that a child in foster care has a consistent adult presence but that they have the services and support they need to thrive. CASA advocates are appointed to one case and visit the children involved with that case regularly. They gather vital information which is shared in a court report with the judge who will ultimately make decisions regarding the child's living situation.

Children with a CASA volunteer assigned to them are more likely to receive services and resources; twice as likely to find a safe, permanent home; and half as likely to re-enter the foster care system. Unfortunately very few children get the support of a CASA volunteer.

There are approximately 85 CASA volunteers serving children in Pinal County. More people are encouraged

- · Volunteers must be at least 21 years old.
- · Volunteers go through a rigorous screening process including interviews, reference check, a fingerprint check, and polygraph exam.
- · Volunteers are asked to make a commitment to one case until its conclusion, typically involving 15-20 hours per month.
- · Volunteers must complete 30 hours of pre-service training.
- · CASA volunteers are advocates, not mentors. Their objective is to help the court system determine the best outcome for the child.
- · CASA volunteers try to build a 360-degree view of the child and his or her surroundings. To do this, they meet with teachers, counselors, physicians, and guardians.
- · CASA volunteers work to ensure that children are in safe, permanent homes where they can thrive.


What is Degenerative Joint Disease?

JD, or Osteo-Arthritis, is a condition that plagues most active adults. It is the degeneration of the cartilage that pads our joints. This occurs from standard usage, though there is evidence that an auto immune component may be at work against the cartilage. As the cartilage disintegrates, the two opposing bones of a joint come in contact and grind on each other. This can cause clicking and cracking to occur when the joint is bent and can become very painful.

Osteo-Arthritis is distinctive from Rheumatoid Arthritis. Osteo-Arthritis is a degenerative process whereas Rheumatoid Arthritis is an inflammatory process. Osteo-Arthritis causes symptoms that get worse with use. In other words, the pain will worsen throughout the day. Rheumatoid Arthritis will have pain that eases with mild use which dissipates the fluid that triggers the pain. Osteo-Arthritis often presents in isolated joints whereas Rheumatoid Arthritis most frequently shows up on symmetrical sides of the body.

Degenerative Joint Disease is most often treated with pain killers and anti-inflammatory drugs until a replacement

joint is deemed necessary. This is like addressing an oil light on our automobile dash board by covering it up with a piece of tape. The annoying light (or pain) may be gone, but the grinding away continues.

An oral supplement of glucosamine sulfate has been used for years with its reputation for regenerating cartilage as long as there is some remaining in the joint. Historically it HAS worked, though it takes a long time and it is subject to many variables during that time.

A recent protocol for stimulating the regeneration of cartilage is through injections. These injections are grouped under the term "ProloTherapy." Unlike steroid injections which shut down the immune system to create an antiinflammatory environment, prolo stimulates an inflammatory response. The strategy is to choose various substances to inject into the joint area that cause "workmen" to rush to the area to rebuild the joint. Of course, with more "workmen" comes more fluid that then push on nerve endings that are pain receptors. So, the choice here is to shut down all reconstruction efforts and live in relative comfort while waiting for a prosthetic replacement or endure some discomfort while investing in reconstruction efforts, though many individuals choose to simply limit their activity in those joints that are effected or at least support them with various braces.

The three major types of prolo-therapy are injecting with a combination of

glucosamine, dextrose and procaine or injecting with ozone or injecting with platelet-rich-plasma (a "stem-cell type" mix). Typically 5-10 injections are needed, spaced a number of weeks apart.

Stem cell treatments are becoming more and more

available. It certainly appears to be a very eloquent way of addressing degenerating systems in our bodies. And, as with any burgeoning industry, it is important to research out reputable resources.
