# Please Mandate Masks in Pinal County

I am Artistic Director of The Oracle Piano Society, a nonprofit arts organization serving the unincorporated area of Oracle in Pinal County's Supervisor District 1. I am writing in strong support of Supervisor Pete Rios' initiative to mandate face masks.

As the father of a medically fragile child, my family has spent enough time in the hospital to recognize the real-world impact of infectious diseases.

COVID-19 is no joke and, according to science, the only known way to prevent its spread is to socially distance and wear a mask.

Preventing the spread of COVID-19 will shorten its lifespan and will protect our vulnerable population.

Knowing this, it is astounding to me that anyone would resist wearing a mask or advocate against mask wearing.

The population most at risk, our greatest generation, made countless sacrifices during World War II. In addition to putting their lives on the line to defend our freedom, citizens engaged in many domestic sacrifices including rationing, volunteerism, and investing in the country.

Wearing a mask to protect that generation is the very least we can do.

We will hold outdoor drive-in concerts until it is safe to convene indoors, we will conduct our educational programs online until it is safe to meet in person, and we will require masks at all events.

# Will the union go back to work?

After nine months on strike, officials with the United Steelworkers

announced that they made an unconditional offer to return to work to ASARCO. This news came after the National Labor Relations Board (NLRB) issued a complaint against

ASARCO alleging numerous violations of federal labor laws. In a letter to union members, the USW explained that NLRB allegations include failure to bargain in good faith, illegally declaring an impasse in negotiations and unilaterally implementing changes to the working conditions.

The strike lines at Ray and Hayden were removed on Monday morning at 6 a.m. as workers left the picket lines to await word if they would be allowed to return to their pre-strike positions.

The Union's decision to end the current Unfair Labor Practices (ULP) strike and by making the unconditional offer to return to work will mean that ASARCO should return the union

members to their pre-strike jobs and avoid any further financial penalties for the company. ASARCO has made claims that it has permanently filled the empty positions at all of their locations.

If ASARCO does not return the striking workers to their pre-strike jobs, the workers are eligible for back pay. Workers who are placed on a recall list would be considered laid off, and they would be eligible for unemployment.

In a letter to Union members, officials stated that this allows the Union to be in a stronger negotiating position for a fair contract.

There was no indication from ASARCO on their plans to return the Union members to their pre-strike positions.



On Monday, July 6, the picket lines in Hayden at the smelter complex and at the Ray pit near Kearny were eerily vacant as striking workers began preparing to return to work.

# The First Postmasters of the Copper Corridor

In the more than two centuries since Benjamin Franklin was appointed the country's first Postmaster General in 1775, the United States Post Office has grown and changed with America. The Copper Corridor's history with the institution doesn't go that far back in history, but is linked with the history of the state of Arizona.

*Copper Area News* wanted to share some of that rich history, exploring the names of the first Postmasters of our region. Join us on a journey to meet those first civil servants and perhaps gains some Historical Perspective.

## SUPERIOR

The Town of Superior was originally called Queen then Hastings. The Superior townsite was laid out in 1902 and the Superior post office officially opened Dec. 29, 1902. George Lobb was the Postmaster.

The post office was located in his general store. Lobb is considered the founder of Superior.

Other towns in the Superior area that no longer exist but were part of the area's history were De Noon, Pinal, Picket Post, Reymert, Queen and Silver King. The mining camps of De Noon and Reymert were named for Judge James De Noon Reymert. Reymert was an attorney, discoverer and owner of the Reymert mine and editor of the *Pinal Drill* newspaper in the mining camp of Pinal. John Knight was the first postmaster for De Noon established March 19, 1890. Elizabeth Reymert was the postmaster at Reymert June 6, 1890. She was the daughter-in-law of Judge Reymert and also managed the Wells Fargo office.

William H. Benson became the first postmaster at Picket Post on April 10,

1878. George L. Miller would take his place on Sept. 25, 1878. The post office was then changed to Pinal on June 27, 1879 with Miller retaining the position. The Queen post office would be established on April 21, 1881. Charles H. Miller was Postmaster. It would be discontinued on Sept. 5, 1881. Silver King was established on Dec. 21, 1877. S.B. Chapin was the postmaster. Dr. Chapin was a physician with an office and drug store on Main Street in Florence. He was only the postmaster for 10 days when the job was taken over by Samuel W. Blakeley.

## GLOBE/MIAMI

The Globe-Miami mining district had a number of mining camps that became towns. Although these places are now ghost towns, they once were large enough to warrant a post office. These towns included: McMillenville, Nugget, Copper

Hill, Pioneer and Stanton.

McMillenville was established in Nov. 12, 1877. It was named for Charles McMillen who had mining interests in the area most notably the Stonewall Jackson silver mine. Charles T. Martin was appointed Postmaster. In 1888, the Arizona Weekly Citizen newspaper reported that McMillenville "has made its mark amongst the foremost mining towns of our country." The camp has two stores, four hotels, four saloons, one bakery, one news depot and confectionery store and three blacksmiths. The camp was made up of workers from nearby mines which included the Stonewall, Robert E. Lee, Democrat, Hannibal and Little Mac.

Nugget was a small camp which provided a mill for the silver mines in the area of Globe-Miami. The post office was established Jan. 7, 1881 and discontinued in 1884. The first Postmaster was George Fantan.

The town of Stanton was located about 18 miles north of Globe. It started as a stage station growing into a community that served local ranches and a mine. The post office was founded on May 14, 1880 and closed down in 1882. Thomas L. Johnson was the Postmaster.

Copper Hill was located just outside of Globe. It once had 500 residents who worked supporting the nearby mines. The post office was established June 18, 1908. Ruth Hayden was the first Postmaster. The great depression marked the end of the town in 1933.

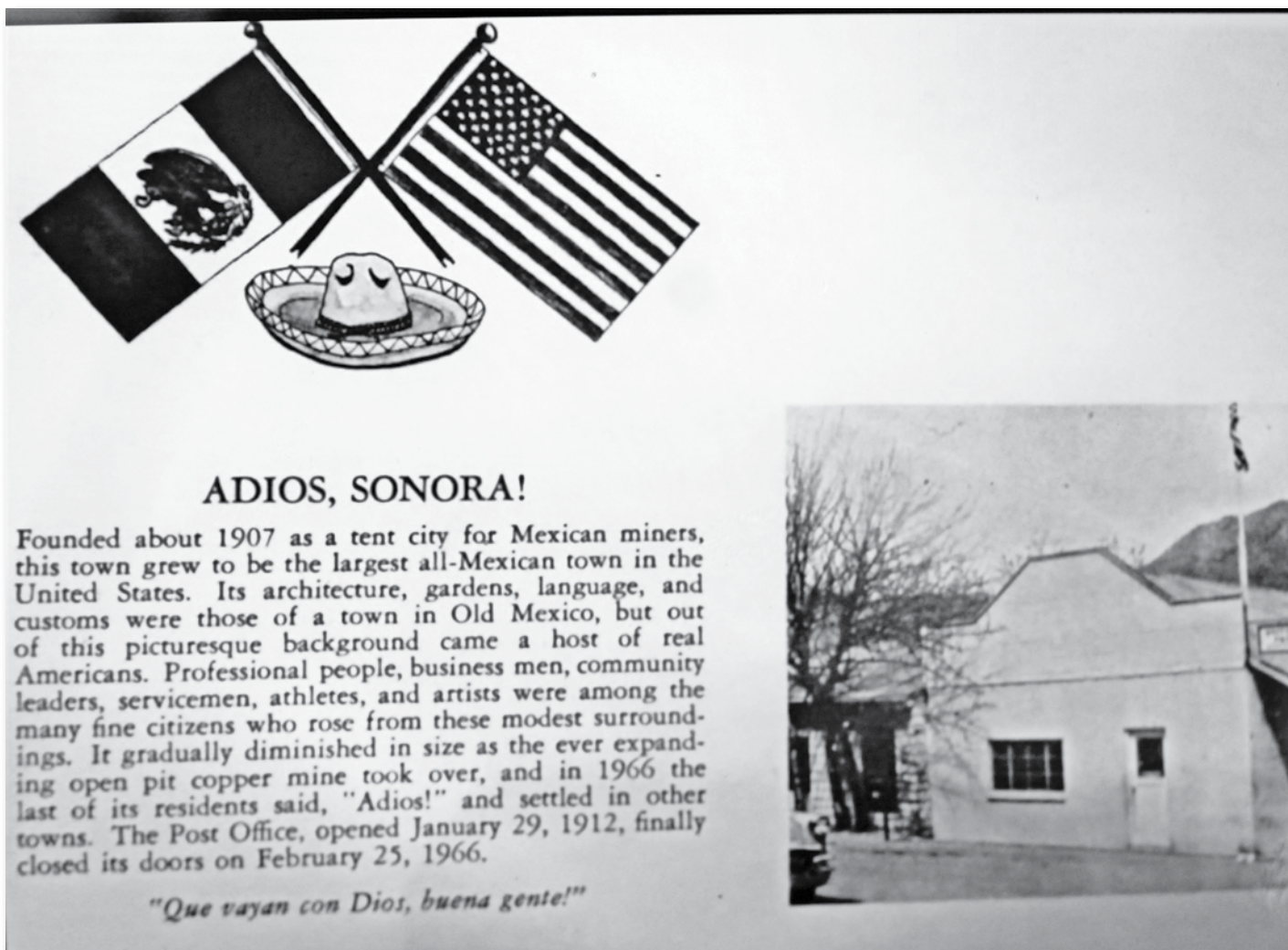
The post office at the now ghost town of Pioneer was established on April 24, 1882 with the Postmaster being Thomas A. Lonergan. The town was named for the Pioneer mine.

The Globe post office was established on Dec. 22, 1876. Edwin M. Pearce was the Postmaster. Pearce had mining claims around the state and was a merchant in Globe.

The first Postmaster of Miami was Gilbert E. Hull. The post office was established Sept. 25, 1908.

## KEARNY/RAY

The Town of Kearny was built in 1958 to accommodate the workers of Ray, Sonora and Barcelona as these towns were being absorbed by the open pit mine at Ray. Kearny was incorporated in 1959 and the first postmaster was Marie Johnson. The first post office established at Ray was on Sept. 8, 1899. Charles R. Clauberg was the postmaster. It would be discontinued in



## ADIOS, SONORA!

Founded about 1907 as a tent city for Mexican miners, this town grew to be the largest all-Mexican town in the United States. Its architecture, gardens, language, and customs were those of a town in Old Mexico, but out of this picturesque background came a host of real Americans. Professional people, business men, community leaders, servicemen, athletes, and artists were among the many fine citizens who rose from these modest surroundings. It gradually diminished in size as the ever expanding open pit copper mine took over, and in 1966 the last of its residents said, "Adios!" and settled in other towns. The Post Office, opened January 29, 1912, finally closed its doors on February 25, 1966.

1903 and reestablished on Aug. 25, 1906 with Enoch W. French as the postmaster.

Barcelona and Sonora were in the same locale as Ray but due to the times, segregation of workers by mining companies was a common practice. Sonora was made up of Mexicans and Mexican-Americans; Barcelona housed Spaniards; and Anglos lived in Ray. All three towns were demolished to make way for the open pit mine. A post office was opened at Sonora on Jan. 29, 1912. Frank Abril was named postmaster. Abril was from a family of merchants in the Tombstone area. He had opened a tailor shop in Sonora in 1911. He was known for supporting the community and as an activist for civil rights.

Other towns that established post offices in the area but are no longer active or they became ghost towns include Kelvin, Riverside, Cochran, Belgravia and Troy. Riverside was established on Oct. 17, 1877. The first postmaster was Charles D. Putnam. It was located along the banks of the Gila River on the newly built road from Florence to Globe. The road was built by the Putnam brothers who owned a ranch in the area. Riverside would soon become a stage stop. The Riverside area would be the scene of some stagecoach robberies including one by the female bandit Pearl Hart. The Apache Kid spent the night at

the Riverside stage stop on his way to Yuma prison in 1889 before his escape the next morning on the Kelvin Grade resulted in the killing of Sheriff Glen Reynolds and a deputy.

The location of Belgravia was first known as Hercules, named for the Ray-Hercules Mining Company. The post office at Belgravia was established Nov. 15, 1918. It served the mill for the Belgravia mine. It would be discontinued in 1930. The first postmaster was Frederick O. Locks.

The first mining camp located on Troy Mountain was known as Skinnerville. The Troy Manhattan Company took over the mine and named the community Troy after Troy, New York, the hometown of one of the owners. The post office was established on April 27, 1901. Mrs. C.T. Hutchings was the Post Master. The mail was discontinued in 1910 and routed to the town of Kelvin.

The Kelvin post office had been established on April 25, 1900 with Sarah Hockett as Postmaster. The town was established by the Ray Mining Company and was named for Kelvin Grove, Scotland by Lord Gordon. The Ray Mining Company was owned by British interests. A concentrating mill was located at Kelvin. Ore was transported from Ray by railroad.

Further down the Gila River towards Florence, the town of Cochran was settled.

Cochran was named for John S. Cochran who owned mining claims in the area. The town was a station for the Phoenix and Eastern railroad. The railroad built a stone station there and Cochran laid out a townsite in 1904. It serviced mines and prospectors in the area, most notably the Columbia, Belle and Martinez mines. He became the first Postmaster on Nov. 5, 1905. Nothing much is left of this ghost town. There are a few building foundations, a metal tank and some old pipelines. Across the Gila River from Cochran are the bee hived shaped coke ovens.

**HAYDEN & SURROUNDING AREAS**  
Hayden was established Dec. 3, 1910. Harry C. Adams, Postmaster.

Hayden Junction established Dec. 3, 1910, with Joseph B. Boughton, Postmaster. Hayden Junction was located near the present day Copper Basin Railway.

The Winkelman post office was established on March 8, 1905. Ernest A. Spann was the first Postmaster. The town of Winkelman was named for Peter Winkelman a rancher in the area.

The post office in Christmas, Arizona was established on June 17, 1905. The town was named for the Christmas mine. William W. Swingle was the Postmaster. It would become known for its postmark

when thousands of Christmas cards and packages would be sent there to be re-mailed and postmarked "Christmas". The post office was discontinued in 1935.

The town of Dripping Springs is located about 14 miles north of Hayden. It was known for its fine ranching and farming land in the valley as well as the numerous mines above it in the Dripping Springs mountain range. The post office at Dripping Springs was established on Nov. 13, 1886. Mary O. Strockey was the Postmaster.

Dudleyville was a farming community.

Several sandbag locations have been set

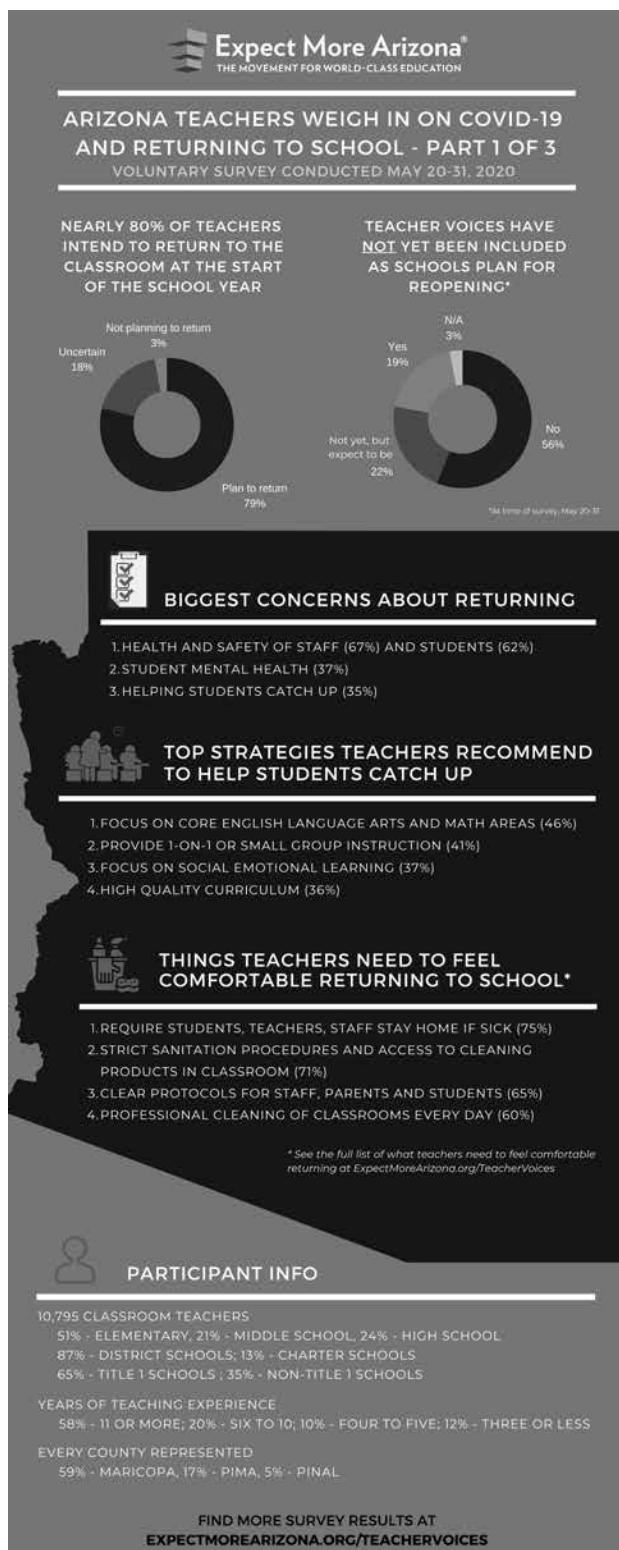

# What Arizona teachers think about re-opening schools for the 2020-21 school year; Expect More Arizona releases results from statewide survey



Arizona educators have many concerns about getting back to teaching and want to be a part of the decision-making process as schools consider their reopening plans. This, according to results from a survey of Arizona educators released by Expect More Arizona.

“The COVID-19 pandemic has created unprecedented challenges for schools all over the world and Arizona has been no exception,” said Christine Thompson, president and CEO of Expect More Arizona. “Spring closures reminded our community that educators are some of the most dedicated and necessary professionals out there.”

According to the survey, 79 percent plan to return to the classroom with 18 percent still undecided. Only one quarter of respondents indicated that the pandemic influenced their decision.

But concern about the virus remains. Half are concerned or very concerned about their safety and health when they return to their classrooms in July or August. By far, teachers’ biggest concerns about returning to school are the health and safety of staff (67%) and students (62%). Other key areas of concern include student mental health (37%) and helping students catch up (35%).

Nearly 10,800 classroom teachers voluntarily completed the survey. While a majority of respondents were from Maricopa County (59%) every county was represented in the survey.

As of May 31, the majority of Arizona teachers had yet to be included in school planning conversations, with 56 percent sharing they had not been included and 22 percent who had not yet been included, but who expected to be in the future.

“While no one knows what the next few weeks, months or even year will hold, it is essential that schools and other education decision-makers include student, parent and teacher voices in the process,” Thompson added. “The large number of participants in our survey speaks volumes about educators’ desire to be heard.”

Three in four respondents want to see rules requiring teachers and students to stay home if they are sick. Additionally, strict sanitation procedures and access to cleaning products in the classroom should be a priority for school districts, along with clear protocols and procedures for staff, parents, and students.

“Now is the time to rally behind schools to support our teachers and students,” said Thompson. “The costs associated with COVID-19 will be substantial, and at a time when budgets are already tight. We must ensure school needs are met so they can continue the vital work of closing achievement gaps and preparing the next generation of leaders,

professionals, entrepreneurs and more.”

The survey was conducted by Expect More Arizona in partnership with the Arizona State Board of Education. Data was compiled and analyzed by Arizona State University’s Mary Lou Fulton Teachers College and Decision Center for Educational Excellence, led by Kristi Glassmeyer, Jeanne M. Powers, and Joe O’Reilly. Other groups assisted in sharing the survey with teachers, including the Arizona Department of Education, Arizona Charter Schools Association, Arizona Education Association, Arizona School Boards Association, Arizona School Administrators, Arizona K-12 Center, Arizona Education Foundation, Tucson Values Teachers and many more.

William D. Harrington, an Irishman would become the first Postmaster. Cox and his partner, Newton Israel, opened a dry goods, groceries and hardware store at the camp in 1868.

The post office was in the store. In September of 1879 Israel and Cox dissolved the partnership. Israel became the postmaster Feb. 23, 1870. In May 1870, Newton Israel was killed by Apaches along with a man named Kennedy during an attack on a wagon train near Cañon del Oro.

George Cox would discover the bodies and burned wagons. Following the Camp Grant Massacre in 1871, where more than 100 old men, women and children were killed by a group of civilians made up of Americans, Mexicans and Papago Indians from Tucson, plans were made to move the fort. In 1873 the fort was moved to Graham County near Safford. The post office was then discontinued.

Feldman was named for Henry Feldman as the post office was located in his ranch house. Feldman was the manager of a cattle ranch owned by George Pusch. The first Postmaster was Hugh Ballinger, son-in-law of George Pusch and store manager at the Pusch & Zellwager ranch. Ballinger was appointed Postmaster on Nov. 22, 1911 after the Dudleyville post office was moved to Feldman and Frank Acton resigned.

Camp Grant was originally a small military garrison set up at the junction of the San Pedro River and Aravaipa Creek. It was first called Fort Aravaipa. In 1860 it became an official military fort named Fort Breckenridge. During the Civil War, troops were removed to help the war effort back east and the Apaches burnt down the abandoned fort. In 1862 the California Column reestablished the old fort and called it Fort Stanford. On Nov. 1, 1865 the name was changed to Fort Grant in honor of President Ulysses S. Grant. Soon, civilians began moving into the area establishing ranches and businesses. The population warranted a post office which was opened Aug. 19, 1869.

George Cox was the first Postmaster. Cox and his partner, Newton Israel, opened a dry goods, groceries and hardware store at the camp in 1868. The post office was in the store. In September of 1879 Israel and Cox dissolved the partnership. Israel became the postmaster Feb. 23, 1870. In May 1870, Newton Israel was killed by Apaches along with a man named Kennedy during an attack on a wagon train near Cañon del Oro.

George Cox would discover the bodies and burned wagons. Alma was located on the west bank of the San Pedro River south of Winkelman near the conjunction of the San Pedro and Aravaipa Creek. The post office was established on May 12, 1891. Frank M. Doll was the Postmaster. Frank owned a store and home there. In January 1895, Frank and his son John were brutally murdered by two Mexicans during a robbery. Mrs. Doll survived the attack. The post office closed in 1898.

# Tonto National Forest closed; access to Arizona Trail limited

Officials with the Tonto National Forest announced that effective July 2, 2020 the nation's sixth largest forest would be closed. The closure came after 224,500 acres have burned on the Tonto National Forest in 2020. Increasingly dry and hot weather also affected the decision to close the forest. There is not a date set to reopen, officials will determine a reopening date based on monsoon moisture and a decrease in fire danger across the forest.

Currently the Tonto National Forest is fighting the Polles Fire in Rim Country. The Polles Fire was caused by a lightning strike on Friday and is burning in the Matagal Wilderness. The communities of Pine and Strawberry are on alert at this time and the Tonto National Bridge State Park is closed. Crews will be working to develop a fire line to protect these communities.

The forest closures and ongoing fires comes as a double whammy for the

communities adjacent to the Tonto National Forest. With campgrounds, trails and picnic areas closed over the entire forest, this means fewer visitors to the area and decreased traffic to local stores and restaurants by those who recreate on the forest. There was a noticeable absence of ATV and four-wheel drive groups visiting local restaurants in Superior over the weekend. COVID-19 has increased the demand for recreating outdoors and the forest closure does affect the local economy. The fires could affect the whole Copper Corridor. Many segments of the Arizona Trail are affected by fires across the State of Arizona; the repairs to the trails are not only costly but are also destructive to the scenic beauty of the trail.

The Legends of Superior Trails (LOST) shared a map showing that the LOST trails in Superior which were still open, however the segments on the Tonto National Forest are closed. This includes recreation in

Arnett Canyon and the Jungle/Pinal City area.

"These are areas that locals can often find some respite from the heat and enjoy outdoor recreation," said Mayor Mila Besich.

The Tonto National Forest also has several near-by higher elevation recreation areas such as the Pinal Mountains, Rim Country, and Pleasant Valley (Young) areas that are also affected. Bruzzi Vineyard in Young, Arizona shared with local media outlets that the road closures affected access to the businesses in their community of Young.

"We all want to protect the forest and

ensure everyone remains safe," said James Bruzzi from Bruzzi Vineyard. "The forest closure is an additional hardship for our businesses on top of COVID-19. Our communities near the Tonto provide places for people to enjoy physically distant recreation, now we can't even offer that."

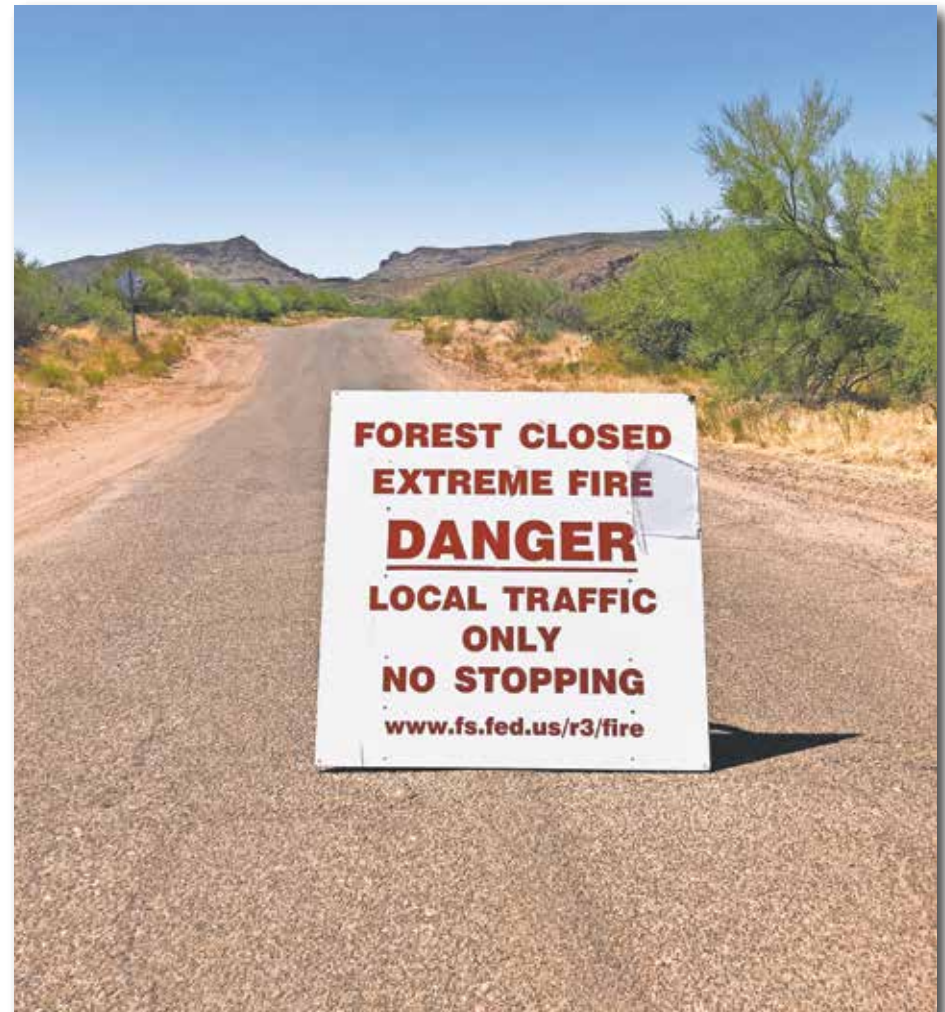
