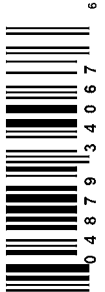

She was an avid sports fan and obsessed over her beloved U of A Wildcats. Her belief in people, students, family and friends helped her impact so many lives. The COS students she mentored were the inspiration for her profound work and dedication. She carved out a beautiful life, was the centerpiece of a wonderful family and created a legacy of work that left an everlasting impact in the community

Robert L. Perkins passed away Saturday, July 30, 2016, at his home in Oracle. Robert lived in Oracle for 60 years and worked for Magma Copper for 36 years. Robert was a loving father, grandfather, great-grandfather, husband and friend.

Written in his own words, about his life:

On April 17, 1932 in Fulton, Missouri, Sam Perkins and Anna Perkins had a new baby boy in their house. They named him Robert Lee Perkins. They told me, when I was old enough to understand, that I weighed 4 pounds at birth and I fit in a shoe box. Big boy, Big Boy. Out of my Mom and Dad's marriage, they had a total of ten children. five of them reached adulthood and half died before the age of three. The little boy was lucky enough to have one brother and three sisters.

This little boy went to school in a one room country schoolhouse, and, by the way, I was taught by the same teacher for my eight years and missed only one day. After eight years, I went on to high school, but, I was not good in school, so I dropped out after three years. However, while serving in the Army, I took my G.E.D. and completed it and received my diploma. To go on with my life story, after I dropped out of high school, I went to work for International Shoe Company for two years.

Then, in 1951, Uncle Sam called me to fight in the war in Korea. So, in early 1952, I got ready to go. They gave me a few months to get ready. On October 2, 1952 I received my notice to report to Fort Leonard Wood, Missouri, just a short piece down the road from my home town, to take training to serve in the U.S. Army. I was 20 years old, knew nothing about the world, but, I kind of woke up fast to say, "Hey, this is real!". I served 17 months in Korea, then reenlisted for three more years to go to Japan; however, that backfired on me and they let me stay for only 14 months. Then the Army sent me to Fort Huachuca, Arizona.

While stationed there I met and married the love of my life, Dolores Sanches. Together, we had seven children: Rosie Evans, Irene Felix, Roberta (Mike) Perkins, Anna Brunson, Rebecca Perkins, Robert (Rhonda) Perkins and Michael Perkins. I am very blessed to have had all these children. I love them dearly. But, my life doesn't end there, because, they left me with 23 grandkids, 44 great-grandkids and two great-great grandkids.

Services were held Saturday, Aug. 6, at Adair-Avalon Chapel in Oro Valley with a reception following at the Perkins home in Oracle.

Pinal County Public Health prepares for back to school shots by hosting a workshop for school nurses

FLORENCE - On Thursday, July 29, more than seventy employees from Pinal County schools participated in the School Health Workshop presented by the Pinal County Public Health Services District.

The focus of the workshop is to keep children in schools healthy. Arizona requires children attending school to be vaccinated against certain diseases, such as measles and pertussis (whooping cough). The workshop included presentations on state vaccination law, childhood immunizations and infectious disease reporting requirements for schools and child care centers.

In the last two years, Pinal County Public Health has responded to multiple vaccine preventable disease outbreaks in schools and the community, including five cases of measles in 2015 and 22 cases of measles in 2016. Both measles outbreaks were extremely resource intensive to control and stop the spread of the highly infectious measles virus. The best way to prevent measles is through two doses of MMR (measles-mumps-rubella) vaccine given according to the recommended schedule.

Whooping cough remains another public health concern, since from January 1 to June 13, 2016, almost 6,000 cases of whooping cough were reported to the Centers for Disease

Control and Prevention (CDC). Outbreaks of whooping cough at middle and high schools can occur as protection from childhood vaccines fades. To prevent your child from coming down with these illnesses, you should contact your health care provider to ensure that you and your family are up to date on your immunizations.

Director of Public Health Tom Schryer said: "It is important to make sure that children are up to date on vaccines before sending them back to school, vaccines are an effective way to keep childhood diseases out of our schools and keep our children safe." School-age children, from preschoolers to college students, need vaccines to protect themselves and the community from serious diseases. Getting every recommended dose of each vaccine provides children with the best protection possible and helps build herd immunity to prevent unnecessary illnesses and deaths in the community. If you are unsure of Arizona's immunization requirements, now is the time to check with your health care provider or local health department.

- Preheat the oven to 375 F. Spray eight cups of a standard muffin tin with nonstick cooking spray.
 - Grate the peeled potato. Rinse with cold water and pat dry with paper towels or use a salad spinner. Divide shredded potatoes into prepared muffin cups.
 - Drop a tomato into each cup. Sprinkle with salt and pepper and then bake for 5-6 minutes.
 - While the potatoes pre-bake, whisk together onions, bell peppers and egg, making sure to lightly beat the eggs.
- Note: basically any ingredient that works in an omelet will

work here!

- Take the muffin tin from the oven, pour the egg mixture into each cup, sprinkle with cheese, and bake for 12-14 more minutes. The eggs will puff up in the oven. When they're done, the center won't jiggle.
- Remove from oven. After they cool for a minute, loosen around the edges with a knife and lift from the pan.
- Serve immediately or let them cool completely before wrapping and freezing. Microwave to reheat.

Mammoth San Manuel Schools will be participating in the [National School Lunch Program and the School Breakfast Program. As part of this program. Mammoth Elementary, First Avenue Elementary and San Manuel JR/SR High offer healthy meals every school day. Breakfast costs .85 Elementary and \$1.10 JR/SR High; lunch costs \$2.50. Your children may qualify for free or reduced-price meals. Reduced-price is .10 for breakfast and .40 for lunch.

Qualifications for children to receive free or reduced price meals include: belonging to a household whose income is at or below the Federal Income Eligibility Guidelines, belonging to a household that receives public assistance, or if the child is homeless, migrant, runaway, foster, or participates in a Head Start or Even Start pre-Kindergarten program.

Household size and income criteria are used to determine eligibility for free and reduced-price benefits if the household does not receive assistance or the children are not in the other categories mentioned above. Children can get free or reduced-price meals if the household's gross income falls at or below the limits on the Federal Income Eligibility Guideline chart.

To apply for free or reduced-price meals, households can fill out the application and return it to the school unless the household has already received notification that their children are approved for free meals this year. Application forms are being distributed to all households with a letter informing households of the availability of free and reduced-price meals for their children and what is required to complete on the application. Applications also are available at Mammoth Elementary, First Avenue Elementary and JR/SR High cafeterias and offices.

Only one application is required for all children in the household and the information provided on the application will be used for the purpose of determining eligibility and verification of data. Applications may be verified at any time during the school year by the school or other program officials. An application for free or reduced-price benefits cannot be approved unless it contains complete eligibility information as indicated on the application and instructions. In the operation of child feeding programs, no child will be discriminated against because of race, sex, color, national origin, age, or disability.

Families can apply for benefits at any time. If a household member becomes unemployed or if the household size increases, the household should contact the school. Such changes may make the children of the household eligible for benefits if the household's income falls at or below the Federal Guidelines. Contact Joanna Diaz, DTR 520-385-2336 ext. 2214 at any time to request an application.

Under the provisions of the free and reduced-price policy, Joanna Diaz, DTR will review applications and determine eligibility. Parents or guardians dissatisfied with the ruling of the official may wish to discuss the decision with the determining official on an informal basis. Parents wishing to make a formal appeal for a hearing on the decision may make a request either orally or in writing to Lisa Armenta 520-385-2336 ext. 1110.

When known to Mammoth San Manuel Schools households will be notified of their children's eligibility for free meals if they are members of households receiving assistance from the:

- Supplemental Nutrition Assistance Program (SNAP);
- Food Distribution Program on Indian Reservations (FDPIR); or
- Temporary Assistance for Needy Families (TANF), if the State program meets Federal standards.

An application is not required for free meal benefits for Assistance Program participants and all of the children in the household are eligible for free meal benefits. If any children were not listed on the notice of eligibility, or if a household does not receive a notice of eligibility, the household should contact the school to have free meal benefits extended to them. Participants in the Special Supplemental Nutrition Program for Women, Infants and Children (WIC) may be eligible for free or reduced-price meals, but they will need to turn in an application including household size and total income.

When known to Mammoth San Manuel Schools households will also be notified of any child's eligibility for free meals if the individual child is considered "Other Source Categorically Eligible", because the child is categorized, as defined by law as:

- Foster
- Homeless,
- Migrant,
- Runaway,
- Enrolled in an eligible Head Start, or
- Enrolled in an eligible pre-kindergarten class.

If any children were not listed on the notice of eligibility, the household should contact the school about their eligibility through the list above, or should submit an income application.

Households notified of their children's eligibility must contact the school if the household chooses to decline the free meal benefits. For more information, you may call Joanna Diaz, DTR or Marie Luna at 520-385-2336 ext. 2214.
