US 60 east of Superior to close briefly for blasting operations this week

Motorists traveling along US 60 between Phoenix and Globe on Thursday morning, Aug. 13, need to plan ahead or allow extra time as the Arizona Department of Transportation begins blasting work as part of a project to build a new passing lane and widen roadway shoulders east of Superior.

The construction of the two-mile-long climbing lane from Devil's Canyon to Oak Flat (mileposts 231-233) will require a full closure of US 60 for up to 90 minutes from 9 a.m. to 10:30 a.m. on Aug. 13.

Traffic on eastbound US 60 will be stopped east of Superior (milepost 227) and westbound US 60 will be stopped at the Top of the World, west of Miami (milepost 235) until the blasting work is completed and the roadway is reopened after all debris is cleared. Law enforcement officers will be stationed at each closure to assist with traffic control.

ADOT anticipates the highway will be closed briefly once a week for blasting for up to three months. As blasting continues there will be a lesser impact on traffic and delays will be reduced.

The \$8.8 million safety improvement project will make it easier for motorists to pass large trucks and slow-moving vehicles whose speed drops because of the sustained grades along this stretch of highway from Devil's Canyon to the Oak

Flat area.

The project will include the following: Construction of a new westbound passing lane from Devil's Canyon to Oak Flat (mileposts 231-233)

- Widening shoulders in the Devil's Canyon area (milepost 233-234)
- Improvements to the Waterfall Canyon bridge (milepost 229)
- Box culvert drainage improvements (milepost 242, west of Miami)

ADOT will work to minimize the traffic impacts as much as possible, including scheduling some nighttime work.

There will be narrow traffic lanes, wideload restrictions and a reduced speed limit through the work zone. Flaggers and pilot cars will be used at different times throughout the project.

Drivers are asked to use caution, watch for construction equipment and personnel, and allow extra time for your commute.

ADOT works to inform the public about planned highway restrictions, but there is a possibility that unscheduled closures or restrictions may occur. Weather can also affect a project schedule. Central Arizona College receives continuation of accreditation through 2022-2023

PINAL COUNTY, Ariz. – Effective March 13, 2015, the Institutional Actions Council of the Higher Learning Commission continued the accreditation status of Central Arizona College through 2022-2023.

CAC was first recognized as a Candidate for Accreditation in 1971 and was fully accredited in March of 1973.

Accredited status indicates the college meets the Higher Learning Commission's Criteria for Accreditation as evaluated through a peer review process. There are five criteria the

College must meet to receive accredited status.

The standards of quality used by the HLC to determine whether an institution is accredited or reaffirmed include:

- · A clear and articulated mission
- Integrity: Ethical and responsible conduct
- Teaching and Learning: quality, resources and support lead to a high quality of education wherever and however offerings are delivered Teaching and Learning: evaluation and

Filtration Plant Now Running

column I wrote to run in last week's Copper Basin News could not be printed owing to lack of space. The gist of the article is that the water filtration plant is now up and running, something it has not done reliably for several years. When the plant was built it was not properly engineered to allow for pressure surges from the well at the elevation of the river and from the water tanks at a higher elevation. The result was "water hammering," which tore apart the pipe mounts in the filtering unit. This is the problem we have now fixed.

That is good news, but I tell you honestly that our water problems are not solved. Our water and sewer lines are old and weakening. The Kearny River Fire put a lot of stress as the fire hydrants received such heavy use and leaks have been springing up almost daily in the water lines around town. Each time a repair is made, old sediments are loosened and carried through the pipes into our homes.

The Town Council has, for the last few months, worked with NCS Engineering on proposals for redoing the water tanks and providing a better pumping system for the homes across the highway from uptown. A grants (or grants) will be sought to accomplish this. We expect to hear soon from Arizona's Department of Housing about our grant to replace some of our fire hydrants and also to begin our ten-year plan for the Town of Kearny (a plan which is a requirement for most of the grants we seek).

With all these repairs, our Public Works Department is short-handed. They have





been called out, day and night, to repair the leaking water lines in addition to their usual scheduled work. I commend them for their willingness to work and their loyalty to the residents of Kearny.

In another direction, Sergeant Dave Blue and the Kearny Police Department are holding a public informational session at Constitution Hall (just past the Town Hall) called "For a Common Cause," about transparency and openness in government and in the conduct of public business. It will take place on Wednesday, August 12, at 6 p.m. and I hope you will be there.







Pomegranates, Pines, Palms and Figs: Plants of the Bible Walk Aug. 15

Superior - Walk just about anywhere in the East Valley and you'll probably find yourself seeking shade, at some point, beneath a palm. They are as decorative as they are functional, especially when swaying in the breeze, and, they bring delight to the eye. Everyone loves a palm tree, whether for food, shade, or, a place to pose for photos. Have you ever considered, though, the iconic tree's role in Biblical scripture and other religious teaching?

What about pomegranates? Learning the lore of these ancient fruits, alone, could be worth a full tour. Pomegranates would have been more likely than apples as the original 'forbidden fruit' in the Garden of Eden. Legend has it the pomegranate was among seven species collected to demonstrate fertility of the promised land; and pomegranate carvings topped columns and pillars in Solomon's temple. As well, they were among symbols sewn into priestly garb. Some say the number of seeds within a pomegranate finds a parallel in the Torah and that its crown-shaped calyx was a

model for crowns in Jewish tradition. Paintings show a pomegranate in the hand of Mary.

Learn more about pomegranates, palms, pines, figs and other plants of the bible lands on Saturday Aug. 15 at Boyce Thompson Arboretum (BTA). Mesa resident and bible scholar David Oberpriller leads a relaxing, slow-paced 8 a.m. walk down smooth, level, and wheelchair -accessible trails where you'll see examples of dozens of plants that are referenced in scripture and thriving at the Arboretum.

Oberpriller's popular tour repeats on the third Saturday of each month, so, mark your calendar for Sept. 19. It's included with BTA daily admission of \$10 for adults and \$5 for ages 5-12. Admission is free for kids under age five and to BTA annual members, and AZ State Parks pass-holders.

ice

½ cup raw sugar or salt for the rim (I like sugar, my boyfriend prefers salt. Please note that you should salt/ sugar your rim before you pour! Also, a red solo cup will not work. The sugar/salt will not stick to plastic. Glass works best.)

Lime wedges for garnish (If you like the drink more tart, squeeze the lime wedge into the glass after you swipe the rim before using it as a garnish.)

10-12 oz. lime juice (Depending on how tart you like it.) 6 oz. tequila

4 oz. triple sec

10-12 oz. prickly pear syrup (Depending on how sweet you like it.)

Stir together syrup, lime juice, tequila, and triple sec; pour over ice if you like it on the rocks or crush it up in the blender. Serve and enjoy!


