Hayden football player in serious condition following accident Saturday

A Hayden High School student and athlete Saturday was seriously injured in a single-vehicle car accident near Aravaipa.

According to the Arizona Department of Public Safety Public Information Officer Timothy Case Jr., the accident was reported on Aug. 22 at 3:59 p.m. on Hwy. 77 at milepost 125. The driver and sole occupant, Santiago Pina, was airlifted to a Phoenix-area hospital with serious injuries. Case said the cause of the collision is still under investigation. "Since the driver is the only person

involved," Case said in an email to Copper Area News, "our investigators will need to interview him once he's released from the hospital to find out what happened."


He added that the entire roadway was blocked for a short period of time while first responders were working to save Pina.

Pina was supposed to play varsity football for Hayden High School. Coach John Estrada said that he showed real promise in practice.

Hayden-Winkelman Schools and many residents of the surrounding communities

on Monday night held a candlelight vigil for Pina. The district posted the following statement to its page on Facebook: "We are extremely appreciative for our community as well as surrounding communities who came today for Santiago Piña and his family. It's a beautiful sight to see such an outpouring of support shown. THANK YOU!. #Lobostrong #Weloveyousantiago."

County, Mammoth Still in Negotiations for Police Service

s many of you know, the Town of Mammoth and the Pinal County Sheriff's Office are currently in negotiations regarding law enforcement services for the town. The question is whether or not to dissolve the Mammoth PD and pay the County Sheriff for police protection.

While this is NOT a decision for me to make, I want to know what the majority of residents from Mammoth want.

This is where the issue stands at this point. Sheriff Babeu has set a minimum cost of \$320,000 for four deputies assigned to patrol Mammoth. The Town of Mammoth has made Sheriff Babeu an offer of \$250,000 plus. The Sheriff will not accept less than \$320,000.

I need to know if Mammoth residents want me to advocate for one position or another with the Sheriff and the Pinal County Board of Supervisors. If the people in Mammoth want the Sheriff to come in, I will work towards helping secure funding for a fourth deputy to be assigned "at-large" for Mammoth and surrounding communities. If residents don't want the sheriff coming in and prefer their own police department, I will stay out of the town's & Sheriff's negotiations.

I know that times are tough in the eastern part of Pinal County. Budgets are tight and extra funds are hard to come by. I

want to help ensure that we have a law enforcement presence in Mammoth that the residents want.

You may also feel free to walk into the Mammoth Office and express your opinion. I would ask that you leave your name so that we make sure no one is tempted to skew the results.

Mammoth Police Report

According to state law, police may arrest suspected offenders by two methods. The suspect may be physically taken into the department and booked into jail, or the arresting officer may write a citation and release the suspect to appear in court later. All suspects are presumed innocent until proven guilty in a court of law. Only criminal citations are listed. All damage amounts are estimates.

Sea Lions host USA Swimming sanctioned meet

Over the weekend of August 22-23, swimmers from throughout Arizona came to compete in the San Manuel Beast Swim Meet. The long course meter (50 Meter Pool) meet was hosted by the Sea Lions Swim Team.

The meet was a USA Swimming sanctioned meet in which any swimmer that is registered with USA Swimming could compete. There were no qualifying times and entrants who completed the three Beast Events (the 200 Meter Butterfly, the 400 Meter Individual Medley, and the 1500 Meter Freestyle) received special awards. The majority of the swimmers attending the meet were from the Tucson area, however, a few swimmers came from the Phoenix area.

Team scores were not kept at the meet, but the Sea Lions Swimmers won more races than any other team. Sea Lions won 32 races, Oro Valley 15, Tucson Jewish Community Center 13, and Swim Neptune 9.

Evan Apuron (12) won all 10 races he swam over the weekend. Tabitha Kellam (12) won 6 races, Ben Fister (10) won 4 races, while Ethan Kellam (9), Riley Stewart (11), and Andres Valenzuela (13) each won 3 races. Johnny Smallhouse (8)

won 2 races and Rocky Andrade (10) won 1 race.

Coaches were pleased with the number of personal best times at the meet.
Coach Alex Gort was delighted about the strength of the 10 and under Boys. In nearly every 10 and under Boys event, a Sea Lion swimmer was battling for first place, and many times they were battling each other for the top spot. The fact that 4 different Sea Lions won those races is very impressive. Even more impressive is the fact that three other Sea Lions; Joey Castellanos (9), Mason Stewart (9), and Emerik Zovko (10) were only fractions of a second from also winning races.

Only 5 individuals completed all three Beast Events and all were Sea Lions swimmers. Rocky Andrade, Riley Stewart, Tabitha Kellam, Evan Apuron, Andres Valenzuela, all completed the toughest events in swimming earned a 'Beast Certificate'.

Star Chavez participated in her first USA Swimming sanctioned meet. She did well in competition and swam some tough events like the 400 Free, 200 IM, and 100 Butterfly.

The Sea Lions swim team hosted the swim meet, but it was only possible

with help from the San Manuel High School Swim Team, Sycamore Canyon Academy, and many other volunteers from throughout the community. Visiting teams were pleased by the small town hospitality and look forward to coming to future meets in San Manuel. 

At the end of her fourth year of teaching, the first year that she was eligible because she was newly tenured, she received the "Teacher of the Year" award. Seroyer was also an executive member of the Madison City School's New Teacher Induction Team where she, along with central staff personnel, coordinated the induction program for new teachers coming into the school system.

Seroyer has presented with Wong for organizations such as the New Jersey Association for Supervision and Curriculum Development (ASCD), the **Texas Teachers Alternative Certification** Program, the North Carolina Model Teacher Education Consortium, Louisiana State University, and has done keynote presentations for Dr. Bill Daggett's International Center for Leadership in Education's Model Schools Conferences.

In addition to their domestic appearances, she also travels with Harry and Rosemary Wong around the world including their latest trip to Hong Kong. She is one of the featured teachers in Wong's online classroom management course and her complete story was featured in a February 2005, www.teachers.net column. Mrs. Seroyer is also featured on the DVD in the new 4th edition of The First Days of School, she is a contributing author of the Wong's brand new book, THE Classroom Management Book and she is the only teacher that travels the world and shares the stage with Wong.
