

Superior prepared to defend state championship

After winning its first state title in 54 years last season, the Superior football program doesn't expect another 50-plus years to pass before winning another state championship. As a matter of fact, the Panthers are poised to win another championship this season.

"Last season was historical and a tremendous accomplishment. I am so proud of that group of young men," said Superior head coach Ryan Palmer, the reigning 1A Coach of the Year. "Winning the state championship is a shared experience that team will celebrate for years to come.

"This is a new year, new season, and

new team. In our preseason meeting I told the team we can hang our hats on last year's championship, and say mission accomplished, or we can use that accomplishment as the new standard of excellence, and say we are just getting started. The unanimous response was the latter.

"Superior football has a motto," Palmer added. "We don't rebuild, we reload. Winning the state championship is the goal of the program each year."

The Panthers do, in fact, have plenty of talent to reload with, including four seniors and two juniors who are threeyear starters.

Seniors Daniel McConnell (OL/DE), Gabriel Castillo (NT), Gabriel Otero (RB/ LB), and Sammy Lopez (WR/DB), along with juniors Adam Navarrette (Off & Def Flex) and Matthew Diaz (RB/LB) are the returning three-year starters. Sophomore center AJ Lara is also a returning starter.

The Panthers have arguably fielded one of the top two quarterbacks in the conference the last six years in Nicolaus Cruz and Steven Ybarra. This year, sophomore Matthew Cruz will play the most important position on Palmer's offense. Expect more success at that position, especially considering Cruz' lineage: he's the younger brother of Nicolaus, a four-year starter and one of the best to ever wear the Superior uniform.

Palmer expects four players to make immediate impacts as new starters: Joshua Marquez, Andrew Martinez, Julian Navarro and Marc Mendoza.

Experience will be the Panthers greatest strength, not just the number of returning starters but their experience in the playoffs: three semifinals appearances in as many years and two state championship game berths in 2017-18.

Still, the Panthers have another strength in 2019.

"Speed will also be a strength of this team," Palmer shared. "Four skill-position players ran 4.8 seconds 40-yard dashes, or under. I have never coached a team with more than two or three players that ran the 40 under five seconds, let alone 4.8." Superior begins the defense of its state championship this Friday at home versus Valley Union. Kickoff is scheduled for 7 p.m.



Input sought for potential assisted living center and tiny house village

The Kearny United Methodist Church is in the preliminary planning stages for an assisted living center and tiny house village on its property adjacent to the church building. Developing such a project is a multiyear project requiring many planning steps.

At this point, to get investors, the church needs a sense of how many people in the Copper Corridor area would be actively interested in such a development. To that end, it is asking people to complete a questionnaire available locally at several locations. Participation in the survey does not legally bind participants but does indicate a strong possibility of utilizing the service in the future. Though there are no guarantees that the project will ultimately be built, there is a strong commitment on the part of the church and

strong support from the Town of Kearny, Pinal-Gila Council for Senior Citizens, Pinal County Economic Development and the housing department.

The vision is to build 12-16 rental tiny houses for elders, young teachers, millennials and adventurers. The village will be for people wanting to downsize or to live simply in a friendly, mutually supportive neighborhood. All units will have a view of the mountains to the south. Tiny houses are stand-alone dwellings of 400 square feet or less similar to studio apartments. All will be designed for independent living but will be accessible to those with limited mobility. Meals, housekeeping and home healthcare are not included but residents may contract independently for such services.

Nearby there will be an assisted living center for an undetermined number of people so that local elders or people with disabilities do not need to be placed in facilities far from home.

The natural desert setting of the land will be maintained to the highest extent possible. All will be supported by the availability of the parish hall as community center. The planning effort is being led by local resident and church member Carol Hosler.

Travel ID getting more attention

With the federally-imposed deadline of Oct. 1, 2020 drawing closer, as of this past Friday the Transportation Security Administration will advise passengers passing through airport security checkpoints that it's important to consider getting a Travel ID in order to meet upcoming new federal identification requirements.

The Arizona Department of Transportation Motor Vehicle Division offers the federallycompliant Travel ID at all MVD locations statewide. It's also available at those Authorized Third Party providers that offer license and ID services.

"This is a significant step for the TSA," said MVD Director Eric Jorgensen. "It's important for the flying public to be aware of these new ID requirements. While those requirements are a federal mandate, licenses and IDs are issued by the state, and we encourage all Arizona motorists to strongly consider getting the Travel ID. It's the simplest way to ensure you have the proper ID needed to pass through airport security starting on Oct. 1, 2020."

He added, "The Motor Vehicle Division has made this process very simple. People can make an MVD office appointment at servicearizona.com. Prior to coming to an office, a visit to azdot.gov/travelID will help begin the application process. Those who make an office appointment will typically be served in fewer than 30 minutes."

In order to get a license or ID, customers need to bring three forms of documentation, including:

- 1. Proof of ID such as a birth certificate or valid U.S. Passport 2. Proof of Social Security number, such as a Social Security
- 3. Two documents proving Arizona residency such as a utility bill, rental statement or similar items
