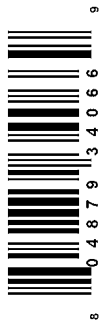

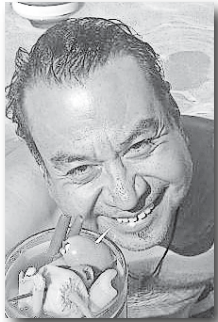
Richard A. Zavala

Armando always looked to the future for something better for himself and his family.

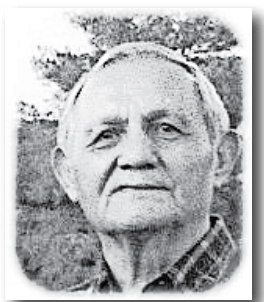

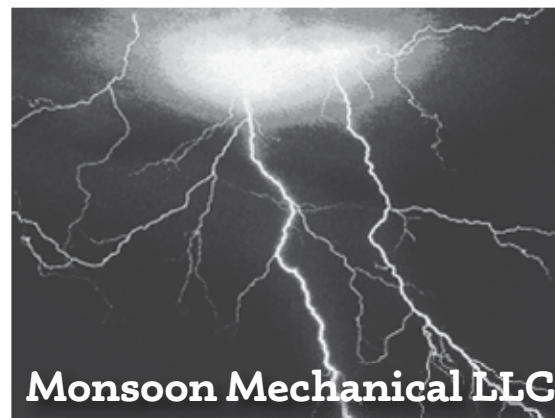

Copper Area News is committed to providing our readers with as much information as possible. We post a daily update on our Facebook page with the total positive COVID-19 Data. This graph shows the daily counts of positive cases for the past week as of press time on Aug. 4, 2020.

There are a few points we would like our readers to consider when following this data.

1. This will continue to be a rolling total of positive cases. It does not reflect recoveries or deaths. The Arizona Department of Health Services does not break out this data.
2. If you see a reduction in numbers from day to day it is most likely due to a data entry error or mis-coding of a zip code (at the state level).
3. This is all zip code based data; most of our zip codes include unincorporated areas. There is no way to track exactly which areas each of the positive cases are. Example, Kearny and Winkelman each have small communities in their zip code that are not in the Town's incorporated boundaries.
4. If you live in Gila County, please follow the Gila County Health and Emergency Management, Facebook. They have maintained their data on recoveries and current positive cases.
5. You can follow other data such as ICU bed use, Ventilator use and hospital capacity online: <https://bit.ly/3inh280>

Working together, we can slow the spread of the virus across the Copper Corridor. Wear a mask in public, remain physically distant (6 feet apart or more), practice good hygiene (wash your hands frequently, sanitize high touch areas) and stay home if you are not feeling well.

Superior Schools announce reopening plans

The Superior Unified School District Governing Board approved the District's 2020/2021 Reopening Plan last week. The plan was developed as a result of Governor Ducey's Executive Order 2020-51. This plan will include the following details:

- Superior Schools will open remotely beginning on Aug. 17.
- Superior Schools will operate remotely for a minimum of 30 days.
- SUSD will use the AZ Department of Health Services COVID-19 metrics data to determine a date when it will be safe to reopen in-person.
- SUSD will allow a limited number of

students to work remotely at each school site. First priority will be given to special needs students and children of first responders/essential workers. All other students will be allowed on campus based on need and capacity. Parents will need to call each school site and check for availability. (Students will be screened and required to wear a mask).

- Transportation will be provided for students attending remotely on campus.
- Breakfast/lunch will be delivered to each bus stop for all students enrolled in SUSD. (More details to follow).

CVIT Remembers Superintendent Pete Guzman

With a broken heart the staff of Cobre Valley Institute of Technology announces the passing of Superintendent Pete Guzman on Wednesday July 1, 2020.

Superintendent Pete Guzman was one of the founding fathers of CVIT in 2000, as the Superintendent at the origination of the District. It was Pete's vision to make CVIT what it is today. Under his leadership CVIT was formed as a career and technology district with Miami, Hayden and Superior High Schools. San Carlos joined CVIT in 2006, Globe in 2008 and finally Ray High School in 2016. CVIT was Pete's heart and soul and he worked

hard to bring opportunities of free career and technical education to high school students in the Copper Corridor. Today CVIT has career and technical education programs in each member high school and sends its students to two community colleges (CAC and EAC) for college level, industry certified instruction so they are truly work and/or college ready after high school graduation.

Pete was a lifelong resident of Arizona. He was born and raised in Hayden, where his career in education began. He was a teacher, coach, athletic director and a K-8 principal from years 1973-2001. From 2002-2013, Mr. Guzman was also the Superintendent for Superior Unified School District. Pete's honors and awards include but are not limited to: Arizona School Boards Association Superintendent of the Year (2007); All-Arizona Superintendent Award from Arizona School Administrators (2006); Certificate of Recognition from American Red Cross (1993); All-Arizona Hispanic Coach of the Year (1992); Arizona Coaches Association; All-Star Coach (1985, 1986, 1988); Arizona Coach of the Year from Arizona Coaches Association (1988); and All-Star Basketball Coach from Arizona Coaches Association (1983).

Pete Guzman was an extraordinary visionary in education. Above all he was an exceptional human being. One could not go out in public with Pete – have lunch at a local restaurant, etc. – without several people stopping by to say hi and thank him

for what he did for them. He left his mark on students, teachers, and staff wherever he was. His big heart, integrity and compassion was next to none. He treated his employees with respect and care; he made everyone feel important and a part of a team. He surrounded himself with good, student-oriented people and when in doubt he would always ask, "How does this benefit students?" His management style brought him a lot of respect and admiration from students, coworkers, and the community at large.

CVIT's former Executive Program Director Beata Tarasiuk remembers Pete Guzman as a person of extraordinary integrity and passion for education.

"He always believed in me and allowed me to reach for the stars in my professional career. It is a mark of a great leader to allow his employees to shine. He left a legacy of kindness excellence. I still have his words sounding in my head: 'If you need me, call me anytime,' and he always answered the phone," Beata said.

Former Administrative Assistant Rachel Cardenas had this to say: "Mr. Guzman was considerate, courteous and very devoted to his profession and family. It was an honor to have worked with him."

Business Manager Donna Roach said, "He was more than just a boss, he was a friend. He always had time to listen, and had plenty of life stories and experiences to share. His passion for CVIT was the engine that pushed him forward."

Mike O'Neal, the Interim Superintendent, said one of his biggest takeaways from working with and being mentored by Pete for the last four years was that if Pete believed it was in the best interest of kids, he was going to do everything within his power to make it happen.

"The impacts Pete has had on lives of students within the copper corridor are immeasurable, and he will be greatly missed," he added.

Franceen Gregovich-Benton, one of CVIT's Founding Board Members and longtime friend and colleague, said: "Pete was so devoted to education and I learned so much from him. He was such a calming influence. I would be worked up about something and he could calm me down and have me look at the bigger picture. He would say to me, 'It will be fine Fran, don't worry.' He was a true blessing to CVIT and me."

Board Member Yvonne Lees remembers Pete as a lifelong educator and visionary. "Pete was always trying to bring new

education opportunities to our region. He was excited to include San Carlos High School in CVIT, he knew that students would benefit from a variety of programs," she noted.

Mike Fane, CVIT's Board Chairman, remembers Pete Guzman as devoted leader and a lifetime coach.

"We often talked about high school sports," Mike said. "Pete had a true passion for sportsmanship and student education and development through team building. He was a coach in his heart throughout his career in education."

"Mr. Pete Guzman was an exemplary leader," said Anna Flores, Vice Board Chairman. "I served under his phenomenal leadership as the School Counselor when he served as the Superintendent and Principal of the Superior Unified School District. I also worked with Mr. Guzman as a CVIT School Board Member. Mr. Guzman made a significant impact in my life regarding his love for students and staff. He made a difference in the lives of everyone he came in contact with. Mr. Guzman's tireless dedication to education made him a class act. He had a firm belief in holding high expectations for all students while meeting their unique needs and supporting their academic success. Mr. Guzman understood that this is a daunting challenge that educators face each day so valuing and appreciating teachers and school staff were one of his highest priorities. He met challenges regarding education, head-on. He truly gave his heart and soul to his family and his school family. He was a true and genuine

Changes for Superior Library

Superior Public Library will begin offering Curbside Service at the library by appointment only beginning Aug. 10, 2020.

Here is how it will work:

Eligibility:

Individuals in good standing holding a valid and up to date library card issued from the Pinal County Library District and its branches are eligible for Curbside Service check out and pickup. If your card has expired you can call the library at 520-689-2327 to renew and update your registration.

Reserving/Scheduling a pickup:

You can go onto our Pinal County Library District Online Catalog at www.pinalcountyyaz.gov/Departments/Library and place a hold on the item(s) you wish to check out. You can also download the new PCLD app on either Apple App Store for iOS devices or get it on Google Play for Android devices. Search for "PCLD." All you need is your current library card to search the

catalog, access your account, see events calendar, download materials, view databases and ISBN reader.

OR:

We will be placing lists of new BOOKS and DVDs that come in each week on Friday morning. You can come pick up a list from the brown box next to the Book Drop and select the items you want to check out and create a list and drop it in the Book Drop with your name and phone number or you can call the library with your request. Limited to 5 books and limit on DVDs is 2 per patron.

If an item is not available at our library we can request from another library if it is available. If you go online and place a hold from another library it will come in with the courier either on Monday or Wednesday. We will give you a call to let you know it came in and arrange a date and time for pick up. Make sure we have your correct phone number. Patron accepts full responsibility for all items being checked out to them at that

time.

When you arrive for pick up you MUST remain in your car and MUST wear a mask. You can call the library on arrival and we will come to the curb to hand you your bag with checked out items. Returning delivered items:

Patron is responsible for returning all borrowed items on or before the due date to Superior Public Library. They must be placed in the Book Drop. Books can be renewed 3 times and DVDs 1 time unless there is a hold placed on the item by another patron.

All returned items will be cleaned and placed in quarantine for 72 hours (3 days) before returning to the shelves or made available for check out again. Only books and DVDs will be checked out at this time.

Patron Code of Conduct:

All Superior Public Library patrons are expected to follow all applicable Code of Conduct guidelines and principles.

Free Dump Day

Free Dump Day in Kearny will be returning as soon as Pinal County Public Works and Health Department determines that it is safe to allow dumping at the Kearny Transfer Station. Until the return of Free Dump Day it is recommended that residents take advantage of vouchers issued by Pinal County that can be used at the Dudleyville Dump. 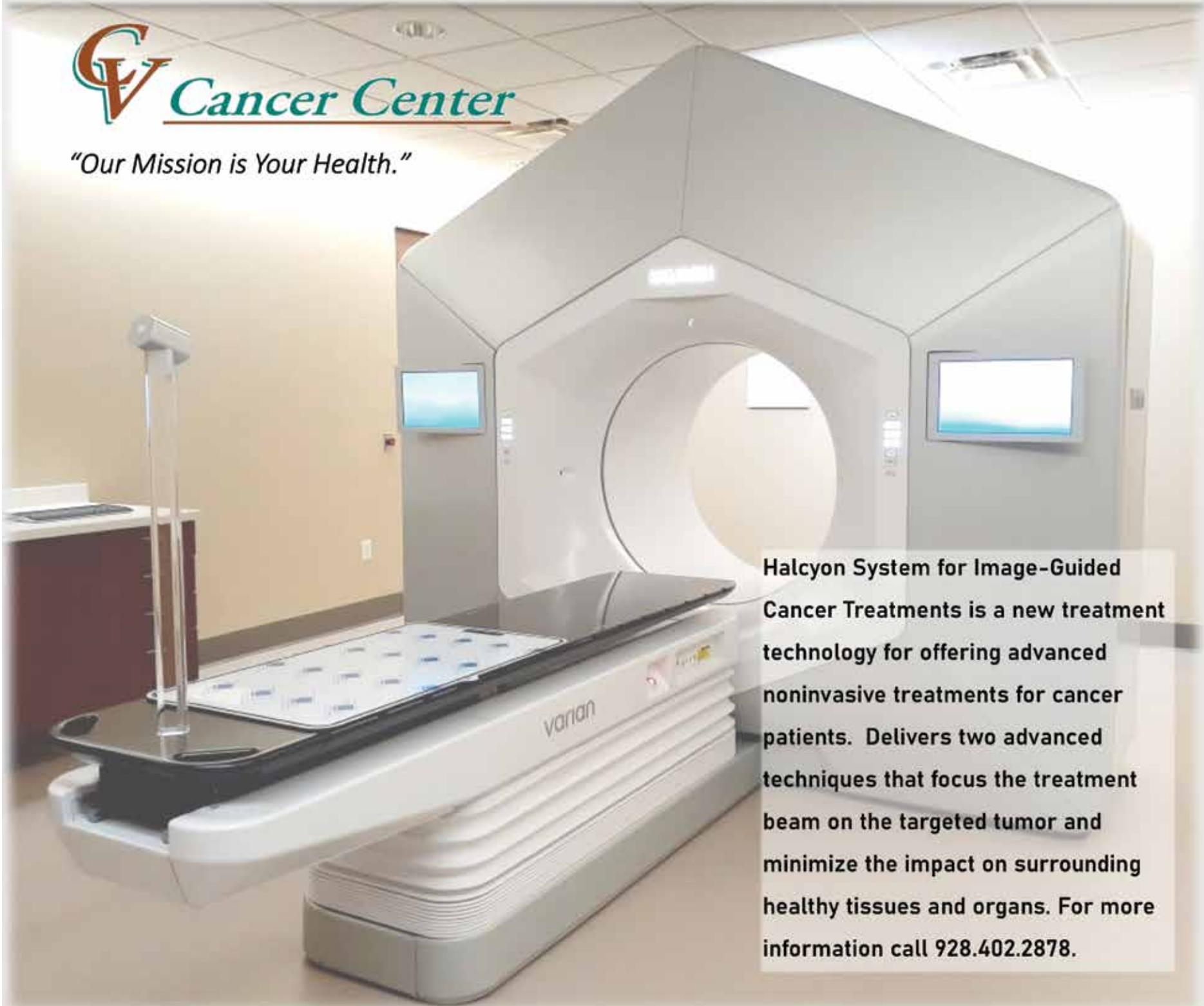
