# Town Council addresses redevelopment in Superior

New development and recommended variances were at the top of the list of actions taken by the Superior Town Council at last week's regular meeting.

Sue Anderson on behalf of the Superior Chamber of Commerce requested the redivision of 161 Main Street. The building, formerly Smokey's, was recently purchased by the Chamber and the group has determined that it only needs half of the building for its purposes. It was originally two buildings combined into one

property in the past. The redivision variance would not only help the town's financial industry by the sale of the property but also has the opportunity to increase the town's tax revenues by allowing a second business in the space. The Superior Town Council approved this variance with the stipulation that the fire wall legal ordinances will be upheld prior to escrow.

Kane Graves, Superior's Town Manager, was happy to report that the Magma Hotel Project is moving forward and they are in the process of submitting the second set of revised

engineering plans that will be presented to the Town Council in September.

In other development issues, the Circle K management is working on its re-zoning application. And one of the few medical marijuana clinics in Pinal County, Superior Organics, is up and running and located at 750 S. Belmont.

Copper Community Hospice was chosen as one of the top 100 throughout the United States for a National Hospice Award. There were only two facilities that received this award in the state of Arizona.

The award was calculated by a survey data bank as to customer service and how patients and families were treated. Margo Badilla a Registered Nurse and Administrator for Copper Community Hospice informed the Town Council and public that they have been here in Superior for two years and although it is not an easy job they have a great team that help the ones in need of end of life or terminal care and the families of patients. Copper Community Hospice has Registered Nurses, Certified Nursing Assistants they provide social visits and volunteer assistance. One important fact stands out in Margo's mind when the Hospice first came to Superior the town and people graciously accepted and welcomed them. Margo said the way the community pulls together and works through things is very unique. Copper Community Hospice is a home hospice with offices located on Main Street in

Superior. The Superior Council was officially introduced to the new Town Clerk, Margaret Gaston, and was recently honored by the Arizona Municipal Clerks Association. Margaret has had a long career of working in the municipal arena. In February 1989, Margaret Gaston was hired by the Town of Kearny **Public Works Department** as a heavy machinery operator. In 1996, she moved to Town Hall as Kearny's Town Clerk and Town Treasurer where she



# Superior Town Council hears concerns regarding the Southeast Arizona Land Exchange, Resolution

Positive and negative opinions on the Southeast Arizona Land Exchange and Resolution Copper Company: the different voices emanating from the crowded Superior Town Council Chambers Thursday night ran the gamut from people who have lived in Superior all their lives to the newly relocated.

Thursday's special meeting began with Superior Councilwoman Soyla "Kiki" Peralta speaking about the history of Superior's relationship with copper mining and Resolution Copper Company.

Superior has one of the largest ore bodies in the country and has been a mining community for over 100 years, Peralta began. There has been growth and decline that comes along with mining. In 2008, Resolution Copper (RCM) submitted a pre-feasibility

Plan of Operations which was just to explore and assess. Peralta said that the Town Council to this date has not seen or received answers regarding an actual Mining Plan of Operations. In February 2013, the Mutual Benefits Agreement between the Town of Superior and Resolution Copper Company was terminated by the town. Peralta said that there were many legal issues and areas in the agreement that were not beneficial to the town. Peralta said that when the Superior Town Council became aware of Hank Gutierrez's conviction for a conflict of interest, it caused the Mutual Benefits Agreement to become null and void; the Town Council expected RCM to act in

Peralta said.

The Town Council simply does not have answers or legal assurances, Peralta said. The Town Council needs RCM to give written, legal assurances with jobs accounts, water quality, tailing sites and environmental impact. "It is our responsibility, everybody's responsibility, to ask these questions and get answers," she said.

Penny Pew from Congressman Paul Gosar office appreciates the townspeople's support and has received hundreds of letters from the community in support. "Gosar has been working towards approval of the Land Exchange. Representative Gosar has an open door policy and always has," Pew said. Penny hopes the town of Superior will reverse their opposition and that everyone can work together.

Sandra Doyle, a Superior resident, spoke of people who have lived and died and if they were looking down on the town of Superior and situation they would be appalled. She wants to know what can be done to work together and feels there are a lot of people that want the mine in the town.

Mila Besich Lira said this is something the town needs to look at responsibly and get the best benefit for the community. The biggest concern is how everything was done and how the council's action blindsided everyone, not only the company, but the supporters

# CVIT program provides technical 'college' training for high schoolers


Ashley Darreas, a senior from Superior Unified School District, participates in many activities and one in particular the Cobre Valley Institute of Technology (CVIT) program. Ashley began the CVIT program her junior year of high school and continues with the program this year. Ashley has a rigorous schedule that starts with six hours of regularly scheduled high school classes. She also participates in cheerleading for football and basketball after school and at games. After this her CVIT classes begin. She has CVIT classes from 4:30 p.m. until about 6 p.m. She has homework for her high school classes and also with CVIT. Ashley also participates in the Family Community Career Leaders of America (FCCLA).

Ashley in enrolled in the Geology CVIT Program and really enjoys the college professors and classes. In her Geology classes she has lectures and labs. Geology is the science that deals with the dynamics and physical history of the earth, the rocks and the physical, chemical, and biological changes that the earth has undergone or is undergoing. One of her classes she recalls measuring sizes of earthquakes with a linear line chart. They were taught to measure the earthquakes based on the chart and even where the earthquake had started. They also had worked with the dirt and sand to see if it stayed sloped or angled from the earthquake. They also take the students on field trips.

Ashley's Geology class last year had 10 students. Having a smaller class gave the students the opportunity to get to know each other and the professor's on a more personal level. The CVIT Geology class was actually held in Superior last year. The professor was from Central Arizona College and at different times an Arizona State University professor would attend and help teach the students.

Christopher Villaverde Jr. is another Superior senior that participates in the CVIT program. Christopher has been enrolled in the electrician field and after this year when he graduates with his high school diploma will also have his associates degree. Christopher started the CVIT program his sophomore year in the graphic design field, but then changed to the electrician field his junior year. He plans to obtain a job in the electrical field right out of high school and CVIT has made this possible for him.

Christopher, like Ashley, has his regular classes at Superior High School. He also participates in tennis, FCCLA and CVIT. This summer Christopher was able to participate in the FCCLA Nationals that were held in Tennessee. During nationals he was awarded a silver metal for his work. Christopher also has an interest in law enforcement and is currently a Pinal County Explorer through the Pinal County Sheriffs Department. He has been with them for about a year and a half now. Christopher said through the CVIT program he has made many new friends and has great teachers.

# Ernie Brace to receive POW, Purple Heart medals

On July 17, 2013, the Secretary of the Navy signed off on awarding Ernest C. Brace the POW and Purple Heart Medals for his time as a POW in Laos/Vietnam.

The awards were sent to the U.S. Marine Corps for presentation and will be made Aug. 16, 2013 at the base theater, Kingsley AFB, Klamath Falls, Oregon.

The awards, except for the POW Medal, were

originally recommended for Brace by Adm. James B. Stockdale on the POWs return in 1973, but were put on hold because Brace was a civilian at the time of his incarceration. The application was represented to SecNavy in 2011 through Senator John McCain's office and drafted by Capt. Rod Knutson, USN, Retired, a fellow POW.

The presentation will be made on the 62nd

anniversary of Brace's being commissioned a Second Lieutenant in the US Marines on August 16, 1951, the day after he turned 20 years old. The presentation is open to the public.

Brace was the longest held civilian prisoner of war in the Vietnam conflict. His story was told on the National Geographic's show Locked Up Abroad on April 17 of this year. He was a Vietnam POW for over seven years.

His family has a history in the Copper Corridor area, Dad Cary, Mom Ruth and two sisters moved to Ray in 1951 and eventually the parents moved to Superior and sister Rose (Bradford) to Kearny. Sister Betty lived in Superior and Florence until her death in 1994. Ernie and his wife reside in Oregon and he

enjoys a very active life at the age of 81. He has written two books about his experiences A Code to Keep and Monkey Paw Soup. Both can be ordered from Amazon. com

The docudrama titled Vietnam POWs:McCain and Brace also featured Sen. McCain's story. He was a military POW and was held captive for five and a half years by the North Vietnamese.

"Had we known that the mutual benefits agreement had to be revised the smart thing to do would have been to have a meeting with stakeholders, Resolution officials and figure out how we can work on things together," Lira said. "The reason this town has been in an uproar for six months now is due to lack of transparency. If you are going to be elected it is best that everyone understands because then you avoid these kinds of problems. Yes, Resolution is a good thing and if we support it we might get some good things for our community like a Heritage Park, open Railroad for tourism, but right now there is no plan."

Andrew Taplin of Resolution Copper would like to see the Town Council put aside the differences that have occurred, put the past behind and start moving forward for mutual success. "To accomplish this," he said, "we need a solid relationship." Andrew feels the issues the Town Council are concerned about can

be addressed and would welcome the opportunity to address the issues and move in an optimistic forward motion.

Curt Shannon with the Gold Canyon Access Fund "would like to see the recreational areas not destroyed by the mining."

Alana Jefferies born and raised in Superior said there is so much more to offer than mining. "The beauty, art and people," she said, "it's a very special place." She really hopes not to see a tailings area across from the Arboretum in Superior. (Resolution Copper Company has not released information regarding its choice for where the tailings will be deposited.)

Manual Ortega brought up the health factor and how

What RCM is looking at they will be here for 50 to 100 years, not just Oak Flat will be affected, he added.

Marilee Lasch spoke about "cancer being worldwide and part of being human beings". When she moved to Superior she opened a little shop but then the mine opened and things changed. Lasch said, "We have to work together as a community and we have to keep the faith."


