

Woman killed in attempt to cross flooded wash

An elderly woman was drowned Monday after being swept down a flooded wash during the heavy rainstorms.

On Monday, Sept. 8, 2014 at 12:38 p.m. the Pinal County Sheriff's Communications Center received a 9-1-1 call from a 69-year-old male subject who reported that he and his wife (age 76) attempted to cross "Cadillac Wash" from Suizo Road (near Oracle Junction) when their vehicle began to float down the wash.

While on the line with the dispatcher, the male advised their vehicle was beginning to take on water. A short time later both exited the vehicle and the male was able to make it to the shore. The male advised his wife who was not able to swim was swept away by the current and he could no longer see her.


Deputies along with officers from the Arizona Department of Public Safety began searching the wash and its bank.

At 1:34 p.m. the Honda Accord the husband and wife had been driving was located approximately one quarter mile down the wash from Suizo Road.

At 2:34 p.m. the female was located near the edge of the river about one quarter mile further down the wash from the car. She was pronounced dead at the scene.

Tim Gaffney, spokesman for the Pinal County Sheriff's Office, said that it was the Pinal County Sheriff's Office Air Unit (helicopter) that spotted the female and directed ground units to her.

"Motorists are always advised not to drive through flooded roads or washes," said Sheriff Paul Babeu. "The husband told our dispatcher, he noticed the water but thought he could drive through it. This is a tragedy and an example of what can happen if you disregard this advice and state law."

Fuels reduction project near Oracle; excess vegetation to be removed

TUCSON, AZ (September 5, 2014) - The Santa Catalina Ranger District, Coronado National Forest will conduct a fuels reduction treatment on 130 acres surrounding the Triangle Y Ranch and adjacent private land.

Implementation will begin in early September and likely conclude in late September. The treatment will be completed with an excavator and skid-steer loader to remove ladder fuels, such as small mesquite and acacia shrubs. In addition to hazardous fuels reduction, secondary objectives include watershed protection and wildlife habitat improvement. By reducing the fuel loading and continuity, the treatment will create a fire buffer around

private land, reduce future fire behavior, and promote herbaceous understory response.

This project is part of a larger effort to reduce hazardous fuels in the Oracle wildland-urban interface. The Forest Service has coordinated the Oracle Fire Department to reduce fuels on both private and public lands. Previously treated areas on the Forest include two projects north and south of the Cody Loop Road.

Hawaiian cowboys have interesting history

While vacationing in Hawaii recently, I came across a photo/history display of the cattle industry in Hawaii in the lobby area of a hotel in Kona, Hawaii. Hawaiian cowboys or "paniolo" as they are known have an interesting history, one that is even longer than that of American cowboys out west. Yes, there were cowboys in Hawaii before they were in Arizona, Wyoming, Texas or other western states.

The first cattle arrived in Hawaii in 1798. British Captain George Vancouver gave King Kamhehameha I five black longhorn cattle as a gift. King Kamehameha allowed the cattle to range freely and forbid his subjects to harm the cows for 10 years so a herd could be established. Having no natural predators on the Big Island of Hawaii, the cattle soon thrived on the rich grasslands. They multiplied quickly and soon over ran the ranges sometimes getting into the islanders crops and destroying their thatched huts. Within 20 years the wild cattle numbered in the thousands

In 1809 a 19-year-old sailor from Massachusetts named John Palmer Parker jumped ship on Hawaii. He would find a job tending fish ponds for the King. During the War of 1812 Parker joined the navy. After the war he returned to Hawaii to live and was given exclusive permission to shoot the wild cattle and supply beef, tallow and hides to locals and foreign whalers and sailors. Within a year Parker had a thriving business. The salt beef industry replaced sandalwood as Hawaii's chief export. Parker soon became a wealthy and respected man. He learned the Hawaiian language and practiced their ways. In 1816 he married King Kamehameha's granddaughter Kipikane. They would have three children and establish the Parker Ranch in 1847 and a family dynasty that would play an important part in Hawaiian history for the next two centuries.

In 1832 King Kamehameha III sent representatives to California to contract Mexican vaqueros to teach Hawaiians how to ride, rope, and tend cattle. The vaqueros would bring their saddles, boots, spurs, lariats and culture to Hawaii. The skilled horsemen soon taught the Hawaiians how to be cowboys a generation before the American cowboys in the "wild west" became well known. Many of them stayed and married Hawaiian women. The vaqueros also introduced the guitar to Hawaii and taught Hawaiians how to play it. Paniolo is believed to have come from the word Espanol which the Hawaiian cowboys began calling themselves. The paniolo would soon become known world wide.

In 1907 a paniolo Eben "Rawhide Ben" Low helped bring a Wild West show to Honolulu and Hilo, Hawaii. Eben was a well known and popular cowboy in Hawaii. In 1892 he lost a hand in a roping accident while herding wild cattle. He was still a working cowboy and would give exhibitions roping steers with one arm. He had been to the Cheyenne Rodeo in 1907 and believed that some of the paniolo he worked with could rope better than the cowboys he saw in Wyoming.

One of the Wild West show's performers was the reigning World Champion steer roper Angus McPhee of Wyoming. On the first evening of the show, two Hawaiian

cowboys defeated McPhee in a steer roping contest. The newspapers pointed out that McPhee had an excuse for losing. He had been driven in an automobile directly from the harbor upon arrival to the show and had used a borrowed horse of questionable ability. During other shows, paniolo defeated McPhee again although he won some of the contests. McPhee praised the roping skills of the paniolo. The Hawaiian people now knew they could compete against the best.

The Cheyenne Frontier Days Rodeo committee sent an invitation for Hawaii to send four of their top cowboys to the event. They would donate \$300 towards travel expenses and provide room and board in Wyoming during their stay. Eben Low paid for the steamship trip to San Francisco and the train ride to Cheyenne to send the paniolo to the rodeo.

Three paniolo made their way to Wyoming in 1908 for the Cheyenne Frontier Days Rodeo. They were Jack Low, Archie Kaaua and Ikua Purdy. The three men who wore floppy hats with a flower lei were laughed at by some of their competitors. The laughing stopped once they saw the Hawaiian cowboys rope. The three paniolo borrowed horses from the local cowboys. Jack Low would finish sixth in steer roping, Archie Kaaua placed third and Ikua Purdy won the steer roping contest. He was now the reigning World Champion. Purdy was the first non-American to win an event at the rodeo where the best cowboys in the world competed. The paniolo were welcomed back to Hawaii as heroes. Ikua Purdy was the great grandson of John Palmer Parker and Kipikane. Purdy never defended his title or left the islands again. He was inducted into the National Cowboy Hall of Fame in

2000. A statue of him stands in the ranching community of Waimea, Hawaii. The artist that created the large statue is Fred Fellows a working cowboy and artist from Sonoita, Arizona who visits Waimea frequently.

The Parker Ranch still exists on the Big Island although it is smaller and has been broken up into other ranches. The Ranch still raises calves that are sent to the mainland, sells natural range fed beef and is open to tourists for horseback riding, hunting and ATV rides. The paniolo cowboys and cowgirls from Hawaii come to the mainland to compete in rodeos as well as compete locally.

Miner Swimmers open season with four school records

After several weeks of practices, the Miner Swim Team opened the season last week at a triangle meet between Canyon State Academy and Tempe Preparatory Academy.

The Miner Boys team tied Tempe Prep with each team earning 72 points. Both Boys teams finished ahead of Canyon State Academy (50 points). Tempe Prep finished ahead of the Miner Girls 101 to 68 (Canyon State is a boys only school).

As is the custom in Arizona High School Swimming, the boys swim first during even years (2014 is an even year). To start things off, the boys Medley Relay was closely contested. Even though Tempe Prep won the race, the Miner relay team of Will Newman, Taylor Woods, Colbey Stratton, and Robert Sweeney set a new school record with a time of 1:59.59, beating the record previously held by Jordan Peasley, Wayne Newman, Martin Seballos, and PJ Mortensen (2011) by two tenths of a second.

Some of the Miner strengths showed during the meet. Junior Theresa Sweeney won the 200 and 500 Freestyle showing off her great finishing speed in the 200 to come from behind. Senior Jazelle Sanchez won the 50 Freestyle and looked solid in the 100 Butterfly. Junior Taylor Woods won the 100 Freestyle and looked great in the 100 Breaststroke. Sophomore Colbey

Stratton won the 50 Freestyle and set a new school record in the 100 Butterfly with a time of 1:08.22 (previous record held by Colten Smith since 2010). Freshman Will Newman made his high school swimming debut with wins in the 200 IM (2:14.55) and 500 Freestyle (5:21.36), the toughest events in high school swimming. Newman's times were fast enough to break school records in both events that were previously held by his older brother Wayne.

While the front line had some great swims, Head Coach Alex Gort was pleased with the number of personal best times the team had as a whole. "At this point in the season, it is about training and getting better each week."

The Miners travel to Scottsdale on Sept. 10 to participate in a triangle meet against Scottsdale Preparatory Academy and Scottsdale Christian Academy at 4 p.m. at the McDowell Mountain Ranch Aquatic Center.

Jr. Miners take on Globe after bye week




The Jr. Miners football team returns to action on September 9, 2014, at Globe. The Jr. Miners had a bye last week after a



Is the Tea Party losing its grip on Arizona?



Aravaipa goes Firewise

The nation's federal and state land management agencies and local fire departments have joined together to empower homeowners with knowledge and tools to protect their homes through the National Firewise Communities Program. Firewise Communities is designed to encourage and educate communities on developing local solutions for wildfire safety. The plan involves firefighters, homeowners, community leaders, planners developers, and others coming together to coordinate efforts to design, build, and maintain homes and properties so they are compatible with nature as wildland fires are a natural process.

Aravaipa Canyon has now become a Firewise Community. The idea started with Raimie Manch, vice president of the Aravaipa Property Owners Association and now Aravaipa Canvon Firewise Director. She contacted all of her neighbors and found that they were interested in Firewise. The Aravaipa Property Owners Association contacted Chris Jones, Agriculture and Natural Resource agent for the Gila

County Cooperative Extension in Globe in June 2013. "Chris pointed me in the right directions, telling me what I needed to know," said Manch. He came out to Aravaipa Canyon and held an informational meeting with interested residents of the canyon. Jones explained the Firewise program to those in attendance. "The primary goal for Firewise landscaping is fuel reduction, limiting the level of flammable vegetation and materials surrounding the home and increasing the moisture content of the remaining vegetation," said Jones.

At the spring homeowners meeting in 2014, Faith Berry, Firewise Region I facilitator and Carrie Dennett, Arizona State Firewise liaison provided information on how to become a Firewise community and answered questions. The Aravaipa Canyon East area is now part of the Pinal Rural Fire Rescue and Medical District.

A water map has been developed displaying locations of water sources that can be accessed by firefighting helicopters. Staging areas and evacuation routes have also been proposed. The maps have been given to fire chiefs of the surrounding communities of Dudleyville, Mammoth, Kearny, Hayden and San Manuel. John Stanford, fire chief of the San Manuel Fire Department helped her set up the staging and evacuation sites. They are also collaborating with the Dudleyville Fire

Department. Manch says that, "The Aravaipa Community is looking forward to working with the Oracle Firewise Community to promote fire prevention."
