Local Superintendent Says, Wake Up Arizona

am writing this as a concerned citizen and superintendent who wants my students back in school. I know we are all tired of the coronavirus and just want to go back to a normal life. Me, too. But we are not where we should or could be at this time. Our collective behaviors make a difference in whether people die. Consider the fact that over 200,000 Americans are dead because of coronavirus and public health agencies are predicting there will be over 400,000 deaths by Jan. 1. The promised vaccine ready by the election or soon after will have no impact on these dreadful numbers.

Unfortunately, too many Arizonans do not follow the Governor's message to "Mask Up" in public places. Wearing masks in public can save lives, it should not be debatable at this time. Those who refuse to wear masks are harming everyone, and that is a shame. I just cannot understand why everyone does not participate in this common sense, science-based strategy that will help get us back to normal, or at least a better place. If we continue to refuse to do the simple things, like wearing a mask in public, we will continue to get nowhere with the virus.

What got me upset this past weekend was simply shopping at a popular grocery chain store in the Valley and counting 22 customers without masks in one store. I was shocked because I thought it was a law. I guess not. I also watched the presidential political rallies and see little or no signs of mask wearing in the crowds. These people will come back into our communities and risk the safety of us all and delay the safe re-opening of our schools. It seem selfish to me.

The way out of this tough time is not going to be fast or easy and will require effort and leadership at all levels. The Governor has a "Mask Up" campaign that will have limited effect if everyone decides not to participate. Closing the economy is not required or even the answer if we could just agree to do a few things that make sense and could potentially reduce the amount of pain and suffering in Arizona and through the United States.

The one thing that is concerning is the lack of commitment to coronavirus testing. Dr. Fauci, the leading disease scientist at the Centers for Disease Control (CDC), has said repeatedly that we need to have more testing. Unfortunately, we are now doing less testing over the past months which seems to go against the original game plan to fight the virus.

In addition, there are many that are concerned with the CDC changing its own coronavirus testing guidelines

on Aug. 24. The new protocol no longer recommend individuals who are around someone who tests positive for coronavirus be tested themselves unless they have symptoms. This is especially alarming considering the CDC estimates that 40 percent of those who test positive for the virus are asymptomatic and can easily spread it to others. Then, just last week, the CDC reversed its guidance and now recommends individuals exposed to someone that tests positive should be tested.

This flip-flop in guidance is concerning and reduces the public's confidence in the CDC and questions the politicization of the agency that was once recognized as the gold standard in disease science throughout the world. This is especially alarming as the vaccination is being pushed forward by the CDC over the coming months. This decision negatively impacts public confidence in the agency and potentially the vaccine itself. This at a time when we need most Americans to get the COVID vaccination to eventually rid ourselves of this deadly virus.

Most medical experts believe the more coronavirus testing we do the better. Of course, initially we can expect to find more positive cases as we ramp up testing. This will then allow us to isolate those who tested positive and begin to reduce the ACTUAL cases of the coronavirus in our state and communities overtime. The most important reason we need to increase testing is to identify more asymptomatic carriers. Those without symptoms. Remember, this virus does not impact everyone the same. Some people get the coronavirus and have mild cold symptoms, or none, while others suffer greatly and die.

What we do know by now is that everyone who gets the coronavirus can spread the disease, including children. The virus wants to keep spreading because that is what this virus does well. Being an airborne disease makes it very efficient in its ability to do so. The scientific community concurs that the best approach is to find the coronavirus and isolate it to avoid community spread.

The next strategy the scientific community agrees upon is that everyone should a wear masks in public to protect others. Is wearing a mask in public during the midst of a deadly pandemic too much to ask of each citizen? I do not think so. I feel that an individual's freedom should be limited if it risks the lives and safety of others. Nobody is suggesting taking away our guns; we just wanting to live safely together and as normal as possible.

It is unfortunate. The message at the top was not delivered earlier in the pandemic and isn't being modeled or endorsed in a meaningful way even today. Americans need a clear message driven by the medical experts like Dr. Fauci, which is reinforced at the top every day going forward. That is what leaders need to do and there is still time. Tell Americans the facts and the truth, and we will do extraordinary things.

The bottom line is that our individual behaviors during this pandemic do impact our state, communities, schools, families, and children. Attending large social events and shopping without wearing a mask is endangering us all. I sincerely hope that we can work together and begin to do the right things. Carbon Monoxide Detectors Can Save Your Life


Most homes have a smoke detector. Does vour home have a Carbon Monoxide Detector? Often called the invisible killer. carbon monoxide (CO) is an odorless, colorless gas created when fuels (such as gasoline, wood, coal, natural gas, propane, oil, and methane) burn incompletely. In the home, heating and cooking equipment that burn fuel are potential sources of carbon monoxide. Vehicles or generators running in an attached garage can also produce dangerous levels of carbon monoxide.

CO alarms should be installed in a central location outside each sleeping area and on every level of the home and in other locations where required by applicable

laws, codes or standards. For the best protection, interconnect all CO alarms throughout the home. When one sounds, they all sound.

Follow the manufacturer's instructions for placement and mounting height Choose a CO alarm that is listed by a qualified testing laboratory and call your local fire department's non-emergency number to find out what number to call if the CO alarm sounds.

If your CO alarm sounds, immediately move to a fresh air location outdoors. Call 911 and make sure everyone who was inside the house is accounted for. Call for help from a fresh air location and stay there



until emergency personnel declare that it is safe to re-enter the home.

Copper Area News is committed to providing our readers with as much information as possible. We post a daily update on our Facebook page with the total positive COVID-19 Data. This graph shows the daily counts of positive cases for the past week as of press time on Sept. 22, 2020.

There are a few points we would like our readers to consider when following this data.

- 1. This will continue to be a rolling total of positive cases. It does not reflect recoveries or deaths. The Arizona Department of Health Services does not break out this data.
- 2. If you see a reduction in numbers from day to day it is most likely due to a data entry error or mis-coding of a zip code (at the state level).
- 3. This is all zip code based data; most of our zip codes include unincorporated areas. There is no way to track exactly which areas each of the positive cases are. Example, Kearny and Winkelman each have small communities in their zip code that are not in the Town's incorporated boundaries.
- 4. If you live in Gila County, please follow the Gila County Health and Emergency Management, Facebook. They have maintained their data on recoveries and current positive cases.
- 5. You can follow other data such as ICU bed use, Ventilator use and hospital capacity online: https://bit.ly/3inh280

Working together, we can slow the spread of the virus across the Copper Corridor. Wear a mask in public, remain physically distant (6 feet apart or more), practice good hygiene (wash your hands frequently, sanitize high touch areas) and stay home if you are not feeling well.

Hayden cancels fall sports

The Hayden-Winkleman Unified School District announced in a Sept. 14 press release that it was canceling fall sports.

"Hayden High School will be canceling all fall sports for the health and safety of student athletes, families, and community," a subtitle reads in the release signed by HWUSD Superintendent Jeff Greogorich.

The complete release is as follows:

Due to the COVID 19 pandemic, the Hayden High School will not be participating in fall sports. The concern is that playing sports could increase COVID 19 exposure to our student athletes, families, and community. The safety of everyone outweighs the need to play sports and risks the lives of the most vulnerable in our community.

The school district's top priority is the health of our students, families, and community. The sacrifice of a high school sport season in the middle of the worst pandemic in 100 years is the most responsible and the right thing

The health risks are too high for our district to play sports which could create a COVID 19 community spread. Unfortunately, the virus has not gone away, and children and adults can become asymptomatic and pass it to others. Athletes could contract COVID 19 and unknowingly pass the virus to family members and they could die. Many of our families are multigeneration which creates an additional risk. It is simply too dangerous to play fall sports that will risk the safety and lives of our student athletes, families, and community, right now.

Two weeks ago, Hayden football head coach John

Estrada told Copper Basin News that the school wasn't sure if the Lobos would have a 2020 season and that his team had pushed back the start of practice for two weeks.

Robert Wayne 'Bonzai' Vickers

Copper Area News has received some articles from a former corrections officer from Arizona State Prison. This retired officer spent 25 years with the Arizona Department of Corrections working all custody levels from juvenile detention units to Death Row. The author wishes to remain anonymous. He hopes to provide the readers with a view of what it is like working with inmates and what life is like behind prison walls.

INTRODUCTION

The job of a corrections officer

is not easy. The nature of the job, working with men or women behind bars can be stressful. Working in high custody units can add to the stress. The Arizona Department of Corrections has a high staff turnover rate. One in five staff members guit within the first couple of years of being hired or use the training and experience they receive to transfer to Sheriff departments or Federal corrections.

Maximum custody inmates are either there because they are doing long sentences, are convicted of

violent crimes or they are problem inmates while in prison. Inmates on Death Row are under a sentence of death and have nothing to lose by acting out against staff or other inmates. Officers must always be on the alert to prevent these inmates from harming other inmates or staff. To understand the type of inmates that are housed on Death Row, I will provide you with a few of their stories, the crimes they committed and some of their prison life.

obert Wayne Vickers was not an imposing figure to look at. He was thin, standing six feet one inch and weighing 148 pounds. If you did not know his history, you would find it hard to believe that he was considered one of the most dangerous inmates in the Arizona State Prison system. Although Vickers had gained a reputation for violence while in Arizona juvenile institutions, it was not a violent crime that brought him to prison. He was 19 years old when sentenced to 3 to 9 years for grand theft for a series of burglaries committed in Tempe, Arizona. He arrived at the prison in Florence in 1977. He would not see freedom again.

When Vickers arrived at Florence, it was a time of extraordinary violence. In 1977 there had been 23 stabbings and seven murders at the Florence prison. He was still a teenager and may have felt he needed to engage in assaultive behavior to keep inmates away from him. He assaulted some black inmates probably in an attempt to impress the white racist prison gang "Aryan Brotherhood". In February of 1978, he stabbed Homer Burns with a shank (prison made weapon). He was convicted of assault with a deadly weapon and sentenced to 10 to 15 years. This set the stage for Vickers to earn his nickname and reputation.

Frank Ponciano was the 21-year-old cell mate of Robert Vickers. He was serving time for second degree murder. On Oct. 4, 1978, Ponciano failed to wake Vickers at lunch time and made the fatal mistake of drinking Vickers' Kool- Aid. Vickers strangled Ponciano with a knotted bed sheet and stabbed him 10 times in the back and side with a home made weapon. Vickers then used a toothbrush with a sharpened handle to carve the word "Bonzai" into the back of the dead Ponciano. Bonzai was the misspelling of Banzai, the Japanese patriotic cheer

or battle cry. From then on, the name Bonzai or Bonzai Bob would be used by inmates and staff when referring to Robert Vickers. After this, Vickers would sign his correspondence "Bonzai Bob" with a miniature swastika dotting the letter i.

Vickers was convicted of first degree murder and sentenced to death. He was the only inmate on Death Row for the murder of another inmate. At the trial it was brought out that corrections staff had missed finding Ponciano dead during at least one count. The death was not discovered until Vickers called over a corrections officer and told him to get Ponciano out of his cell. When the officer hesitated, Vickers shoved the burning end of a cigar into one of Ponciano's bare feet. When Ponciano did not react to his foot being burned, the officer called for back up.

In 1981, Vickers was scheduled for execution but a stay was granted by U.S. District Judge Carl Muecke. Vickers was angry because he had asked to be executed. Vickers told the press that he hoped someone "snuffs Judge Muecke's momma" and that he would carve the Judge's name on his next victim. The death penalty for Ponciano's murder would later be overturned and Vickers would be given a sentence of life in prison.

On March 4, 1982, Vickers was working as a porter cleaning a four-man pod area. The other three inmates were locked in their cells. Buster Holsinger, a fellow Death Row inmate, made a lewd comment about Vickers' teenage niece. Vickers had shown Holsinger a photograph of his niece and a drawing she had sent him in a letter. Holsinger then asked Vickers if he had ever performed a certain sex act on his niece. Vickers became infuriated and went back to his cell. He made a homemade incendiary device using an ice cream carton which he filled with five bottles

of Vitalis hair oil and tissue paper which he used as a fuse. He went to the front of Holsinger's cell, lit the oil and tossed the burning carton on Holsinger. When there were not enough flames to engulf the obese and invalid Holsinger, Vickers tossed more hair oil on him. Holsinger's cell became filled with smoke and flames as his mattress, bedding and other items caught on fire. Holsinger died from inhaling the hot fumes of the burning oil. The other two inmates were hospitalized for smoke inhalation. Vickers would be given another death sentence for Holsinger's murder.

Bonzai became well known for being able to slip out of handcuffs and for making and hiding weapons. Vickers assaulted 12 corrections officers and 20 inmates while in prison. He received disciplinary sanctions for 40 counts of making and possessing weapons. In 1986, Vickers managed to stab an officer in his lower side with a home-made spear. He made the weapon out of a sharpened piece of metal he had taken out of a typewriter. Vickers was in his cell at the time. The officer had iust served Vickers his breakfast through a slot when Vickers stabbed him. He formed a 30 inches long handle out of tightly rolled and pasted newspapers.

Special security measures were taken with Vickers. Besides regular handcuffs, thumb cuffs were used whenever Vickers was removed from his cell. In Cell Block-6. a special "cage" was created and welded at the entrance of his regular cell. Vickers would have to enter the cage while nude. His regular cell would then be closed behind him. Officers would then visually inspect him for any weapons, handcuff keys or contraband. He would then be given clothes to put on. Officers would then cuff him, remove him from the cage and escort him to wherever he had to go. Vickers was moved from CB-6 to

the Special Management Unit, a super maximum custody unit. This unit would house the most troublesome inmates in the state.

On May 5, 1999, Robert Wayne "Bonzai Bob" Vickers was executed by lethal injection. His last meal included two green chile burritos, French fries with ketchup, vanilla ice cream, cream soda and one cigarette. There were no regrets from prison staff when Bonzai was finally executed except maybe why it took so long.

AIA adjusts metric to begin competition between teams

About two weeks ago, the Arizona Interscholastic Association announced a geographical area needed 10 people or fewer per 100,000 test positive for COVID-19 to play games in contact sports such football and soccer. Last week, the AIA, with the support of its Sports Medicine Advisory Committee, adjusted the benchmark metric to 75 people or fewer per 100,00.

As a result, it appears soccer and football around the state will begin competition this week and next.

In a press release, the AIA referenced other states that have similar COVID-19 rates to Arizona that are "currently playing football with safeguards put in place by their executive boards." The AIA believes, after "viewing these games for several weeks" that it can successfully and safely conduct football with this new benchmark.

"Seeing the positive results in other states was a big help to reach this conclusion," AIA Executive Director Hines said in the statement. "It's a testament to those associations for putting proper rules in place so football can happen. We have similar numbers and similar safety recommendations as compared to those states."

Football is the lone remaining fall sport that has not starting game competition. All other sports – golf, cross country, swimming & diving, fall soccer, badminton, and girls volleyball – have met the respective benchmarks to begin competition.

"We have been given the opportunity to compete in football. However, it will take all of us — coaches, players, parents, fans, and administrators — to implement all of the modifications," Hines added. "This is critical for us to stay on the current track. It is equally as critical that all involved understand the importance of adhering to the guidance of athletic trainers and medical personnel."

Football is scheduled to commence Sept. 30-Oct. 2.


